


Supplementary Figure 1. Correlation between models. We tested the association of SNPs across the genome with  $\Delta$ NIHSS using an additive linear model adjusted by sex, age, the two Principal Components SNP genotyping batch, TOAST classification and baseline NIHSS. To test the effect of tPA on the results, we perform a joint analysis in the complete GENISIS cohort including tPA as covariate and compare it to the same model without tPA. The figure show how in both models, the results are highly correlated. The X-axis shows the negative  $\log_{10}$ -transformed p-values for the model with tPA as covariate












