Height of the COVID-19 deaths peak

Correlations between significant variables

Correlations between variables reaching or close to reaching significance in univariate models of the deaths peak height were verified. Results are presented in **Supplementary Table 1**. High correlations could be observed between educational facilities closure day and: gathering restrictions day (0.84, $p < 0.001$), border closure day (0.76, $p < 0.001$) and mobility score at the day of first reported death (0.76, $p < 0.001$). The latter one was also highly correlated with gathering restrictions day (0.74, $p < 0.001$). In addition, the number of deaths when closing borders highly correlated with border closure day (0.84, $p < 0.001$). Correlations between number of deaths and number of infections when closing borders and between number of infections and border closure day were close to reaching the high level (0.69, $p < 0.001$, both).

Sensitivity analysis - Selection algorithms

When applying stepwise, backward, forward and genetic selection algorithms to the base case model of deaths peak height, the model with four significant covariates was selected (**Supplementary Table 2**). The fact that the genetic algorithm selected this model indicates its best fit properties. The plot of AICC values across all possible models constructed with the use of covariates from the full model, is depicted on **Supplementary Figure 1**. The best model was associated with the lowest AICC value.

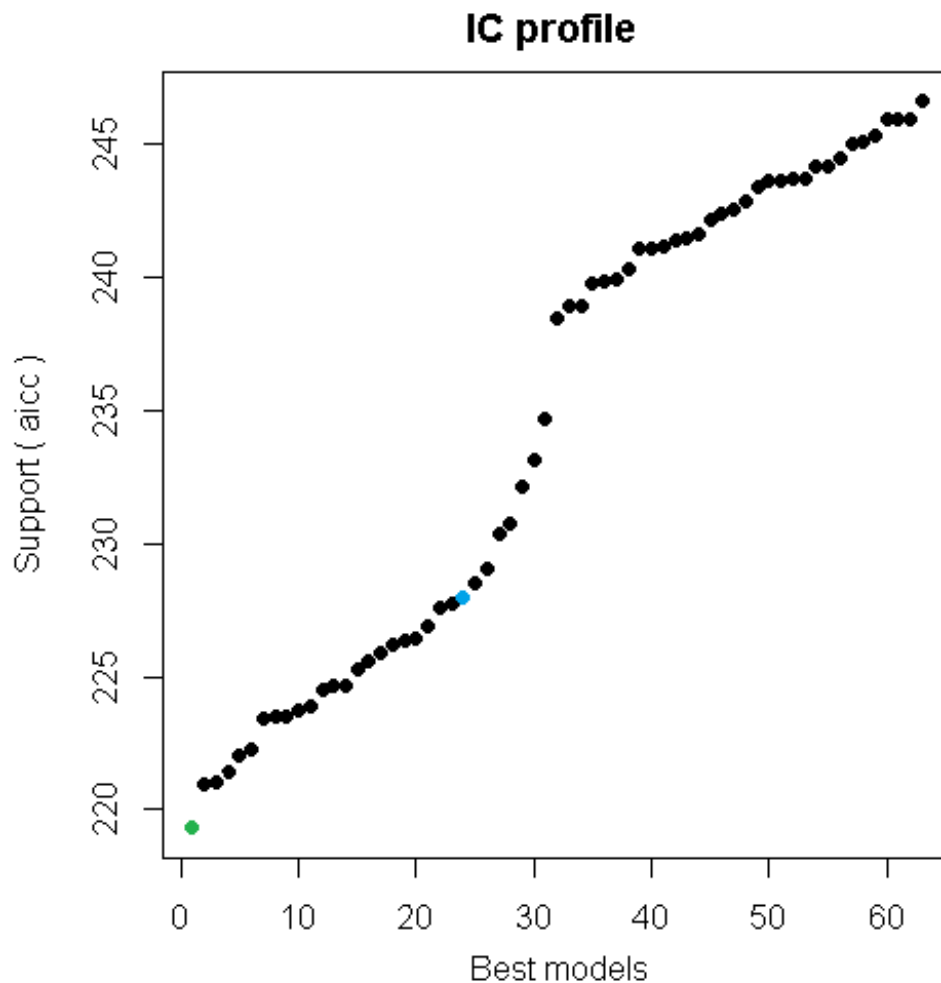

Sensitivity analysis – Exclusion of countries with imputed government restriction dates

The base case and the final GLM models of deaths peak height were re-run on data after exclusion of countries for which government restriction dates, such as businesses or border closure dates, were imputed (N=29). Results are consistent with the base case findings in terms of significance of covariates of interest (**Supplementary Table 3**).

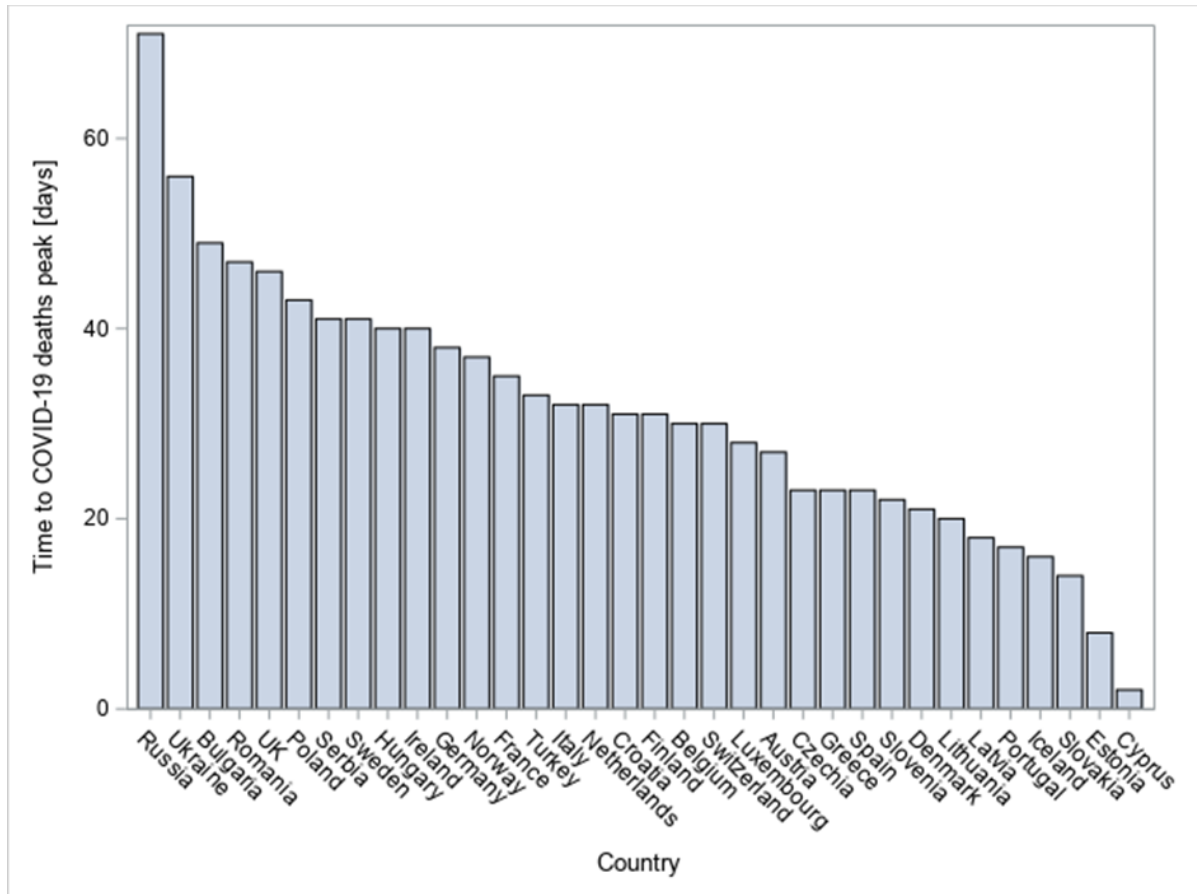

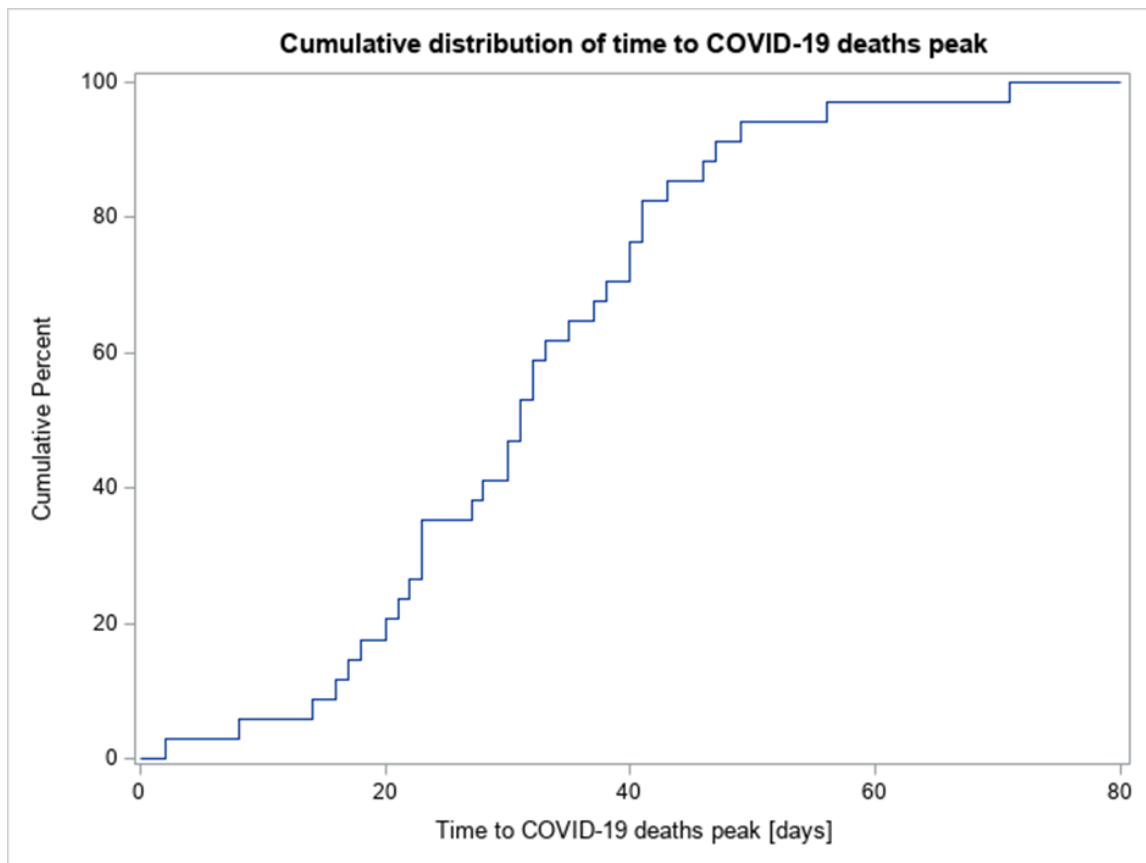

Correlations between significant variables

Correlations between variables reaching or close to reaching significance in univariate models of time to the peak were verified. Results are presented in **Supplementary Table 4**. High correlations could be observed between educational facilities closure day and: gathering restrictions day (0.84, $p < 0.001$), border closure day (0.76, $p < 0.001$) and mobility score at the day of first reported death (0.76, $p < 0.001$). The latter one was also highly correlated with gathering restrictions day (0.74, $p < 0.001$). The number of people that arrived at airports highly correlated with the number of foreign tourists (0.75, $p < 0.001$).

Sensitivity analysis – Selection algorithms

When applying backward or genetic selection algorithms to the base case model of time to the peak, the model with four significant covariates was selected: all beds capacity, population size, number of foreign tourists and border closure day (**Supplementary Table 5**). The fact that the genetic algorithm selected the model indicates its best fit properties, hence this model was selected as the final one.

The stepwise and forward algorithms selected a similar model, but borders closure day was replaced by mobility score at the day of first reported death. However, fit statistics were slightly worse than those of the final selected model.

The plot of AICC values across all possible models constructed with the use of covariates from the full model, is depicted on **Supplementary Figure 4**. The best model was associated with the lowest AICC value.

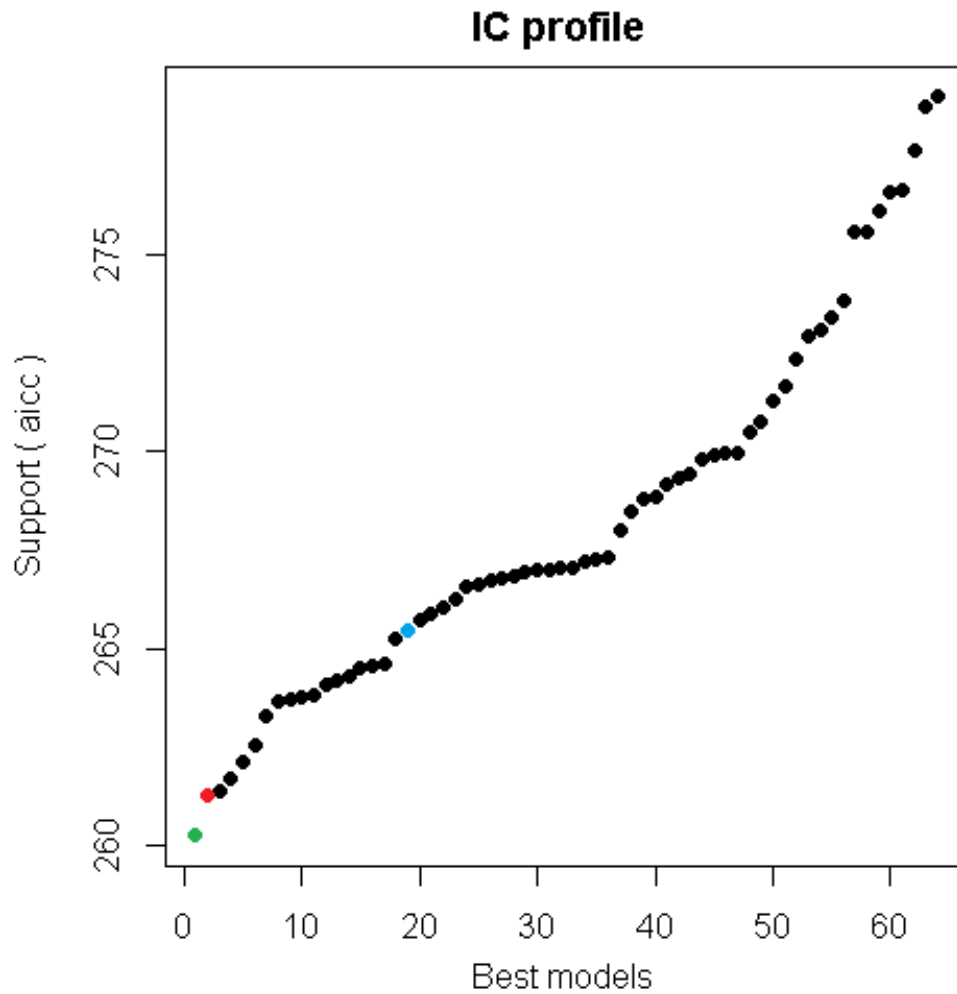

Sensitivity analysis – Exclusion of countries with imputed government restriction dates

The base case and the final GLM models of time to peak were re-run on data after excluding countries for which border closure dates were imputed (N=31). As a result, all beds capacity and population size remained significant in the final model, whereas remaining two variables, number of foreign tourists and border closure day, were close to reaching the significance level ($p < 0.1$) (**Supplementary Table 6**).
