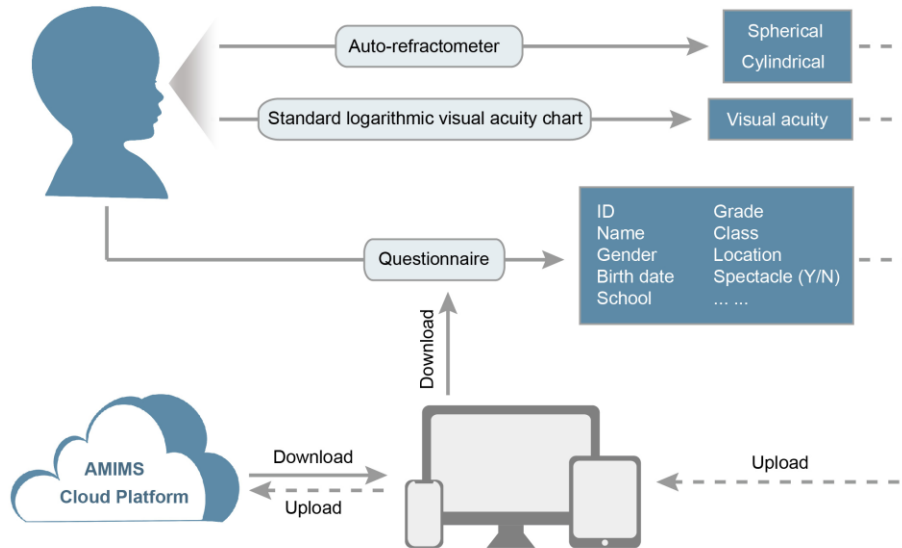

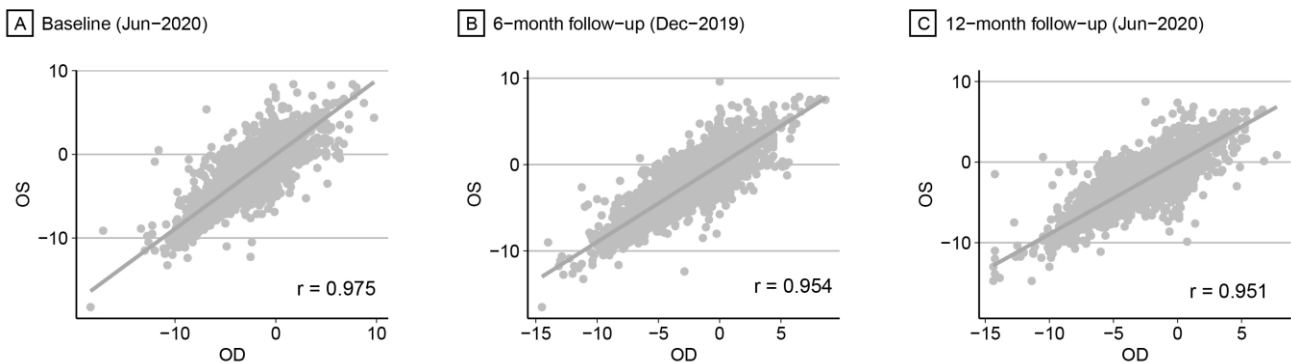

Supplemental Figure S2. Correlations between left- and right-eyesight across three examinations.

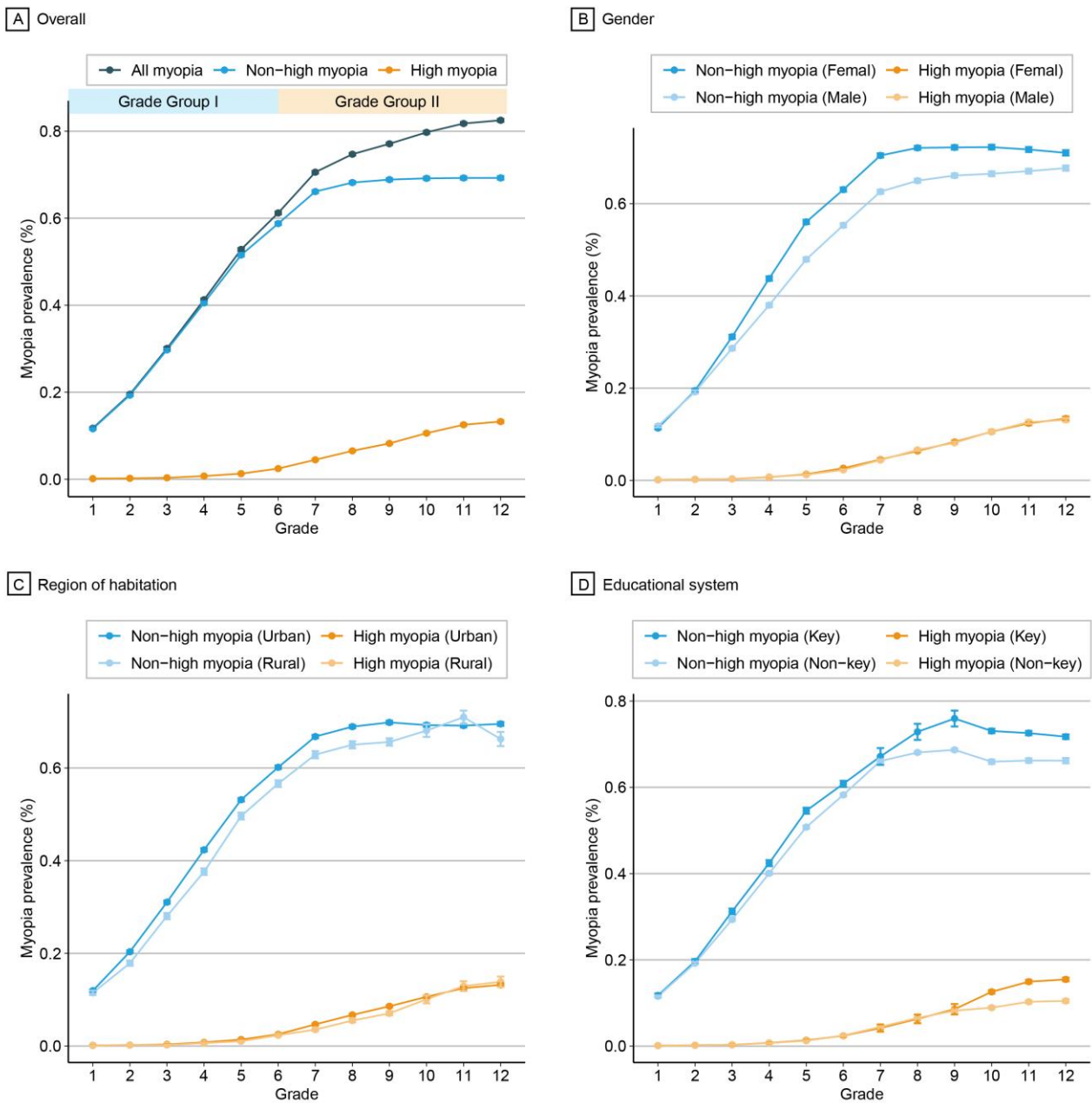

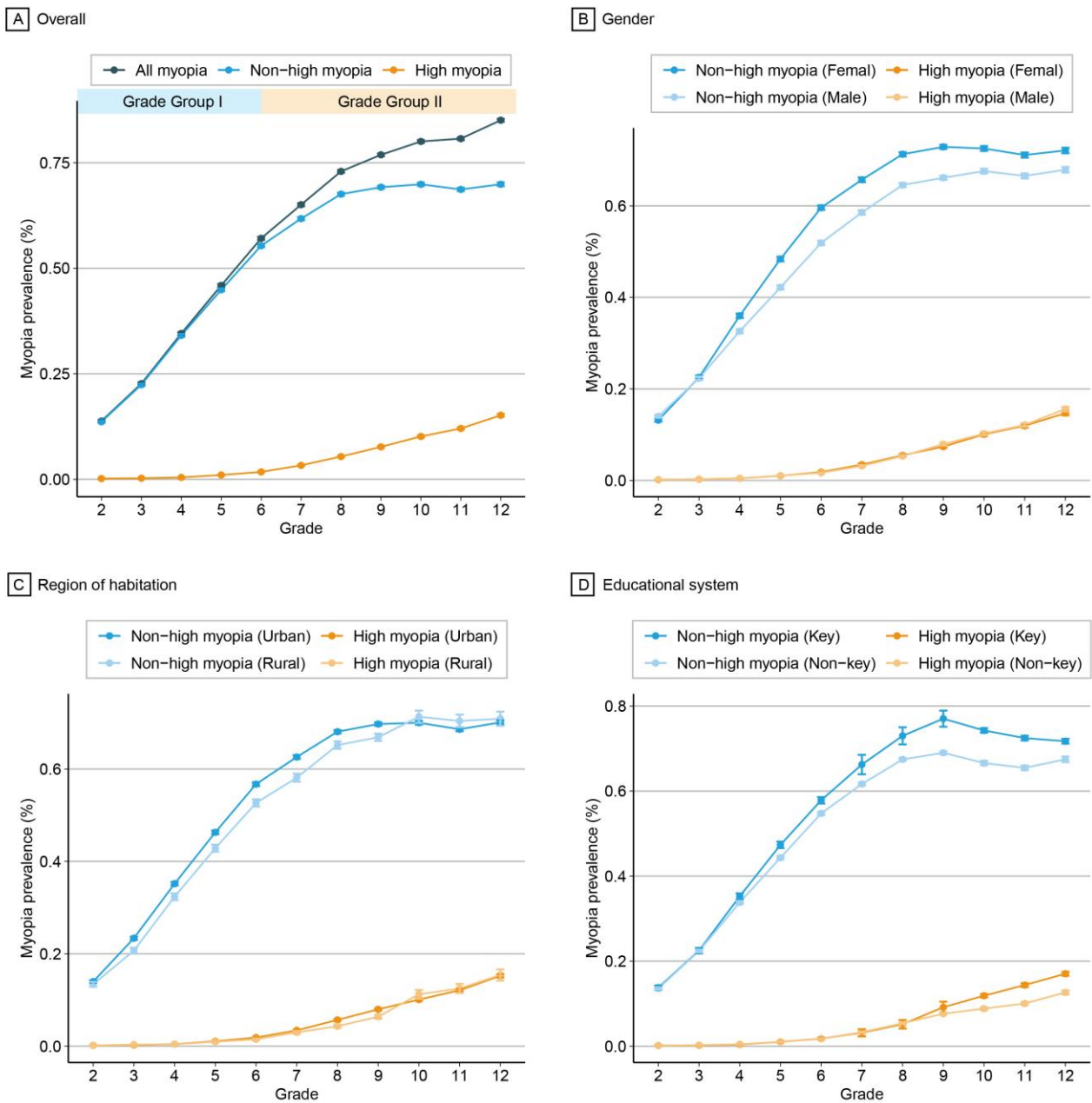

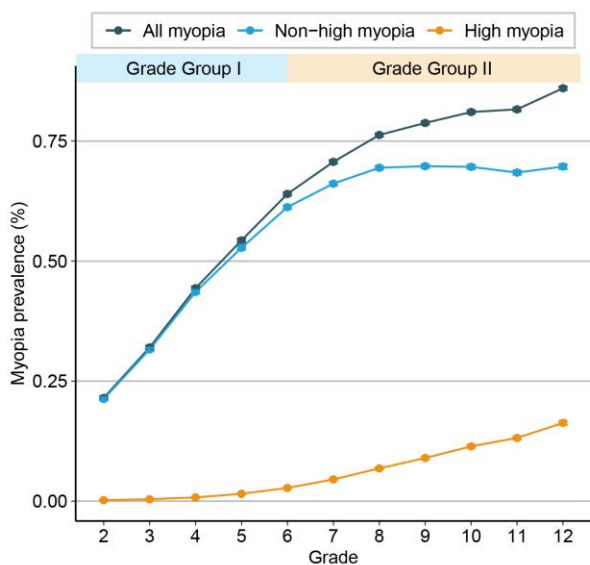

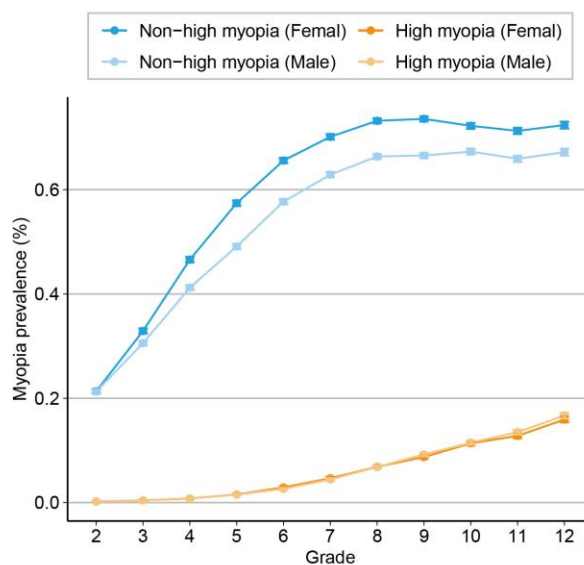

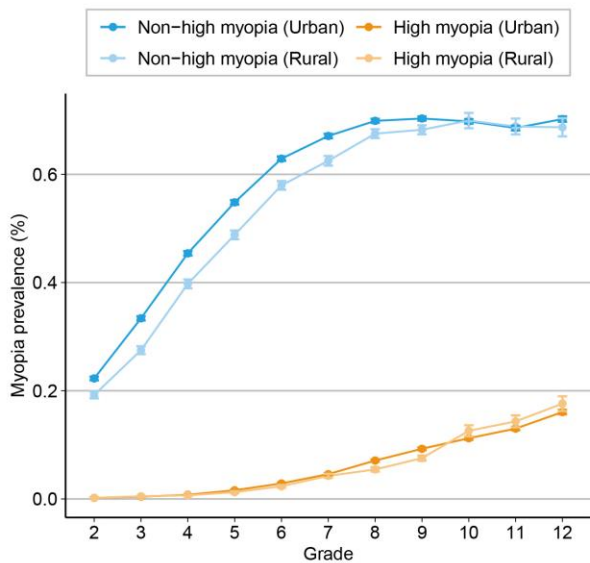

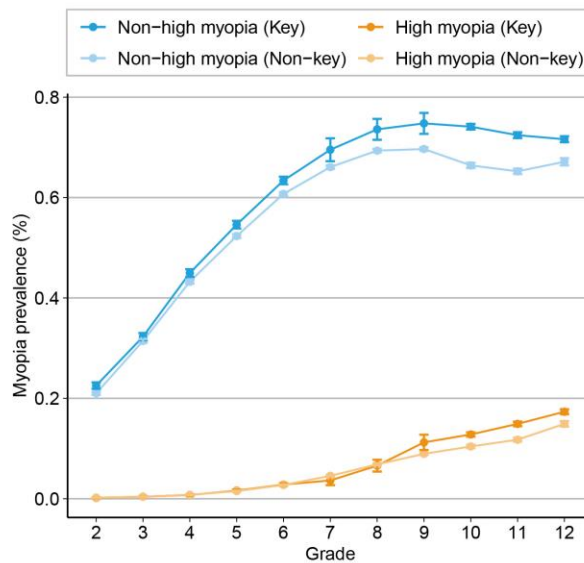

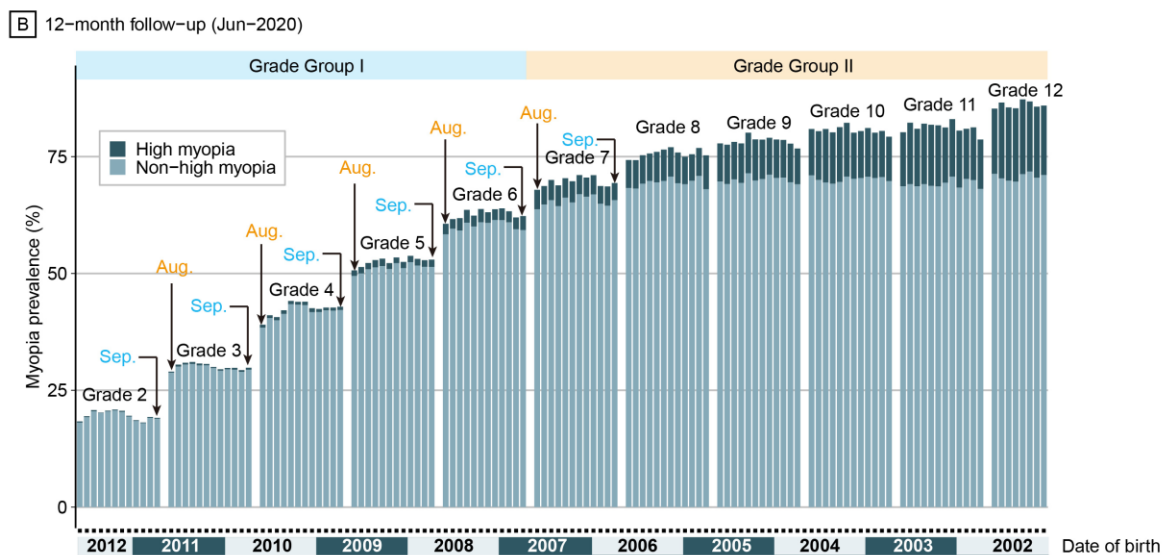
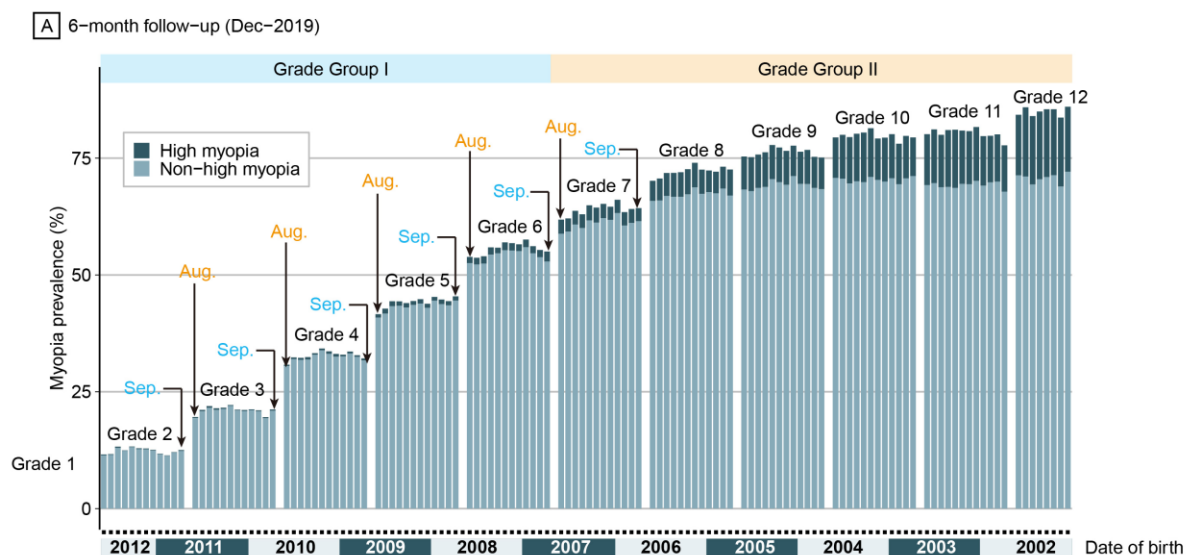
C Region of habitation



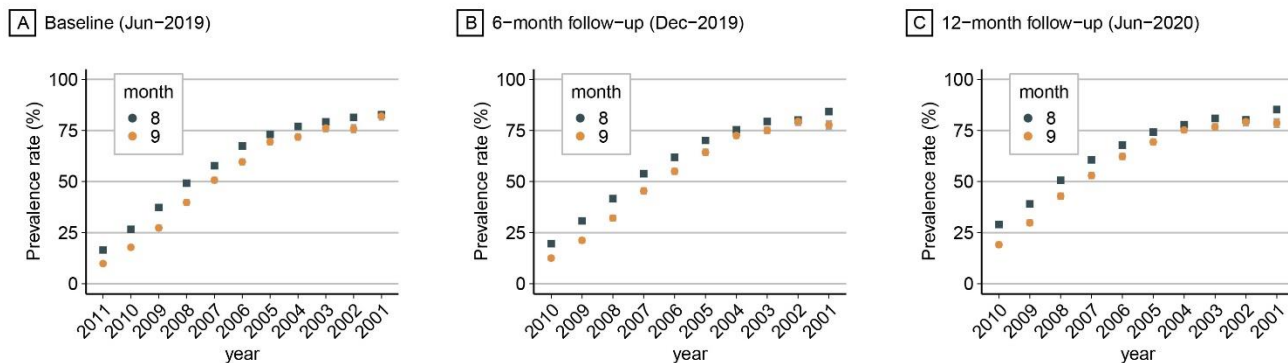

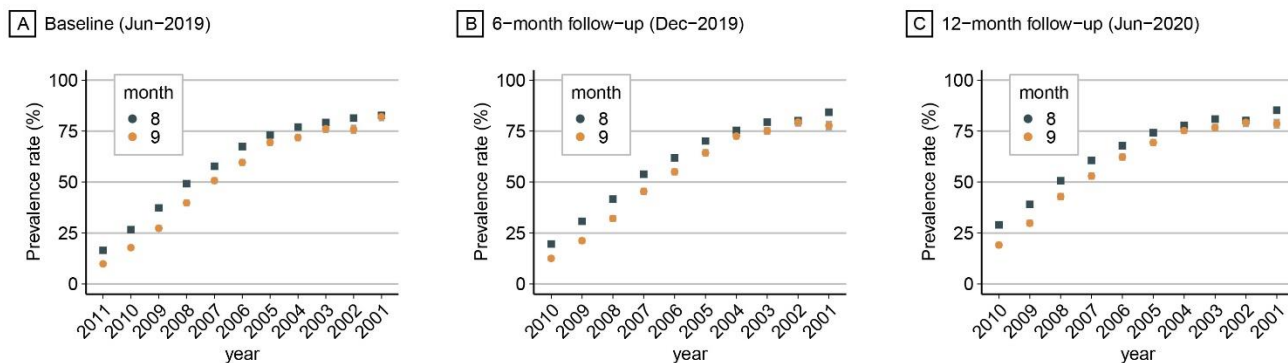
