98 **ABSTRACT**

99 **Aim:** To determine whether healthcare workers (HCW) hospitalized in Spain
100 due to COVID-19 have a worse prognosis than non-healthcare workers
101 (NHCW).

102 **Methods:** Observational cohort study based on the SEMI-COVID-19 Registry, a
103 nationwide registry that collects sociodemographic, clinical, laboratory, and
104 treatment data on patients hospitalised with COVID-19 in Spain. Patients aged
105 20-65 years were selected. A multivariate logistic regression model was
106 performed to identify factors associated with mortality.

107 **Results:** As of 22 May 2020, 4393 patients were included, of whom 419 (9.5%)
108 were HCW. Median (interquartile range) age of HCW was 52 (15) years and
109 62.4% were women. Prevalence of comorbidities and severe radiological
110 findings upon admission were less frequent in HCW. There were no difference
111 in need of respiratory support and admission to intensive care unit, but
112 occurrence of sepsis and in-hospital mortality was lower in HCW (1.7% vs.
113 3.9%; $p=0.024$ and 0.7% vs. 4.8%; $p<0.001$ respectively). Age, male sex and
114 comorbidity, were independently associated with higher in-hospital mortality and
115 healthcare working with lower mortality (OR 0.219, 95%CI 0.069-0.693,
116 $p=0.01$). 30-days survival was higher in HCW (0.968 vs. 0.851 $p<0.001$).

117 **Conclusions:** Hospitalized COVID-19 HCW had fewer comorbidities and a
118 better prognosis than NHCW. Our results suggest that professional exposure to
119 COVID-19 in HCW does not carry more clinical severity nor mortality.

124 **INTRODUCTION**

125 As of 30 October 2020, coronavirus disease 2019 (COVID-19), caused
126 by severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2), has
127 affected 44,592,789 people worldwide (1). Spain has been one of the countries
128 with the highest number of confirmed cases and deaths.

129

130 Healthcare workers (HCW) are at high risk of infection with SARS-CoV-2
131 because of their exposure to infected patients. Several seroepidemiological
132 studies have shown discordant results. In New York and Sweden the
133 seroprevalence of SARS-CoV-2 among hospital HCW was high compared with
134 the community (2,3). However, in Germany the seroprevalence in HCW was
135 very low, 0.33% (4). A recent systematic review and meta-analysis, that
136 included 11 studies, reported that the overall proportion of HCW who were
137 SARS-CoV-2 positive among all COVID-19 patients was 10.1% (5). In Spain,
138 20.4% of confirmed COVID-19 cases were HCW (6).

139

140 In Scotland, HCW and their households contributed a sixth of COVID-19
141 admissions to hospital (7). In Spain and USA, 10% and 8% of HCW with
142 COVID-19 were hospitalized respectively (6,8). Young women nurses were
143 more frequently infected (9-11). Comorbidities were frequent in HCW
144 hospitalized with COVID-19, particularly diabetes, hypertension, obesity,
145 asthma and immunodepression (6, 10,11).

146

147 There is still controversy over the risk of death in HCW with COVID-19.
148 While it is high in Mexico, it is low in Germany and Malaysia (12,13). The main
149 objectives of this study were to describe the clinical characteristics and
150 outcomes of HCW hospitalised in Spain due to SARS-CoV-2 infection, and to
151 determine if working in healthcare is associated with higher rates of
152 complications and mortality.

153

154 **METHODS**

155 **Study design and population**

156 The SEMI-COVID-19 Registry is an ongoing, nationwide, multicentre,
157 observational retrospective registry, participated by 150 hospital centres
158 throughout Spain. Detailed features of the registry have been reported
159 elsewhere (14-16). A total of 10,600 consecutive patients were recruited from
160 March 1, 2020 to May 22, 2020.

161

162 **Inclusion criteria**

163 The SEMI-COVID-19 Registry includes patients > 18 years admitted to
164 hospital with COVID-19 confirmed microbiologically by reverse transcription
165 polymerase chain reaction (RT-PCR) testing of a nasopharyngeal swab sample,
166 sputum specimen or bronchoalveolar lavage. The exclusion criteria were
167 subsequent admission of the same patient or denial or withdrawal of informed
168 consent. This study analyses the subpopulation of patients between 20 and 65
169 years of age. In Spain, 20 years is the youngest possible age for working in
170 healthcare and 65 years is the retirement age. HCW were defined as

171 physicians, nurses, nurse aides, and non-healthcare professionals such as the
172 administrative and cleaning staff of hospitals and healthcare centres.

173

174 **Procedures and variables**

175 Admission and treatment of patients took place at the discretion of the
176 attending physicians based on their clinical judgment, local protocols, and the
177 updated recommendations of the Spanish Ministry of Health.

178

179 Data were collected retrospectively in an online electronic data capture
180 system and were extracted from electronic health records. Approximately 300
181 variables were collected including epidemiological data, RT-PCR data, personal
182 medical and medication history, symptoms and physical examinations findings
183 at admission, laboratory and diagnostic imaging tests, pharmacological
184 treatment and ventilator support during hospitalization, complications and death
185 during hospitalization, and readmissions and survival 30 days after diagnosis.
186 Comorbidity was assessed using the Charlson Comorbidity Index (CCI) (17).
187 Degree of independence was classified as independent or mild, moderate, and
188 severe. Obesity was defined as body mass index $>30 \text{ kg/m}^2$.

189

190 The main endpoint was mortality during admission. Intensive care unit
191 (ICU) admission, days in the ICU, invasive or non-invasive ventilation, all-cause
192 re-admission, 30-days all-cause mortality, and length-of-stay were secondary
193 endpoints.

194

195 **Ethical aspects**

196 The study was carried out in accordance with the Declaration of Helsinki.
197 The processing of personal data strictly complied with Spanish Law 14/2007, of
198 July 3, on Biomedical Research and Spanish Organic Law 3/2018, of 5
199 December, on the Protection of Personal Data and the Guarantee of Digital
200 Rights. The study was approved by the Provincial Research Ethics Committee of
201 Málaga (Spain) following the recommendation of the Spanish Agency of
202 Medicines and Medical Products (AEMPS, for its initials in Spanish). All
203 patients—or their caregivers, in the event they presented with cognitive
204 impairment—gave their informed oral consent.

205

206 **Statistical analysis**

207 The patients were divided into two groups: HCW and non HCW (NHCW).
208 Continuous variables were tested for normal distribution with the Kolmogorov-
209 Smirnov test. Quantitative variables are expressed as mean (standard
210 deviation, SD) or median [interquartile range]. Comparisons between groups
211 were made using Student's t-test and the Mann-Whitney U test. Categorical
212 variables are expressed as absolute frequencies and percentages.
213 Comparisons between them were made using the chi-square test with the Yates
214 correction and with the Fisher's exact test when necessary.

215

216 Two multivariate logistic regression models were performed to analyse
217 the association between working in healthcare and mortality,. The first model
218 included age, sex, ethnicity, CCI score, and healthcare working. The second
219 model included the previous variables and added the comorbidities with a
220 statistical significance $p < 0.1$ in the univariate model.

221

222 In all cases, statistical significance was established as $p < 0.05$. Statistical
223 analysis was carried out using Statistical Package for the Social Sciences
224 (SPSS) 21.0 software for Windows.

225

226 RESULTS

227 **Figure 1** shows the flowchart for patient inclusion. A total of 4,393
228 patients were included, of which 419 (9.5%) were HCW. Among HCW, 142
229 (33.9%) were medical doctors, 107 (25.5%) were nurses, 98 (23.4%) were
230 nurse aides, and 72 (17.2%) held other positions within healthcare. The
231 departments that most infected patients worked in were primary care (16.6%),
232 the emergency department (11.3%), and internal medicine (11.3%).

236 Demographic and clinical characteristics

237 Baseline demographic and clinical characteristics and comorbidities are
238 shown in **Table 1**. HCW were more often Caucasian women, and reported more
239 frequent contact with a COVID-19 patient (57.8% vs. 22.1%, $p < 0.001$).
240 Moderate and severe dependence was more frequent in NHCW. There was no
241 difference in comorbidity measured as Charlson index score, but the prevalence
242 of comorbidities as alcohol use disorder, hypertension, dyslipidemia, obesity,
243 diabetes, myocardial infarction, stroke, dementia, chronic obstructive pulmonary
244 disease, obstructive sleep apnea-hypopnea syndrome, chronic kidney disease
245 and malignancy was higher in NHCW.

248 The median time from first symptoms to admission was 7 [5-9] days,
249 without difference between HCW and NHCW. There were some differences in
250 symptoms and physical examination findings. Dry cough (72.3% vs. 67.3%,
251 $p=0.003$), asthenia (54.6% vs. 44.8%, $p<0.001$), arthralgia (48.1% vs. 39.2%,
252 $p<0.001$), ageusia (14.6% vs. 9.4%, $p=0.001$) and anosmia (14.6% vs. 8.7%,
253 $p<0.001$) were more frequent in HCW, and temperature $\geq 38^{\circ}\text{C}$ (74.4% vs.
254 68.5%, $p=0.007$) and oxygen saturation $\leq 92\%$ (24.2% vs 11.8%, $p<0.001$) in
255 NHCW.

256

257 At admission the levels of serum glucose, creatinine, urea, lactate
258 dehydrogenase, aspartate aminotransferase, alanine aminotransferase, C-
259 reactive protein, ferritin, D-dimer, hemoglobin and the count of white blood cells
260 were lower in HCW. NHCW presented more frequently severe radiological
261 findings—i.e. pleural effusion, bilateral condensation, and bilateral interstitial
262 infiltrates (all $p\leq 0.025$).

263

264 **Treatments**

265 There were no differences in the treatment for COVID-19 disease
266 between HCW and NHCW except for hydroxychloroquine and remdesivir (93%
267 vs. 89.3%; $p=0.02$ and 1.5% vs. 0.5%; $p=0.023$ respectively).

268

269 **Outcomes**

270 Sepsis was more frequent in NHCW (3.9% vs. 1.7%; $p=0.024$). There
271 were no differences in the occurrence of other complications, the need of
272 respiratory support or ICU admission. The length of hospital stay was 8 (7) days

273 without difference among HCW and NHCW. During hospitalization 194 (4.4%)
 274 patients died. In-hospital mortality was lower in HCW (0.7% vs 4.8%; $p < 0.001$).
 275 The readmission rate was 2.9%. Half of readmissions were due to COVID-19
 276 disease (**Table 2**). The 30-days survival was 96.8% in HCW and 85.1% in
 277 NHCW ($p = 0.001$). **Figure 2** shows the Kaplan-Meier survival curve.

282 The factors associated with in-hospital mortality are shown in **Table 3**. In
 283 the first multivariate analysis model, age, male sex and Charlson Comorbidity
 284 index score were associated with higher in-hospital mortality and healthcare
 285 working with lower mortality (OR 0.219, 95%CI 0.069-0.693, $p = 0.01$). In the

286 second model, including comorbidities, healthcare working was also associated
 287 with a lower in-hospital mortality (OR 0.285 95%CI 0.089-0.908; p=0.034).

291 **DISCUSSION**

292 The main findings of our study were that hospitalised HCW had less
 293 severe COVID-19 and lower mortality.

294

295 The demographic characteristics of our patients were consistent with
296 other reports (14,18,19). Worldwide, men were more likely to be infected by
297 SARS-CoV-2 than women. However, among HCW, women were the most
298 affected (8,9,13,20). We think that this difference is due to the higher proportion
299 of females in healthcare professions. When we compared our HCW cohort with
300 those reported in other studies, our patients were more than ten years older (8-
301 10,13,20,21). This could be due to the different inclusion criteria used in each
302 study. In the USA, Hughes et al (8) reported on the characteristics of 100,570
303 HCW with a median age of 41 years, of whom only 6832 were hospitalised.
304 Wang et al included 80 HCW hospitalised in Wuhan, of whom 57 were
305 confirmed cases and 23 were clinical diagnosis (11). In our cohort, only
306 hospitalised patients between 20 and 65 years old with a confirmed diagnosis of
307 COVID-19 were included, while the rest included all HCW with COVID-19.

308

309 An interesting finding in our study was that upon admission HCW
310 presented milder symptoms, such as loss of smell or taste and arthralgia, less
311 severe radiological findings and lower lactate dehydrogenase, C-reactive
312 protein, serum ferritin and D-dimer levels. And all of it even though there was no
313 difference between HCW and NHCW in time from onset of symptoms and
314 admission. There was not an explanation for this, but we hypothesize that it
315 could be due to HCW were hospitalised earlier and more easily than NHCW.

316

317 ARDS is overwhelmingly the main cause of death in hospitalised COVID-
318 19 patients. In our study, sepsis was less frequent in HCW but there was no
319 difference in ARDS, the rest of complications, the need of respiratory support

320 nor the ICU admission. In-hospital and 30-days mortality were lower in HCW. In
321 a systematic review Similar results were reported in the systematic review by
322 Sahu et al. (5). A healthy worker effect could explain these results. Severely ill
323 and chronically disabled are ordinarily excluded from employment (22). The
324 difference observed in prevalence of comorbidities between HCW and NHCW
325 supports this explanation. The better clinical and analytical profile of the HCW at
326 admission may be due to their knowledge of mild symptoms of COVID-19 and
327 their ability to identify them in themselves. In this regard, increased education
328 on the earliest and mildest symptoms of COVID-19 could help NHCW to
329 recognize and to report them to a healthcare centre earlier in the course of their
330 disease.

331

332 There are geographical differences in mortality observed in hospitalised
333 COVID-19 HCW. In a teaching hospital in Belgium the mortality of HCW was
334 0.5% (20). In a single-centre study in Wuhan, in-hospital death in HCW with
335 confirmed SARS-CoV-2 infection was 1.7%, more than twice in our study (11).
336 The mortality in a multicentre study in New York City was 21%, far higher than
337 that we observed (19). Also, high mortality, 14.7%, was reported in Brazil (10).
338 In Mexico, a mortality of 2% of HCW with COVID-19 was reported (21). Their
339 mortality was higher than ours even though only 9% of them needed to be
340 hospitalized. The authors explain their high mortality because of different
341 reasons. On the one hand, in Mexico there is a high prevalence of comorbidities
342 which are associated with severe COVID-19. On the other hand, due to
343 structural inequalities, their healthcare system is highly heterogeneous and
344 there is a remarkable amount of marginalized communities. Therefore, the

345 prevalence of comorbidities, the level of economic wealth, and the organization
346 of healthcare in the different countries could explain these differences observed
347 in the mortality.

348

349 Several studies have reported that age, male sex and comorbidity were
350 associated with higher mortality in COVID-19 patients (23-26). However the
351 research about healthcare working as risk factor of mortality is scarce. HCW
352 worry and are afraid to be infected and die for COVID-19. Our results confirm
353 that COVID-19 is less severe and leads to less mortality in HCW. This is one of
354 the novel contributions of our study.

355

356 Among the strengths of our study are its multicentre design, the inclusion
357 of patients from the entire country, and the large number of patients included,
358 which provides an adequate statistical power to confirm hypotheses. However,
359 our study also has limitations. Only hospitalised patients were included, so it is
360 not possible to extrapolate our results to non-hospitalised patients. The large
361 number of researchers involved and variability in the availability of data in each
362 hospital could have led to information bias. Finally, the voluntary participation of
363 each centre could have caused selection bias.

364

365 In conclusion, HCW had fewer comorbidities, milder symptoms, and a
366 better prognosis than the NHCW. Our results suggest that professional
367 exposure to COVID-19 in HCW does not lead to greater clinical severity nor
368 mortality.
