27 Abstract:

Coronavirus (SARS Covid-19) has become a global public health concern due to its 28 unpredictable nature and lack of adequate pre-existing conditions. Achievement of WASH 29 30 services is being acknowledged as indispensable in safeguarding health. However, on a global 31 scale, it is currently not clear whether deprivation or non-obtainability of which of the factors are 32 closely related to Covid-19 dynamics and up to which degree. We have analysed 6 months' data 33 related to five Covid-19 indicators for most of the countries in the world with three groups of 34 indicators of WASH, socio-economic factors and mobility & stringency. Four successive steps 35 were followed to carry out the analysis: (a) identification of relevant key explanatory variables of 36 Covid-19, (b) identification of indicators (n=103) for other 5 sub-groups of factors (viz. WASH, economy, health, society, mobility & stringency) through literature review, (c) utilizing 37 Spearman's rank-order correlation for measuring the association of the possible explanatory 38 39 variables with those of Covid-19 (of spatial nature), and then (d) continuing the same for 6 consecutive months (from March to August 2020) until we get an almost unchanging trend. We 40 have found a strong positive correlation between lesser effects (i.e. either less confirmed case or 41 42 higher recovery rate) of Covid-19 and better access to WASH as well as socioeconomic factors throughout this time for a significant amount of the indicators. Since a handful of research is 43 available to discuss the association between Covid-19 with other probable determinants along 44 45 with the nature and degree of their relationship, this study should be perceived as an expanded

view on the complexities of Covid-19 interrelationships towards understanding determinants of
Covid-19 dynamics, which could help to shape an agenda for research into some unanswered
questions.

50 **1. Introduction:**

51 Severe acute respiratory syndrome-coronavirus (SARS-CoV-2), emerged in China in December 52 2019, is causing an outbreak of respiratory disease (COVID-19 disease by WHO). The new 53 SARS-CoV-2 virus is known to spread by person-to-person contact (through respiratory droplets 54 over a short distance) or via faecal-oral routes (hypothesised by Heller et al. 2020). Studies have shown that coronaviruses exist and can maintain their viability in sewage and hospital 55 56 wastewater, originating from the faecal discharge of infected patients. Concerns have been raised 57 over inequity in access to various prevention and control measures for slum dwellers, refugees 58 etc. (Singh et al. 2020), even though Tedros Adhanom Ghebreyesus (DG, WHO) has urged a 59 "whole-of-government, whole-of-society approach" for Covid-19 (Lau et al. 2020). According to Lau et al. (2020), one of the important reasons for this might be limited access to safe water and 60 sanitation. Connection of control of covid-19 and global access to handwashing facilities has also 61 62 been established for low-income countries (Brauer et al. 2020). The insecurity of water may also act as a deterrent for covid-19 mitigation, especially in developing areas (Stoler et al., 2020). 63 64 Odith et al. (2020) have also emphasized probable induction of Covid-19 transmission rate from the shortfall in water and sanitation, using Nigeria as a case study. Amankwaa & Fischer (2020) 65 and Jiwani & Antiporta (2020) have also emphasised on the effects of poor WASH services on 66 67 Covid-19 fatalities in sub-Saharan African countries. Caruso & Freeman (2020) have argued on the effects of inequality of sanitation facility with relation to the spread of Covid-19. Mushi & 68

Shao (2020) have stated the possible role of WASH services regarding the prevention of the further spread of covid-19, especially for lower- and middle-income countries. Ray (2020) have opined on the importance of hygiene about Covid-19. All of these works indicate a possible significant level of connection between inequality of WASH services and Covid-19. WHO and UNICEF have long been suggested about the importance of WASH in itself (UNICEF 2019) and also related to Covid-19 (WHO, 2020 a, b). Thus, these works indicate towards shortfalls WASH may relate to higher Covid-19 (occurrence and transmission).

Some socio-economic and demographic parameters were closely associated with COVID-19 76 77 cases-fatality rate. These include - per capita gross national income, net migration, voters' turnout ratio for Asian countries (Varkey et al. 2020), average age, the population density and density of 78 doctors in Germany (Ehlert, 2020), tourism (Farzanegan et al. 2020; Lapointe, 2020; Gössling et 79 al. 2020), household size, use of public transport, aged population and self-reported health for 80 England and Wales (Sá, 2020), mean income in the 10 districts of the city of Barcelona – Spain 81 82 (Baena-Díez et al., 2020), socioeconomic characteristics in neighbourhood community in 7 states 83 of USA (Hatef et al., 2020), early life environment, life trajectory and socioeconomic status (Holuka et al. 2020), income and population density (Jani & Mavalankar, 2020), morbidity rate, 84 risky health behaviours, crowding, and population mobility in South Korea (Weinstein et al. 85 2020), poor healthcare infrastructure, high population and room density, and informal job 86 markets in low-income countries (UN Habitat, 2020; Mishra et al., 2020), poverty and income 87 88 inequality in ten Latin America and the Caribbean (LAC) cities (Bolaño-Ortiz et al., 2020), 89 working age population (i.e. demographic composition) in Italy and South Korea (Dowd et al., 2020), total population, poverty and income for some of the 31 countries in Europe (Sannigrahi 90 91 et al., 2020), population, GDP and population density for Wuhan, China (Xiong et al., 2020) etc.

92 These studies indicate a varied relationship between social, economic, demographic influencing93 factors and Covid-19.

Apart from these, there are, at least 2 groups of real-time indicators which are supposed to have 94 95 intervened with the dynamic of Covid-19, one is government measures through lockdowns and containment protocols and another is people's daily behaviour and activities. First, has mostly 96 been interpreted through Oxford COVID-19 Government Response Tracker (OxCGRT) (Hale et 97 al. 2020) and the second through Google community mobility reports (Google, 2020). Some 98 works have suggested in support of their association with Covid-19 (Carlitz and Makhura, 2020; 99 100 Castex et al., 2020; Yang et al., 2020). There are some drawbacks to these works. Either some studies have incorporated a selectively 101 few arrays of indicators, or their operational boundary is one or a group of countries of a region. 102 103 Also, most of them deal with Covid-19 dataset of one single date, whereas it is well known that 104 various parameters of this pandemic are very spatiotemporally dynamic i.e., changing with time

as well as space (Sahin et al., 2020). For these reasons, we have conceptualized this work.

106 **2. Research Questions:**

107 There are some features that we have tried to encapsulate in this study.

(a) Are the various indicators of Covid-19 and indicators of WASH-related, at the globalscale?

(b) If they are related, how much is their degree of association?

(c) Does their relationship remain similar throughout Covid-19 pandemic? i.e. Do the
 WASH conditions are affecting covid-19 conditions similarly from the onset of the
 pandemic?

- (d) If the effect of WASH on indicators of Covid-19 have decreased over time, then whatabout other socioeconomic factors?
- (e) Are the various indicators of socioeconomic dimensions and indicators of WASH-related,
- 117 at the global scale?
- (f) If socioeconomic factors and Covid-19 are related, how much is their degree ofassociation?
- (g) Do the socioeconomic factors are affecting covid-19 conditions similarly from the onsetof the pandemic?
- (h) If the effects of socioeconomic factors (excluding WASH) on indicators of Covid-19
 have decreased over time, then what about stringency and mobility factors?
- (i) If the stringency and mobility factors are related to Covid-19, how much is their degreeof association?
- (j) Do the stringency and mobility factors affect covid-19 conditions similarly from the onsetof the pandemic?
- 128 **3. Method and data:**

We have collected data of water, sanitation and hygiene from WHO/UNICEF JMP (2017) 129 dataset and WDI (2020). We have used the data from the latest available year in this work. These 130 set of indicators have been used as indicators of socioeconomic status following the framework 131 used by Roy and Pramanick (2019). We have collected data of Covid-19 from for 6 different 132 dates (30th of March to 30th August, 2020) from JHU CCSE (2020). We have used data for 5 133 dimensions of water, 5 dimensions of sanitation, 3 dimensions of hygiene (i.e. 63 indicators of 134 WASH, suppl. table 1-3) and 5 dimensions (with 5 indicators) of Covid-19. Also, we have used 135 136 data for 21 dimensions (via 33 indicators) of socio-economy (except – WASH, suppl. table 4)

and 2 dimensions (with 7 indicators, suppl. table 5) of stringency and mobility. List of indicatorsis given in table 1. More details about sub-indicators are provided in the supplementary file.

The statistical analysis has been conducted using R 3.6.2, (R Core Team. 2019) and 'Hmisc' (v. 139 140 4.4-0) package for performing correlation. Data for worldwide coronavirus cases are taken from package 'coronavirus' (v. 0.2.0) from Johns Hopkins University Center for Systems Science and 141 142 Engineering (JHU CCSE) Coronavirus repository and analysed for cumulative cases for 6 different dates of consecutive 6 months (30-03-2020, 30-04-2020, 30-05-2020, 30-06-2020, 30-143 07-2020 and 30-08-2020). Though this Covi-19 pandemic started in 31st Dec. 2019, we have 144 145 taken up March as our starting phase of consideration. Because, the spread of the SARS-CoV2 virus is asymmetrical for the countries of the world, and we can see that from March-April 2020, 146 it had spread to most of the countries of the world with varying degree. We have also selected 147 148 the span of the duration of study as 6 months (March-August, 2020), because - we think if nothing severely disturbs the dynamics of pandemic (as we can see so far, Nov. 2020), six 149 150 months is sufficient to convey information about changing influence of various factors (WASH 151 or others) on Covid-19 pandemic. Spearman's rank-order correlation has been used for finding 152 the association between the variables because the data is not normally distributed. Datasets, used for analysis, is provided in the supplementary files. 153

157 **4. Results:**

158 **4.1. WASH and Covid-19:**

159 **4.1.1. Water and Covid-19:**

160 Most of the indicators that represent good socioeconomic condition related to water, like - basic drinking water, piped services, on-premises services, available when needed services, safely 161 managed drinking water services etc. are strongly positively related to total confirmed, recovered 162 and death. They show a lesser degree of positive correlation with recovery rate and case fatality 163 164 rate. Another group of indicators that represent not so good socioeconomic condition related to water, like - non-piped services, unimproved water services, limited water services etc. have a 165 strongly negative correlation to total confirmed, recovered and death. They show a lesser degree 166 of negative correlation with recovery rate and case fatality rate. 167

However, if we delve deeper into each indicator, the see some apparent conflict in results, for all
6 dates (i.e. total span under consideration of the study, 6 months), especially concerning total
confirmed (TC) and total death (TD). Some of the indicators that represent good (BDWS) or
better (IWS, IWS – P, IWS – AN, IWS - AP) conditions of safe and better access to water are

172 positively related to total confirmed and total death. Also, some of the indicators that represent

173 poor (UWS, LWS) of safe and better access to water are negatively related to total death.

4.1.2. Sanitation and Covid-19:

Most of the indicators that represent good socioeconomic condition related to sanitation, like -175 basic sanitation services, improved sanitation facilities, sewer connection facilities, wastewater 176 177 treated facilities, septic tank facilities etc. are a higher degree of positive correlation to total confirmed, recovered and death. They show a lesser degree of positive correlation with recovery 178 rate and even lesser with case fatality rate. Another group of indicators that represent not so good 179 180 socioeconomic condition related to sanitation, like – limited sanitation facilities, open defecation, unimproved sanitation facilities etc. have a strongly negative correlation to total confirmed, 181 recovered and death. They show a less strong negative correlation with recovery rate and even 182 lesser with case fatality rate. 183

For all 6 dates (i.e. total span under consideration of the study, 6 months), some of the indicators that represent poor (OD, USF, LSF) conditions of safe and better access to sanitation facilities are negatively related to total death and confirmed. Also, indicators that represent good (BSS) or better (ISF, ISF – SC, ISF – ST, ISF – WT, ISF - SM) conditions of safe and better access to water are positively related to total confirmed and total death.

Indicators that depict poor (OD, USF, LSF) conditions of safe and better access to sanitation
facilities are negatively related to CFR; whereas indicators that represent good (BSS) or better
(ISF, ISF – SC, ISF – WT) conditions of safe and better access to water are positively related to
CFR.

193 **4.1.3. Hygiene and Covid-19:**

Basic handwashing facility has a higher degree of positive correlation to total confirmed, recovered, death and recovery rate. However, it has a lesser degree of positive correlation with the case fatality rate. Another group of hygiene indicator, that represent not so good socioeconomic condition, like – limited and no handwashing facilities have a higher degree of negative correlation with total confirmed, recovered, death and recovery rate. These have a lesser degree of negative correlation with the case fatality rate.

- 200 Indicators that represent good (BHF) conditions of safe and better access to hygiene facilities are
- 201 positively correlated to total confirmed (TC) and total death (TD).

209 **4.1.4. Trends in WASH- Covid-19 relationships:**

We can see from Fig 1 that the level of correlation, be it either positive or negative, has decreased over time, i.e. from March to August 2020. This is similar to 3 indicators of Covid-19, namely – total confirmed, recovered and death. Especially, from June 2020 onwards, this is very distinct.

From the dendrogram (Suppl. Figure 1) of WASH-Covid-19, it is visible that there have 2 distinct groups throughout the study, one with case fatality and recovery and another with total confirmed, recovered and death. Most of the indicators of WASH have remained polarized in heatmap i.e., indicators of good and bad WASH conditions have remained in two opposite correlation groups in case of one group (with total confirmed, recovered and death). But, for the other group (containing case fatality rate and recovery rate), this is not distinctly different related to WASH indicators.

4.2. Socioeconomic dimensions and Covid-19:

This study has identified a few contributory elements which have exhibited high association with Covid-19 dynamics across the countries. Among health-related indicators, the share of health expenditure, health security, life expectancy, physician-nurse density and per capita out-of-

pocket health expenditure have a higher degree of positive correlation with total confirmed, recovered and death related to Covid-19. Two other health-related indicators have a lesser degree of positive correlation with the same, namely – per capita share of health expenditure and crude death rate. Share of per capita out-of-pocket health expenditure has a higher degree of negative correlation with the same 3 indicators related to Covid-19.

Among economy-related indicators, globalization, real GDP and connectedness have a higher degree of positive correlation with total confirmed, recovered and death related to Covid-19. But the Gini coefficient has a lesser degree of negative correlation with the same.

Among demographic indicators, the median age of the population and aged population have a higher degree of positive correlation than population density with total confirmed, recovered and death; whereas the total population is negatively correlated with them.

Among societal indicators, literacy rate, democracy level, human capital and development, international tourism arrival, the share of urban population and social progress have a higher degree of positive correlation than with total confirmed, recovered and death; whereas employment to population ratio, hunger level, the share of vulnerable employment, unemployment and prevalence of deaths from water, sanitation and handwashing facilities have a negative correlation with the same.

248 **4.2.1. Trends in Socioeconomy- Covid-19 relationship:**

From the dendrogram (Suppl. Figure 2) of socioeconomy-Covid-19, it is clearly visible that there have 2 distinct groups throughout the study, one with case fatality and recovery and another with the rest (i.e. total confirmed, recovered and death).

Mostly, the indicators of socioeconomic conditions have remained polarized in heatmap i.e., indicators of improved and poor socioeconomic conditions have remained in two opposite correlation groups in case of one group (with total confirmed, recovered and death). But, for the other group (containing case fatality rate and recovery rate), this is not distinctly different related to socioeconomic indicators.

257 **4.3. Stringency, mobility and Covid-19:**

Among these indicators, time spent in residential areas (i.e. Rsd) has a higher degree of positive correlation with total confirmed, recovered and death related to Covid-19, than stringency index (SnI). On the other hand, the density of visitors in workplaces (WkP), transit stations (TnS) and retail & recreation places (RnR) have a higher degree of negative correlation to those indicators of Covid-19, than the density of visitors in grocery, pharmacy (GnP) and parks (Pks). Primarily (i.e. March 2020), the case fatality rate is more correlated to these indicators that recovery rate, and both have a lesser degree of correlation that aforementioned 3 indicators regarding Covid-19.

- Excluding the first month (March 2020), the recovery rate has been negatively correlated to
- stringency.

4.3.1. Trends in Stringency and mobility - Covid-19 relationships:

- 271 From the dendrogram (Suppl. Figure 3) of stringency-mobility-Covid-19, it is clearly visible that
- there have 2 distinct groups during the earlier stage of study (March-May 2020), one with case
- fatality and another with the rest (i.e. recovery, total confirmed, recovered and death). However,
- its nature has changed in the following months (June August 2020), one group with case
- fatality and recovery and another group with the rest (i.e. total confirmed, recovered and death).
- 276 Mostly, the indicators of stringency and mobility conditions have not remained polarized in 277 heatmap i.e., the nature and degree of correlation are changing with time.
- 278 The overall time wise (here, month) change of number of significantly correlated associations
- between Covid-19 and other 3 groups of indicators (viz. WASH, socioeconomic factors and
- stringency & mobility) are shown in Fig 4.

284 5. **Discussion:**

From this study, there are some basic understanding that can be inferred. For the WASH sphere, providing basic as well as improved drinking water, sanitation and hygiene facilities are directly positively connected to the recovery rate of Covid-19. Likewise, reducing unimproved drinking water, sanitation and open defecation is negatively connected to recovery rate. This means, not only for the specific domain of WASH but inclusive access to these facilities are also connected

to the health sector as well as disaster prevention (like – a pandemic connected to water). The
hassle-free access of purified water (at least not associated to wastewater, Lapolla et al., 2020;
Bogler et al, 2020) at home premises (Frumkin et al., 2020; Kassem and Jaafar, 2020; Staddon et
al., 2020), access to improved sanitation facilities at household level as well as the availability of
household hygiene measures (in form of soaps, hand sanitizers etc.) (Schmidt, 2020; Yu et al.,
2020) have become the frontier force of precautionary prevention.

296 The other socio-economic factors also ascribe to similar perception regarding the covid-19 pandemic. Among the health-related factors, better health security, a higher density of physicians 297 298 and nurses, better life expectancy, higher per capita out of pocket expenditure and the lower 299 crude death rate is positively associated with better recovery rate. These results are in line with Adams & Walls, 2020 (for healthcare workforce), Kandel et al., 2020 (for health security) etc. 300 301 Among the economic factors, higher real GDP, connectedness, globalization and lower economic inequality are positively associated with a better rate of recovery. These outcomes are in line 302 with Makridis & Hartley, 2020 (for real GDP), McKibbin & Fernando, 2020 (for 303 304 macroeconomy) etc. Among the societal factors, higher literacy, social progress, democracy score, human capital and development along with lower unemployment, employment 305 vulnerability and huger are associated with better recovery. These findings are also in line with 306 UNDP report (for human development), Khemraj & Yu, 2020 (for human capital), Kawohl & 307 Nordt, 2020 (for unemployment) etc (see Fig 5). 308

This new pandemic has undoubtedly emphasised the frivolity of the present condition as well as the significance of the global WASH access system. These are the bare minimum requirements which have been either neglected or not properly implemented (sometimes due to lack of awareness). Other socioeconomic factors, though of varying degree, has a high level of correlation with various indicators of the covid-19 pandemic. This entails towards the importance of deliverance of socio-economic development globally.

There are some possible drawbacks in our work. Firstly, WASH data is from 2017, not immediate pre-pandemic data. It is because WHO-UNICEF JMP dataset is most robust and

320 uniform till date. However, recently, there have been some issues regarding the applicability of WASH data towards predicting the WASH-Covid19 relationship accurately (Quispe-Coica and 321 Pérez-Foguet, 2020). But we don't have any better alternative. Second, the socio-economic 322 323 indicators are also not of immediately pre-pandemic time (see Suppl. Table 5). This is due to the unavailability of the latest data (2019-20) for all of the socioeconomic indicators. Third, this 324 analysis has not been done on the sub-national or lower scale. Because the objective was to 325 326 understand the determinants of the covid-19 pandemic in general, for large scale. Also, the sub-327 national data are not comprehensive and uniformly available for all countries. Fourth, the study period (March-August 2020, i.e. 6 months) is odd. Though the onset and spread of covid-19 328 pandemic are asymmetric for different countries, we think from March 2020 onwards, it had 329 started in most of the major countries of the world. Also, we have taken 6 months (up to August 330 331 2020) because the study also tries to understand and lingering association of determinants with Covid-19 pandemic, and as we can see from the data that this duration is long enough to serve 332 the purpose. Lastly, we have chosen only one date (30th of each month) which is not continuous. 333 334 We have taken nearly equidistant dates from each month as we think this is enough to give us a broad outline of the role of determinants. 335

We see whatever kind of association do the determining factors have with those of Covid-19, the degree is lessening through time (except – those related to mobility and stringency). This means two things, (a) other factors (which are outside the operational boundary of this study) might be getting superior control over the dynamics of Covid-19 than those included in this study, and/or (b) the data of aforementioned determinants are of pre-pandemic time, means they are not being updated daily or monthly (like – Covid-19). From this we can infer, these factors have been determining the trajectory of the covid-19 pandemic in the old normal (pre-pandemic) as well as

will continue to do so in the new normal (post-pandemic). We think once robust data areavailable of these determinants after the pandemic, we might see a similar level of association.

The present study has advocated the utility of interpreting determinants in epidemiological 345 346 research, which can be diverse, with this Covid-19 pandemic as a case of example. The present work has explored the association between the WASH, social, demographic, mobility, economic 347 348 as well as health parameters and Covid-19, extracting insightful tales of dynamics of Covid-19 349 pandemic. Therefore, we hope, this study could be a reference for future health research and their 350 controlling factors towards synthesizing a multidisciplinary approach for either prevention or 351 control or both (Ross et al., 2020). Additionally, all the data used in this work are open source 352 and freely available (we have also provided the raw data and results in supplement), in so doing, reproducibility, as well as scientific replicability, can be achievable. 353
