


Figure S1: Gene burden PheWAS of pLOF variants in MYBPC3

Gene burden PheWAS of pLOF variants (N=45, Table S1) in *MYBPC3*. Phecodes are plotted along the x axis to represent the phenome, and the association of the gene burden with each Phecode is plotted along the y axis representing $-\log_{10}(p \text{ value})$. The red line represents the Bonferroni-corrected significance threshold to adjust for multiple testing (p=3.58E-05), and the blue line represents a nominal significance threshold (p=0.05).




Figure S2: Gene burden PheWAS of ClinVar P/LP variants in MYBPC3

Gene burden PheWAS of nonsynonymous coding variants classified in ClinVar as P/LP in *MYBPC3* (N=45). Phecodes are plotted along the x axis to represent the phenome, and the association of the gene burden with each Phecode is plotted along the y axis representing – log₁₀(p value). The red line represents the Bonferroni-corrected significance threshold to adjust for multiple testing (p=3.58E-05), and the blue line represents a nominal significance threshold (p=0.05).




Figure S3: Gene burden PheWAS of ClinVar P/LP pLOF variants vs. ClinVar P/LP missense variants in *MYBPC3*

Association of MYBPC3 Missense Variants with HCM




Figure S4: Selection of pDM variants in *MYBPC3* for association with HCM




Figure S5: Gene burden PheWAS of pLOF variants *MYH7*




Figure S6: Gene burden PheWAS of ClinVar P/LP variants in *MYH7*




Figure S7: Selection of pDM variants in MYH7 for association with HCM
