Supplementary Information Text

Details of the driven oscillator model.

When forcing is weak, one can approximate a generic driven oscillator with linearized dynamics using a second-order Taylor series expansion. The result is a familiar equation from classical mechanics which describes the behavior of damped harmonic oscillators, a physical analogy of which being a swing-set or pendulum. The second-order linear differential equation is as follows:

$$\frac{d^2x}{dt^2} = -\omega_0^2 x - \zeta \omega_0 \frac{dx}{dt} + A\sin(\Omega t)$$

For natural frequency ω_0 , dampening ratio ζ , driving amplitude *A*, and driving frequency Ω . The response of the system has the following analytical solution:

$$x(t) = X_0 \sin(\Omega t + \theta)$$

Where the phase of the system θ is described by:

$$\theta = \arctan\left(\frac{\zeta\omega_0\Omega}{{\omega_0}^2 - \Omega^2}\right)$$

And the amplitude X_0 has the form:

$$X_{0} = \frac{A}{\sqrt{(\omega_{0}^{2} - \Omega^{2})^{2} + \zeta^{2} \omega_{0}^{2} \Omega^{2}}}$$

Several insights can be gained from these expressions. First, this type of system will always oscillate in sync with the environment, no matter how weak the driving amplitude A, or what frequency Ω . Second, the phase of the system θ is not dependent on driving amplitude A. In contrast, the amplitude of such systems scales proportionally with changes in driving strength. For the purpose of modeling disease time-series, we replaced the input expression $A \sin(\Omega t)$ with an arbitrary linear combination of weather time-series:

$$\operatorname{input}(t) = \sum_{i=1}^{n} a_i \operatorname{var}_i(t)$$

Where $var_i(t)$ denote weather time-series obtained individually for each county and scalar coefficients a_i represent global weightings of each possible driving force. Here, the inputs i = (1, ..., n) are comprised of daily temperature, solar irradiance, and specific humidity. Finally, the driven response x(t) was allowed to relate to the final output, seasonal infection incidence rate, through the following linear function with temporal lag τ :

$$output(t) = \alpha x(t - \tau) + \beta$$

For simplicity, the frequency of the environment Ω was assumed to equal $2\pi/365$. Thus, nonlinear regression could be used to find parameters $\omega_0, \zeta, \alpha, \beta, \tau, a_i$ that most accurately relate the input signal input(*t*) to time-series of seasonal disease in each county.

Details of the phase oscillator model.

The simplest model of a weakly driven limit cycle is parameterized only by its phase θ , where the driving force is effectively always tangential to the orbit. The coupling between the limit cycle oscillator and its driving force can be any periodic function of the phase mismatch $\phi - \theta$. From Ermentrout and Rinzel (58) we have the simplest possibility:

$$\frac{d\theta}{dt} = \omega + A\sin(\phi - \theta)$$
$$\frac{d\phi}{dt} = \Omega$$

Where ω is the natural frequency of the limit cycle, ϕ denotes the phase of the driving force, A is the driving amplitude, and Ω is the frequency of the driving signal. One can learn about the response of the system by considering only phase locked solutions in which the angle between the phase oscillator and the environment $\phi - \theta$ is constant:

$$0 = \frac{d}{dt}(\phi - \theta) = \Omega - \omega - A\sin(\phi - \theta)$$

By solving for $\phi - \theta$ we obtain:

$$\phi - \theta = \arcsin\left(\frac{\Omega - \omega}{A}\right)$$

This equation has several implications. First, entrainment of the system requires the argument of arcsin to be less than 1. Thus, a phase oscillator will only synchronize with its environment when the driving amplitude A is sufficiently large compared to its frequency mismatch with the environment $\Omega - \omega$. The relative phase of entrained solutions varies inversely with driving amplitude like $\sim 1/A$. For the purpose of modeling disease time-series, we expanded the input expression to include a county-specific amplitude term γ , yielding: $A\gamma \sin(\phi - \theta)$. Similar to our treatment of the driven oscillator, county-specific input amplitude γ and phase $\phi(t)$ were inferred from a linear combination of weather time-series var_i(t), parameterized by scalar coefficients a_i :

$$\operatorname{input}(t) = \sum_{i=1}^{n} a_i \operatorname{var}_i(t)$$

The entraining cue input(t) was defined individually for each county based on their weather time-series. For simplicity, the frequency of the environment Ω was assumed to equal $2\pi/365$. Lastly, the output of the system was taken as a simple sinusoidal function of the phase $\theta(t)$:

$$\operatorname{output}(t) = \alpha \sin(\theta(t) - \Theta) + \beta$$

Because the long-term behavior of stably entrained solutions depends only on the ratio $(\Omega - \omega)/A\gamma$, the system is degenerate with respect to the frequency mismatch and driving amplitude $A\gamma$, which cannot be known exactly. In modeling disease time-series, we fixed $\omega = 2\pi/300$ while parameters $A, \alpha, \beta, \Theta, \alpha_i$ were fit through nonlinear regression.



Fig. S1. (A) Latitude versus peak timing for an aggregate of less common diagnoses. To assess the robustness of the latitude-phase scaling, the top 10 most common diagnoses, comprising over 70% of the dataset (see Table S1) were excluded. After filtering based on noise criteria (see Materials and Methods), a total of 1,183 counties were included. The resulting linear slope (*m*) and corresponding Pearson correlation coefficient ($R = 0.35, p < 2.55 \times 10^{-34}$) are consistent with what is observed in the main analysis. (B) Latitude versus peak timing for Streptococcal Sore Throat, the most common diagnosis code associated with a singular pathogen. After filtering based on noise criteria (see Materials and Methods), a total of 476 counties were included in the analysis. The resulting linear slope (*m*) and corresponding Pearson correlation coefficient ($R = 0.23, p < 3.53 \times 10^{-07}$) are consistent with the main analysis.
