

ST3 Recruitment Survey

During the most recent specialty training application round for ST3 Anaesthetics, the number of posts available was far exceeded by the number of applicants. According to figures released by the Royal College of Anaesthetists, 1056 applicants competed for 359 posts at ST3 level this year, while 865 were granted an interview.

This is a difficult time for many trainees who have worked hard over the past 12 months of the pandemic supporting their colleagues on ICUs up and down the country. We sympathise with everyone who missed out on an ST3 post this time around, and would like to help to facilitate everyone in achieving their plans in the next few months.
