

Supplementary materials: Modelling the effect of a border closure between Switzerland and Italy on the spatiotemporal spread of COVID-19 in Switzerland

Abstract

This document provides supporting information for “Modelling the effect of a border closure between Switzerland and Italy on the spatiotemporal spread of COVID-19 in Switzerland”. In particular, data sources and manipulations are recorded, as well as more supporting plots for the results section.

1. Data sources and manipulations

In this section, we provide additional information on the data used in this analysis.

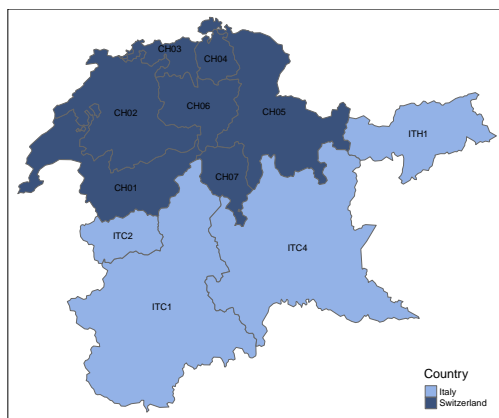


Figure 1: Map of the regions included in the analysis

1.1. Case data

Case data for Switzerland is provided by the Bundesamt für Gesundheit (BAG) [1]. The time series starts at 2020-02-24 and is updated on weekdays. However, all cases and deaths occurring on weekends are allocated to the respective weekend days and published the following Monday. The data is available at NUTS-3 level and aggregated to the NUTS-2 level. For Italy, case data is provided by the Presidenza del Consiglio dei Ministri – Dipartimento della Protezione Civile (PCM-DPC) [2]. The data is available at the NUTS-2 level. The time series starts at 2020-02-24 and is updated daily. For the considered regions and time-frame, we

10 observed two instances of negative numbers of new cases, which is impossible. However, as these barely
11 deviated from 0 (one instance recorded -1 and another -10 new cases in a given region on a given day), we
12 set new case counts on these days in these regions to zero.

13 1.2. Population and population density data

14 All population data was considered for the year 2020. It is available via Eurostat [3]. Data for the
15 population of Swiss cities was retrieved from Swiss Federal Statistical Office [4]. Data for the population of
16 Italian cities was retrieved from Istituto Nazionale di Statistica [5].

17 1.3. Data on public holidays.

18 Information about national public holidays during the study period in Switzerland was retrieved from
19 Eidgenössisches Justiz- und Polizeidepartement EJPD [6]. Information about national public holidays during
20 the study period in Italy was retrieved from Governo Italiano Presidenza del Consiglio dei Ministri [7]. The
21 public holidays used are summarised in Table 1:

22 Public holidays that fall on a Saturday or Sunday are not recorded in Table 1.

23 1.4. Testing data

24 For Switzerland, testing data is found via the BAG [8]. The time series is available daily and goes from
25 2020-01-24 until the present. For Italy, testing data is obtained via ECDC [9]. The time series is available
26 weekly and starts at week 5 of 2020 (week commencing 2020-01-27). Both datasets provide testing rates as
27 number of tests per 100 000 inhabitants.

28 1.5. Temperature data

29 Temperature data was obtained from European Climate Assessment and Dataset [10]. This dataset
30 contains daily temperature data for various weather stations. We matched each of the 11 regions in our
31 analysis to the weather station closest to the centroid of the region, that did not contain missing data.

32 1.6. Border closures

33 Data on border closures was scraped from the web page of the International Organisation for Migration
34 (IOM) [11]. This web page contains information on travel restrictions in matrix format, where the rows
35 represent the countries that are imposing the restrictions and the columns are the countries to which re-
36 strictions are imposed upon. The data is available at regular intervals for both countries considered in our
37 analysis, from 2020-03-08 and is updated regularly. In these matrices, border closures are recorded at levels
38 “No restrictions”, “Partial restrictions”, “Total restrictions” and “No official restrictions reported”.

39 **1.7. Mobility data**

40 To include the change in movement of populations in our model, we considered the Facebook² Data
41 for Good dataset on movement range [12]. It contains data at NUTS-2 level for Italy, which can be used
42 as is. The Swiss data is available at NUTS-3 level, which we can easily aggregate as a weighted average
43 over the NUTS-2 region (with the weights being the population in the NUTS-3 regions). The variable of
44 interest in that data set is `all_day_bing_tiles_visited_relative_change`. This variable is computed as
45 the difference between movement on a given day, and movement at baseline, with respect to movement at
46 baseline [13]. Movement at baseline is defined as the movement in the month of February 2020. It is recorded
47 from 2020-03-01 and updated regularly.

48 **1.8. Matrix of neighbourhood order**

49 We used a matrix of neighbourhood order O in our model that describes the neighbourhood orders between
50 the analysed regions. The data used to create this matrix was obtained from Eurostat [14]. The matrix O is
51 an $R \times R$ matrix, with R being the number of analysed regions. The matrix entry $o_{rr'}$ equals the minimum
52 of border crossings on the path between the two regions (e.g. $o_{rr'} = 1$ if r and r' are direct neighbours) [15].
53 This matrix is symmetric, i.e. $o_{rr'} = o_{r'r}$.

54 **2. Relative increase (RI) time series**

55 In this section, we plot the difference and relative increase in new and cumulative cases over time between
56 the counterfactual scenarios A and B, and the baseline scenario.

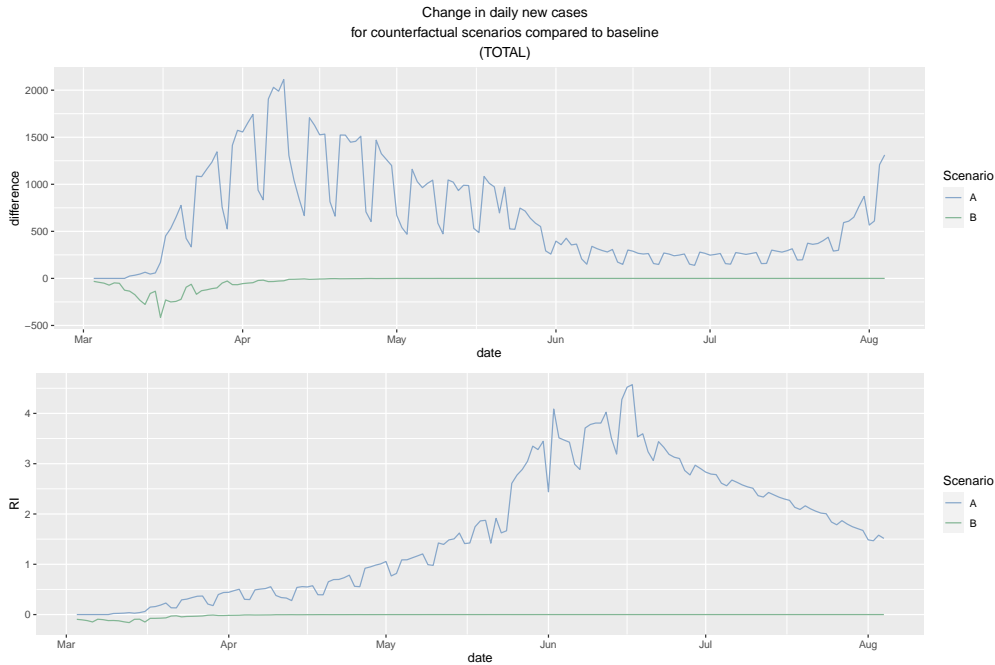


Figure 2: Change in daily new cases compared to baseline between 2020-03-02 and 2020-08-04

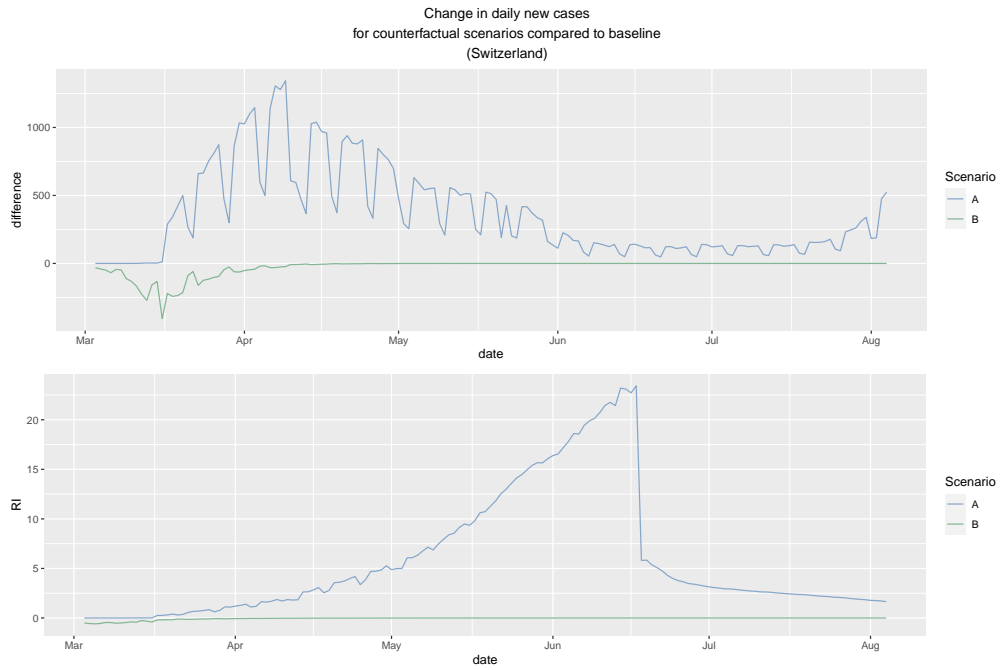


Figure 3: Change in daily new cases compared to baseline in Switzerland between 2020-03-02 and 2020-08-04

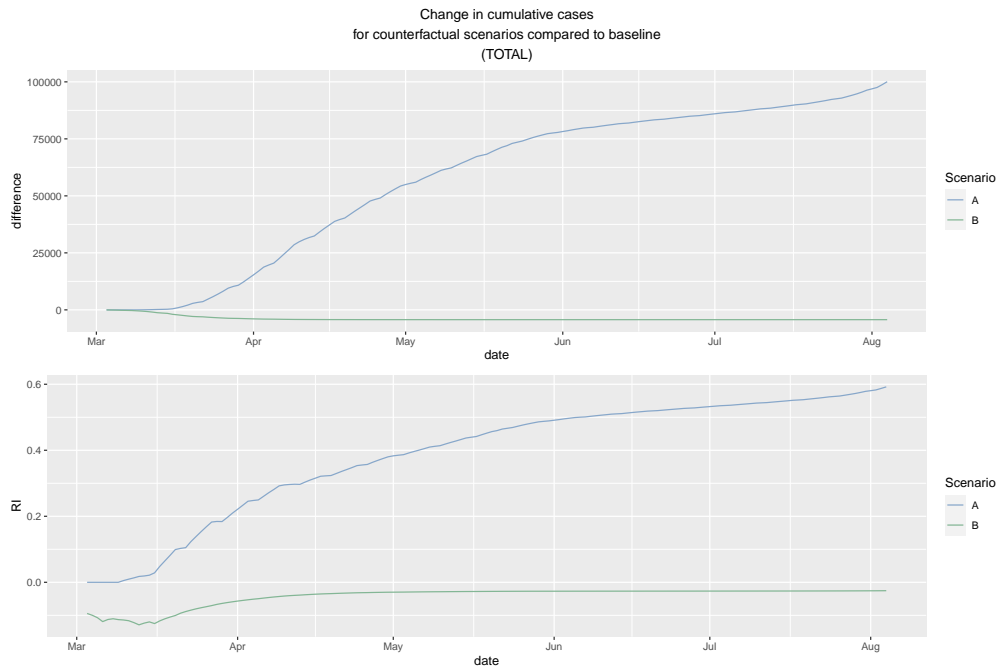


Figure 4: Total change in cumulative cases compared to baseline between 2020-03-02 and 2020-08-04

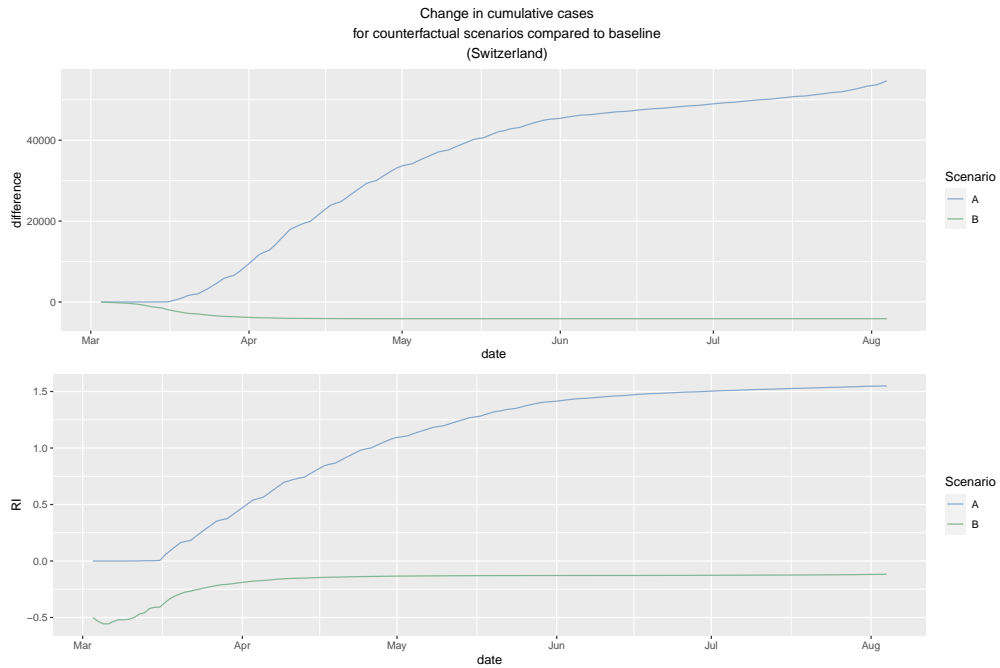


Figure 5: Change in cumulative cases compared to baseline in Switzerland between 2020-03-02 and 2020-08-04

57 **3. Comparison of cases predicted under baseline scenario with observed cases**

58 To illustrate prediction accuracy, we compare the daily incidence predicted under the baseline scenario,
 59 where every model parameter and time-dependent matrix is set to reality, with observed cases over the study

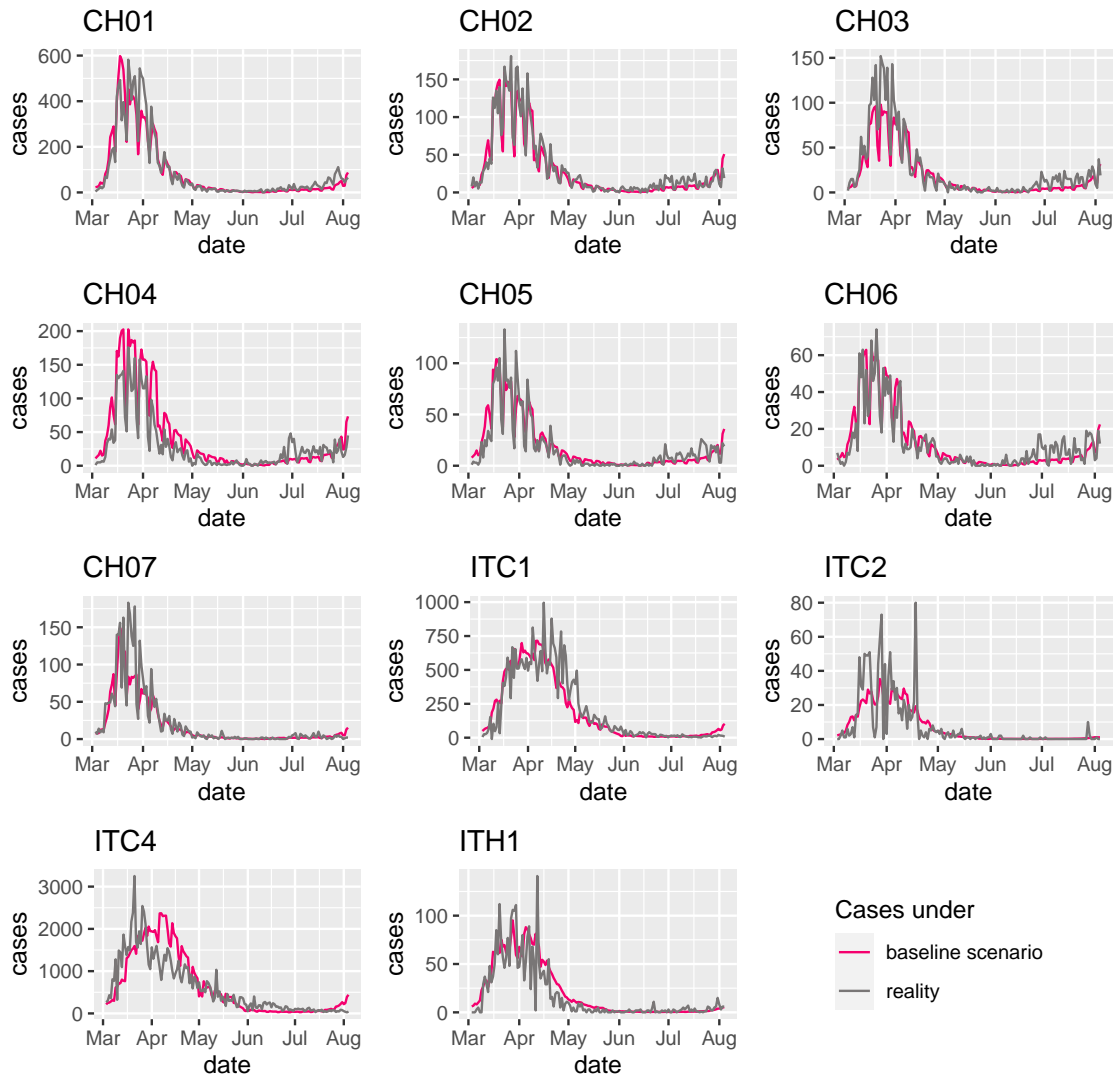


Figure 6: Observed cases and cases predicted under baseline scenario

 60 period. The comparisons can be seen below in Figure 6.

Comparing real case counts with baseline prediction

61 **4. Lag distribution**

62 In this section, we plot the estimated lag u_l distribution, that is, the weight each past day is attributed

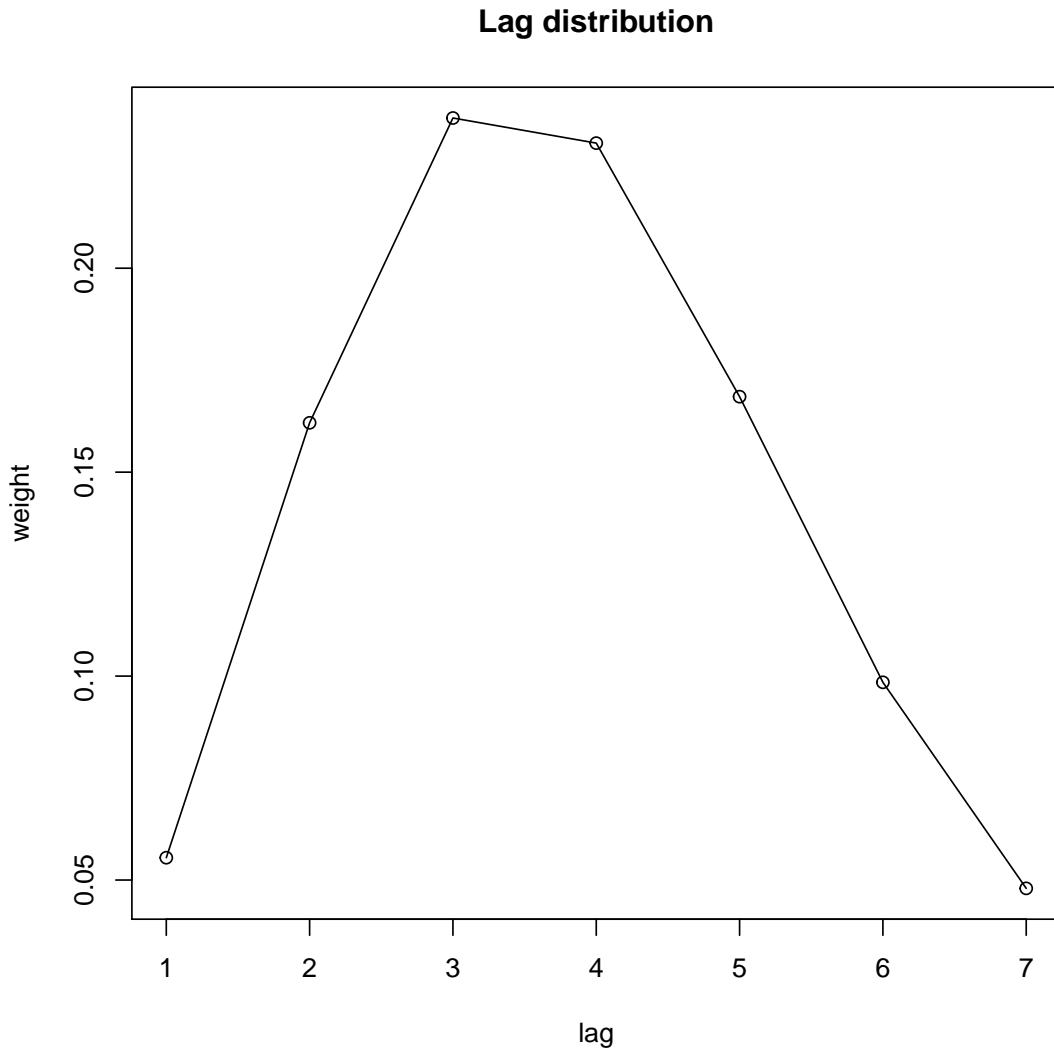


Figure 7: Lag distribution

 63 in the autoregressive process. The distribution is seen in Figure 7.
