Supplementary file B - Simulated client script

Call-in simulation

- Look up the pharmacy on Google Maps and note basic operational details, such as opening hours or COVID19-related client interactions. Take note of any COVID-related messaging.
- Call the customer service number on the Google Maps profile, or if no profile or no number provided, try a simple google search, otherwise contact the study coordinators. They will check if the number in the database is personal or official; if personal further discussion is needed to assess risk of detection.
- **Ask if they have medicines that you can use to protect yourself from getting COVID19, using appropriate language** as agreed during the training. Avoid prompting for information unless it is in the script.
- Make a mental note of **questions asked or advice given**. Encourage the provider to talk by listening actively and saying “don’t know” if the provider asks, for example, if you know how to prepare ginger home remedy.
 - If asked why you are asking for the medicines, say that your job requires interaction with customers, some of who don’t wear masks
 - If asked where you are located, mention a name of a place near the pharmacy
- If any products are recommended, ask and **write down the names**. You can also ask for the price to keep the conversation natural, but the price data is not being collected
- Ask the service provider **how you can get the medicines**. List down the **options given**, and then if “pick up from the pharmacy” is one of the options, mention that you would rather not visit the pharmacy physically, because you are afraid of getting exposed to COVID19.
- If not told spontaneously,
 - ask what **symptoms you should look out for** if you suspect COVID19 infection? If asked what symptoms you have, emphasize you don’t have symptoms but just want to be ready.
 - ask **what you should do if you suspect you have COVID19 infection?**
- Thank the service provider and mention that you will get back to them to arrange how to get the medicines.

Completing the debrief questionnaire

- The debrief questionnaire should ideally be completed within 30 minutes of the simulation, while memory is still fresh. In any case, do not call another pharmacy before the previous debrief interview has been done.
- It is **very important to say honestly how the call went**, even if you feel like it didn’t go very well. The **study is assessing the pharmacy and not you**, the simulated client.
- Try to capture the responses to open-ended questions close as possible to what the provider says (verbatim)
- If there is follow-up interaction, you can leave the questionnaire “unsubmitted” and finish later. Open a fresh page if you need to do another pharmacy
- If further information comes in after you have submitted, relay to the study coordinators who will then edit the record from the back end.

Supplementary file D - In-depth Interview Topic Guide:

Notes to interviewer:

1. As first option, use Teams platform with video on. If internet is slow, try Teams without video and if that still doesn't work then use plain old telephone (POT).
2. If using POT, put the phone on speaker and record on a standard audio recorder placed next to the phone, and if using Teams, record directly through the application.
3. When setting up the interview, ask about internet access, preference of platform, etc. Inform the participant that they will need to be in a quiet place for about 30-60 minutes and that earphones are preferred to speaker mode.
