

Appendix A: Massachusetts Safer Teachers Safer Students (STSS) SARS-CoV-2 Screening: K-12 Public School Survey

The data collected from this survey will assist other K-12 public schools and policymakers in supporting SARS-CoV-2 screening in two ways:

First, information about learning models and screening strategy will be shared on a public STSS Data Dashboard for each participating district. The dashboard will provide: an updated snapshot of screening practices other districts are taking; an FAQ page to help newcomers to screening to get off the ground running; and, a source of information for communities and policy makers deciding when to open some level of in-person learning by giving them insight into what other districts are doing and under what circumstances. Questions in this survey that will supply information for the public dashboard are noted at the start of each section.

Second, data from this survey will be used for a research study to evaluate the feasibility, acceptability, affordability, and impact of routine SARS-CoV-2 screening among asymptomatic K-12 students and educators/staff. Data collection using this survey was approved by the Mass General Brigham Institutional Review Board for Massachusetts public schools. The goal of this research is to identify barriers, facilitators, and best practices for SARS-CoV-2 screening in schools, in order to understand the potential role that screening programs may play in facilitating safe in-person learning for public school districts with widely varying access to resources. All data for the research study will be deidentified and combined with data from other districts; no individual districts or towns/municipalities will be identified.
