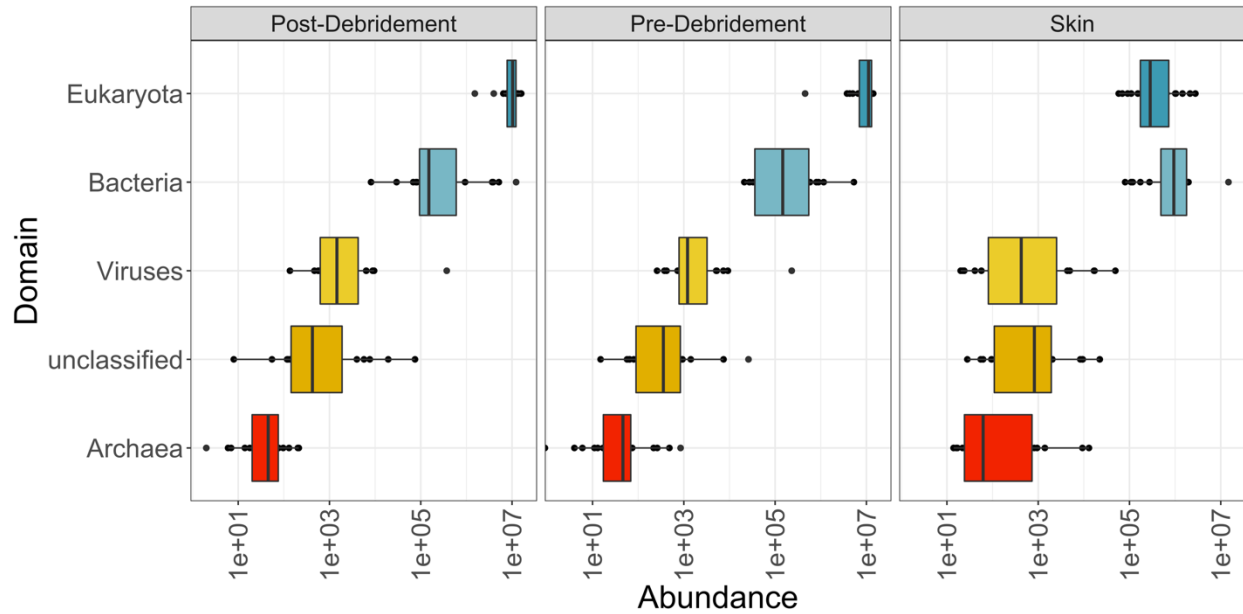


Figure S1. Domain-level taxonomic composition of metagenomic samples. Read abundances in each domain for each sample type, as classified by Kraken2 against the full NCBI RefSeq database. Samples contained $6,794,663 \pm 2,588,627$ eukaryotic and $1,205,730 \pm 2,588,627$ bacterial reads, on average across all samples. $13,278 \pm 55,825$ reads were classified as viral, on average. An additional $3,660 \pm 10,720$ reads remained unclassified, on average. Center line, median; box limits, upper and lower quartiles; whiskers, 1.5x interquartile range; points, outliers; $n = 20$ patients.

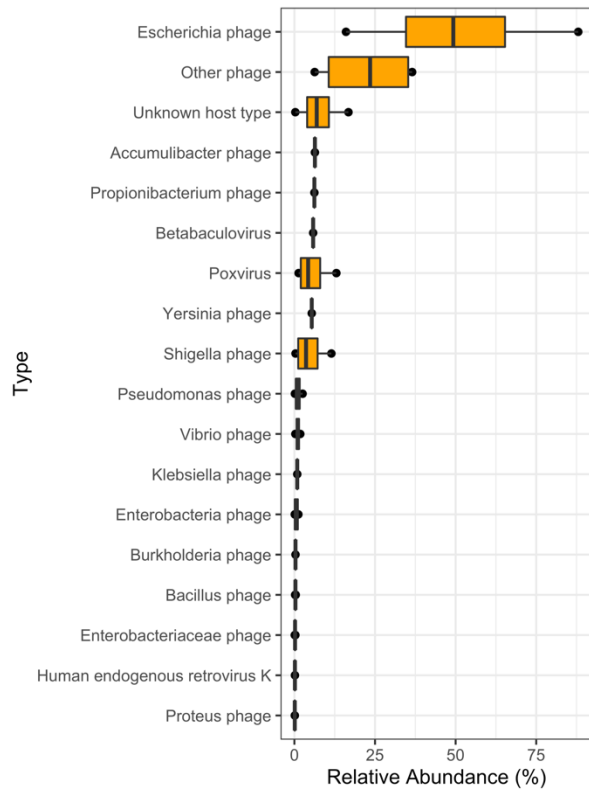
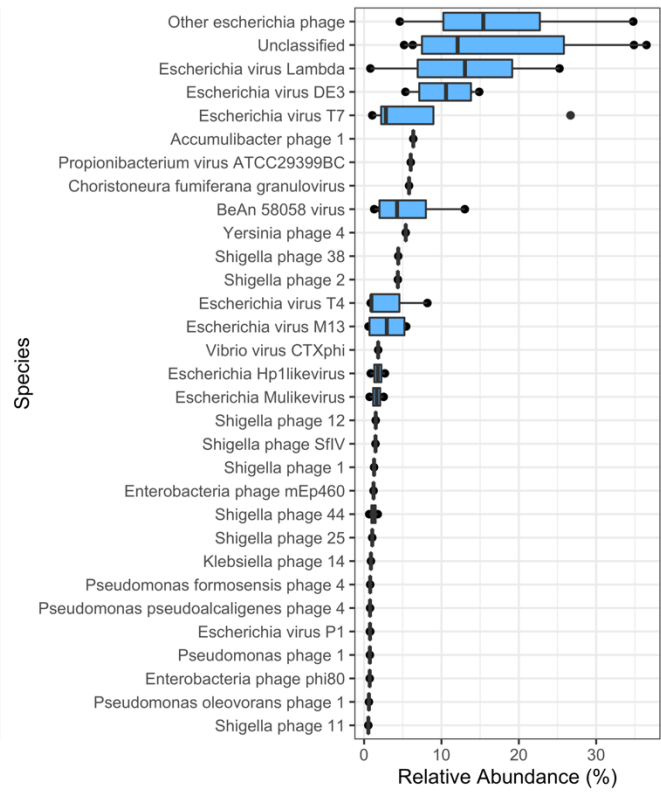

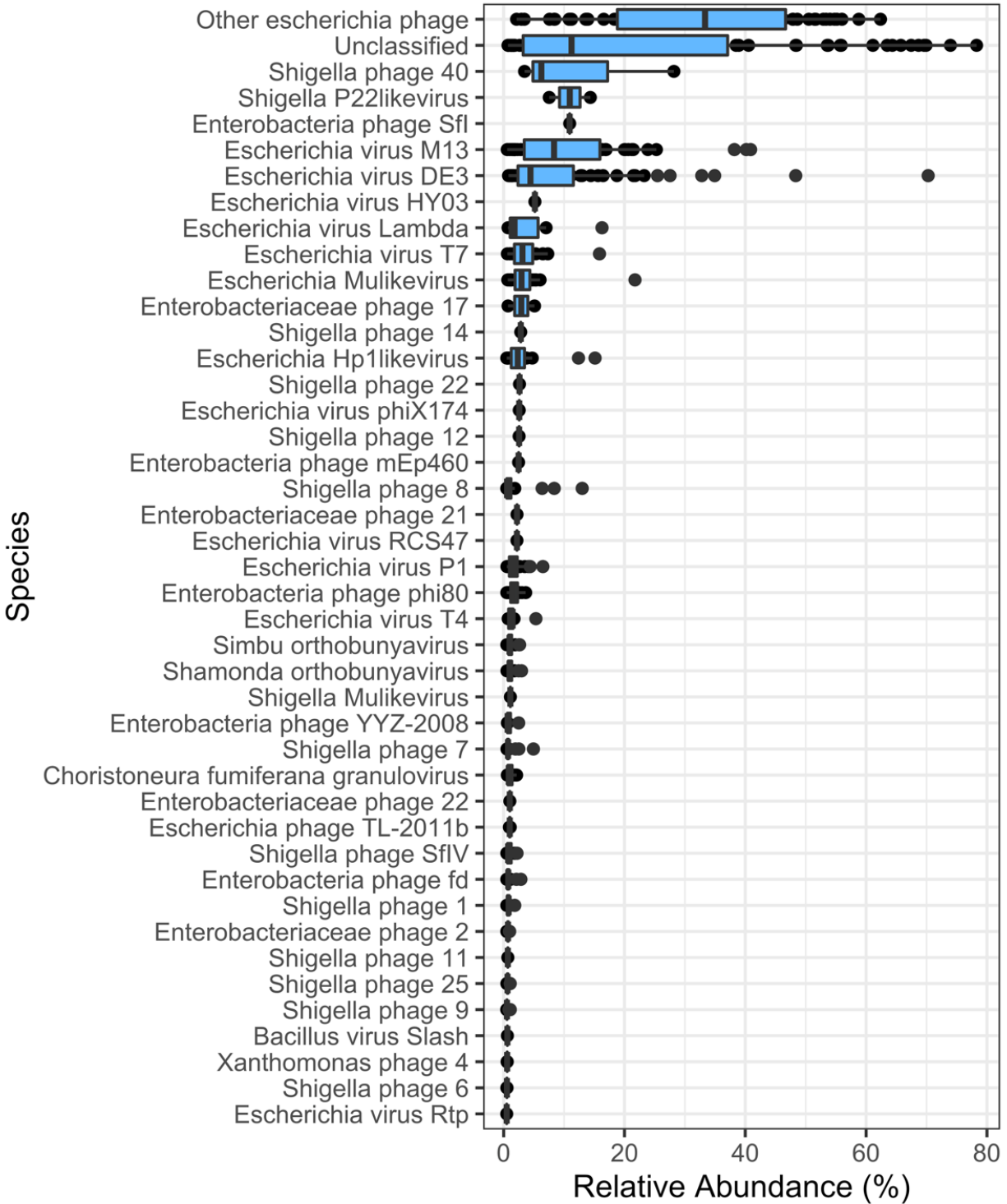
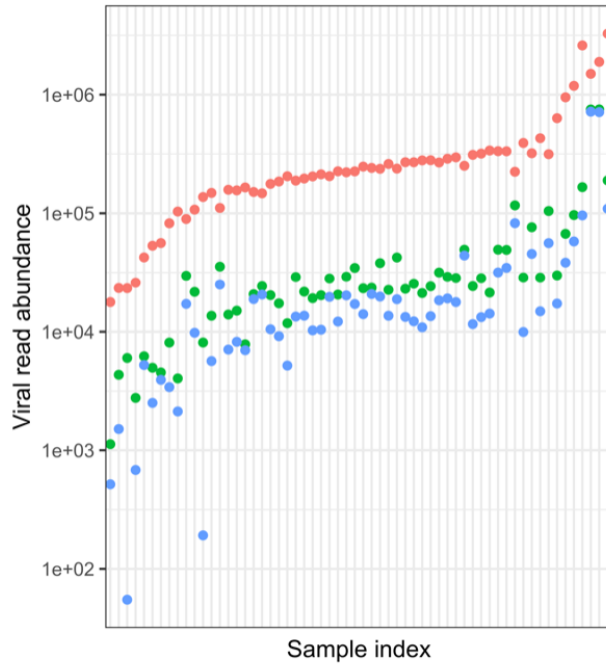
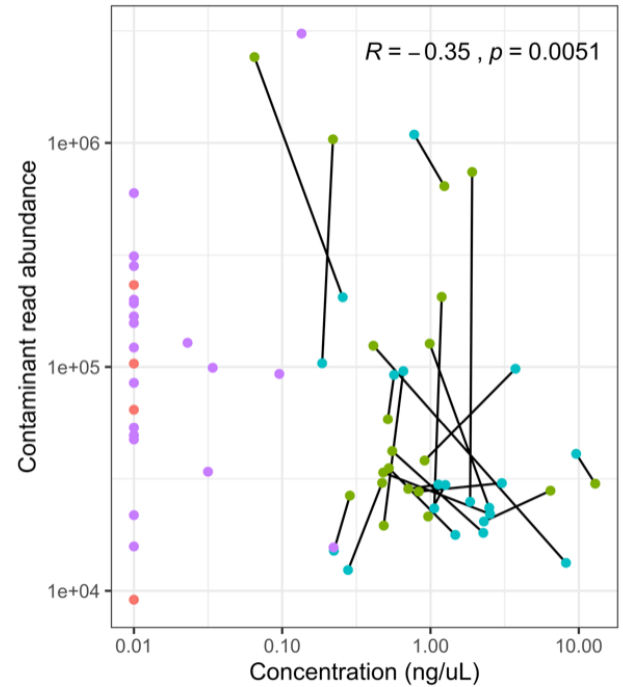

Taxa displayed were designated as contaminants with relative abundance > 0.5% in > 1 skin or wound sample prior to decontamination. Center line, median; box limits, upper and lower quartiles; whiskers, 1.5x interquartile range; points, outliers; $n = 20$ patients.

Figure S4. Decontamination summary. Read abundances for each sample, at each step of decontamination (a). Only experimental samples are shown, not negative or positive controls. Raw is the number of initial reads, decontaminated is the number of reads after contaminants are removed, and defined is the number of reads with a taxonomic or host classification. (b) Contaminant read abundance as a function of extracted DNA concentration, with points colored by sample type, and wound samples from the same patient connected by black lines. Overall Spearman correlation coefficient R and p -value are shown.

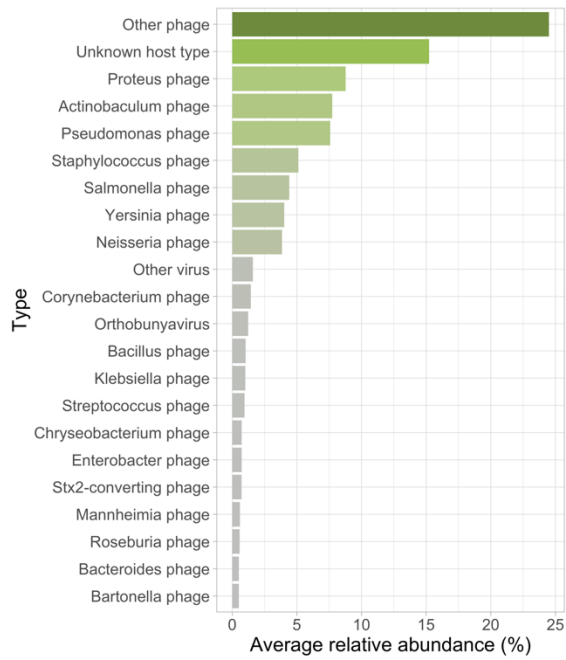
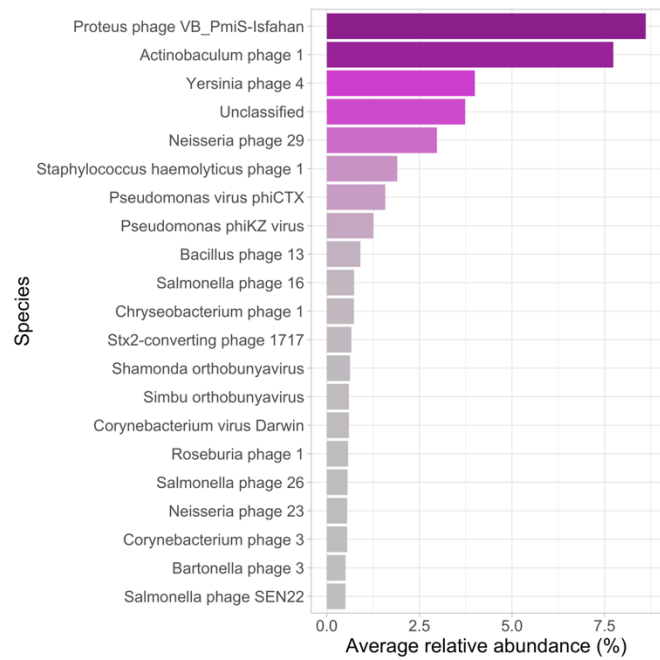

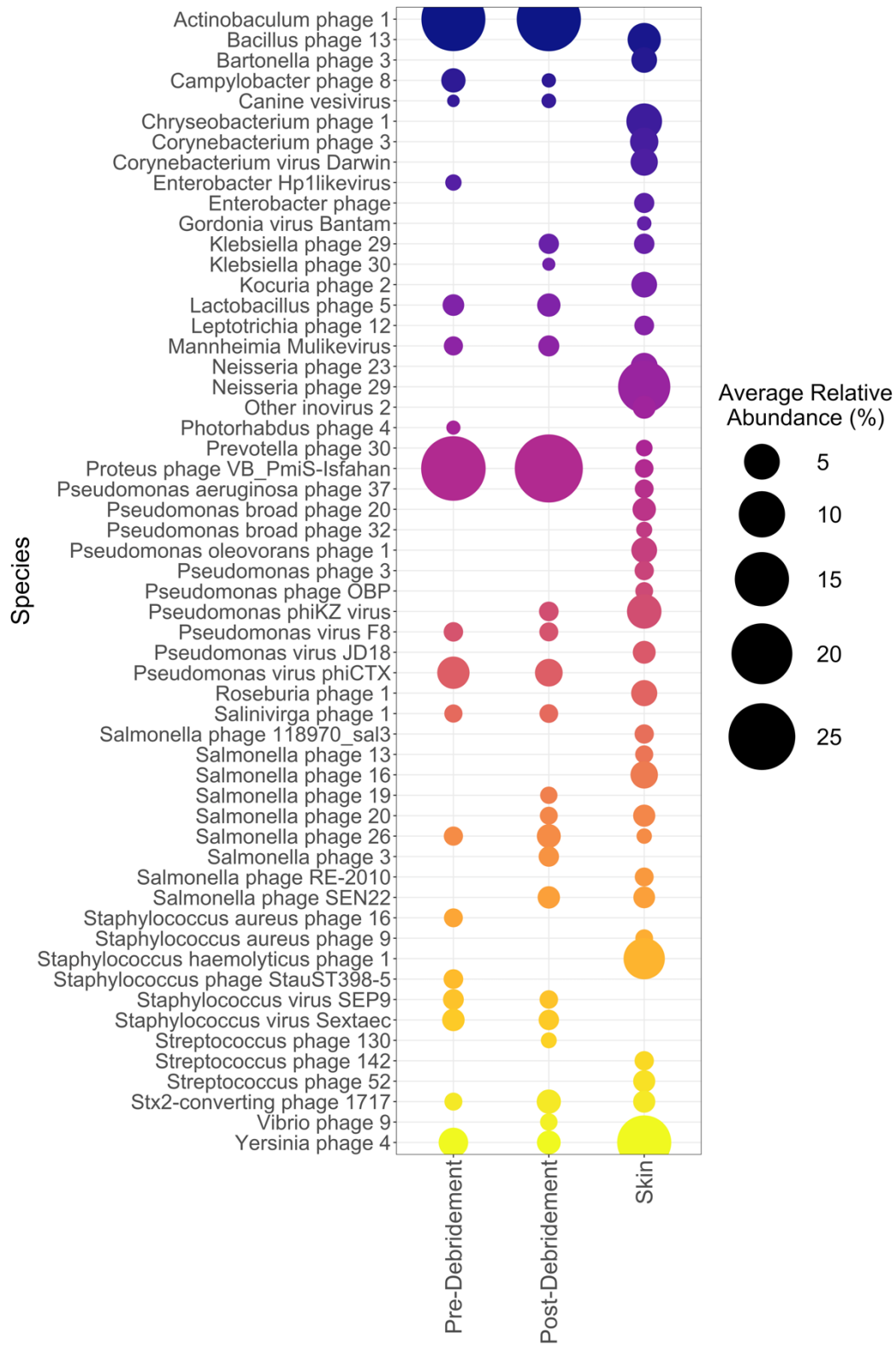

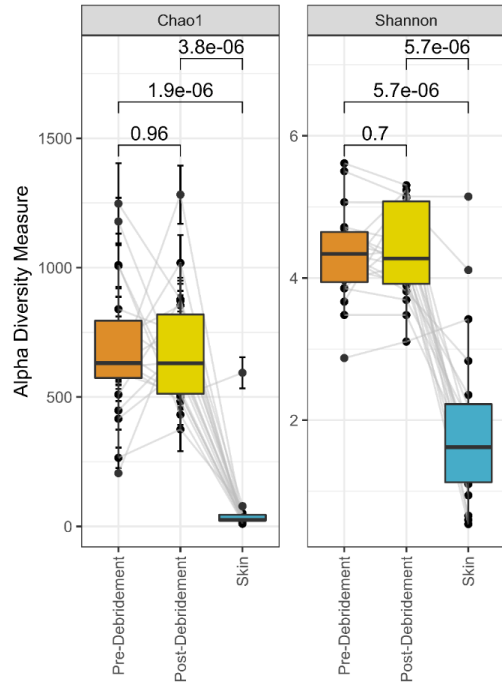
