

Use of Magnetic Resonance Imaging in Pediatric Cardiac Arrest Survey

Objective: The main goal of this study is to describe current practices regarding the use of brain MRI for prognostication in children after cardiac arrest.

Patient population: Hospitalized children receiving post-cardiac arrest care after an in- or out-of-hospital cardiac arrest.
