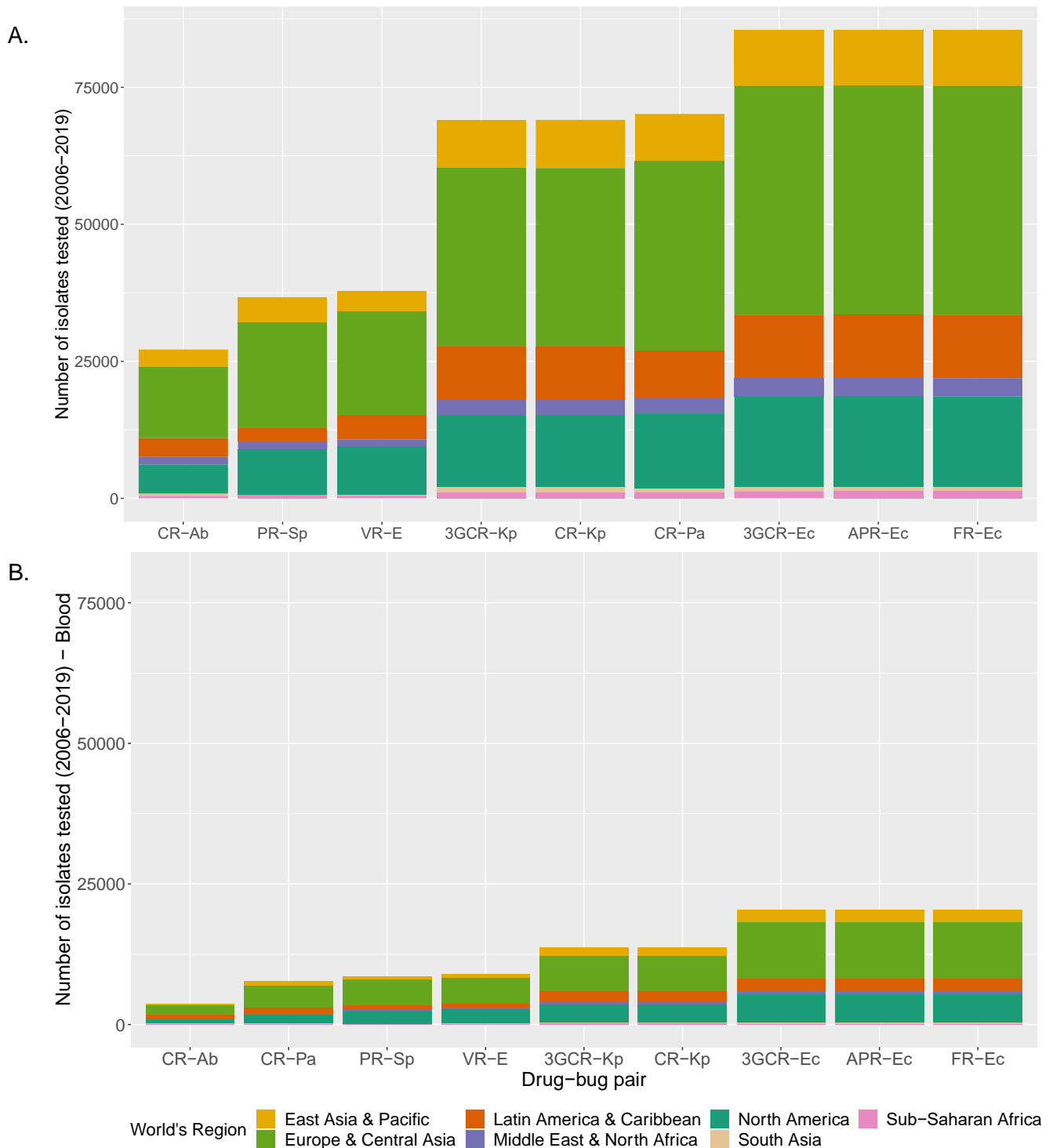

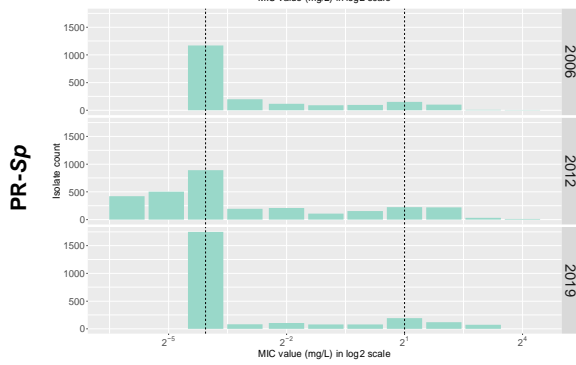
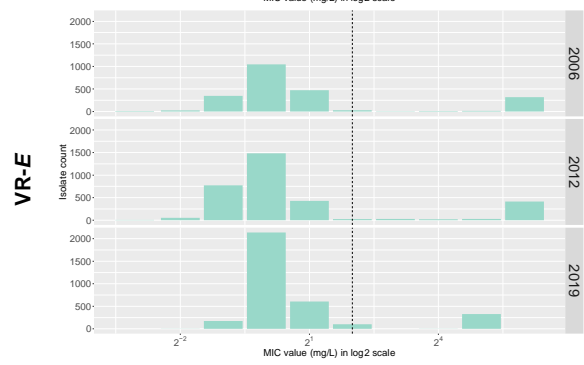
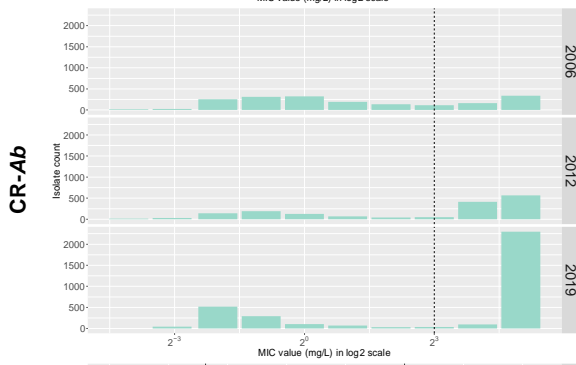
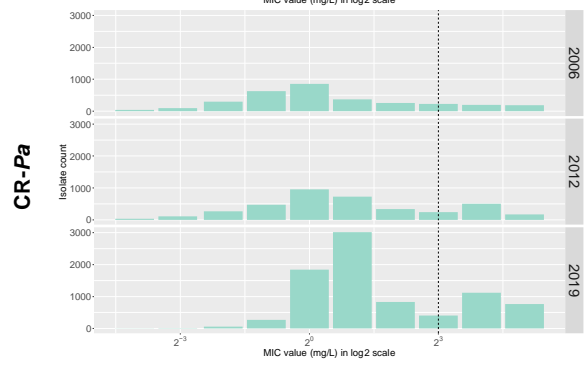
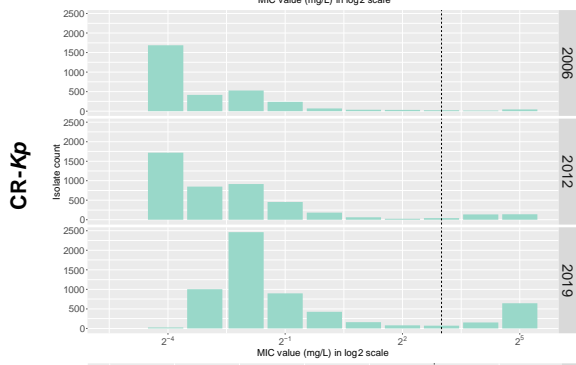
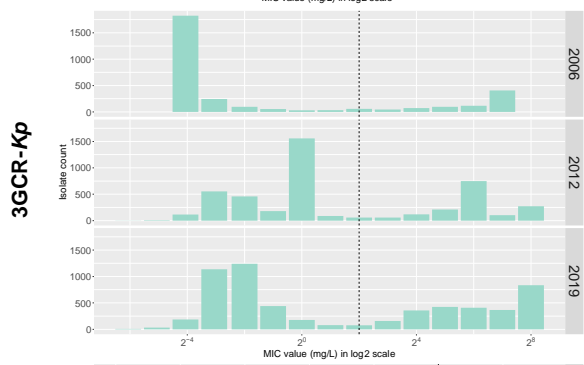
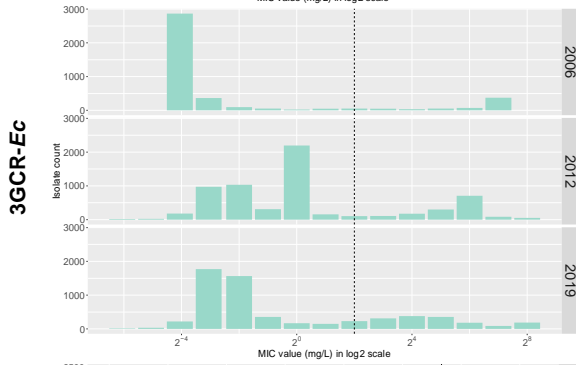
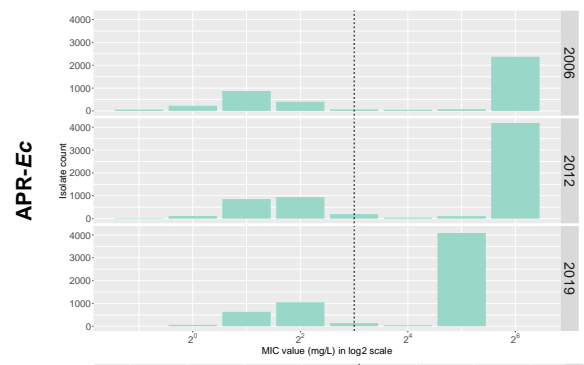
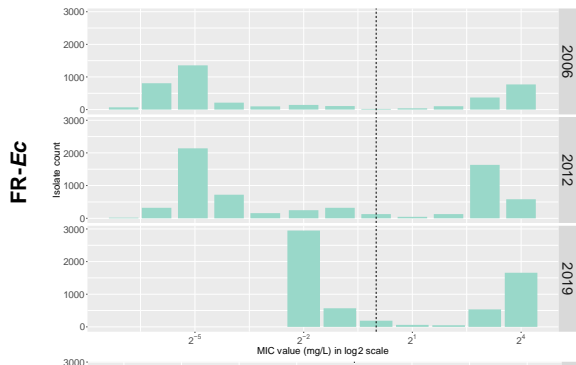

Supplementary Figure S2. Number of isolates tested per drug-bug pair in the ATLAS database, by regions of the world (2006-2019).

(A) ATLAS data represented a total number of tested isolates from all infection sources per drug-bug pair (main analysis) as follow: $n = 85485$ each for FR-*Ec*, APR-*Ec* and 3GCR-*Ec*; $n = 70151$ for CR-*Pa*; $n = 69064$ each for 3GCR-*Kp* and CR-*Kp*; $n = 37739$ for VR-*E*; $n = 36685$ for PR-*Sp*; $n = 27153$ for CR-*Ab*. (B) ATLAS data represented a total number of tested isolates from blood source only per drug-bug pair (sensitivity analysis 3) as follow: $n = 20401$ each for FR-*Ec*, APR-*Ec* and 3GCR-*Ec*; $n = 13699$ each for 3GCR-*Kp* and CR-*Kp*; $n = 9017$ for VR-*E*; $n = 8560$ for PR-*Sp*; $n = 7752$ for CR-*Pa*; $n = 3736$ for CR-*Ab*.



Supplementary Figure S3. Distribution of MIC values for 3 years (2006, 2012 and 2019), for all drug-bug pairs.

Represented here are the raw data for all bacterial isolates tested against a specific class of antibiotics in ATLAS. If two molecules are considered in a class, highest MIC value between the 2 molecules is considered. MIC values are shown in log scale base 2. The MIC breakpoints from the 2019 *European Committee on Antimicrobial Susceptibility Testing* (EUCAST) standards are depicted with the dashed lines.

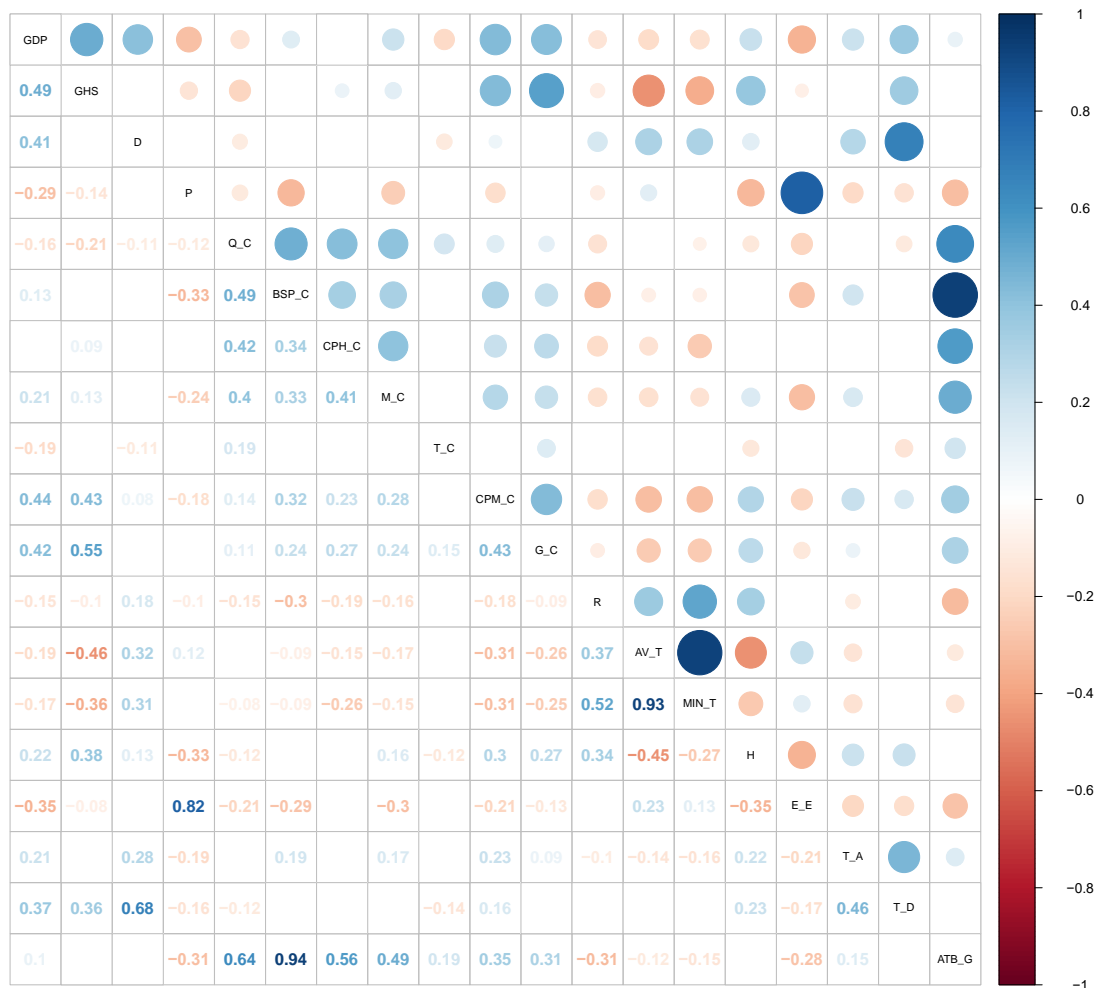

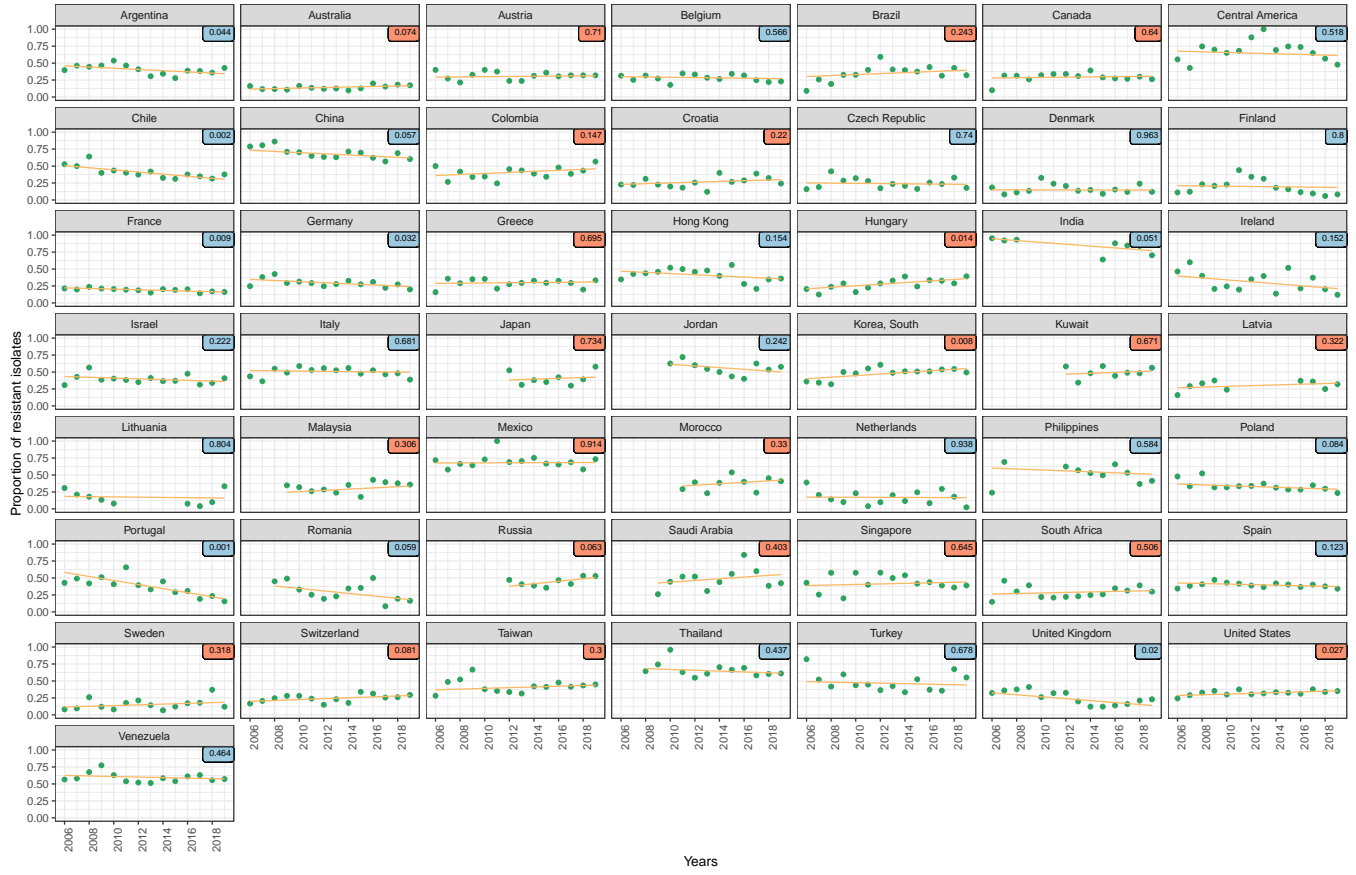
Supplementary Figure S4. Correlogram for covariables data used in the mixed-effect negative binomial model (for all 51 countries and 14 years).

GDP: Gross Domestic product; GHS: Global Health Security Index; D: population density; P: population number; Q_C: quinolone consumption; BSP_C: broad spectrum penicillin consumption; CPH_C: cephalosporin consumption; M_C: macrolide consumption; T_C: trimethoprim consumption; CPM_C: carbapenem consumption; G_C: glycopeptide consumption; R: average rainfall; AV_T: average temperature; MIN_T: minimum temperature; H: average relative humidity; E_E: extreme climatic events, T_A: tourism arrivals; T_D: tourism departures; ATB_G: global consumption.

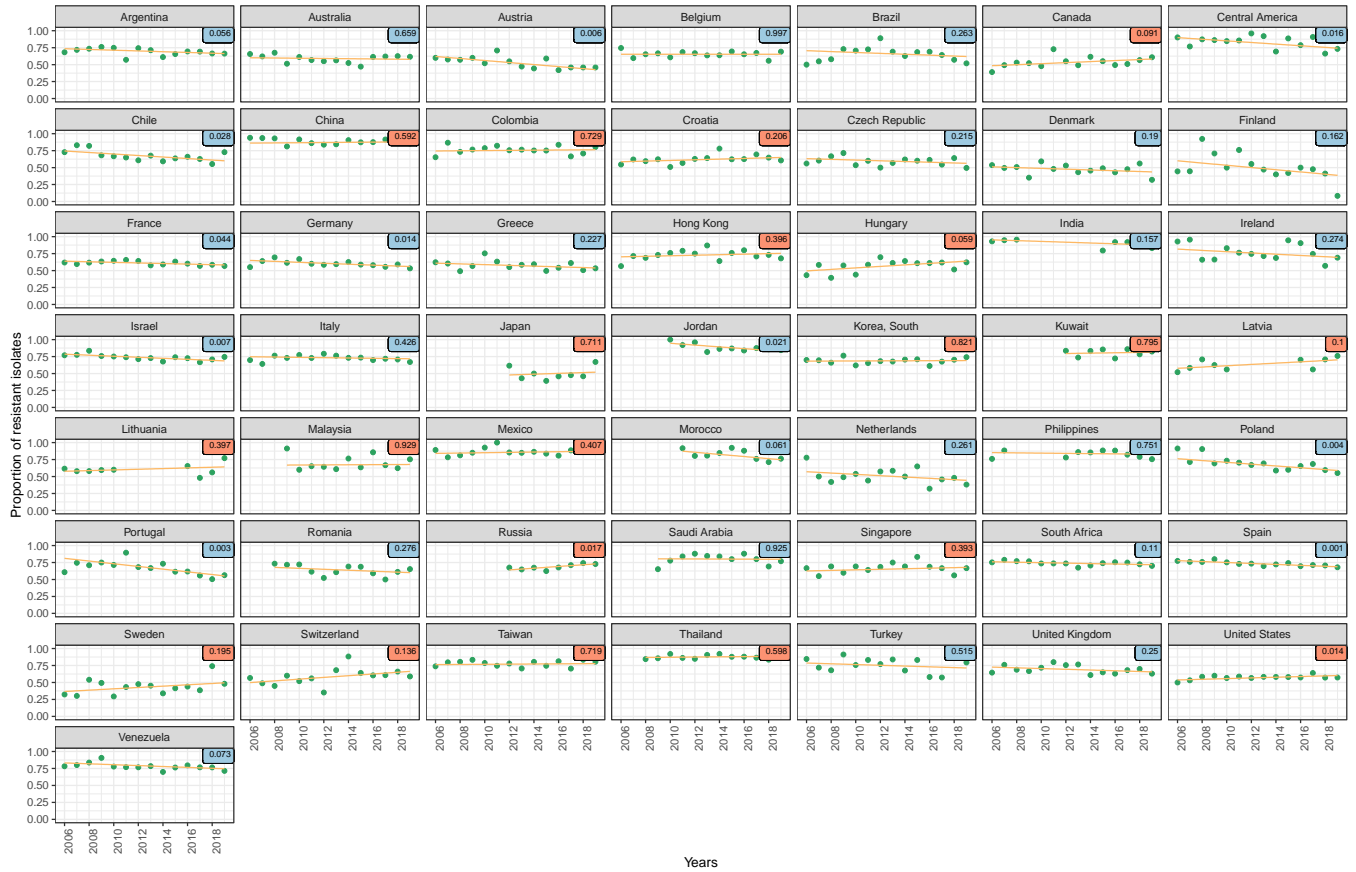
Shown here are the Pearson correlation coefficient for each pair of variables (r). Blue colors represent positive correlation between variables. Red colors represent high negative correlation. Only significant correlation coefficients (p -value < 5%) are shown in the correlogram. Co-variables associated with $r > |0.7|$ were excluded from the model. Population number and Minimum Temperature were excluded (because considered less biologically relevant or less correlated to ABR rates). Global antibiotic consumption was not included at the same time as broad-spectrum penicillin consumption in any model.

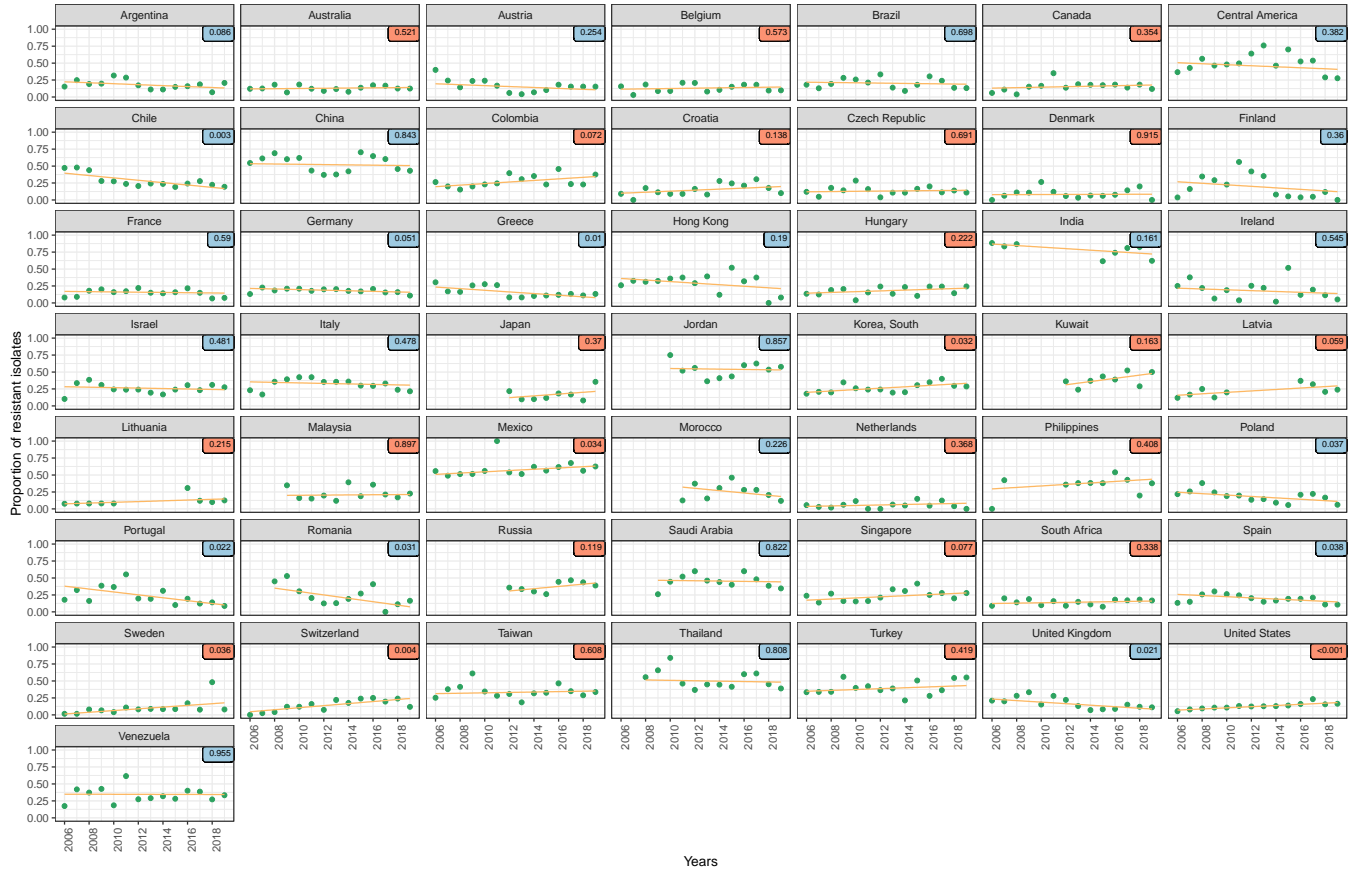

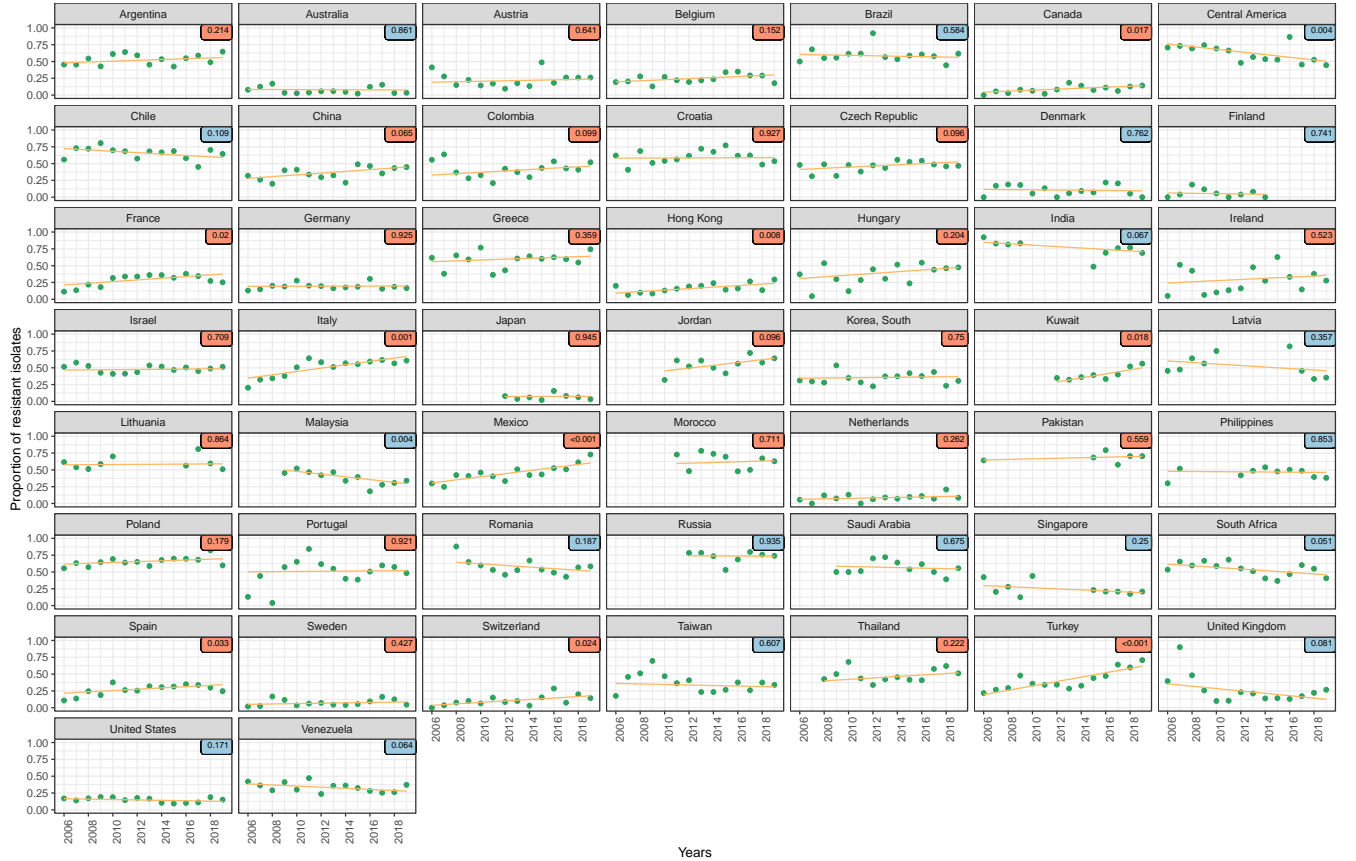

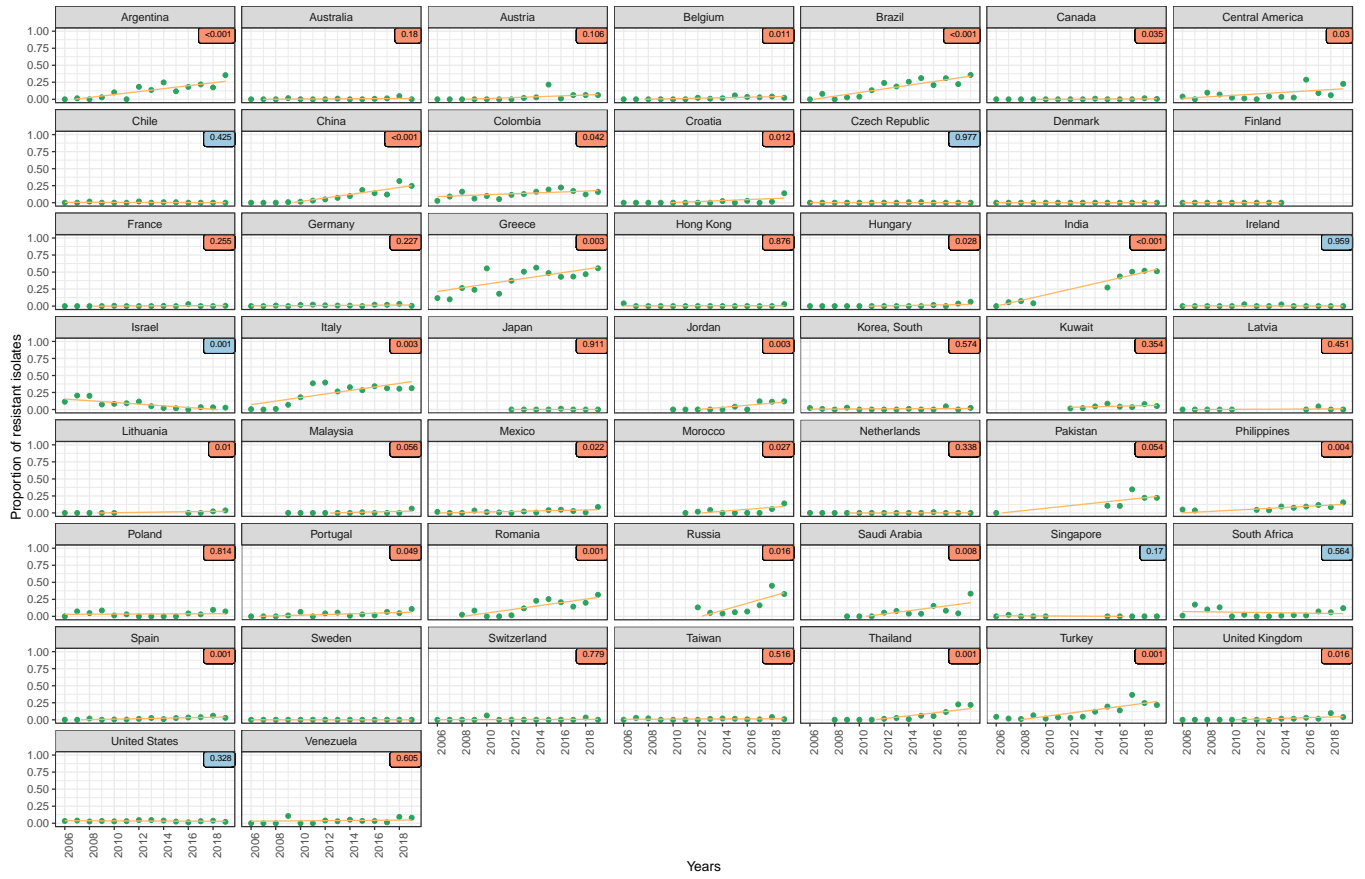

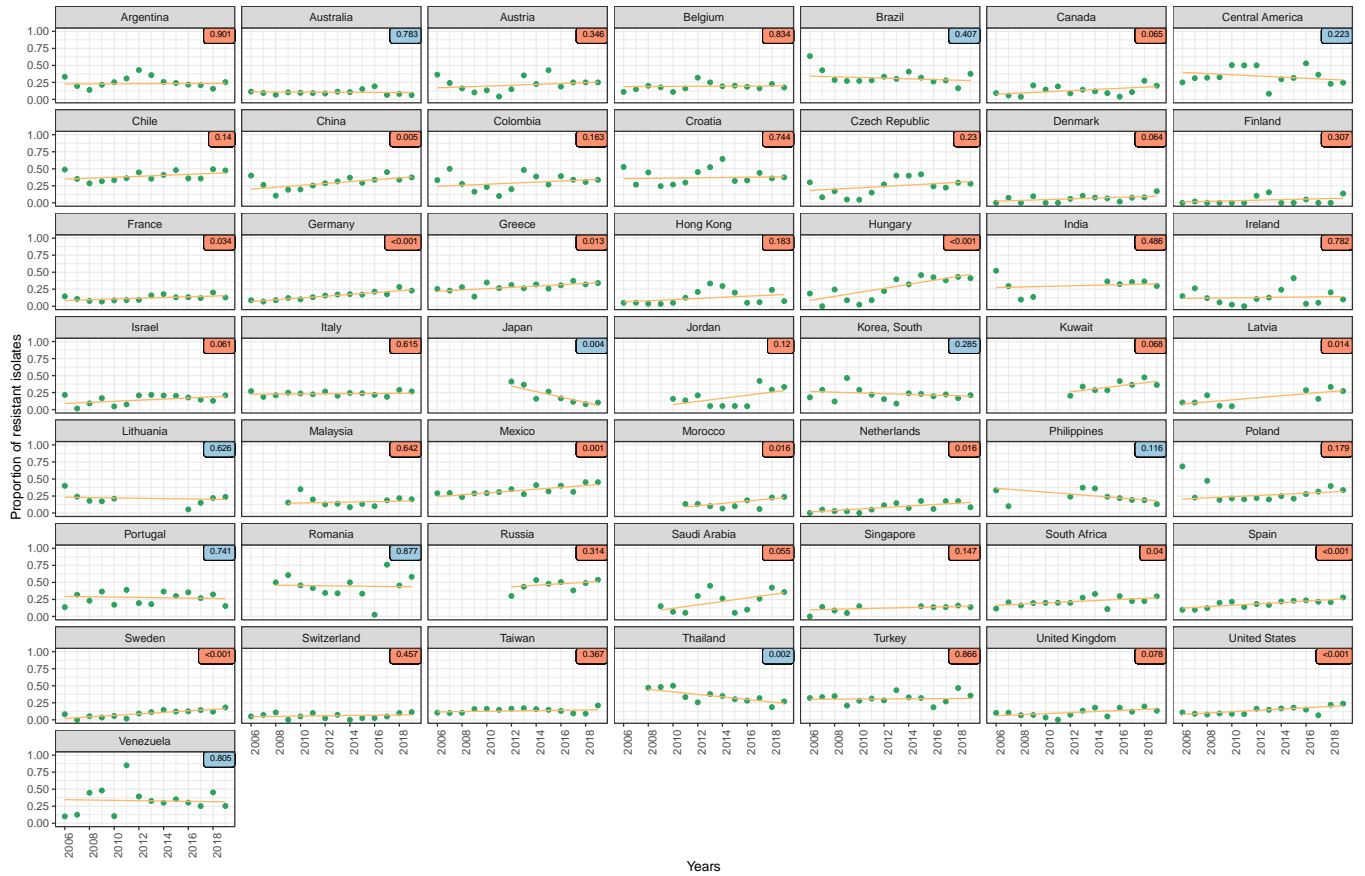

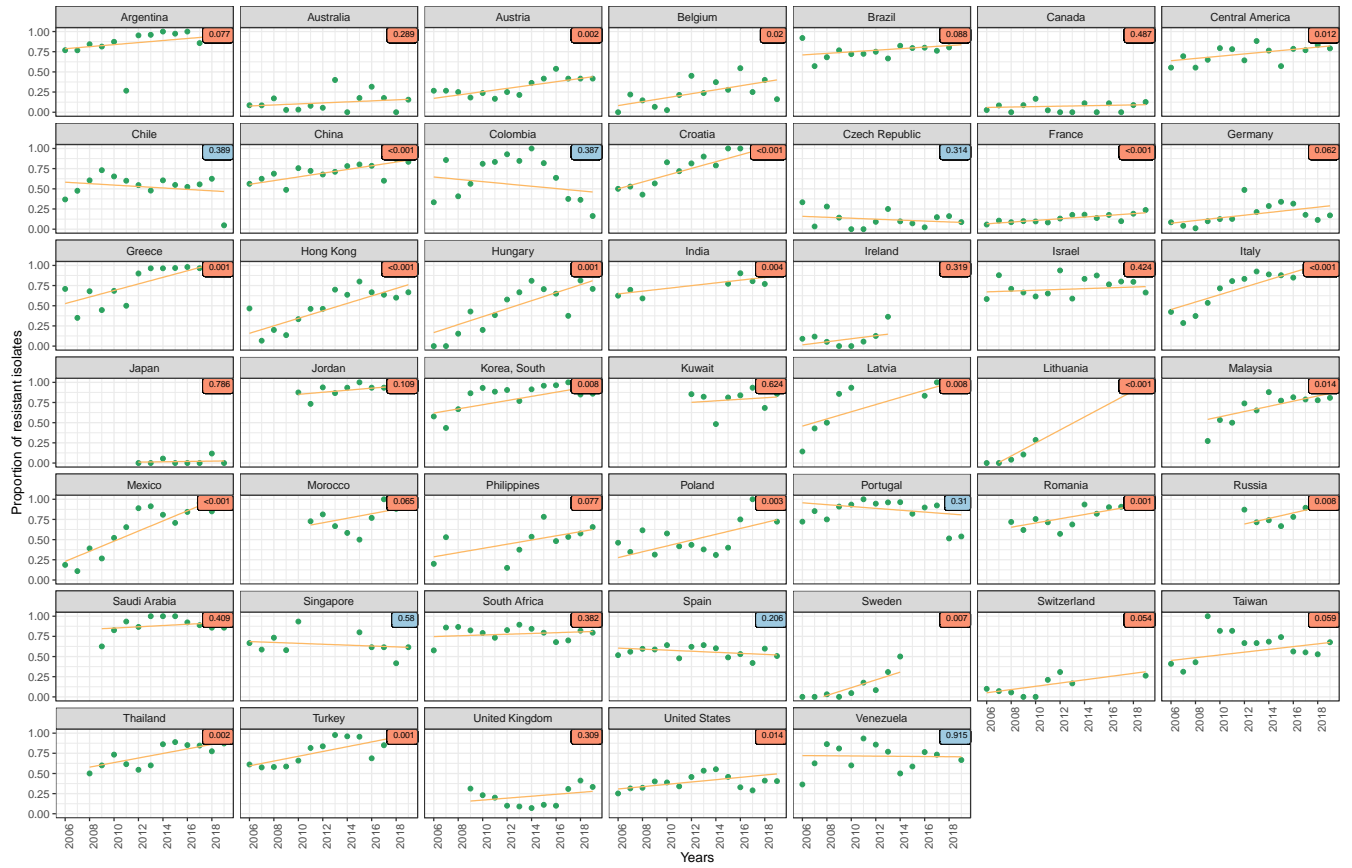

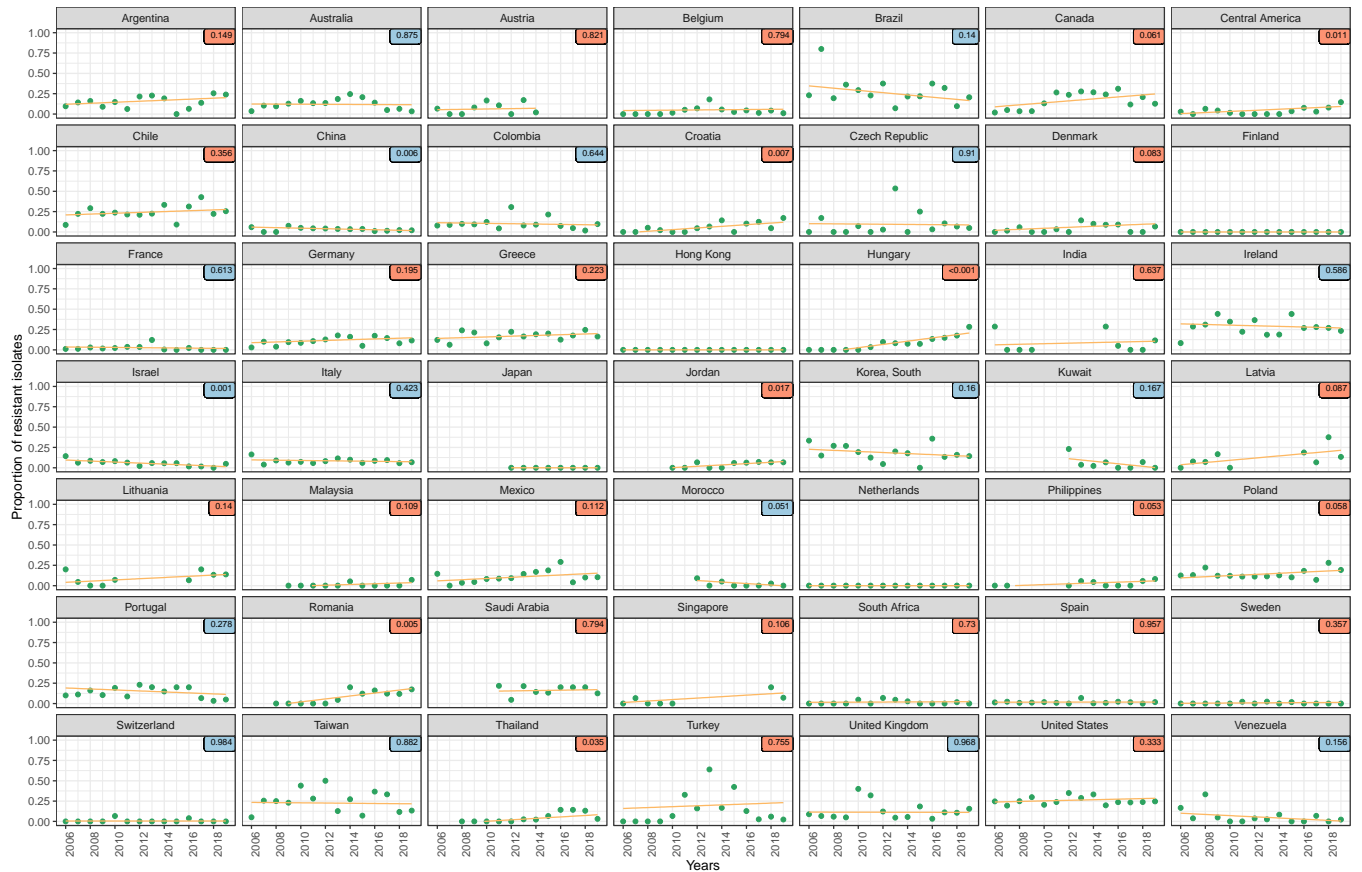

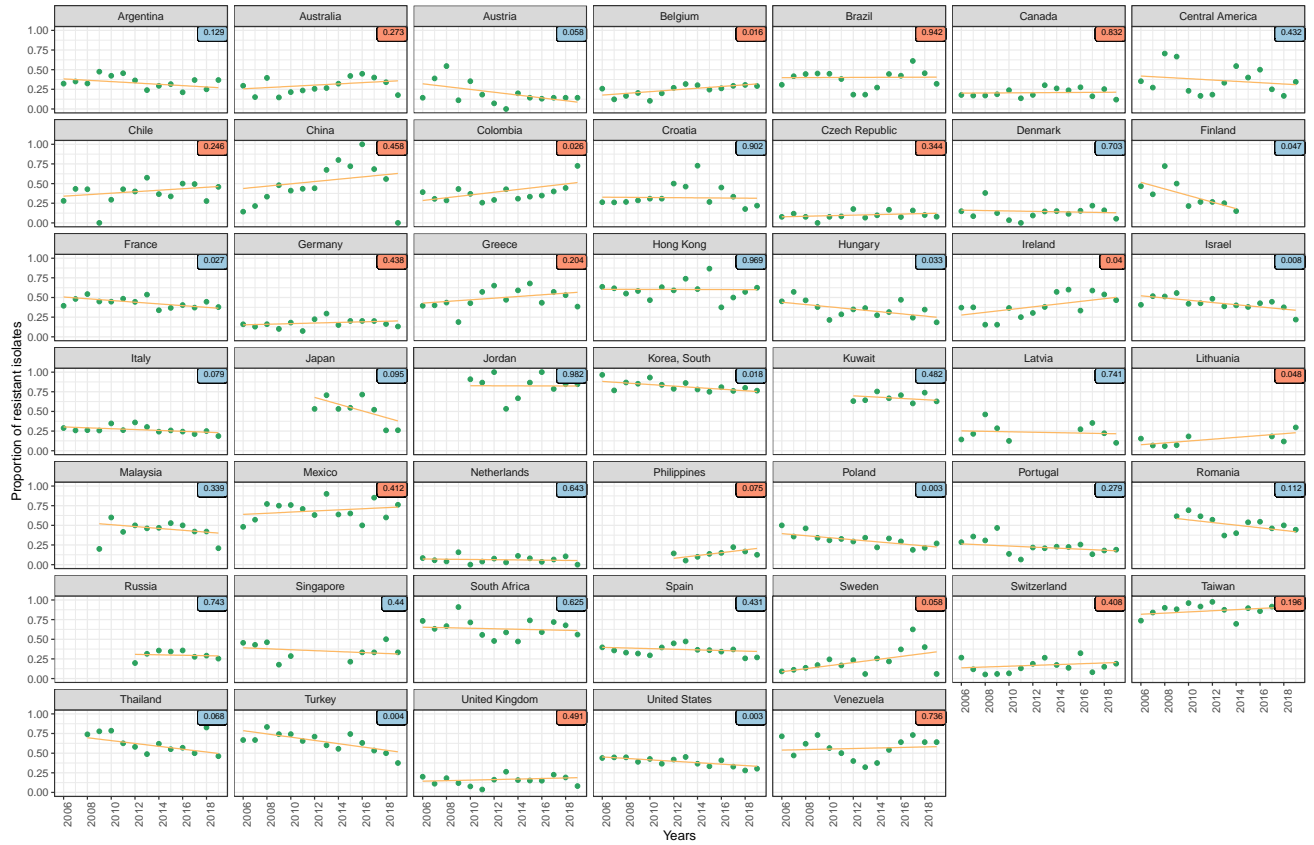

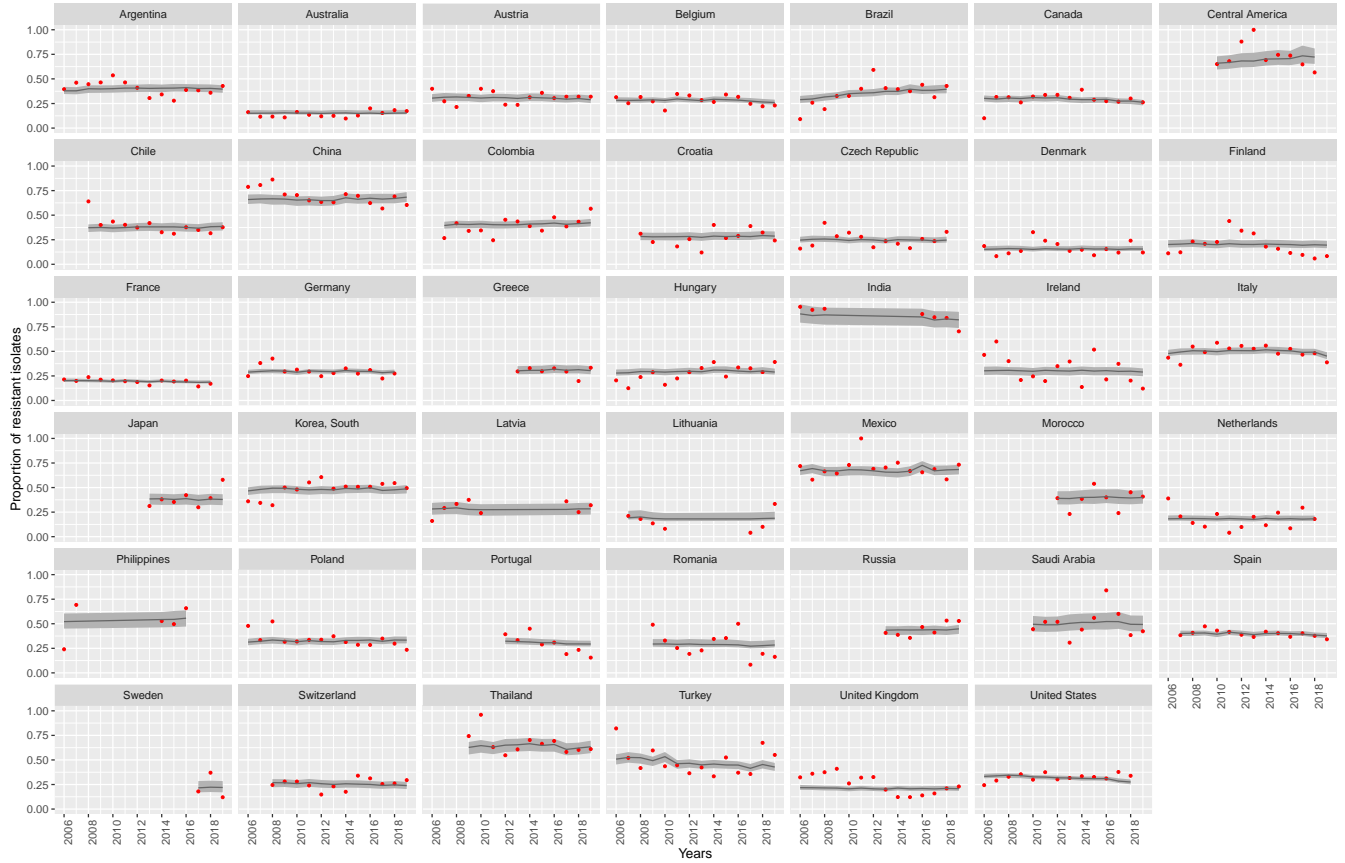


Supplementary Figure S5. Temporal trends (2006-2019) per country, for all drug-bug pairs.

Temporal trends for FR-*Ec* (A); APR-*Ec* (B); 3GCR-*Ec* (C); 3GCR-*Kp* (D); CR-*Kp* (E); CR-*Pa* (F); CR-*Ab* (G); VR-*E* (H); PR-*Sp* (I). Weighted linear regression temporal trends are shown in yellow (weights are the number of isolates tested per country and per year). P-values associated with the temporal trend are included on the top right. Blue color represents a decreasing trend. Red color represents an increasing trend. 95% confidence intervals (CI) around binomial proportions were calculated using Bayesian probability interval estimates with Jeffrey's prior. Number of countries included for each drug-bug pair were the following: 51 for 3GCR-*Kp* and CR-*Kp*; 50 for FR-*Ec*, APR-*Ec*, 3GCR-*Ec*, and CR-*Pa*; 49 for VR-*E*; 47 for CR-*Ab* and PR-*Sp*.

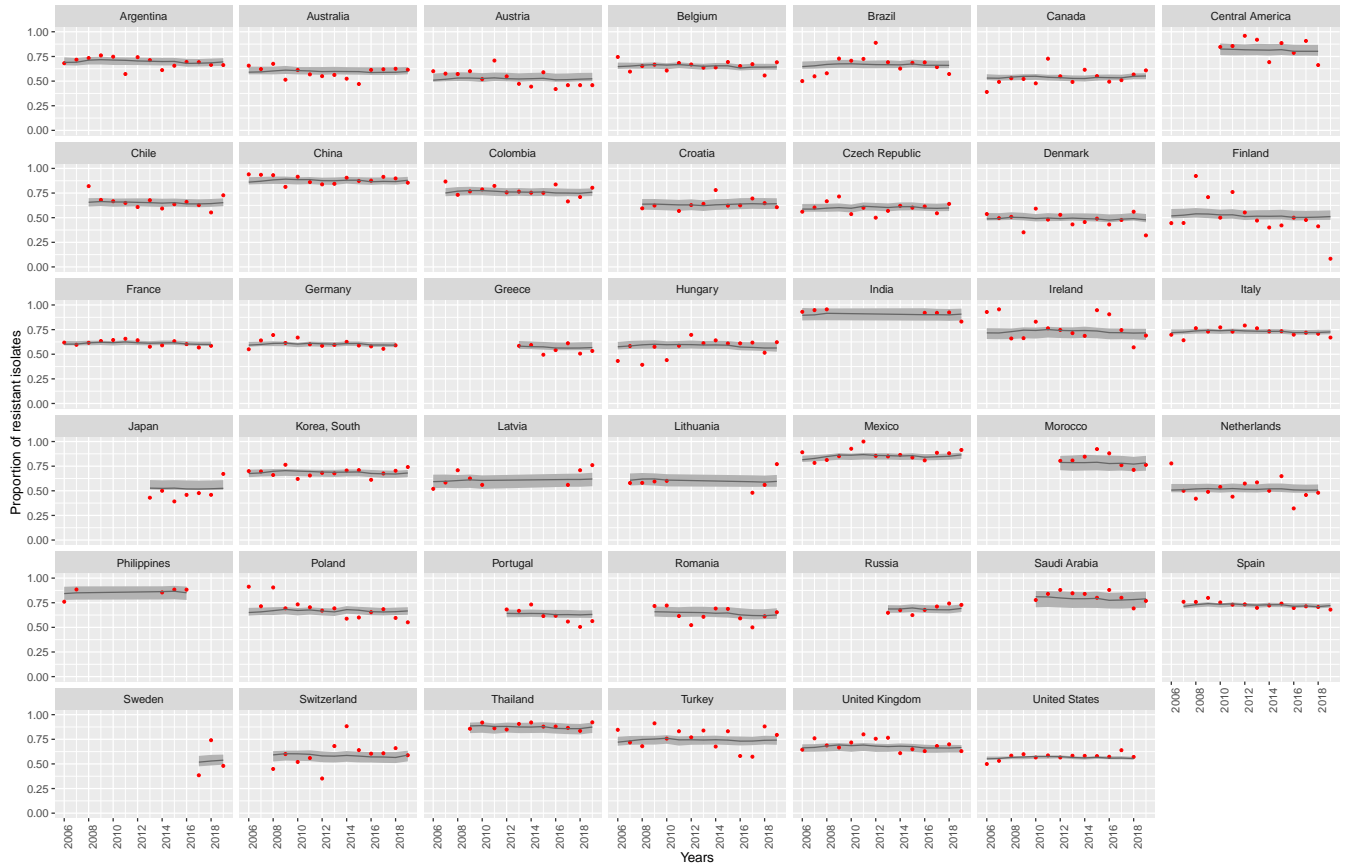

Fitted trajectories with 95% CI – 3GCR-Ec



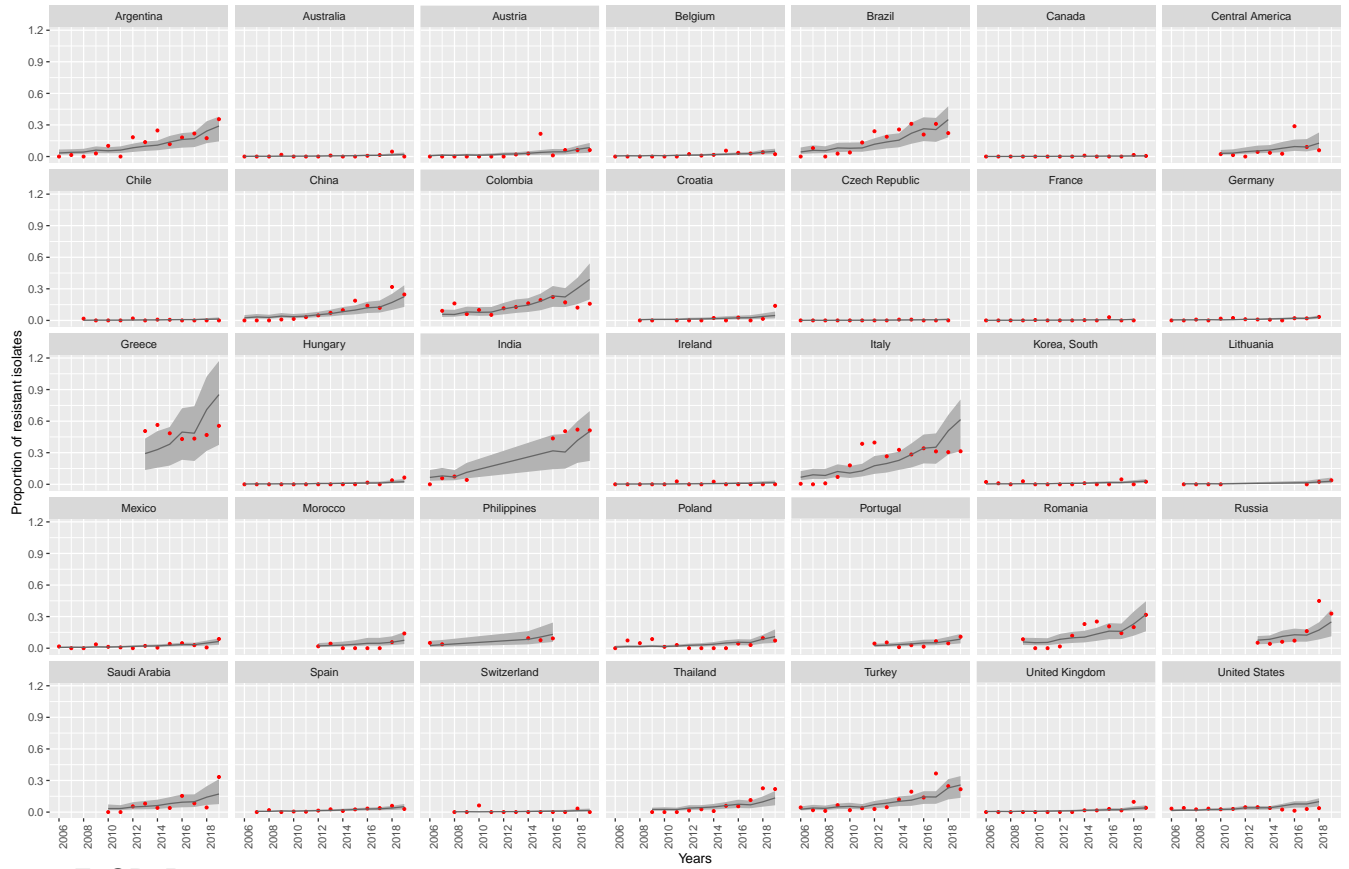

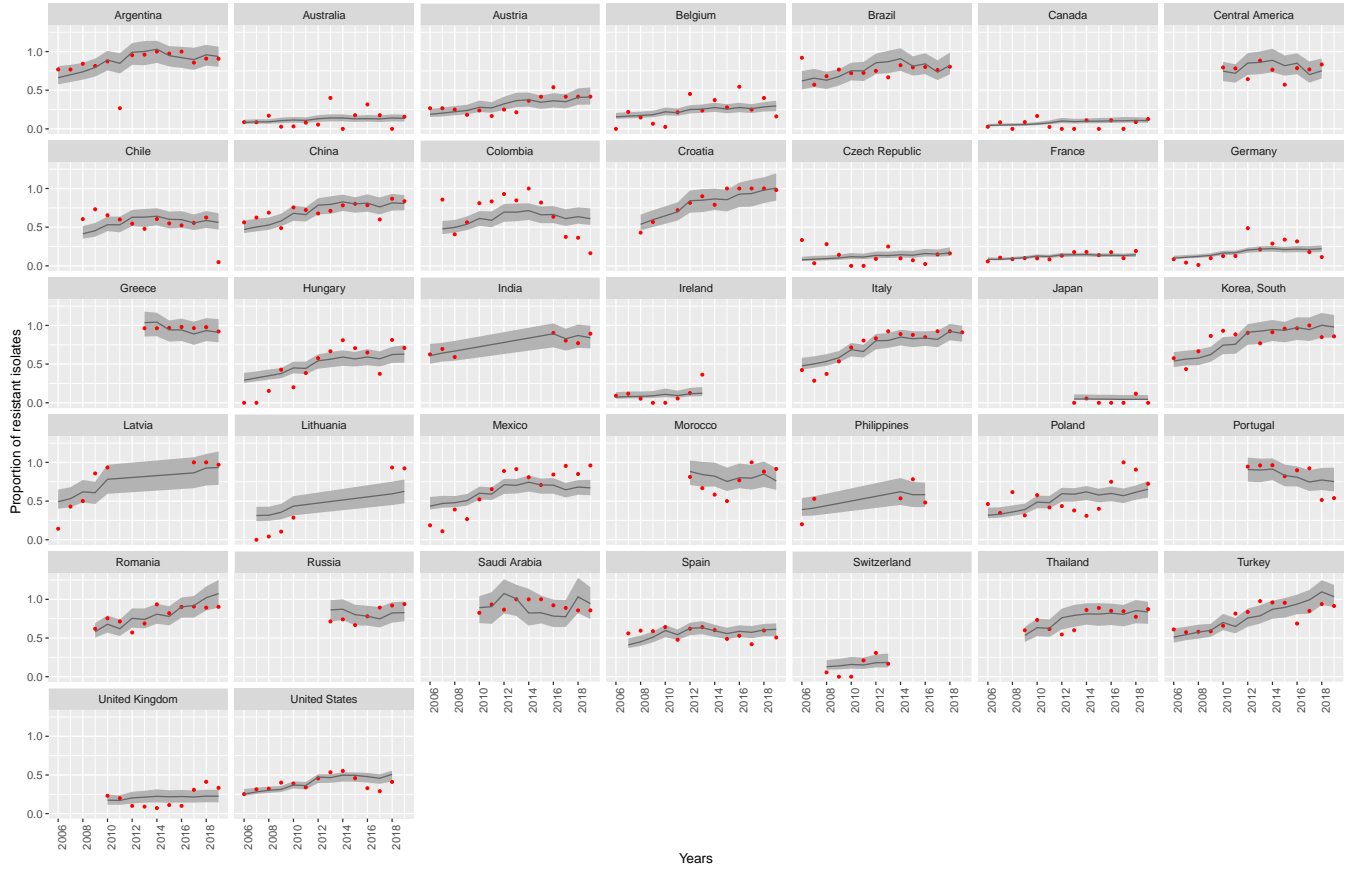

Fitted trajectories with 95% CI – CR-Pa



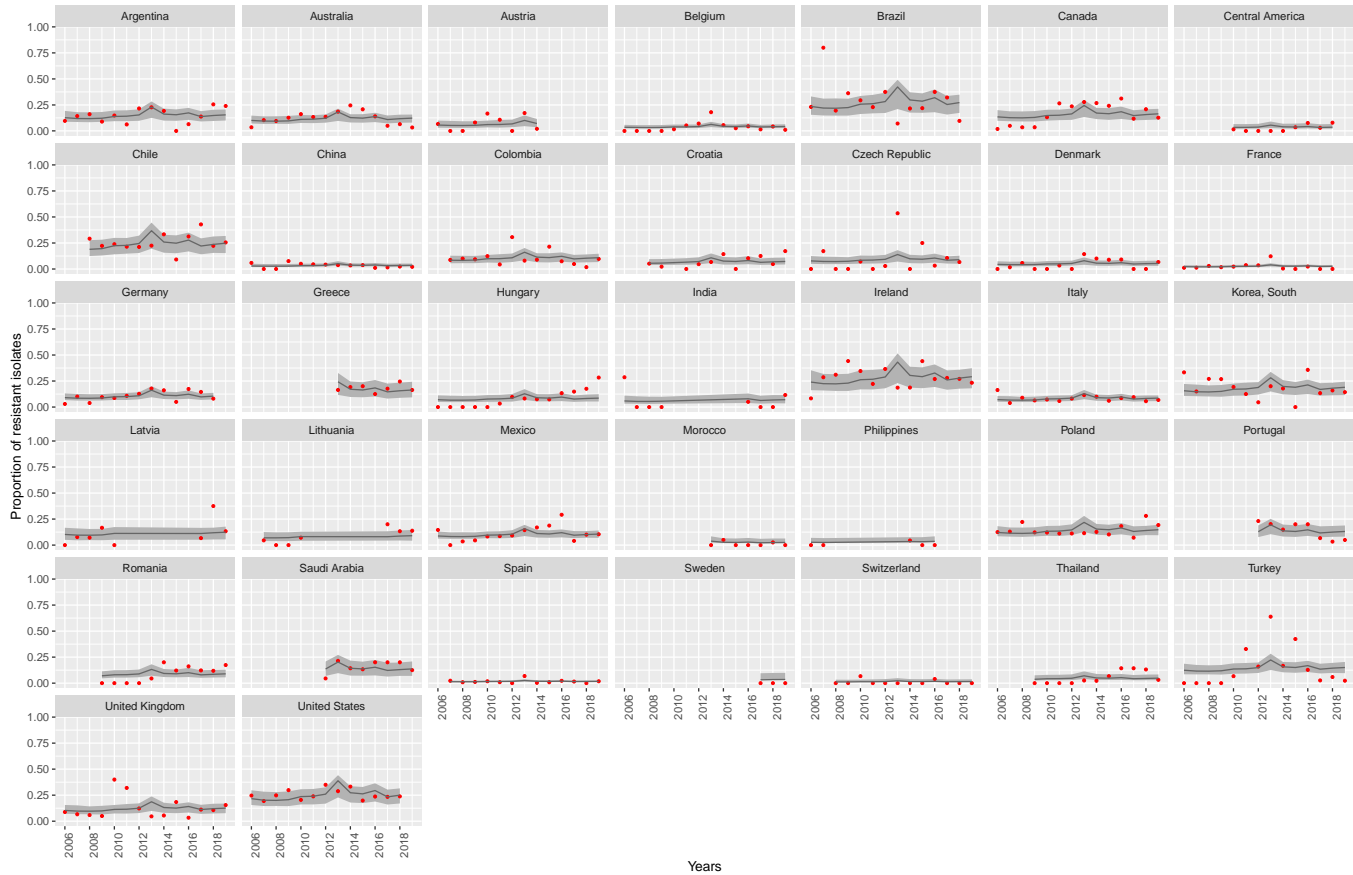

Fitted trajectories with 95% CI – CR-Ab

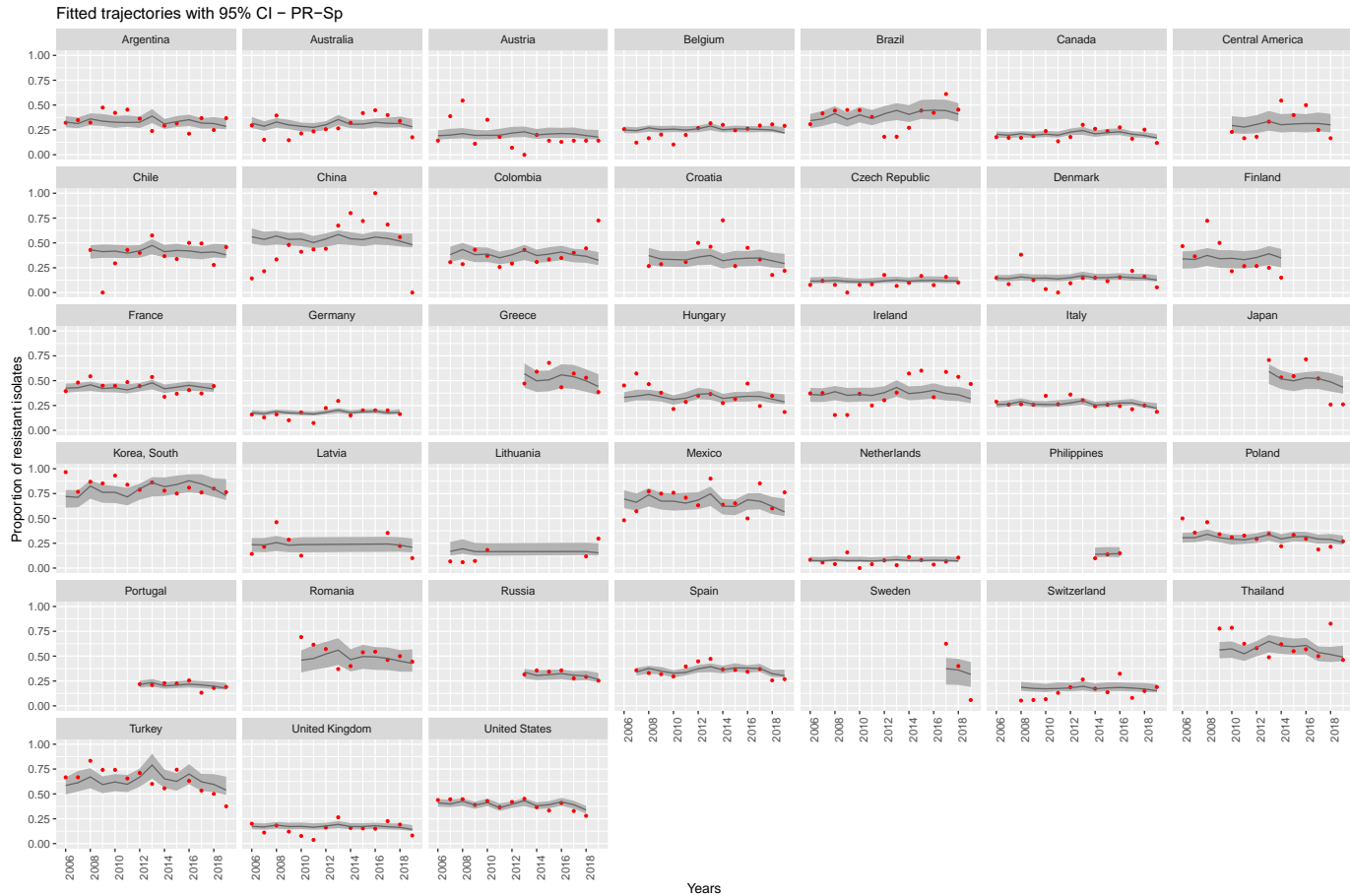

Supplementary Figure S6. Observed vs fitted values by final multivariable models (M_{multi}), for all drug-bug pairs.

Plots for FR-*Ec* (A); APR-*Ec* (B); 3GCR-*Ec* (C); 3GCR-*Kp* (D); CR-*Kp* (E); CR-*Pa* (F); CR-*Ab* (G); VR-*E* (H); PR-*Sp* (I).

Red points are the observed ABR rates by country-year with corresponding 95% confidence intervals. Black lines are the fitted values by the final multivariable models M_{multi} specific to each drug-bug pair.

For each drug-bug pair, selected covariables are the following: for FR-*Ec*, quinolones sales, the GHS index, extreme climatic events, and average temperature; for APR-*Ec*, the GHS index, extreme climatic events, average temperature, and tourist departures; for 3GCR-*Ec*, the GHS index, extreme climatic events, and average temperature; for 3GCR-*Kp*, the GHS index; for CR-*Kp*, the GHS index, and average temperature; for CR-*Pa*, the GHS index, and tourist departures; for CR-*Ab*, carbapenems sales, global antibiotic sales, the GHS index, and the GDP; for VR-*E*, no covariables; for PR-*Sp*, global antibiotic sales and average relative humidity.

Supplementary Result 1. Sensitivity analyses description.

Sensitivity analysis 1. To assess the potential impact of defining a threshold on the minimum number of isolates tested by country-year on the quality of the model's estimations, we ran an additional analysis by using a threshold of 20 isolates instead of 10.

Sensitivity analysis 2. To assess the potential impact of using ESAC-Net data instead of IQVIA MIDAS data for antibiotic sales for Denmark, Latvia, Lithuania, and the Netherlands, we ran an additional analysis excluding these four countries.

Sensitivity analysis 3. To assess whether different isolates sources could impact the association between antibiotic resistance and covariables, we ran an additional analysis on a subset of isolates originating only from blood source (representing bloodstream infections (BSI)).

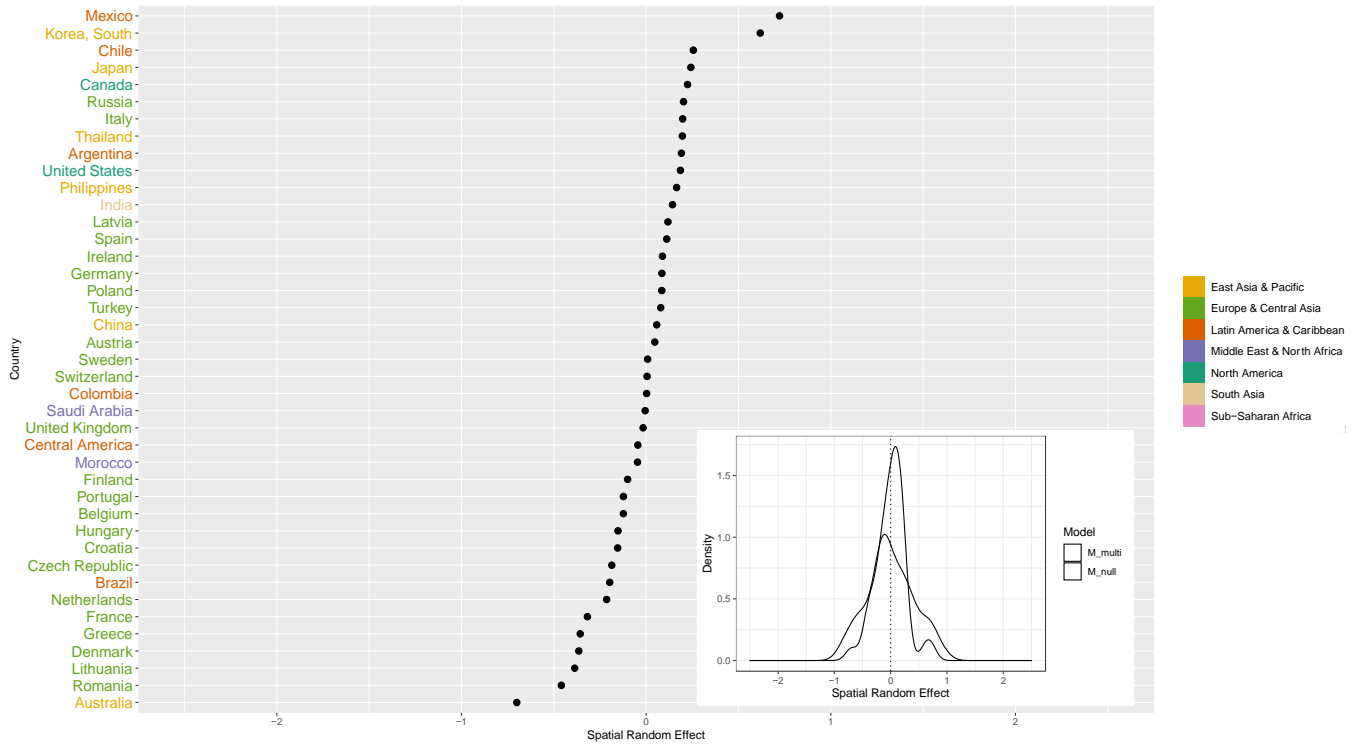
Sensitivity analysis 1 showed similar estimates for all covariables coefficients compared to the main analysis, in both the univariate and multivariable analysis. Choosing an isolate threshold of 10 to ensure data reliability was adequate, as sample size is high, but estimations are still consistent when increasing this threshold to 20.

For sensitivity analysis 2, covariables selected in the final multivariable model for FR-*Ec* were different than the main analysis. However, quinolones sales were still a relevant factor as it was kept in the final multivariable model. Results concerning association of antibiotic sales and antibiotic resistance were thus not affected by using EARS-Net data.

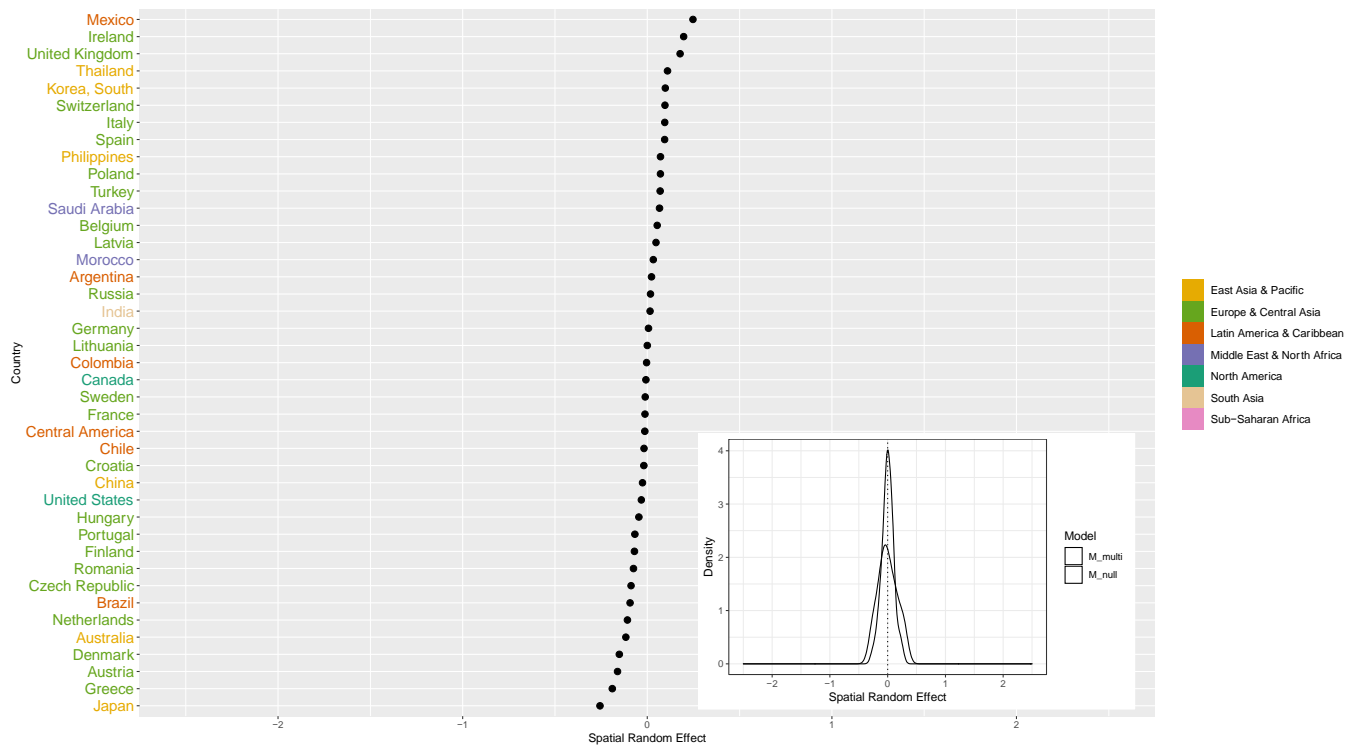
Overall, sensitivity analyses 1 and 2 showed that there were no major changes in interpretation in the statistical analyses.

Results from sensitivity analysis 3 were expected to be sensibly different: BSI are a particular infections' subset, usually associated with healthcare settings and worse medical outcomes. We decided to run that analysis even if including only BSI strongly reduces sample size and modifies drug-bug distributions, as BSI can represent more stable surveillance data across different countries. Indeed, some countries only reported few blood isolates per year, falling below the threshold of 10 isolates by country-year and were thus being removed from the analysis. Results should be considered accordingly. Number of blood isolates included in the analysis are depicted in sup figure S2 B (p19). In the results, temperature was not associated anymore with antibiotic resistance in FR-*Ec*, APR-*Ec*, 3GCR-*Ec* and CR-*Kp*, but was associated with 3GCR-*Kp*. Interestingly, temperature was still associated only with resistances in Enterobacterales. These results support the findings from the main analysis. GDP was not associated anymore with CR-*Ab* in the multivariable analysis. From the univariate analysis, we observed that CR-*Ab* estimates for GDP showed a different association (1.25 [1.02-1.54] in the main analysis versus 0.82 [0.60-1.12] in the BSI sensitivity analysis 3). This result suggest that high GDP is not significantly associated with high resistance in CR-*Ab* when looking at BSI infections only. Global antibiotic sales were not kept in the final multivariable model for PR-*Sp* but estimates from the univariate analysis were similar between the main analysis and BSI only. Overall, analysis of BSI showed stable results compared to main analysis, except for temperature associated with a different Enterobacterales pair, 3GCR-*Kp*, and GDP not associated with resistance in CR-*Ab*.

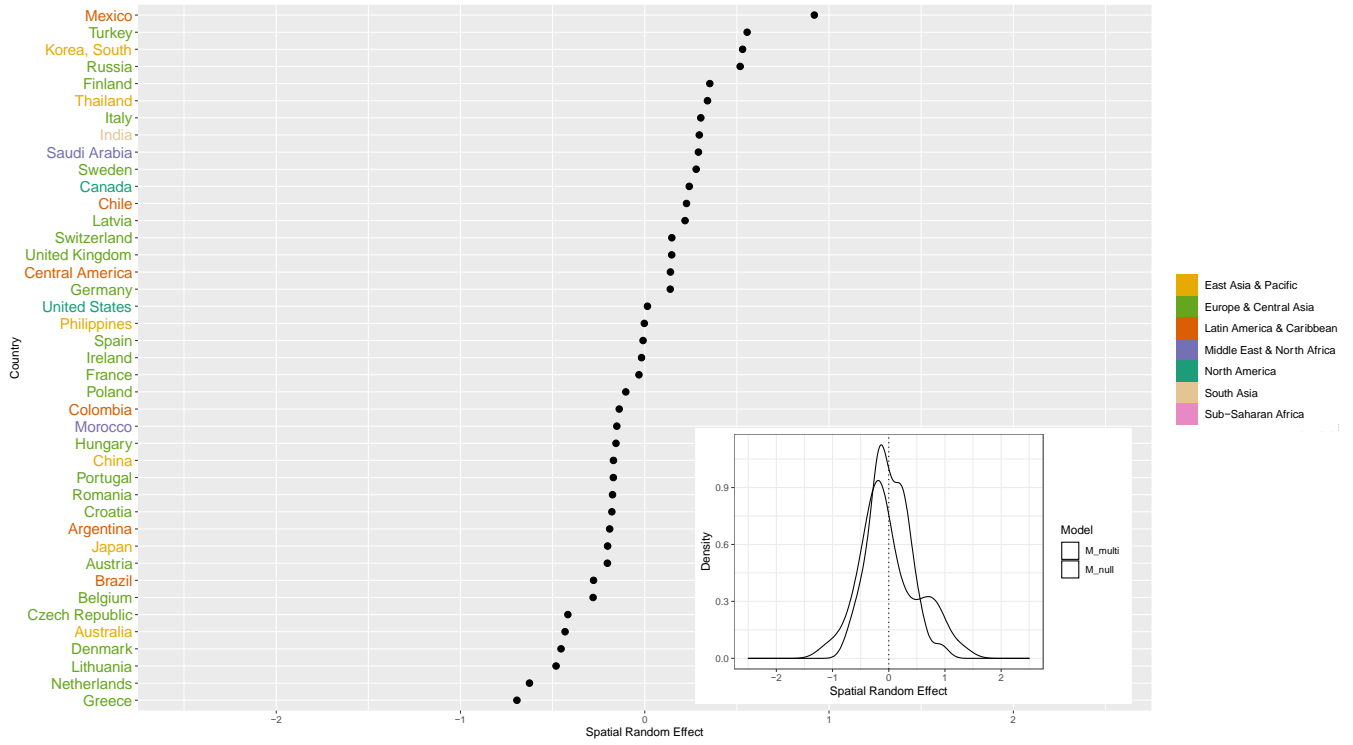

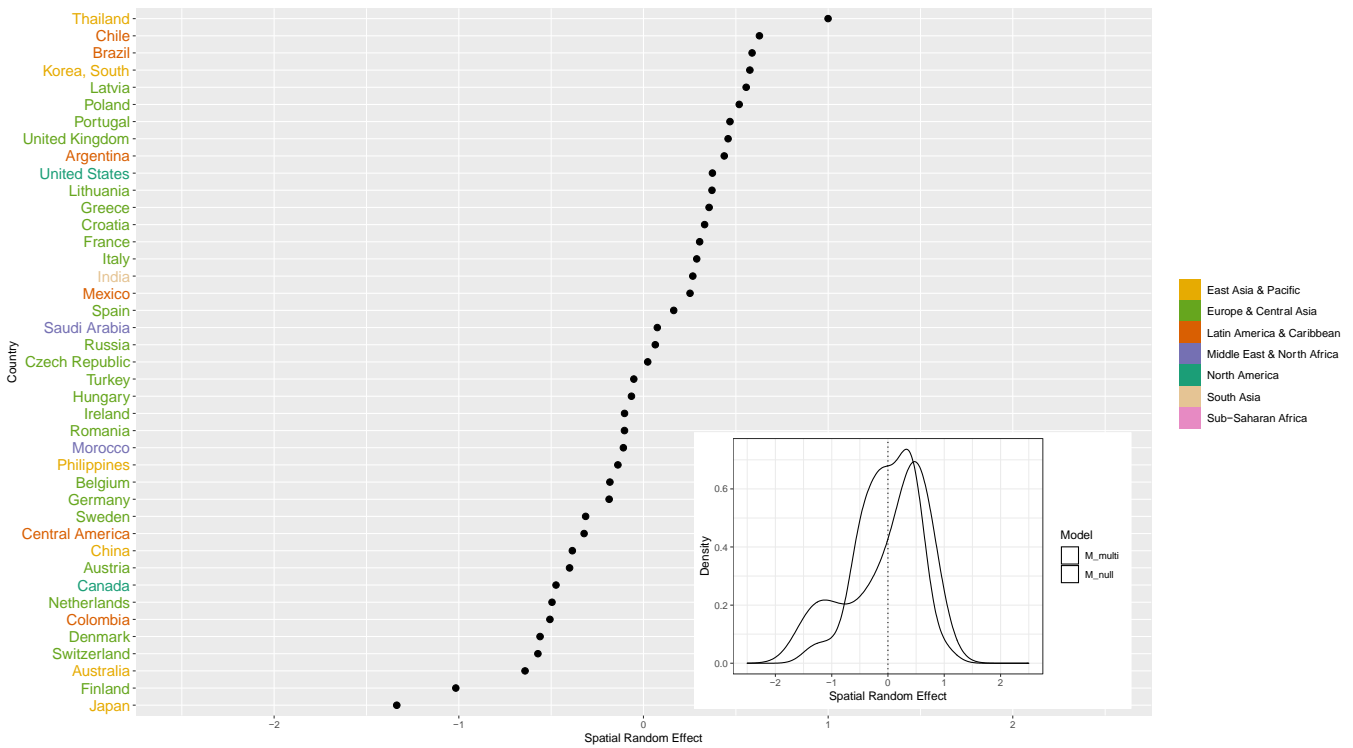

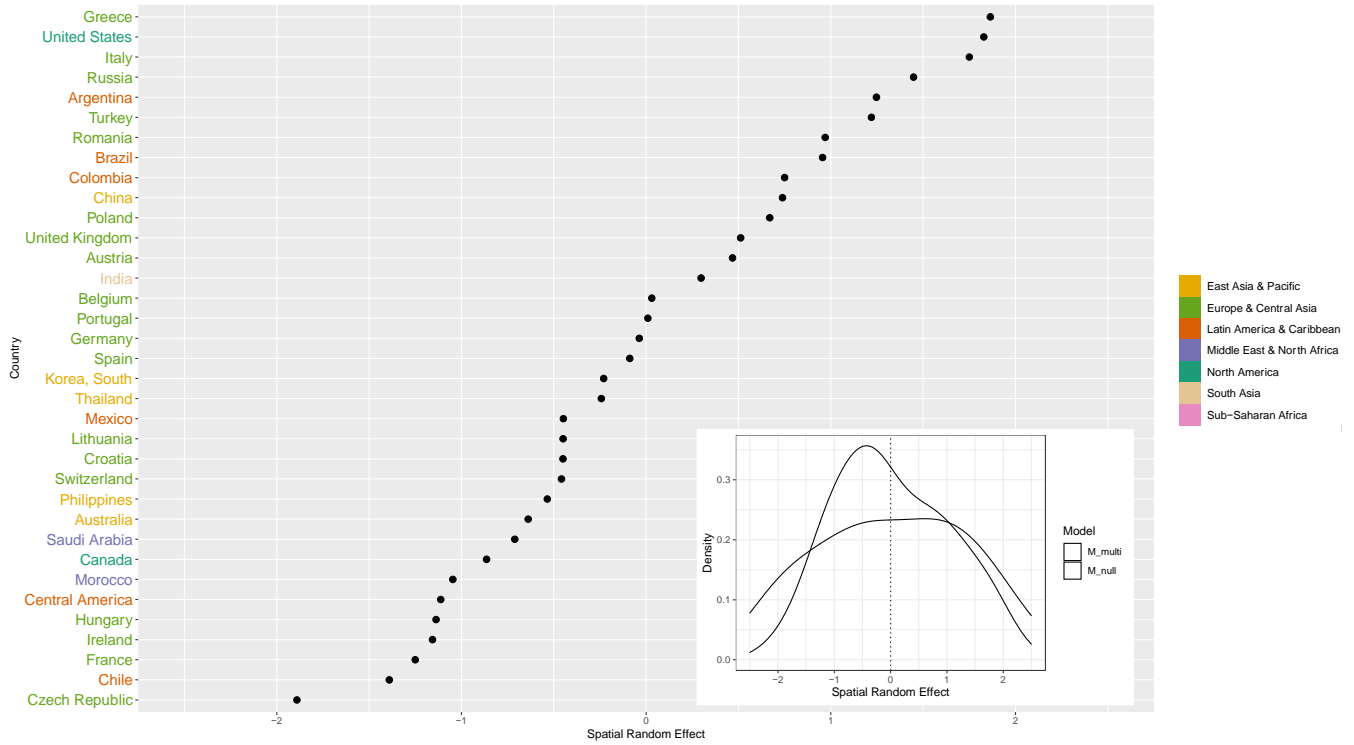

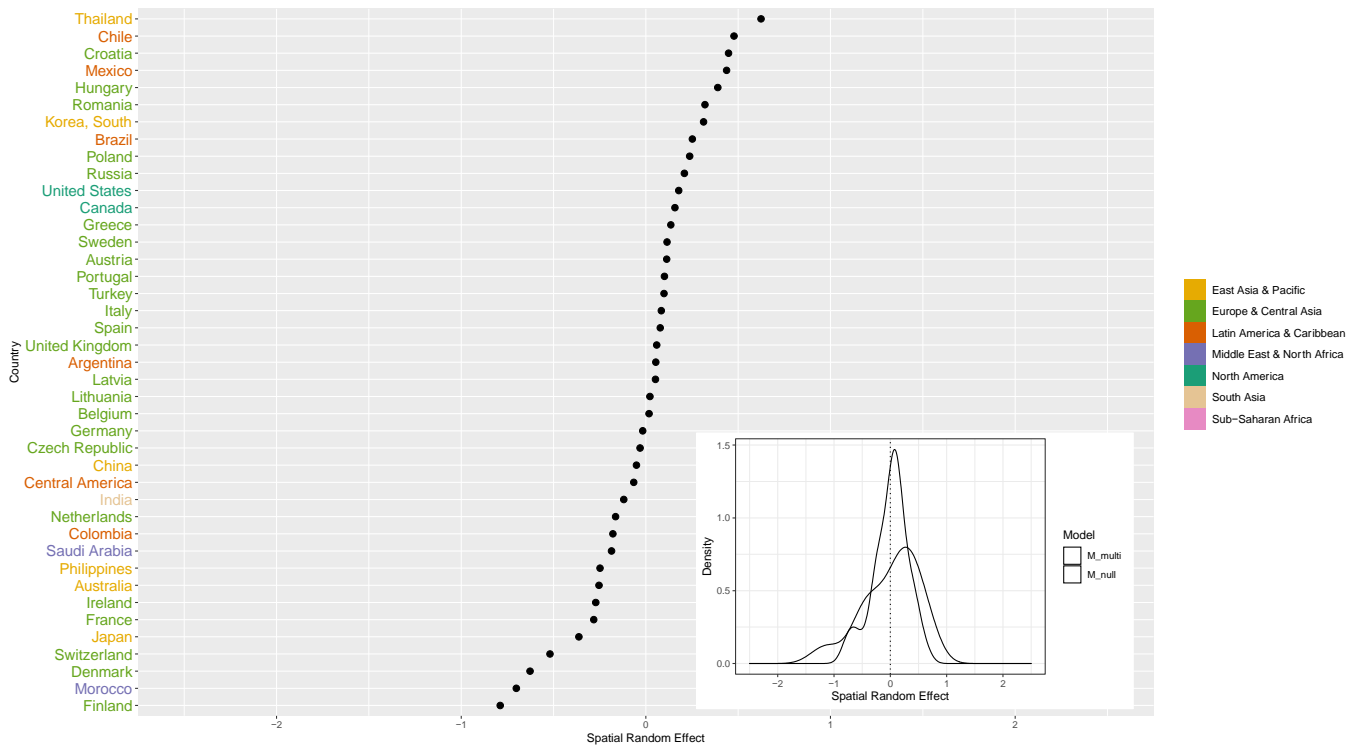

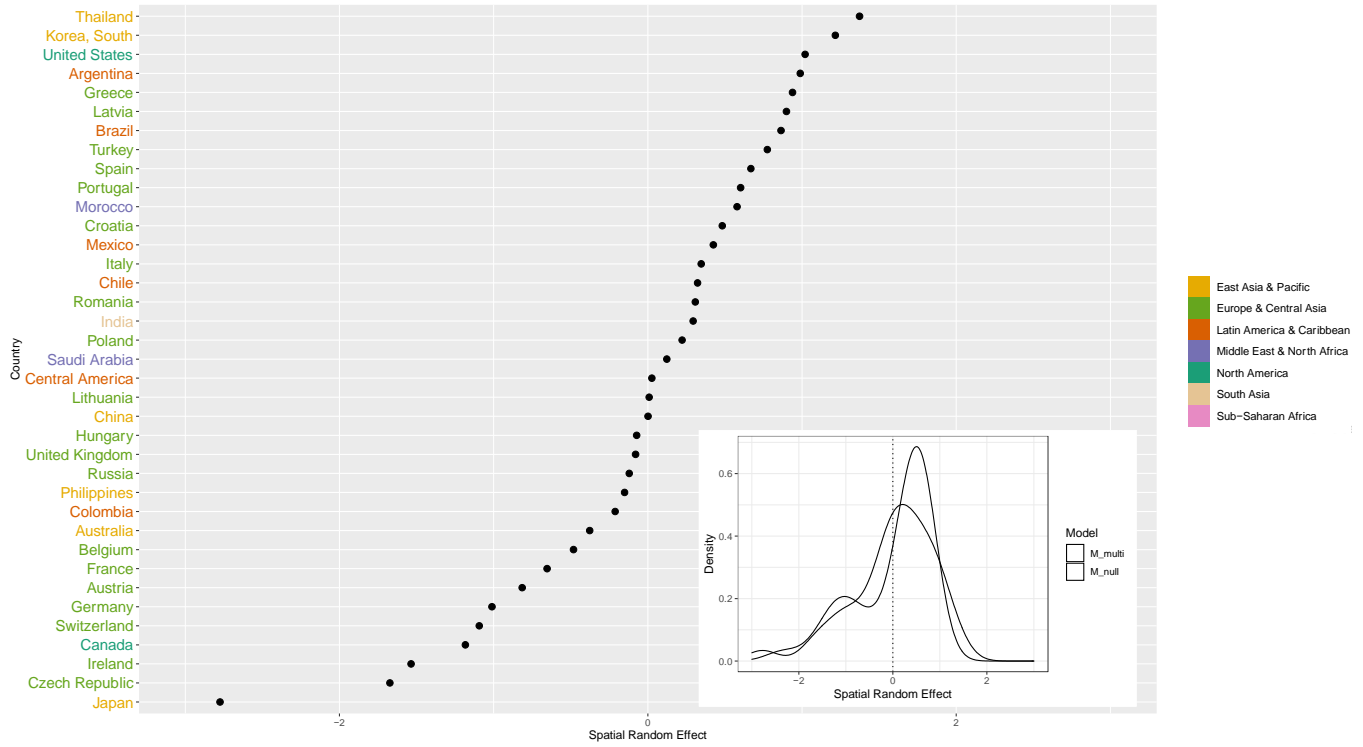

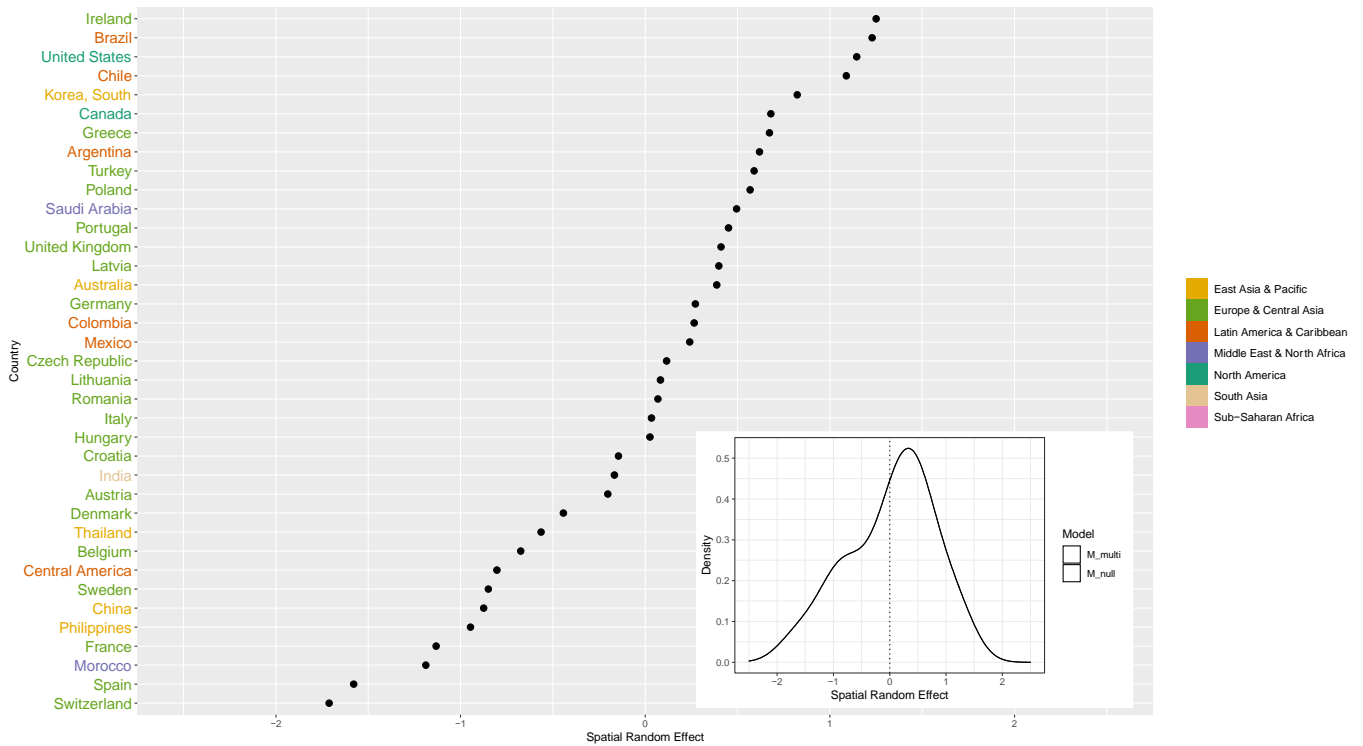

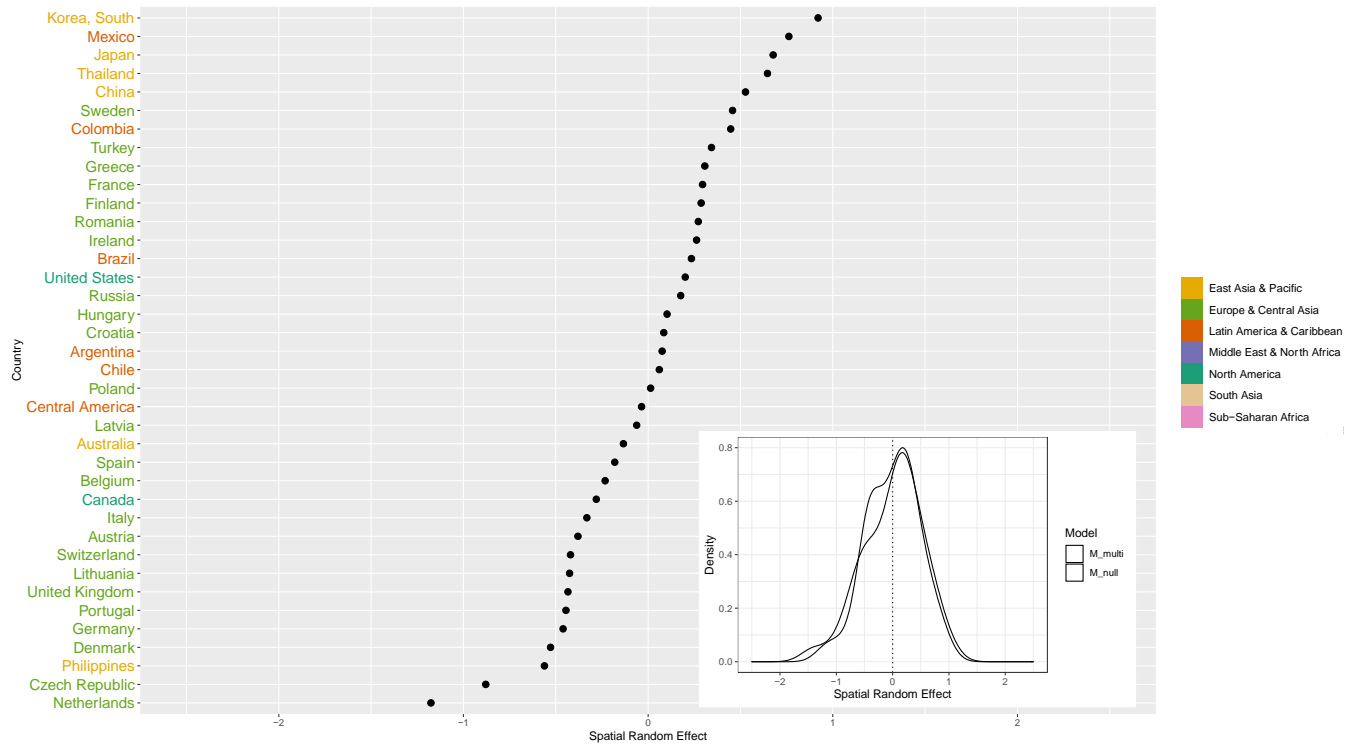
