



A. Linear models adjusted for infant sex, birthweight, gestational age at birth and maternal age. B. Linear models adjusted for infant sex, birthweight, gestational age at birth and maternal age and cell-type gene expression proxies. The x-axis is the \log_2 fold change (FC) and y-axis is the $-\log_{10}$ P-value, the highlighted in blue are genes with $p < 0.05$. The horizontal dashed line corresponds to $p=0.05$.
