#### S2: Sensitivity to smoothing of the contact parameter, c

Our study tracks the infectious contact ratio, c per week, to investigate the change in human behaviour. Specifically, we estimated the log proportional change in the contact ratio from the previous week,  $\phi$  (Eq. 10 & 11) with a prior  $\sim \mathcal{N}(0, \epsilon)$ , where  $\epsilon$  is a hyperparameter controlling the extent of smoothing: i.e., the lower the  $\epsilon$  hyper-parameter, the larger the influence of c from the previous week.

To examine the effect of smoothing on the estimation of infectious contact ratio c, we conducted a series of sensitivity analyses. First, we simulated data assuming three scenarios in which the contact ratio remains at 1.0 for two weeks following an introduction of SARS-CoV-2, and the ratio drops, on the third week, by 25, 50 and 75% respectively (green lines in Fig. S2). We then fitted the model (as described in Section 2.1.6 to the simulated data to assess whether the posterior distributions of c tracks the "true" change in the contact ratio, c. We found that 95% highest posterior density (HPD) overlaps with the "true" contact ratio at 25% and 50% reduction in weekly contact (Fig. S1). When the contact ratio declines by 75%, the estimated contact ratio was overestimated for one week following an abrupt change (Week 3 at 0.75 in Fig. S1). We conclude that our approach to smooth the weekly contact ratio is unlikely to substantially bias interpretation as changes in human mobility per week are typically within 25% and unlikely to exceed 75% (Fig. S2).




Figure S1: Smoothing of the contact parameter, c based on Eq.10 & 11 (main text) is unlikely to bias inference of the 95% predictive intervals, so far as the weekly change in contact remains below 75%. We simulated data assuming three scenarios in which the contact ratio remains at 1.0 for two weeks following an introduction of SARS-CoV-2 and the ratio drops by 25, 50 and 75% respectively. The top panels show the "true" contact ratio (green line) and the estimated contact ratios (box and whiskers) over two weeks before and after the change in the contact ratio (i.e., between Week 2 and 3). With each box, the thick horizontal line, box edges and whiskers correspond to the median, 50% and 95% density of posterior distributions, respectively. The bottom panels show the simulated data (black crosses), and the coloured bands correspond to 95% predictive intervals of the model fit, incorporating uncertainty in parameter estimation and sampling.




Figure S2: Google Mobility data indicate the weekly changes in contact are within 25% of the previous week in the majority of weeks. Shown are four categories of contact mostly likely related positively to SARS-CoV-2 transmission. The x-axis refers to the week since the first public health intervention was introduced on 2020-03-12 (Table 1 & 2).

### S3: Assessment of model fit: standardised residuals

To provide a rigorous assessment of the model fit, we examined the standardised residuals of the fitted model. By integrating over the posterior density of each parameter,  $\Phi$ , the marginal standardised residual of each data point i was defined as:

$$r_{x,i} = \frac{1}{\sigma_x} \int_{\Phi} (x_{data,i} - x_{model,i}(\Phi)) d\Phi$$

where  $\sigma_x$  is standard deviation of x, which is either the number of hospital admission or logit-transformed frequency of the Alpha strain.




Figure S3: Standardised model residuals of models. Poor fits are indicated by the mean residuals deviating from confidence intervals (blue dotted lines indicated the Bonferroni-corrected 95% intervals).

# S4: Assessment of posterior accuracy, precision and prior contraction

We leveraged the properties of posterior distributions to identify potential model fitting problems that might manifest from our model assumptions. To examine the accuracy and precision of posterior distributions, we first generated simulated observations based on the estimated posterior mean parameters. We then refitted our model to the simulated observations (i.e., secondary fitting) to compute the posterior z-score for each parameter, which measures how closely the posterior recovers the parameters of the data generating process. [33]:

$$z = \frac{\mathbb{E}_{\text{sim}} - \mathbb{E}_{\text{post}}}{\sigma_{\text{sim}}},$$

where  $\mathbb{E}_{post}$  denotes the posterior mean of the fit to the actual data that we consider the 'true' parameter.  $\mathbb{E}_{sim}$  and  $\sigma_{sim}$  denote the mean and standard deviation of the posterior distribution of the secondary fitting. The smaller the z-score, the closer the bulk of the posterior is to the true parameter [33]. In contrast, large z-values may be indicative of overfitting and, or poor bad prior specifications [33].

To examine the influence of the likelihood function in relation to prior information, we computed the posterior contraction, k:


$$k = 1 - \frac{\sigma_{\text{post}}^2}{\sigma_{\text{prior}}^2}$$

where  $\sigma_{\text{post}}^2$  and  $\sigma_{\text{prior}}^2$  correspond to the variance of posterior and prior distributions, respectively. The k values close to zero indicate that data contain little information (i.e., rendering priors strongly informative). Conversely, values close to 1 indicate that data are much more informative than the prior [33].

We found that the most of our model parameters and hyperparameters — were estimated with accuracy and precision and identifiability, with the absolute posterior z-scores below three (Fig. S4). A small number of log proportional changes in contact,  $\phi$  showed a tendency towards overfitting (the absolute posterior z-scores above three). The larger absolute posterior z-scores all coincided with periods of relative stasis in the contract ratio and included the weeks indexed 34 in NI and 6, 8, 9 and 49 for ROI (Fig. 3, main text). Thus, caution might be warranted when interpreting the contact ratio for these weeks — nonetheless, a small number of z-scores exceeding the absolute number of three is unlikely to be a cause of concern [33]. We found that the posterior distributions for  $\phi$  contracted by over 50% compared to the prior distribution, i.e.,  $\sim \mathcal{N}(0,\epsilon)$ , for most weeks, meaning that the weekly changes in contact were moderately informed by the smoothing hyperprior  $\epsilon$ , which was itself well-identified from data (Fig. S4). The  $\phi$  parameters were poorly identified for the last two weeks of the studied period (weeks indexed 50 and 51 in both

justifications) as hospital admission data in the subsequent weeks required to inform these parameters were not included in model fitting.




Figure S4: Accuracy, precision and identifiability of estimated parameters. Posterior z-score (y-axis) measures how closely the posterior recovers the parameters of the true data generating process and posterior contraction (x-axis) evaluates the influence of the likelihood function over the prior, respectively. Smaller absolute posterior z-scores indicate that the posterior accurately recovers the parameters of the data generating process: the absolute value beyond three to four may indicate substantial bias [33]. The posterior contraction values close to one indicate that data are much more informative than the prior. Other parameters refer to all estimated parameters excluding log-proportional changes (see Table 1 for the list of estimated parameters). The estimated parameter are represented by filled dots, which are labelled if mentioned in text.
