

1 **Cycling for climate and public health: a missed opportunity for France**

25 **ABSTRACT**

26 In addition to its potential contribution to reaching climate targets, cycling may generate substantial
27 population-level health benefits through the physical activity it requires. Due to the lack of nationally
28 representative mobility data, the health impact of current levels of cycling is still unknown for France.
29 Relying on a health impact assessment framework and using recent nationally-representative data on
30 mobility, we assessed the health and related economic benefits of cycling in 2018-2019 in France. We
31 show that such benefits remain moderated and fall short when compared to those estimated in
32 other countries with high cycling levels. We argue that cycling in France did not receive the attention
33 and investments it deserves over the past decade and thus represents a missed opportunity for
34 climate action and public health.

37 **Introduction**

38 A recent report released by the French Agency for Food, Environmental and Occupational Health &
39 Safety estimates that 95% of the French adult population faces a risk of deteriorating health due to
40 lack of physical activity [1]. The agency highlights the importance, among others, of collective
41 mobility choices in contributing to this situation. Among these, cycling may represent a particularly
42 relevant active transportation option in France, as an estimated 60% of commuting trips shorter than
43 5 km are still made by car [2]. Moreover, the transportation sector is responsible for 31% of the
44 national greenhouse gas emissions in France, representing the highest emitting sector [3]. With more
45 than half of these emissions attributable to individual motorized vehicles, encouraging a shift to low-
46 carbon modes such as cycling is an important lever to meet national emission reduction targets.

47 In countries with high cycling levels, it has been assessed that physical activity through cycling
48 generates substantial population-level health benefits [4]. Due to the scarcity of country-level
49 representative mobility data, the contribution of current levels of cycling is still unknown for France.
50 Until recently, the latest nationally-representative mobility survey was conducted in 2008. In early
51 2022, the data was released from the most recent round of this mobility survey, the *Enquête mobilité*
52 *des personnes* (*People's mobility survey*) conducted in 2018-2019 [5]. We used this updated data to
53 assess the health and related economic benefits of cycling in 2018-2019 in metropolitan France.

55 **Methods**

56 Demographic data consisting of age-specific population sizes and mortality rates were retrieved from
57 the National Institute of Statistics and Economic Studies (INSEE), using the central projection scenario
58 with low fertility.[6]

59 Mobility data were extracted from the 2019 *Enquête mobilité des personnes (People's mobility*
60 *survey)*. The 2019 round collected data from 13,825 households in metropolitan France.[5] One
61 member of each household was selected and questioned about their trips across the previous day.
62 The sampling design and sampling weights ensure that the survey data is nationally representative Of
63 travel behaviours for individuals aged 6 years or older, across weekdays and weekends. Distances
64 travelled were calculated based on reported departures and arrival location, and converted into
65 times considering an average speed of 14.9 km.h⁻¹ [7].

66 Based on the approach described by Fishman et al. (2015), we used age-specific weekly cycling
67 minutes, population counts, and mortality rates for 2019, and assumed a linear dose-response
68 function of 10% reduction in all-cause mortality for 100 minutes of cycling per week [8]. Given that
69 the meta-analysis by Kelly et al considered all-cause mortality, any increase in mortality in terms of
70 road accidents and exposure to air pollution is already accounted for in the dose-response estimate.
71 Risk reduction estimates were scaled at the yearly level assuming a linear dose-response function.
72 The age range considered for a reduction of mortality attributable to physical activity increase was
73 20-89 years. Younger and older ages were disregarded because the evidence for the health effects of
74 physical activity in those age categories are small.

75 We estimated the yearly number of premature deaths averted by active transportation for each age.
76 We also calculated the years of life lost (YLL) averted by active transportation, along with the annual
77 monetary benefits of cycling based on the standard value of statistical life year (VSLY). National
78 guidelines for the socioeconomic evaluation of public investments recommended a VSLY of €135,000
79 in 2019 [9]. Lastly, we used age-specific death rates to estimate the increase in life expectancy due to
80 cycling at 2019 levels.

82 **Results**

83 The average weekly minutes of cycling per person in 2019 in France was estimated at 8.7 min.w⁻¹,
84 peaking at 13.4 min.w⁻¹ among the 70-74-year-old group (Table 1). Overall, we estimate that 2019
85 levels of cycling represented nearly 2,900 yearly premature deaths and 38 000 YLL prevented. This
86 translates into a <1-month increase of life expectancy in the general population. We evaluated that
87 the annual monetary benefits of cycling reached €5 billion in France.

101

102 Discussion

103 The French health benefits of cycling appear low when compared to those reported for the
 104 Netherlands back in 2010-2013, where cycling contributed to a half-a-year-longer life expectancy and
 105 annual monetary benefits of cycling reached €18.6 billion, for a population about 4 times smaller
 106 than France [4]. However, it is worth highlighting that even if they appear moderate, the French
 107 levels of cycling already provide substantial monetary benefits which would further increase with an
 108 augmentation in bike practice. Hence, public investments in cycling-promotion policies, such as

109 improved cycling infrastructures and facilities, are likely to yield a high cost-benefit ratio in the
110 medium term.

111 Despite repeated calls to decrease motorized trips for the interest of the climate and to increase
112 active mobility for public health, the level of cycling for France did not evolve substantially between
113 2008 and 2019. The modal share of cycling remained the same (2.7%) across both survey rounds [5].
114 Therefore, we argue that public policies to promote cycling represent a missed opportunity for both
115 climate targets and public health in France over the last decade.

116 Unfortunately, recent announces do not reveal a massive shift in mobility policies. As in many other
117 European countries, the French government has recently cut taxes by 15 cents per liter of gasoline
118 in response to the latest increase in fuel prices [10]. This policy will cost about €2 billion over 4
119 months. In comparison, the 2018 French strategy to promote cycling, one of the most ambitious ever
120 implemented in the country, relied on public investments of only €0.45 billion over 7 years [11].

121 We hope that the health and climate benefits of cycling will soon be recognized and that it will
122 receive the attention and investments it deserves. Recently, due to the Covid-19 impact on public
123 transportation, some local authorities have rapidly incentivized cycling by rolling out pop-up bike
124 lanes. This resulted in a large short-term increase in cycling, including in France [12]. Commitment of
125 national and local authorities is critical to sustaining these changes and the contribution of cycling to
126 public and planetary health.
