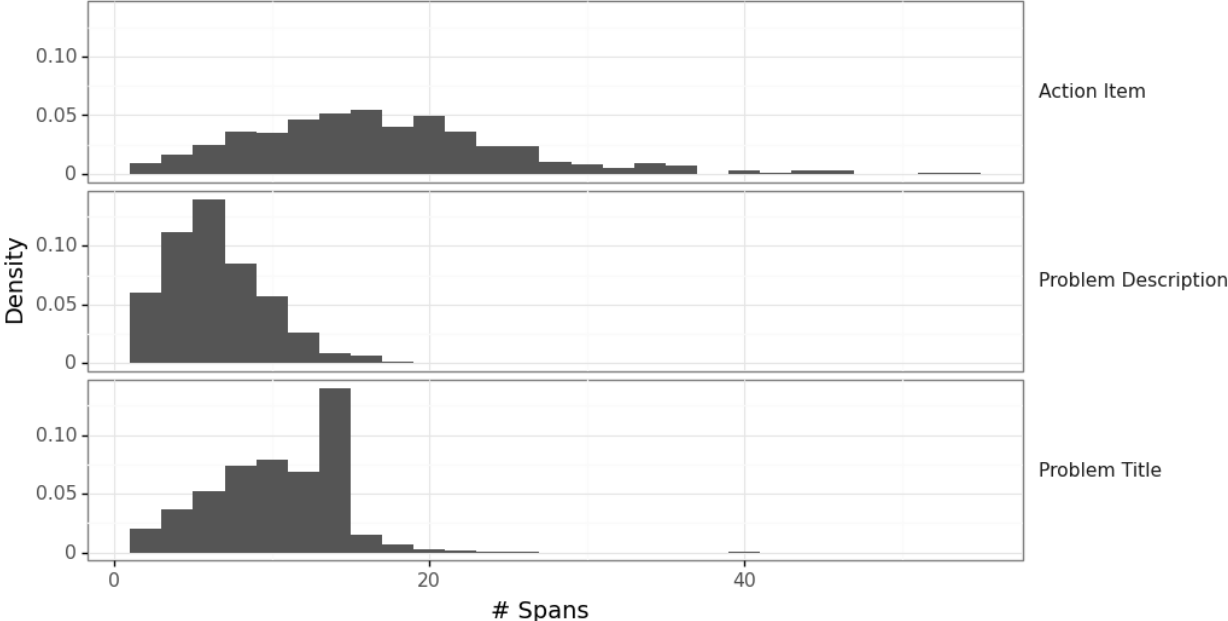

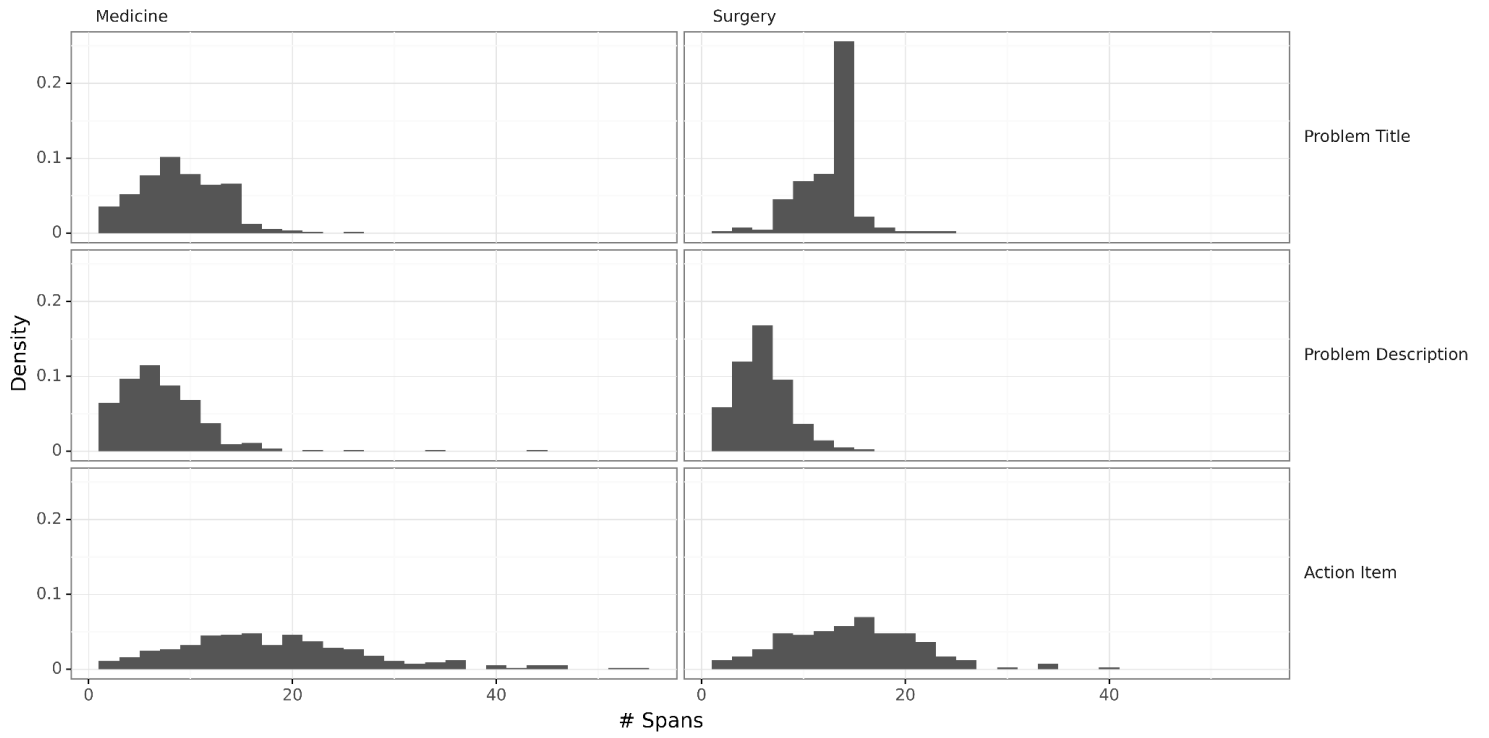

Supplementary Figure 2 - Span Type per Note Distribution



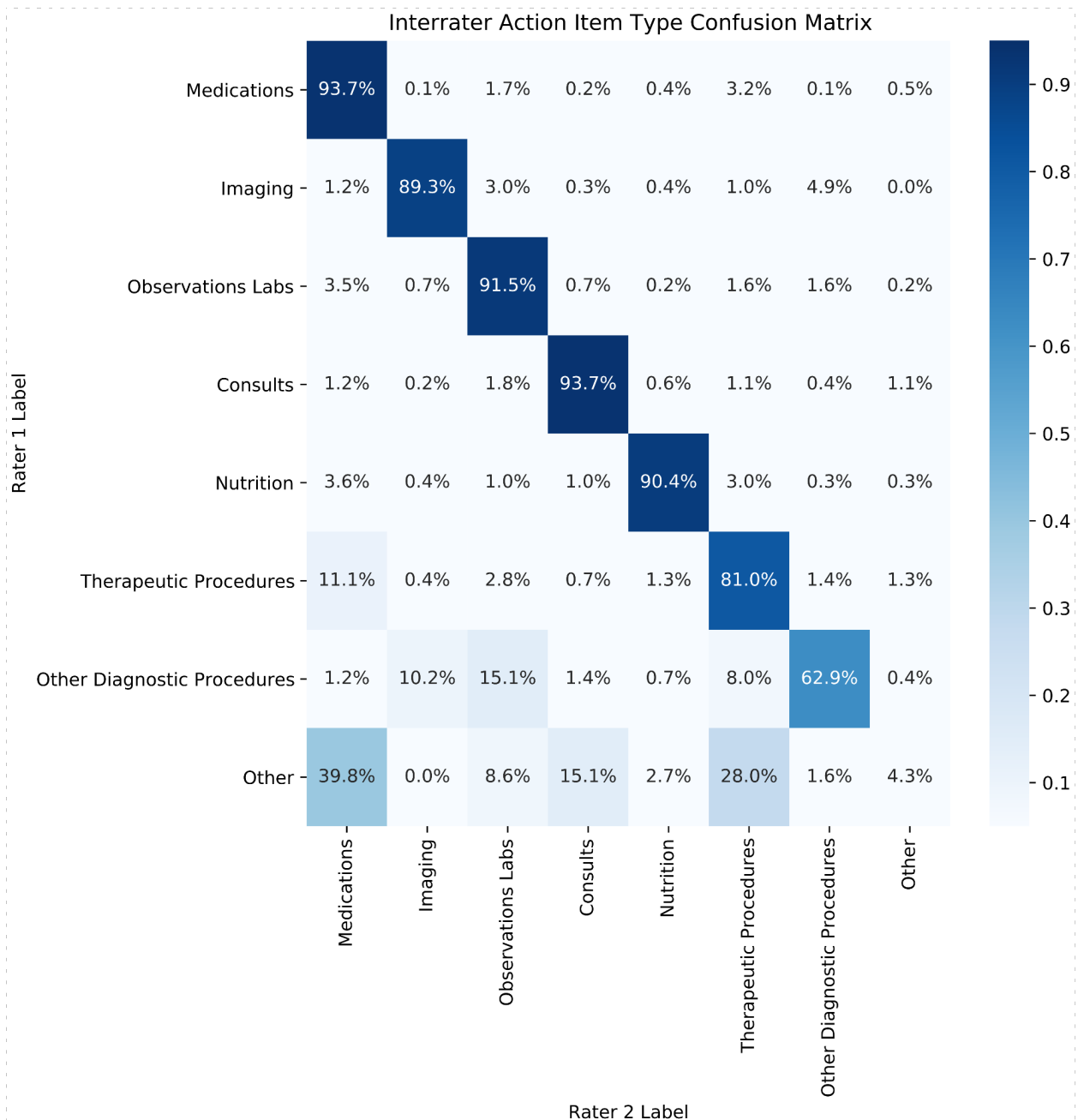
Histogram of the number of spans per note by the span type (row). The histogram is normalized by the number of spans per type. “# Spans” is the number of spans.

Interrater agreement for action item types as a confusion matrix of pairwise agreement. Percentage in each cell is the percent of spans labeled as the type specified by rater 1 (row) that were labeled as the type specified by rater 2 (column). For example, 1.7% of spans rated by rater 1 as Medications (first row) were labeled by rater 2 as Observations / Labs (third column). Raters are arbitrarily numbered. Cells are colored by the percentage as denoted by the colorbar to the right.

Supplementary Text - Labeling Instructions and Quiz

Background

Assessment and plan sections tend to follow a problem oriented structure. In this task we'd like to annotate the problems for assessment and their associated action items and categorize those action items. The task consists of labeling spans of free text.

Task

In this task you'll get a medical note. Your task is to label Assessment and Plan sections with the following types of text spans:

1. Problem titles - They can be a single condition (e.g. pneumonia, COPD ex.), contain multiple conditions (e.g. DKA/AG acidosis), a clinical development (e.g. IHD s/p CABG), a body system (e.g. GI) a clinical concept (e.g. FEN) or other patient care concepts (e.g. Prophylaxis, Access).
2. Problem descriptions - assessment of the problem, states facts about the patient's previous and current condition in the prism of the discussed problem. Does not imply an action should be done.
3. Action items - prescribed plan for the given problem. Includes both explicit and implicit actions. Action items are atomic statements which should be understandable on their own, for example in a bulleted list. For action items the task consists of both span markup as well as categorizing them to 8 categories.

Action item labeling

Action items are to be classified into one of the 8 categories:

Action item categories

Category	Description	Examples
