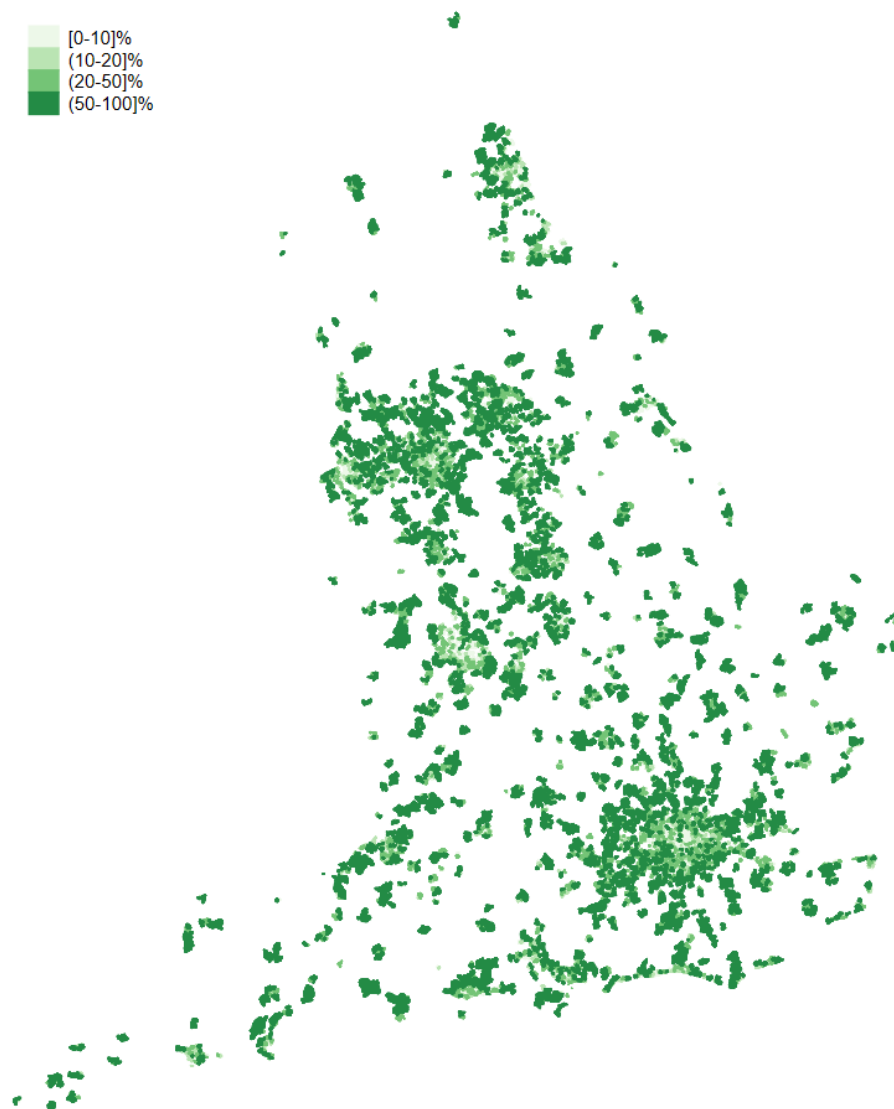

Figure S1 Distribution of urban geographic areas that were included in the analyses (categorised by greenspace exposure)

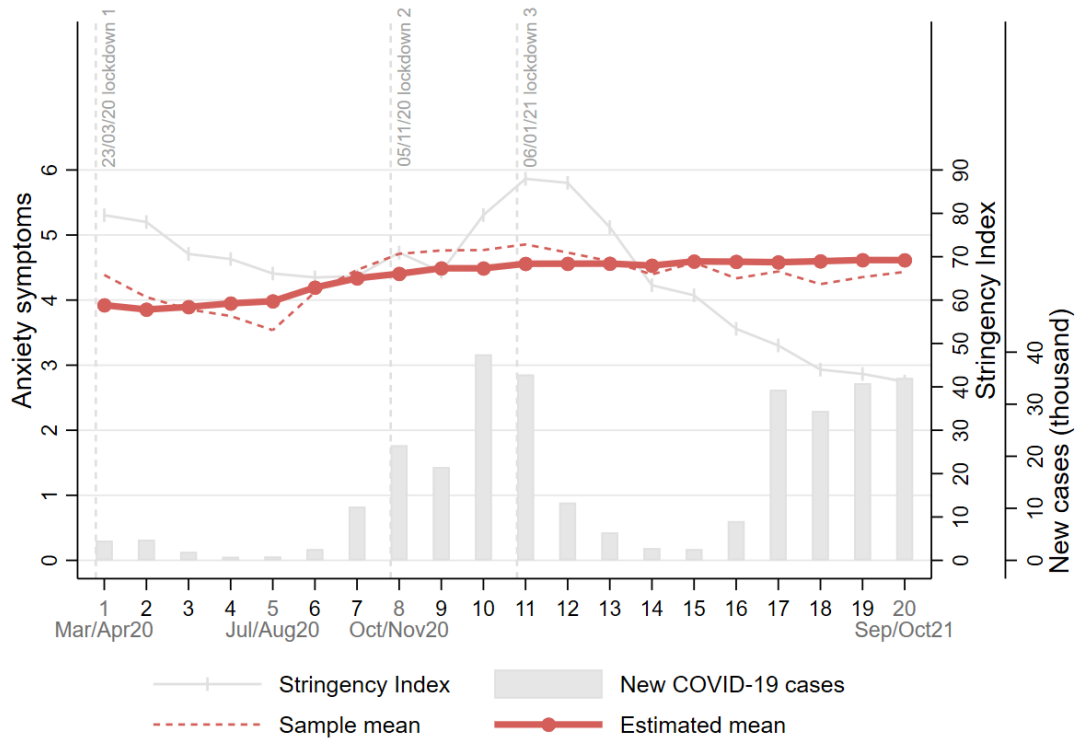


Figure S2 Overall growth trajectories of anxiety symptoms (unconditional model with free time scores)
