### Comparison of College Walk-in Clinic Practice Standards Across Canada

Following initial data collection in British Columbia (BC), policy documents referring to standard of care requirements at walk in clinics Canada were reviewed to determine if there was a consistency in standards of practice and policies governed by each province and territory's College of Physicians and Surgeons or Medical Council.<sup>1-10</sup> We initially searched through each province or territory's College of Physician and Surgeon's or Medical Council's website where we found information from eight provinces and one territory. We then sent an email to the College for each individual province and territory, requesting direction to publicly available information regarding the practice standards for walk-in clinics for primary care within their respective jurisdictions. In our email, we asked each College and Council to identify standards applicable to walk-in clinics that included:

- Clarification to patients about expectations regarding continuity of care.
- Communication with patients regarding abnormal results from investigations ordered by a physician at a walk-in clinic.
- Documentation standards.
- Patient safety and care quality expectations, and;
- The responsibilities for medical administration and/or clinical oversight.

## Results

We received replies from all ten provinces and two of the three territories in Canada. Through personal correspondence with the Charge Physician of Nunavut, it was confirmed that there are no walk-in clinics in this territory and this role is filled by the health centers and the emergency department in Iqaluit. From the policies in place at time of data collection, common practices observed included that the walk-in service providers must: collect a thorough health history and assessment, identify the patient's regular primary care provider, and that they must ensure appropriate follow up and continuity of care.

A detailed comparison of provincial and territorial standards of practice and expectations can be found in Supplementary Table 1.
