### 44 **ABSTRACT (249/250 words)**

45

46 **Objective.** Public health authorities recommend symptom monitoring of healthcare 47 personnel (HCP) after defined exposures to Monkeypox (MPX). We report on the rapid 48 development and implementation of mobile responsive survey solutions for notification 49 of possible exposure, exposure risk assessment and stratification, and symptom 50 monitoring. 51 52 Setting. Academic health center in Boston, Massachusetts, after admission of first 53 diagnosed case of MPX in the United States during the current global outbreak. 54 55 Participants. Research Electronic Data Capture (REDCap) design and programmers, 56 Infection Control, Occupational Health, and Emergency Preparedness specialists, and 57 HCP with possible exposure to MPX. 58

- 59 **Interventions.** Design and deployment of Research Electronic Data Capture (REDCap) 60 tools to identify HCP with possible exposure to MPX, perform exposure risk assessment
- and stratification for post-exposure prophylaxis (PEP), and conduct symptom monitoring
- 62 during the exposure window. Project enhancements included dashboards for HCP
- 63 tracking and SMS text reminders for symptom monitoring.
- 64

65 **Results.** Tools to support the contact tracing and exposure investigation were deployed within 24 hours of identification of a patient with suspected MPX, with the full suite in 66 production within 4 days of confirmation of the diagnosis of MPX. Clinical follow up of 67 68 HCP was integrated into the design, and real-time versioning allowed for adjustments 69 leading to improvements in HCP symptom monitoring compliance and enhanced 70 tracking. 71 72 **Conclusions.** During the current MPX outbreak, timely and comprehensive evaluation 73 of potential HCP exposures is necessary but presents logistical challenges. Rapid

74 development of MPX-specific solutions using REDCap enabled flexibility in design and

75 approach, and integration of targeted clinical support enhanced functionality.

#### 76 **INTRODUCTION**

- As the outbreak of Monkeypox (MPX) outside of endemic areas continues,<sup>1</sup> healthcare
- facilities and public health authorities face the challenge of rapid identification of
- individuals with possible exposures to MPX and subsequent management. While there
- 80 are various definitions of exposure developed by the United Kingdom,<sup>2</sup> Centers for
- 81 Disease Control and Prevention (CDC),<sup>3</sup> and World Health Organization,<sup>4</sup> the
- 82 challenges of efficient notification of possible exposure, performance of a risk
- 83 assessment to allow for risk stratification, and symptom monitoring during the exposure
- 84 window are substantial. Of immediate importance is risk stratification because
- individuals at higher risk may be offered post-exposure prophylaxis (PEP) in the form of
- 86 vaccination, however the optimal window to offer vaccination is within 4 days of
- 87 exposure.<sup>5</sup>
- 88
- 89 We developed and deployed a suite of tools using REDCap (Research Electronic Data
- 90 Capture) as part of our MPX response building on prior use supporting planning and
- 91 preparedness efforts at Massachusetts General Hospital (MGH) and within the Mass
- 92 General Brigham (MGB) system. The REDCap technology was in use prior to the
- 93 current MPX outbreak as part of planned monitoring of HCP caring for patients in our
- 94 facilities' Biocontainment Unit and the Special Pathogens Unit at the Region 1 Emerging
- 95 Special Pathogens Treatment Center. Use of this technology was further developed to
- 96 support MGB during the COVID-19 pandemic, including use for symptom attestation
- 97 prior to on-site work for HCP,<sup>6</sup> symptom monitoring after COVID-19 vaccination,<sup>7-9</sup> and
- 98 creation of survey tools for COVID-19 exposure notification, risk assessment and
- 99 stratification. REDCap is a secure, web-based software platform designed to support
- 100 data capture for research studies.<sup>10,11</sup>
- 101
- 102 We report on the rapid development of MPX-specific solutions and early experience in
- 103 deploying the technology including 1) Notification of Possible Exposure; 2) Exposure
- 104 Risk Assessment and Stratification, and 3) Symptom Check, as well as access to these
- 105 tools for use by others. Each solution was additionally enhanced by clinical support
- teams providing HCP with counseling and guidance.

#### 107 **METHODS**

108 Three tools were developed: 1) Notification of Possible Exposure; 2) Exposure Risk

- Assessment and Stratification, and 3) Symptom Check. The flow of data into and
- 110 between these tools is depicted (**Figure 1**).
- 111

#### 112 Determination of the At-Risk Population

- 113 HCP were initially identified as possibly exposed through pre-established standard
- 114 processes used for contact tracing and exposure investigations at our institution,
- 115 utilizing a trace within the electronic health record (EHR), and supplemented with
- 116 interviews with managers conducted by Infection Preventionists (IPs) and Occupational
- 117 Health Services (OHS) clinicians. The dataset included first and last exposure dates
- and was imported into a REDCap project and combined with additional HCP data using
- a custom MGB REDCap external module developed previously to support OHS
- 120 operations. Additional HCP data included contact information such as email address
- 121 and phone numbers.
- 122

#### 123 REDCap Build

- 124 The tools were developed using all native REDCap v12.0.19 functionality except for two
- 125 MGB custom External Modules: Employee Data Sync and Custom Survey Login.
- 126 External Modules are individual software packages that are created and installed by a
- 127 REDCap developer/administrator. REDCap provided technical support for the core
- 128 project needs; however, due to the need for rapid assessment to deploy PEP, and
- 129 complexity of exposure assessment, the establishment of a team of clinicians to support
- 130 HCP use of all three tools was determined to be necessary and a Call Center was
- established. The Call Center staff were identified and trained via a Labor Pool that was
- established as part of MGH's Hospital Incident Command System which was mobilized
- to support this response. External Modules extended current functionality of REDCap
- and, for this project, enhanced data workflow, and allowed Call Center staff to login and
- initiate a record on behalf of the HCP.

- 137 The REDCap build consisted of multiple surveys, email and SMS notifications, and an
- advanced approach combining custom logic utilizing @CALCTEXT action-tag with
- 139 nested IF-statements for providing dynamic feedback to inform HCP of the results of
- 140 their Exposure Risk Assessment and Stratification and Symptom Check. For Symptom
- 141 Check compliance, the Call Center utilized an MS Excel file that was programmatically
- 142 updated daily with HCP data exported from REDCap via an Application Programmable
- 143 Interface (API).
- 144
- 145 This project was conducted as part of Infection Control and Occupational Health
- 146 Services and not subject to human subjects review.

#### 150 **RESULTS**

- 151 Three integrated modules were developed within REDCap. Detailed specifications of
- 152 the tools, including an implementation guide is provided (Supplement), including
- 153 instructions on accessing the project at REDCap and github.
- 154

#### 155 Notification of Possible Exposure Tool

- 156 In order to both identify HCP who could have been exposed to the index patient, and to
- 157 exclude HCP with no possible exposure, all HCP on the comprehensive trace list
- 158 received the Notification of Possible Exposure Survey tool.
- 159
- 160 The trace list included first and last exposure dates and was exported from the EHR to
- an MS Excel file and then imported into REDCap using the Data Import tool. These data
- were combined with additional HCP data, email address and phone numbers, using the
- 163 custom MGB REDCap external module: Employee Data Sync. Once an email address
- 164 was available, REDCap automatically sent an email to the HCP with information about
- the type of exposure, dates, and locations and allowed the HCP to attest to preliminary
- 166 exposure question (yes/no). If the HCP indicated "Yes" to the preliminary question, they
- 167 were enrolled into a symptom monitoring tool: Symptom Check. This enrollment
- 168 occurred prior to exposure risk assessment and stratification. Within approximately 24
- 169 hours of preliminary diagnosis of the patient with MPX, the Notification of Possible
- 170 Exposure surveys were created and emailed to the first set of identified HCP and HCP
- 171 began to respond immediately.
- 172

#### 173 Exposure Risk Assessment and Stratification Tool

- 174 Once HCP had been identified as meeting a preliminary definition of MPX exposure
- 175 based on response to the Notification of Possible Exposure, the next step was risk
- assessment and classification. Applying a framework based on the CDC<sup>3</sup> and
- 177 developed in collaboration with the Massachusetts Department of Public Health, the risk
- stratification was finalized on May 20, 2022, and integrated into the REDCap design
- over the next day and a half to complete the build on May 22, 2022. HCP were
- 180 presented with a series of exposure scenarios and asked to identify which one(s)
- applied to their interactions with the index patient. Based on their responses, each HCP
- 182 was categorized as High, Intermediate, or Low/Uncertain Risk. Individuals who
- answered "No" to all were recategorized as No Risk and were removed from the
- investigation and from Symptom Check. Individuals who reported being unsure were
- 185 contacted by the Call Center staff to review their case and determine their risk
- 186 classification.
- 187
- 188 The survey displayed each category's questions as a progression. Starting with the
- 189 High Risk category questions, if HCP indicated yes/unsure, they did not proceed to the
- 190 next category and questions did not display for Intermediate or Low/Uncertain Risk. If
- 191 HCP indicated no for the High Risk category, they proceeded to Intermediate and so on.
- 192 Multiple hidden fields on the survey were used to calculate the risk category and
- 193 number of days from last exposure (I.e., the exposure window). These derived
- variables were used to display specific text to the HCP utilizing @CALCTEXT action-tag
- 195 with nested IF-statements (I.e., if PEP was recommended or not).

#### 196

#### 197 Symptom Check Tool

198 Individuals identified in High, Intermediate, and Low/Uncertain Risk classifications

- required symptom monitoring for 21 days from their last exposure per public health
- 200 guidance. While HCP at our healthcare facility were required to attest to be
- asymptomatic with respect to COVID-19 symptoms prior to on-site work,<sup>6</sup> the symptoms
- 202 from MPX included those not part of our standard COVID-19 symptom screening, and
- 203 the immediate actions based on a positive symptom screen differed.
- 204
- 205 The Symptom Check survey included information about symptom monitoring for
- 206 Monkeypox, the HCP symptom monitoring start and end date, and asked "Since your
- 207 last survey, have you had the following symptoms". Symptom questions included fever,
- 208 chills, new lymphadenopathy and new skin rash. If the HCP answered yes to any
- symptom, the survey would display instructions to self-isolate and contact OHS
- 210 immediately. This information was also automatically emailed to HCP. Reports were
- 211 available in REDCap to OHS and the Call Center staff to immediately identify any HCP
- reporting symptoms. Symptom Check compliance was encouraged by multiple
- 213 methods: email, calls and text messaging.
- 214
- 215 Compliance with symptom monitoring was assessed: 67.0% of HCP were compliant
- with their Symptom Check 100% of surveyed days. Among the remaining HCP,
- 217 Symptom Check was missed, on average, for 4.1 days during the exposure window to
- 218 date; these HCP received follow up calls from Call Center and OHS staff. Employees
- 219 Symptom Check start dates varied and many last exposure dates were before the 21
- 220 day window (i.e., before implementation of the survey). Therefore, not all employees
- were required to complete the full 21 days and some employees with re-exposures were
- required to complete more than 21 days (i.e., those who continued to provide care to
- the patient and were in the Low/Uncertain category).
- 224
- 225 Integrating Clinical Follow Up Into Design
- 226 REDCap provided technical support for the core project needs, however, due to the
- need for rapid assessment to deploy PEP, and complexity of exposure assessment,
- establishment of a Call Center was needed. This workflow addressed HCP with limited
- technical proficiency, language barriers, or both, as well as focused review of HCP
- reporting High or Intermediate Risk exposures who may be offered PEP.
- 231
- 232 Timeline of Implementation and Versioning in Real-Time
- 233 The initial identification of a possible case of MPX occurred on May 17, 2022, with
- confirmation by the CDC on May 18, 2022. The first Notification of Possible Exposure
- was sent at 8:21pm on May 18, 2022, and initial Symptom Checks began at 5:54pm on
- 236 May 19, 2022. Upon confirmation of risk exposure categorization and stratification with
- 237 Massachusetts Department of Public Health on May 20, 2022, the first Exposure Risk
- Assessments and Risk Stratifications were deployed via phone call on May 22, 2022.

- 241 Versioning of assessments were included as part of the strategy to maintain data
- 242 integrity and reporting consistency. The Symptom Check was reduced from twice daily
- to once daily during the study period and additional functionality was added to support
- HCP including SMS (text message) reminders and by expanding the call center's scope.
- Adding in the SMS option for daily reminders resulted in an increase in compliance.
- HCP who enrolled in SMS messaging had an average daily compliance rate of 94.9%,
- while those only receiving email reminders had a compliance rate of 88.4%.
- 248
- 249 Support for HCP with limited technical proficiency or language barriers
- 250 For each tool, managers assisted in identifying a subset of HCP who, for either
- technical or language barriers, or both, required one-on-one assistance with the tools.
- 252 Call Center clinicians contacted HCP by phone to provide information about the MPX
- 253 Exposure Risk Assessment and completed the HCP assessment.
- 254
- 255 Support for HCP with Reported High and Intermediate Risk Exposures
- HCP reporting High and Intermediate Risk exposures received a prompt upon survey
- completion indicating that they would receive a follow up by Call Center clinicians to
- assist in exposure verification and categorization, and to provide PEP counseling, whenindicated.
- 260

#### 261 Integrated Dashboard for Tracking

- For Symptom Check compliance, the Call Center utilized an MS Excel file that was programmatically updated daily with HCP data exported from REDCap via an
- programmatically updated daily with HCP data exported from REDCap via an
  Application Programmable Interface (API). Survey data collected in REDCap was
- loaded into an MS Excel file via a Power Query accessing the REDCap API. A
- transformation of the data was preprogrammed that would produce a final dataset of
- 267 non-compliant HCP and their associated contact information. Call Center staff were
- trained on how to easily perform the extract, which required no knowledge of coding,
- advanced excel knowledge, or authentication into REDCap. Call Center staff were
- trained on how to document if a phone call was made and any notes that may assist in
- 271 future efforts.
- 272
- Additionally, many reports were created within REDCap that allowed stakeholders and
- technical staff the ability to monitor the actual symptom data that was being generated.
- 275 Most notably a report was created that would return any HCP who had reported being
- 276 symptomatic at their latest assessment.

#### 277 DISCUSSION

278 Timely and comprehensive evaluation of exposures, including risk assessment, and

279 ongoing symptom monitoring is necessary and can present logistical challenges,

280 especially in the setting of an emerging outbreak with evolving definitions of exposures

and urgency to offer and deploy PEP for a subset of exposed individuals. We report on 281

282 rapid development of MPX-specific solutions using REDCap and early experience in deployment.

283 284

285 Utilizing REDCap as the base technology enabled flexibility in design and approach.

286 and integration of targeted clinical support enhanced the functionality of the tools 287 developed. The technology used by the clinical team supporting HCP had to be intuitive,

288 accessible in real time by multiple remote staff, provide search abilities for HCP records,

289 and a data entry interface. Using another previously developed custom MGB REDCap

290 external module, assigned team members were able to access a user-friendly interface

291 to search for HCP records within the REDCap project. Proactive identification of HCP

292 who may benefit from clinical support, either based on technical proficiency (including

293 both access to email and comfort with survey completion) or language barriers, or for

294 whom counseling for PEP is indicated, was a critical component of the approach. As the 295 tools continue to be deployed, workflows including clinical support can continue to be

- 296 optimized for efficiency.
- 297

298 The MGH Monkeypox REDCap Toolkit and any custom external modules code are 299 available to other organizations to use (Supplement). Customization may be indicated if 300 an organization or entity is adapting local public health definitions of exposure or follow 301 up based on responses. The overall strategy of the solution design and development 302 was collaborative, with different developers creating components of the solution

303 simultaneously by focusing on specific areas: survey question formats, automated

- 304 notifications, authorized access and reporting.
- 305

306 In summary, there was an immediate need to operationalize exposure notification, risk 307 assessment and stratification, and symptom monitoring technology within days of 308 identification of a case of MPX. This was possible due to the modularized nature of

309 REDCap, the concise communications from the teams involved including OHS and

- 310 Infection Control on their system needs, and the experience of the development team in
- 311
- creating similar tools prior to and during the COVID-19 pandemic to support operations 312

and research efforts. We anticipate that sharing this approach and the tools employed 313 may assist others in similar circumstances, and lead to advancements and

314 improvements. There is also broad applicability of these tools outside of healthcare

315 settings, where many of the same needs have been identified in the response to

316 community spread of MPX.





**Figure 1. Data Architecture of MGH Monkeypox REDCap Toolkit.** Contact trace data from the Electronic Health Record (EHR) was extracted from MS Excel and imported into REDCap. HCP received the Notification of Possible Exposure Survey, and if they attested "yes" they proceeded to Symptom Check and Exposure Risk Assessment and Stratification surveys. Call Center staff utilized the Integrated Dashboard to track compliance and establish follow up for symptoms, as well as risk level confirmation, and counseling for post-exposure prophylaxis, if indicated. The REDCap External Modules (Employee Data Sync and Custom Survey Login) were used to enhance the project functionality.



**Figure 2. Timeline of Implementation for MGH Monkeypox REDCap Toolkit** Within hours of identification of a suspect MPX case at Massachusetts General Hospital, a request for REDCap build was submitted. The Notification of Possible Exposure tool was deployed within 24 hours of preliminary diagnosis of MPX, and the Symptom Check Tool shortly thereafter, with first responses received within 24 hours of confirmation of MPX diagnosis. The Exposure Risk Assessment and Stratification Tool was deployed on May 22, 2022 followed by SMS Symptom Check reminders on May 24 and automated compliance reporting on May 26, 2022.




