

1 **Canadian newspapers support mifepristone medical abortion**  
2 **to improve fulfillment of the right to health (2015-2019)**

1           **Abstract**

2  
3           In 2015, mifepristone, the international gold standard for medical abortion, was approved for  
4 use in Canada. Our content analysis of Canadian newspaper coverage describes arguments in  
5 favor or against medical abortion and the evolving regulatory framework for mifepristone from  
6 six months before approval until the last province included the medication as a publicly insured  
7 health benefit (2015-2019).

8           Our study found an exceptionally high level of support for the approval, introduction and  
9 removal of regulatory barriers to mifepristone for medical abortion. Of 402 articles, 67% were  
10 pro-medical abortion, 25% presented balanced or neutral coverage and only 8% presented solely  
11 anti-medical abortion viewpoints. Of the 761 stakeholders cited, more than 90% made positive or  
12 neutral statements about medical abortion. Most articles discussed medical abortion as a health  
13 issue and contained arguments about how liberalization of the regulatory framework and public  
14 payment for mifepristone would improve abortion availability (68%), accessibility (87%),  
15 acceptability (34%) and quality (19%). Mifepristone's introduction in Canada was presented in  
16 newspapers as a way to increase women's health, specifically in rural areas where disparities in  
17 abortion access exist.

18           Rather than formal balance, which presents contrasting arguments as equally valid even  
19 when the scientific evidence for one vastly outweighs the other, our study identified evidentiary  
20 balance where coverage aligned with the majority of evidence and expert opinion. Our results  
21 differ from analyses in other high-income countries (United Kingdom, United States) that have  
22 found that media frame abortion as a stigmatized and controversial issue or mention abortion  
23 predominantly with respect to electoral politics rather than as a health issue. The Canadian print  
24 media presented overwhelmingly favorable arguments towards the expansion of mifepristone  
25 medical abortion and served to destigmatize abortion by framing the introduction and universal  
26 coverage of medical abortion as fulfilling core components of the right to health.

## 1 Introduction

2 In 2015 Health Canada, the federal regulator, approved mifepristone for medical abortion  
3 in Canada. Mifepristone, also known by the name RU-486, is the gold standard medication for  
4 medical abortion<sup>1</sup> according to the World Health Organization (WHO)<sup>2,3</sup>. It was unavailable in  
5 Canada until January 2017, when it reached the market as Mifegymiso<sup>®4</sup>, a combination pack of  
6 mifepristone and misoprostol.<sup>5</sup> The introduction of mifepristone is arguably the biggest national  
7 policy change to affect the delivery of abortion services in Canada since 1988 when the Supreme  
8 Court of Canada found that the criminalization of induced abortion was unconstitutional and  
9 abortion was struck from the criminal code, subsequently to be treated like any other medical  
10 procedure.<sup>6,7</sup>

11 Canada is a provincially decentralized federation where the federal government is  
12 responsible for regulation of medical devices and pharmaceuticals, but provinces are responsible  
13 for the regulation, coverage and delivery of public healthcare services in alignment with  
14 minimum universal standards. The federal statute, the Canada Health Act,<sup>8</sup> sets out the inter-  
15 relationships and responsibilities. For decades, abortion has been a legal<sup>9</sup> and common<sup>10</sup>  
16 healthcare procedure in Canada, with nearly one in three women having an abortion during their  
17 lifetime.<sup>11</sup> Nevertheless, rural-urban disparities in abortion access have been documented in  
18 Canada.<sup>12,13</sup> In 2016, the United Nations Committee on the Elimination of Discrimination  
19 Against Women expressed concern about disparities in access to abortion and called upon  
20 Canada to “ensure access to legal abortion services in all provinces and territories”.<sup>14</sup>

21 As a highly effective form of medical abortion that requires less provider specialty  
22 training and infrastructure,<sup>3,15</sup> mifepristone has the potential to address the rural-urban disparity  
23 in abortion access in Canada.<sup>16</sup> However, initial approval in July 2015 was accompanied by  
24 significant regulatory barriers to access such as physician-only dispensing and direct observed  
25 dosing of the medication.<sup>17</sup> Experience in other countries, including France and the United States  
26 of America (USA), indicates that over and above the approval of mifepristone for use in medical  
27 abortion, the regulatory framework for its distribution influences the rapidity and extension of  
28 use after introduction.<sup>18</sup>

29 The period between the federal regulatory approval and last provincial approval for  
30 universally subsidy of mifepristone represents a unique historical moment. We chose to examine  
31 this moment to understand how the issue of mifepristone specifically and medical abortion in

1 general was represented by the news media. This period encompasses six months leading up to  
2 the approval of mifepristone for use in Canada in July 2015, the subsequent modifications of the  
3 regulatory framework (including the removal of most barriers to prescribing and dispensing by  
4 November 2017)<sup>19,20, 21</sup> as well as the decisions by provincial health plans to include  
5 mifepristone as a covered health benefit with the last province doing so in 2019.

6 The press is a medium for politicians and interest groups to express their views. This  
7 contributes to setting the policy agenda by influencing public attention and understanding of  
8 issues. These expressions in the press also influence perceptions of priority, potential policy  
9 responses and, at times, actions of policymakers.<sup>22-24</sup> We were interested in how the introduction  
10 and regulation of mifepristone for medical abortion was reported by Canadian print media, with a  
11 specific focus on arguments made for and against regulations and coverage by provincial health  
12 plans as they related to the four components of the right to health: availability, accessibility,  
13 acceptability and quality.<sup>25-27</sup>

## 14 15 16 **Methods**

17 We performed a content analysis of all Canadian newspaper articles published from  
18 January 1, 2015 to November 30, 2019 including the terms “medical abortion” or “abortion pill”.  
19 We identified articles by searching the Canadian Newsstream<sup>28</sup> database which includes the full  
20 text of more than 360 Canadian Newspapers from across the country, representing the major  
21 daily newspapers as well as smaller community newspapers. We chose the time period from  
22 January 1, 2015 to November 30, 2019 to include the time leading up to the approval of  
23 mifepristone in July 2015 until after the last Canadian province included mifepristone as an  
24 insured benefit in September 2019. Two of Canada’s three territories include mifepristone as an  
25 ensured health benefit (Yukon since October 2018 and Northwest Territories since June 2019).  
26 The third territory, Nunavut, does not include mifepristone as an ensured health benefit but more  
27 than 90% of Nunavut’s population has been insured for mifepristone since May 2017 through the  
28 federal governments’ non-insured health benefit program for eligible First Nations and Inuit  
29 people.<sup>29,30</sup>

### 30 **Sample selection**

31 We read full text record in full to determine relevance. We excluded articles if they:

- 1 a. did not discuss the introduction and regulation of medical abortion in Canada;
- 2 b. were not a newspaper or newswire story (for example the record was transcribed
- 3 dialogue of a TV interview); or
- 4 c. were an exact duplicate copy abstracted twice in the database (same text
- 5 published with the same title by the same outlet on the same day).

6 We treated variations of stories or editorials that were substantially similar, for example a  
7 newswire story published by different news outlets with different headlines and minor editorial  
8 changes and print and online versions of a story that included different content published by the  
9 same news outlet (for example a shorter print and longer online version of an article), as unique  
10 records.

### 11 **Coding**

12 Our content analysis of the newspaper articles applied an *a priori* coding scheme to  
13 identify the main themes and categorize the article's tone (pro-medical abortion, neutral or anti-  
14 medical abortion). We tested and validated the coding framework by two coders coding a sub-  
15 sample of 10 articles and comparing their results. Emergent themes and questions that arose  
16 during coding were discussed and agreed upon by AP and TK.

17 If the article included quotes from individuals that expressed pro-medical abortion and  
18 anti-medical abortion views, we coded the article as neutral. If the article did not include any  
19 arguments for or against medical abortion, for example the announcement of inclusion of  
20 mifepristone coverage in a provincial drug plan without any editorial commentary from the  
21 journalist or expression of pro or anti positions, we coded the article as neutral. If the journalist,  
22 editor or letter writer and/or the individuals quoted were exclusively supportive of introduction  
23 of mifepristone in Canada and removal of regulatory barriers to medical abortion, including  
24 coverage of mifepristone in provincial drug plans, we coded the article as pro-medical abortion.  
25 If the journalist, editor or letter writer only expressed arguments against mifepristone or abortion  
26 in order to critique them, we coded the article as pro-medical abortion. If the journalist, editor,  
27 letter writer and/or individuals quoted expressed only opposition to the introduction of  
28 mifepristone for medical abortion and removal of regulatory barriers we coded the article as anti-  
29 medical abortion.

30 We categorized the themes using the core components identified in the WHO's AAAQ  
31 (Availability, Accessibility, Acceptability, and Quality) right-to health framework,<sup>25</sup> identifying

1        *availability* (abortion availability and discussion of regulations that would limit uptake and  
2        availability specifically physician and ultrasound availability, additional training for healthcare  
3        providers and physician dispensing), *accessibility* (financial and geographic barriers in the  
4        context of mifepristone introduction e.g. provincial insurance coverage, travel time to point of  
5        care), *acceptability* (privacy, cultural acceptability, restrictive regulations that could reduce  
6        acceptability, such as physician observed dosing, or increased administrative burden such as  
7        patient written consent) and *quality* (medically approved, scientifically valid and of good  
8        technical quality). With respect to quality, we analyzed whether the article provided information  
9        about the administration and function of mifepristone as well as arguments made about safety  
10       and health risks. We identified whether information from reputable medical sources, such as the  
11       WHO or the Society for Obstetricians and Gynecologists of Canada, was provided. We also  
12       specifically coded for and analyzed arguments made against abortion (anti-abortion discourse)  
13       and discussion of abortion as a human or women’s rights issue.

14                We further analyzed which professional categories of stakeholders are cited in the  
15        articles: academics/researchers (who were labelled as such by the journalist or affiliated with a  
16        university), health professionals (coded by individual profession e.g. physician, midwife, nurse,  
17        pharmacist and then grouped together), elected or staff representatives of government, civil  
18        society organizations (such as Action Canada for Sexual and Health and Rights or Campaign for  
19        Life), religious leaders, and members of the public. During coding, we added the category  
20        “abortion clinic staff” to identify individuals who are not healthcare providers and who were  
21        supporting provision of abortion care in either a public or not-for-profit setting. The professional  
22        category was determined by the first mentioned professional designation or occupational sector,  
23        or affiliation given for a stakeholder who was quoted in the article. For example, a stakeholder  
24        described as a professor or researcher or affiliated with a university would be coded as an  
25        academic. An individual quoted in more than one article is coded for each article they were cited  
26        in. For each article, the professional category of each stakeholder quoted, and tone of the  
27        statement (pro-medical abortion, anti-medical abortion and neutral) was coded.

1           **RESULTS**

2           Of the 600 records for news articles published between January 2015 and November  
3           2019, we included 402 in the analytic sample. Of all 600 records, we excluded 198 because they  
4           were not relevant (did not address the introduction and regulation of medical abortion in  
5           Canada), were not a newspaper or newswire story, or were an exact duplicate. Of the 402 articles  
6           included in the sample, 113 were variations of the same story with minor variations in the  
7           content.

8           **Article tone and stakeholders quoted**

9           In Canadian print media coverage of the introduction and regulation of mifepristone  
10          between 2015 and 2019, we found the majority of articles were pro-medical abortion (269  
11          articles, 66.9%), followed by neutral coverage (102 articles, 25.4%), see Figure 1. Only 31  
12          articles (7.7%) expressed solely negative attitudes towards the introduction of, and increasing  
13          access to, medical abortion in Canada (labelled anti-medical abortion). The vast majority of the  
14          anti-medical abortion articles were letters to the editor (30 of 31); one newspaper story on  
15          political candidates running as independents included a negative statement about mifepristone by  
16          a candidate running on an anti-choice platform.<sup>31</sup> Interested in the concentration of anti-medical  
17          abortion views in opinion pieces, we analyzed the distribution of anti, neutral and pro-medical  
18          abortion views expressed in opinion pieces (letters to the editor, op eds and editorials). Of the 67  
19          opinion pieces, 33 (49.2%) were pro-medical abortion (including 17 out of 18 editorials  
20          published by editorial boards with the 18<sup>th</sup> editorial taking a neutral stance); 30 (44.8%) were  
21          anti-medical abortion and these were all letters to the editor from the public; and 4 opinion pieces  
22          (6.0%) presented arguments both in favor and against expansion of medical abortion in Canada  
23          through the introduction and regulation of mifepristone, and were coded as neutral.

27           ***Frequency of anti, neutral and pro-medical abortion statements and stakeholder professional***  
28           ***categories***

29           In total, there were 761 quotes from stakeholders in our sample of 402 articles. The  
30           frequency of anti-medical abortion statements made in the sample was 9.3% (71 of 761), neutral  
31           16.3% (124 of 761) and pro-medical abortion 74.4% (566 of 761).

1 The most common professional categories of quoted speakers were government (218,  
2 30.3%), civil society organizations (189, 23%) and healthcare professionals (129, 17.9%), see  
3 Figure 2. Within the professional categories, the voices of healthcare professionals (93.7% of  
4 physicians, 92.3% of nurses) and academics (94.5%) were predominantly in favour of the  
5 introduction of, and increased access to, mifepristone in Canada. Pro-medical abortion views also  
6 dominated those solicited from speakers affiliated with abortion clinics (90.3% pro and 9.7%  
7 neutral) and organized civil society (76.2% pro). The groups which held the largest proportion of  
8 perspectives against medical abortion were the public (22.9%), organized civil societies (19.8%)  
9 and the government (11.0%). However, the majority of voices within each of these groups were  
10 still pro medical abortion (public [62.9% pro], organized civil society [77.0% pro] and  
11 government [60.6% pro]). There were 2 religious leaders quoted in the pool of 761 quotations,  
12 both of whom made anti medical abortion statements.

### 19 **Thematic Analysis using the AAAQ Framework**

20 Each news article was coded to analyze the main themes presented. Of the 402 articles  
21 included in this study, almost half (190, 47.15%) identified one or more regulatory, financial  
22 and/or health system barriers to medical abortion. We apply the WHO’s AAAQ right to health  
23 framework<sup>27</sup> to categorize the types of barriers or facilitators of medical abortion identified in  
24 Canadian print media and thematically analyze and illustrate the types of arguments made by  
25 different stakeholders.  
26

### 27 *Availability*

28 In Canada, print media coverage of the approval and introduction of mifepristone for  
29 medical abortion put a clear emphasis on the issue of availability. First, the drug regulatory  
30 process in Canada which approved mifepristone in 2015 was identified as an important step to



1 improve the availability of medical abortion in Canada in 25 articles (6.2%). For example, the  
2 CP Wire service in 2015 stated:

3 *“To be clear, medical abortion has been available in Canada for decades.*  
4 *However, Canadian women have had to rely on less effective, less safe*  
5 *medications for this purpose. This is a step in the right direction towards*  
6 *ensuring Canadian women have access to legal first trimester abortion care*  
7 *that is as safe and accessible as it is in other parts of the world.”*

8 (30/07/2015)

9  
10 More than half of the articles reviewed (68.2%, n=274) discussed how increased access to  
11 mifepristone would support increased abortion availability. A third of these (n=94, 34.3%)  
12 specifically mentioned mifepristone’s potential to increase availability of abortion in rural areas.  
13 An illustrative quote from the CP Wire Service was from Brian Gallant, then-premier of New  
14 Brunswick, the first province in Canada to introduce universal health coverage for the nearly  
15 \$400 cost of Mifegymiso, saying:

16 *“We believe access to essential medical services shouldn’t depend on a*  
17 *person’s postal code or income bracket,’ [...] Mifegymiso [...] will help*  
18 *improve women’s access to reproductive health care, especially in rural*  
19 *regions far from hospitals that perform surgical abortions.’”* (24/07/2017).

20  
21 The specific regulations that could hamper availability of mifepristone were identified in  
22 92 articles. The most common barriers to availability identified were requiring physicians and  
23 pharmacists to undergo special training to prescribe or dispense mifepristone (n=28, 30.4%)  
24 which was removed in May 2017, requiring physicians to be registered and certified to provide  
25 mifepristone (n=11, 11.9%) and to directly dispense mifepristone to patients (n=38, 41.3%),  
26 restrictions which were removed in November 2017, and requiring ultrasound prior to medical  
27 abortion (n=34, 36.9%) which was removed in April 2019, see Figure 3.

When mifepristone was first approved, regulations required physician prescribers to take an online certification course and for them to be registered with the manufacturer in order to prescribe the medication. This was identified as a time-consuming hurdle which would limit the number of health professionals who would be able to prescribe mifepristone. The Toronto Star noted that:

*“Doctors and pharmacists, the very people unlikely to have spare work hours, must take a six-hour online course to prescribe or dispense it. Those who have taken the course are acting out of professionalism and human decency. But why should abortion still live in the realm of charity? It is legal. It is a basic human right.”* (06/03/2017).

Physician dispensing, meaning that doctors had to stock and sell mifepristone themselves rather than write a prescription that could be filled at pharmacy, was described as:

*“... so complicated that [doctors] don't bother with it at all. It's so problematic... it requires a lot of jumping through hoops, something that isn't required for any other legal prescription drug”* (Toronto Star, 07/03/2017).

Additionally, physician dispensing was discussed as a barrier to medical abortion moving into the realm of primary care because, as opposing to pharmacist dispensing, it would:

*“...discourage family doctors who do not specialize in women's reproductive services from offering the pills...”* (Globe and Mail, 21/01/2017) because *“It's quite an investment for a physician to be a dispensing practitioner...”* (Globe and Mail, 17/10/2016).

This limitation would be felt: *“...particularly among women in rural and remote communities whose family doctors do not have the capacity to run a parallel drug-dispensing operation.”* (Globe and Mail, 12/07/2016).

Obligatory ultrasound prior to medical abortion was identified as disproportionately affecting rural women. The Globe and Mail quoted an academic and health professional from Ontario saying saying:

1                    "... women in areas where ultrasounds are not readily available, such as  
2                    Nova Scotia and some remote and rural parts of Canada, may be facing  
3                    unnecessary delays. These regulations are being used in a scapegoating  
4                    manner to justify practice restrictions..."

5  
6                    and the article identified other evidence-based methods of pregnancy dating such as pelvic exams  
7                    (27/09/2018). Removing the ultrasound requirement had the potential to: "...encourage more  
8                    health providers to start prescribing Mifegymiso. It's going to improve the process overall."  
9                    (Globe and Mail, 17/04/2019).

### 10 11                    ***Accessibility***

12                    The accessibility domain requires health services to be accessible to everyone without  
13                    discrimination, which includes lack of access based on financial status. At least one theme  
14                    related to mifepristone accessibility was discussed in the majority of articles analyzed (n=351,  
15                    87.3%). The most common barriers to accessibility identified were lack of provincial drug plan  
16                    coverage for mifepristone (n=189, 47.0%) and the overlapping issue of financial access as a  
17                    barrier (n=76, 18.9%). As noted earlier, drug plan coverage of mifepristone was discussed as a  
18                    way of increasing availability of medical abortion, however the lack of coverage was identified  
19                    as a barrier to access. For example, the Globe and Mail reported that:

20                    "[m]ost women are not going to pay out of pocket [for a pill] when they can  
21                    have a safe and effective surgical abortion at no cost to [them]...It diminishes  
22                    the promise of opening access to women in more rural areas where surgical  
23                    abortions are not readily available." (2016).

24  
25                    Almost half of the articles (n=200, 49.6%) included statements (either by the writer or by  
26                    stakeholders cited in the article) arguing for drug plan coverage of mifepristone as a means of  
27                    supporting accessibility of medical abortion. When mifepristone was initially approved for  
28                    medical abortion, the cost of the medication (\$300-450 CAD)<sup>32</sup> had to be borne by the woman  
29                    seeking it. In contrast, surgical abortion, an in-hospital or in-clinic procedure, was covered by  
30                    public health insurance in Canada. Implementing drug plan coverage of mifepristone would  
31                    increase accessibility of abortion, and this often overlapped with increasing rural access to

1 abortion. For example, the Globe and Mail quoted an academic health professional from British  
2 Columbia as saying:

3 *“Being able to have the medication also covered by the government, this helps*  
4 *tremendously so that women can access care in their own communities and*  
5 *can judge whether medical or surgical abortion is better for them based on*  
6 *what their health needs are, not what their postal code is” (03/01/2018).*

7  
8 The timeline in Figure 4 describes print media coverage of the introduction and regulation of  
9 mifepristone for medical abortion in Canada from the six months prior to approval by Health  
10 Canada (January 2015), through the time when the product became available on the market in  
11 July 2017, and over the period of the removal of each of the regulatory restrictions that presented  
12 barriers to availability and accessibility, including affordability, up until the last Canadian  
13 province included coverage of mifepristone in its provincial pharmaceutical formulary in  
14 September 2019.

15

19 Figure 4 illustrates that throughout this period, the tone of print articles about  
20 mifepristone and medical abortion in Canada have been predominantly pro-medical abortion or  
21 neutral. The majority of anti-medical abortion articles printed coincided with the initial Health  
22 Canada approval of mifepristone in July 2015 and subsequently when it became available on the  
23 market in January 2017. Even at these points in time, the pro-medical abortion and neutral  
24 articles make up the majority of newspaper publications. After November 2017, when all  
25 restrictive regulations except the ultrasound requirement had been removed, only one anti-  
26 medical abortion article was published, and it coincided with the removal of the requirement for  
27 ultrasound to be performed prior to medical abortion in April 2019.

28  
29 ***Acceptability***

30 Acceptability states that health services must be respectful of medical ethics, including  
31 privacy and confidentiality, and be culturally sensitive. We found 34.1% (n=137) of articles

1 included at least one theme on how mifepristone supported acceptability of medical abortion and  
2 how specific regulatory restrictions challenged its acceptability. Equity, cultural sensitivity and  
3 privacy were highlighted as benefits of medical abortion in 14.4% of articles (n=58). The Chief  
4 Executive Officer of the Society of Obstetricians and Gynaecologists of Canada was quoted as  
5 saying:

6 “... allowing Canadian women access to mifepristone would have no impact on  
7 the number of women choosing abortion but would help make an "intensely  
8 personal issue" a private health matter between a woman and her doctor.”

9 (Vancouver Sun, 13/01/2015).

10  
11 The ability to offer a medical abortion at a time and place determined by the pregnant person,  
12 and thus to make the decision truly private, was discussed in 10.2% of articles (n=41).  
13 Regulations such as physician observed dosing and requiring patient written consent prior to  
14 medical abortion were identified as barriers to the acceptability of mifepristone for medical  
15 abortion in 20 articles. Opposition to physician observed dosing, the requirement for a doctor to  
16 witness women taking the mifepristone in their office, was objected to in 17 articles. A quote  
17 from an academic health professional from a western Canadian university exemplifies these  
18 arguments that physician observed dosing is: “...medically unnecessary and demeaning to  
19 Canadian women” (The Province, 20/04/2016).

## 20 21 **Quality**

22 Quality as a domain of the right to health, states that health services must be scientifically  
23 and medically approved. Mifepristone is considered the gold standard in medical abortion by the  
24 WHO and is on its list of essential medications.<sup>33</sup> We found 19.2% of articles (n=77) included  
25 scientific information on how mifepristone works and 11.2% (n=45) of articles provided safety  
26 information from the WHO or other reputable scientific bodies.

27 Within the group of speakers quoted in the articles, we looked at whether journalists were  
28 using speakers with the professional background to reinforce that mifepristone is a scientifically  
29 and medically approved method of medical abortion. We specifically looked at the representation  
30 of two groups with expertise on the topic of medical abortion in Canada:

1 (1) The 16 physician members of the Society of Obstetricians and Gynecologists of Canada  
2 (SOGC) who authored the Medical Abortion Clinical Practice Guideline released in 2016 as sub-  
3 sets of all physicians quoted and (2) the 28 Collaborators of the Contraception and Abortion  
4 Research Team (CART-GRAC) working on a national study on Mifepristone Implementation in  
5 Canada (CART-Mife Study), as subsets of all of the stakeholders quoted. The SOGC is the  
6 national specialty organization for the practice of obstetrics and gynecology in Canada and is  
7 responsible for producing national clinical practice guidelines and maintaining continuing  
8 education in women's sexual and reproductive health. CART-GRAC is a Canadian multi-  
9 disciplinary research team based at the University of British Columbia (UBC) focused on  
10 conducting national, cross-sectoral research to improve family planning care available to  
11 Canadians.

12 Of the 761 quotations across all articles, 8.1% (62 quotations) were from the authors of  
13 the SOGC guideline on Medical Abortion and 18.1% (138 quotations) were from people  
14 affiliated with the CART-Mife Study. Of the 313 articles which included a quotation, 18.2% (57  
15 articles) quoted at least one speaker who authored the SOGC guideline on Medical Abortion and  
16 30% (94 articles) quoted at least one speaker affiliated with the CART-Mife Study (Figure 5). Of  
17 the 146 quotations identified as made by physicians, 42% were authors of the SOGC guideline  
18 on Medical Abortion (Figure 6).

1           **Discussions of “the right to life”, women’s rights and personal views influencing policy in**  
2           **press coverage of the introduction and regulation of mifepristone for medical abortion**

3  
4           *Anti-abortion discourse*

5           We coded all of the articles for the presence of any anti-abortion discourse, which was  
6           identified in just under a fifth of articles (n= 78, 19.4%). The majority of articles that included  
7           anti medical abortion themes were news stories (n=42, 53.8%) and letters to the editor (n=30,  
8           38.5%). The others were wire stories (n=5, 6.4%) and 1 editorial (1.3%). More than half of the  
9           articles that expressed any anti-abortion views also included statements from supporters of  
10          increased abortion access or only quoted anti-medical abortion themes to critique them (all wire  
11          stories, the editorial and 41 of 42 news stories were neutral in tone). Only letters to the editor  
12          from the public made solely anti-medical abortion arguments and were categorized as anti-  
13          medical abortion in tone.

14          The most common arguments made against medical abortion included the assertion that  
15          abortion is a form of homicide (mentioned in 38 articles), morally wrong in that it disrespects the  
16          sanctity of life or is an irresponsible choice (mentioned in 24 articles) or is harmful to women’s  
17          health (mentioned in 26 articles). Less common themes included the need to provide women with  
18          other options, including adoption in case of unintended pregnancy (mentioned in 2 articles), that  
19          medical abortion will increase the overall number of abortions (mentioned in 1 article) and  
20          opposition to public funding for medical abortion (mentioned in 12 articles).

21          Of the articles that included statements about the danger of medical abortion for women’s  
22          health, 23.07% (n=5) also included information on the safety of medical abortion from the WHO  
23          or other reputable national or professional scientific body and 26.9% (n=7) included scientific  
24          information about how mifepristone works. Analyzing these 7 articles as a sub-set provides  
25          insight into the overall positioning of anti-abortion discourse with Canadian print media  
26          coverage during the introduction and regulation of mifepristone in Canada. In all but one of the  
27          articles, mifepristone is described as an “essential medicine” and reputable scientific information  
28          about how mifepristone works is provided. Mifepristone is described as inducing “*an abortion*  
29          *similar to a natural miscarriage within one to two days after a woman takes the pills*” in 5 of 7  
30          articles. In 6 of 7 articles, the ratio is two or three pro-medical abortion speakers for each anti-  
31          medical abortion speaker.<sup>34-39</sup> Furthermore, the pro-medical abortion speakers are highly credible

1 because of their professions and organizational affiliations. For the most part these speakers, who  
2 attest to the safety of medical abortion and mifepristone’s potential to improve access and  
3 reproductive health outcomes, are either physicians working with prestigious hospitals and  
4 national medical organizations, or representatives of government. The sole dissenting anti-  
5 medical abortion stakeholder quoted is from a civil society organization and is not a physician.  
6 The seventh article in the sub-sample includes information on a provincial government’s  
7 announcement of inclusion of mifepristone in the provincial formulary, as well as information  
8 about how the drug works. It features one quote each from anti and pro-medical abortion civil  
9 society organizations.<sup>40</sup>

### 10 11 ***Abortion as a woman’s right***

12 A minority of articles (15.4%, n=62) discussed abortion as a women’s right and how  
13 mifepristone supports women to exercise this right. Government officials made statements on  
14 abortion as a woman’s right, including then and current Prime Minister Justin Trudeau who was  
15 quoted as saying “... *Canada would remain unequivocal in its defence of a woman’s right to end*  
16 *a pregnancy.*” (The News, 16/05/2019). Just as those expressing anti-abortion viewpoints  
17 invoked women’s health in their arguments against abortion, the framing of abortion as a  
18 woman’s right (the right to choose) was also frequently linked to the right to health and to access  
19 to healthcare among those who spoke in favor of women’s right to make their own decisions  
20 about abortion. A quote that exemplifies the parallels drawn between women’s right to choose  
21 and the right to health came from Stephen McNeil, then and current premier of Nova Scotia, who  
22 is identified in the article as a Roman Catholic. He framed his perspective when addressing the  
23 issue as that of “a parent of a daughter” before going on to state his support for the removal of  
24 restrictive regulations on medical abortion:

25 “*She [my daughter] has the right to make a decision for herself and my job is to*  
26 *love my daughter if she so chooses to make a decision on her health [...] it’s about*  
27 *doing what’s right and we believe women deserve access to this health care and*  
28 *we will do so.*” (CP Wire Service, 22/09/2017).

### 29 30 ***Should the personal be political?***



1 An unanticipated emergent theme in our content analysis was discussion of the place of  
2 personal views in politics and policy-making. This theme was discussed in 25 articles. Among  
3 these, 22 articles (88%) stated that personal belief should *not* be a part of public policy decisions.  
4 These 22 articles included statements from elected government officials discussing mifepristone  
5 but declining to state their personal views on abortion in general or mifepristone specifically. For  
6 example, The Daily Gleaner reported that:

7 *“Justice Minister Peter MacKay declined to comment on the decision [of*  
8 *Health Canada to approve mifepristone] during a stop in Calgary to make an*  
9 *unrelated announcement. “Oh gosh. I think that would best be directed to*  
10 *(Health) Minister (Rona) Ambrose,” he said. “It is an issue of course for*  
11 *women, families, Canadians everywhere, but I think your question would best*  
12 *be directed to Health Canada...Personal opinions are best kept personal.”*  
13 (31/07/2015).

14  
15 The executive director of Action Canada for Sexual Health and Rights was quoted as stating:  
16 *“Health ministers are responsible for ensuring our reproductive health, and no personal or*  
17 *political beliefs should interfere with people claiming those rights.”* (Winnipeg Free Press,  
18 27/06/2018). There were 3 articles (12%) in which an elected government official or a candidate  
19 who planned to stand for election said that they would advocate for restrictions on mifepristone  
20 because of their personal beliefs against abortion.

## 21 22 23 **Discussion**

24 Our analysis of Canadian newspaper coverage of mifepristone from January 2015 to  
25 November 2019 found an exceptionally high level of support for the approval, introduction and  
26 removal of regulatory barriers to medical abortion. Further, newspapers privileged scientific and  
27 factual perspectives from experts on the introduction and regulation of mifepristone in Canada.  
28 This alignment with the weight of scientific evidence and expert opinion is an example of  
29 evidentiary, as opposed to formal balance, in media coverage of abortion.<sup>41</sup>

30 Over two thirds of articles were pro-medical abortion, that is they only made statements or  
31 stated quoted stakeholders who supported the introduction and expansion of medical abortion,

1 with a further quarter of articles presenting balanced or neutral coverage. Purely anti-medical  
2 abortion views were marginalized both in terms of quantity (8% of the records reviewed) and in  
3 terms of quality of reporting, as almost all were letters to the editor from the public. Only a  
4 single article among the 402 (0.3%) represented a news article presenting solely an anti-medical  
5 abortion perspective. Similarly, over ninety percent of the quoted statements from stakeholders  
6 were positive or neutral. Across all sectors of stakeholders, mifepristone statements were  
7 dominantly pro-medical abortion, whether from government, civil society or healthcare  
8 providers.

9 In the United Kingdom, Purcell et al analyzed articles on abortion from British and Scottish  
10 newspapers in 2010.<sup>42</sup> They found that the majority of articles described abortion using negative  
11 language and that abortion was presented as being ‘controversial’. Abortion was stigmatized by  
12 being associated with ‘undesirable’ traits such as binge drinking, promiscuity and teen  
13 pregnancy. The framing of abortion as a positive or legitimate choice was marginalized. In  
14 contrast we found the anti-medical abortion discourse was marginalized in Canada, with over  
15 90% of articles in Canadian print media being classified as pro-medical abortion or neutral.  
16 The marginalization of anti-medical abortion views within Canadian print media, both in the  
17 volume and in the location of publication (letters rather than news stories) has important  
18 implications to discuss for journalistic balance. In the context of the United States, Sisson et al  
19 found that even among journalists publishing in feminist news outlets, 65% of journalists  
20 grappled with the concepts of neutrality and balance when reporting on abortion, and a quarter  
21 felt compelled to present “both sides of the abortion debate” as a requirement of balanced  
22 reporting.<sup>43</sup> Only a third of these USA reporters took a stance more similar to our findings in  
23 Canadian newspaper coverage of mifepristone: placing priority on the merit of the arguments  
24 made and not uncritically replicating misinformation.<sup>43</sup> This USA study highlights the problem  
25 false balance in reporting. When an issue already has scientific consensus, presenting 'the other  
26 side' gives that non-scientific or ‘anti-science’ perspective an unwarranted legitimacy and implies  
27 equal standing. This can result in uncertainty and confusion among the public about the  
28 established scientific evidence.<sup>44</sup>

29 Our study of print media coverage in Canada demonstrates evidentiary balance. We found  
30 greater weight was given to evidence-based or scientific views in discussions of the introduction  
31 and regulation of mifepristone medical abortion. The distribution of abortion reporting - over

1 90% reporting pro- or neutral views to the introduction of a medication which would increase  
2 access to medical abortion, reflects that the weight of scientific opinion agrees that abortion is a  
3 necessary medical procedure for women's health and that abortion is relatively safe, for example  
4 safer than childbirth.<sup>45</sup> This is further supported by the choice of authority figures such as  
5 physicians and scientific researchers as quoted stakeholders in pro and neutral articles. Our  
6 analysis showed that when physicians were quoted, 42% of the physicians were noted Canadian  
7 experts in abortion, having contributed to a national guideline on medical abortion. Around one  
8 third of articles with quotations, quoted someone affiliated with a national university-based study  
9 on the use of mifepristone. By consistently including expert voices in support of mifepristone  
10 and medical abortion, and relegating the dissenting, non-expert voices to letters/opinion pieces,  
11 the Canadian media has presented a view on abortion which is balanced in that it communicates  
12 expert consensus on the issue.

13 Further, we found consistency over time in the tone of coverage of medical abortion.  
14 Coverage was positive from six months before the approval of mifepristone through to  
15 announcement of public coverage by the last province. Over the study period, Canadian  
16 provincial and federal regulators and governments acted to increase the availability, accessibility  
17 and acceptability of medical abortion in Canada. They iteratively liberalized regulations and  
18 policies resulting in a federal system with the least restrictive regulatory framework for  
19 mifepristone medical abortion in the world.<sup>6,46</sup> The Canadian print media communicated  
20 arguments that supported these regulatory and policy changes as opposed to arguments that could  
21 create backlash against the establishment of mifepristone medical abortion is available as an  
22 integrated part of the publicly funded, universal healthcare system.

23 The rural-urban disparity in abortion access in Canada has been repeatedly identified by  
24 Canadian researchers,<sup>12,13,47-52</sup> with mifepristone access via primary care being proposed as a  
25 solution to improve access in rural areas.<sup>16</sup> This was also the narrative presented by the Canadian  
26 media. Most articles argued for changes to the regulatory framework which would support  
27 increased availability, accessibility and acceptability of mifepristone medical abortion. When  
28 themes were analyzed from the AAAQ right to health<sup>25-27</sup> perspective, articles consistently  
29 presented mifepristone as a way to support the availability (68.2%, n=274), accessibility (87.3%,  
30 n=351) and acceptability (34.1%, n=137) of medical abortion for all. A third of articles that  
31 addressed the issue of availability specifically focused on mifepristone increasing availability of

1 rural abortion. Among the 313 articles which included speakers, researchers with the CART-  
2 Mife team were quoted 30% of the time and physicians on the SOGC's Medical Abortion  
3 guideline committee were quoted 18.7% of the time. Citation of these authorities by the media  
4 reinforced that mifepristone is of high quality, scientifically accepted and medically approved  
5 medication for medical abortion.

6 Our finding that mifepristone and medical abortion were reported as a health issue is in  
7 direct contrast to that found in newspapers coverage in the USA, where abortion tends to be  
8 covered as a political issue. Woodruff<sup>53</sup> analyzed news articles on abortion from select USA  
9 newspapers during 2013-2016, a similar time period to our content analysis, and found that  
10 abortion was not covered as a health issue but as a political issue, and specifically an electoral  
11 issue. The most common abortion content in this American study was the relationship to electoral  
12 politics and candidate's positions on abortion. Their study found only 5.6% of articles identified  
13 that abortion restrictions pose barriers to abortion access and 2.8% identified abortion as being  
14 safe and common. In contrast, almost half (190, 47.15%) of the articles in our Canadian content  
15 analysis identified one or more regulatory, financial and/or health system barriers to medical  
16 abortion. Further, 68.2%, n=274 discussed how increased mifepristone access would increase  
17 abortion availability, and 11.1% of articles explicitly stated that that medical abortion was safe,  
18 with supporting information from the WHO or other reputable scientific bodies.

19 In contrast to the American findings, we found that only a minority of articles (6.2%)  
20 discussed the role of a politician or policy maker's personal view on abortion, and among these  
21 88% included arguments against personal views influencing public policy. This dramatic  
22 difference in the representation of abortion in print media between Canada and the USA may be  
23 a reflection of a Canadian political value that public policy should not be driven by personal  
24 views. In addition, Farney (2009)<sup>54</sup> explains that, in contrast to American conservatives,  
25 Canadian conservatives have historically distanced themselves from socially conservative party  
26 positions on issues such as abortion and lesbian, gay and bisexual rights. Certainly, our content  
27 analysis indicates that publicly expressing anti-abortion views is not perceived as an effective  
28 electoral strategy by political parties or most elected officials.

29 We found that the vast majority of Canadian articles included pro-abortion viewpoints, yet  
30 abortion as a women's rights issue was only identified in a minority of articles (15.4%). Media  
31 coverage on the introduction and regulation of mifepristone for medical abortion in Canada

1 between 2015 and 2019 reflected the historical demotion of partisanship on social issues in  
2 Canada in that the discussion of medical abortion was framed as a health issue, frequently  
3 exploring different components necessary to realize the right to health, rather than as moral or  
4 political debate which would pit the rights of the fetus against those of the woman.

### 6 ***Strengths and Limitations***

7 Our content analysis comprehensively included all print media over the time period relevant  
8 to mifepristone introduction and regulation, from six months before initial approval until after the  
9 last Canadian province included mifepristone in the provincial drug plan. We also included all  
10 print media, regardless of circulation number or geographic coverage (national versus local  
11 newspaper). This comprehensiveness allowed us to capture the entire narrative presented by the  
12 print media and to examine if and how it changed over time as the regulatory landscape evolved.  
13 We used an *a priori* coding scheme and identified key themes in advance. The data presented in  
14 this paper only considered print news media and did not include radio, television or social media.  
15 Our study considered only one facet of media reporting to the public (print media) and therefore  
16 cannot be taken as fully representative of the wider media coverage of mifepristone's  
17 introduction and regulation in Canada.

### 19 **Conclusion**

20 We found coverage by Canadian print media was supportive of the approval and  
21 introduction of mifepristone for medical abortion and presented medical abortion as a health  
22 issue framed and supported by science, rather than as an issue of partisan politics, morality or  
23 women's rights. Print media coverage communicated arguments about mifepristone medical  
24 abortion's potential to improve fulfillment of the right to health by advancing availability,  
25 accessibility, acceptability and quality. Mifepristone's introduction in Canada was presented as a  
26 way to increase women's health, specifically within rural areas where disparities in abortion  
27 access exist. Speakers with expertise, physicians and academic researchers, were cited frequently  
28 in support of increasing the availability, access and acceptability of medical abortion, and their  
29 statements and stature reinforced perceptions that mifepristone medical abortion fulfills the  
30 quality aspect of the right to health. Anti-medical abortion discourse was marginalized in the  
31 overall narrative. The marginalization of anti-abortion arguments is an example of evidentiary

1 balance in reporting, where the weight of expert opinion supports abortion as a safe and  
2 necessary health procedure.

3 This content analysis is not able to draw conclusions about the influence of coverage on  
4 political decision-making or the knowledge of the public. However, the Canadian print media  
5 presented arguments that were overwhelmingly favorable towards the expansion of mifepristone  
6 medical abortion and served to destigmatize abortion by framing the introduction and universal  
7 coverage of medical abortion as a health issue and by providing evidence-based information  
8 about safety.

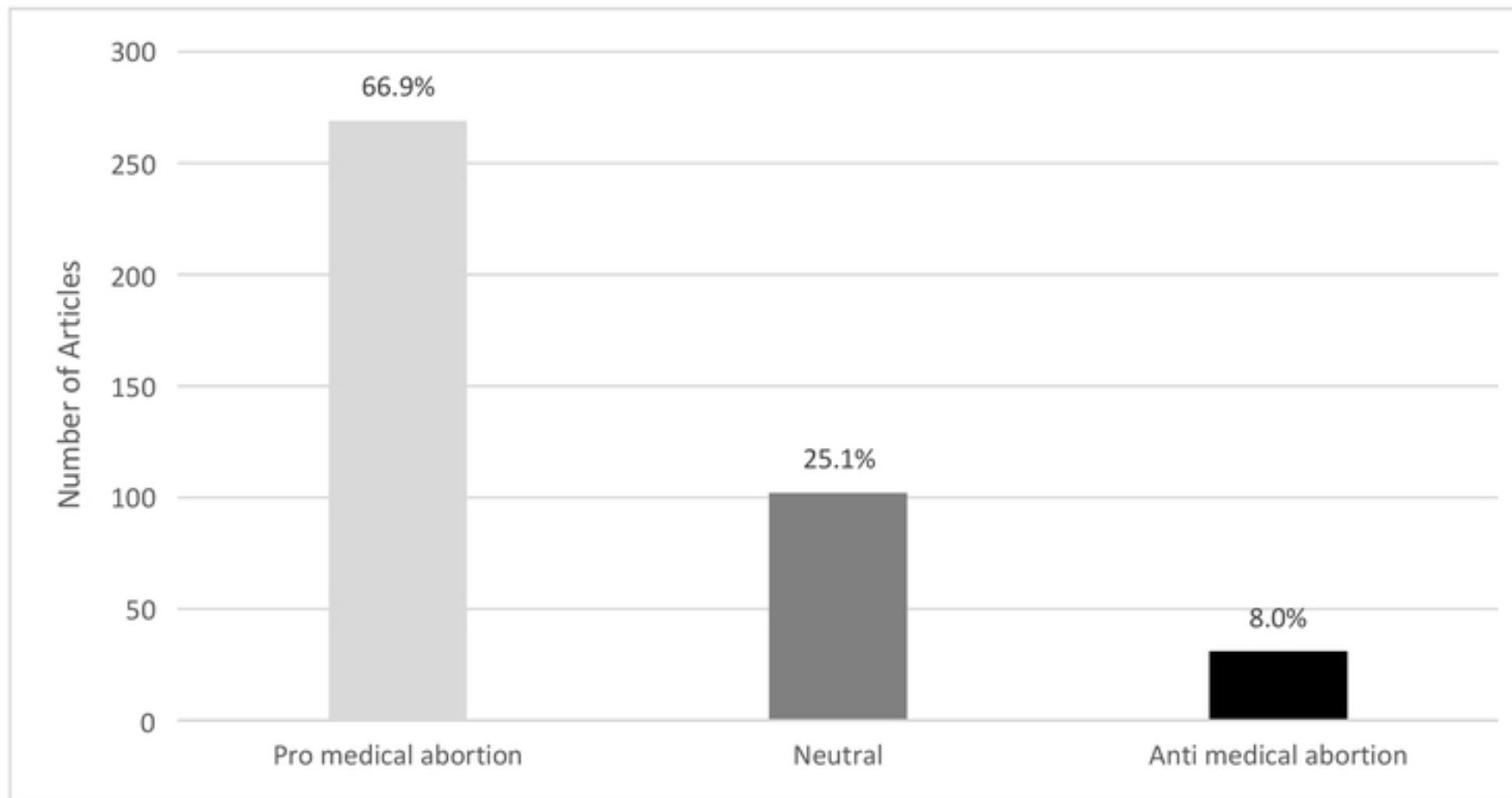

**Figure 1: Canadian newspaper article tone of reporting, Jan 2015 to Nov 2019**

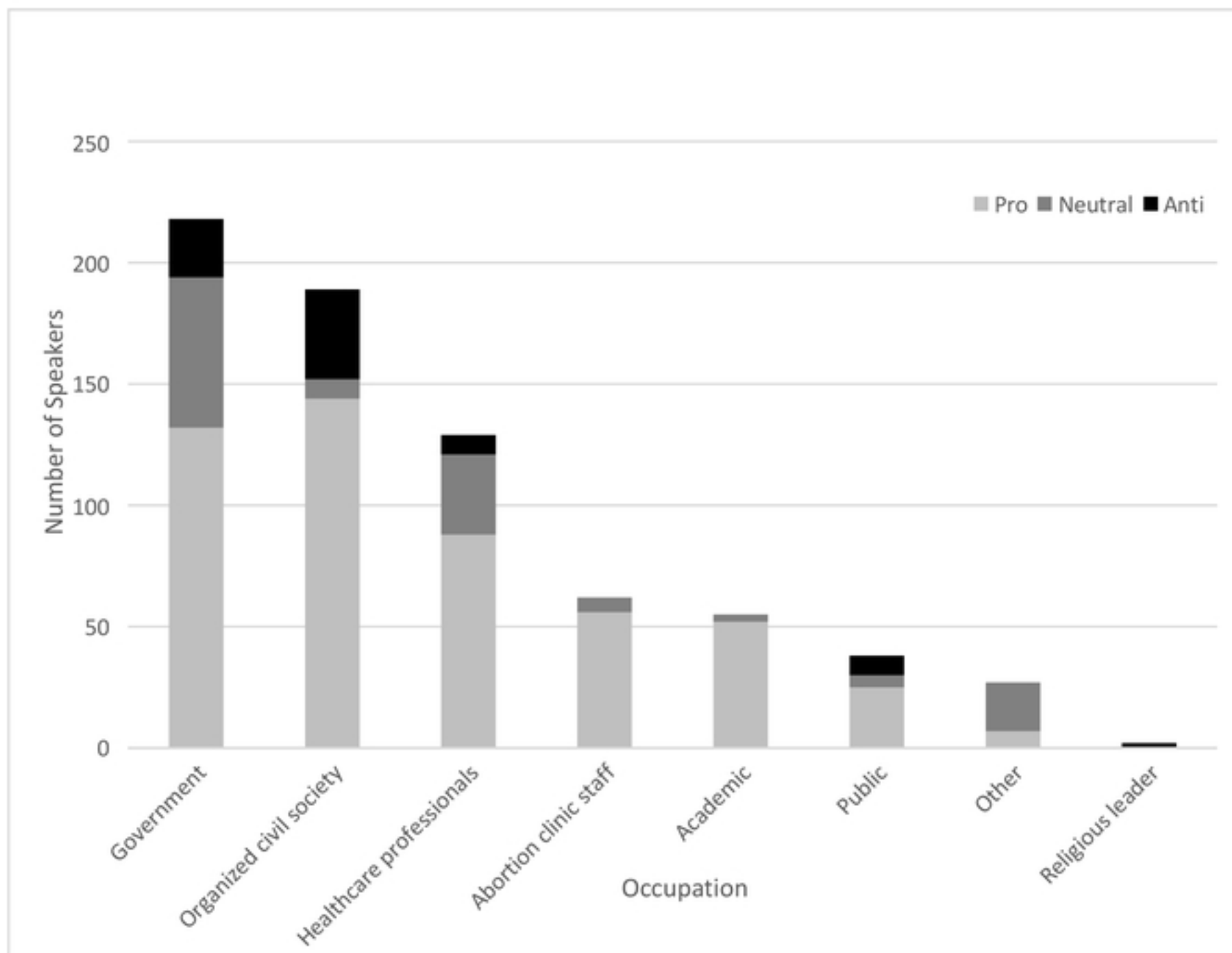
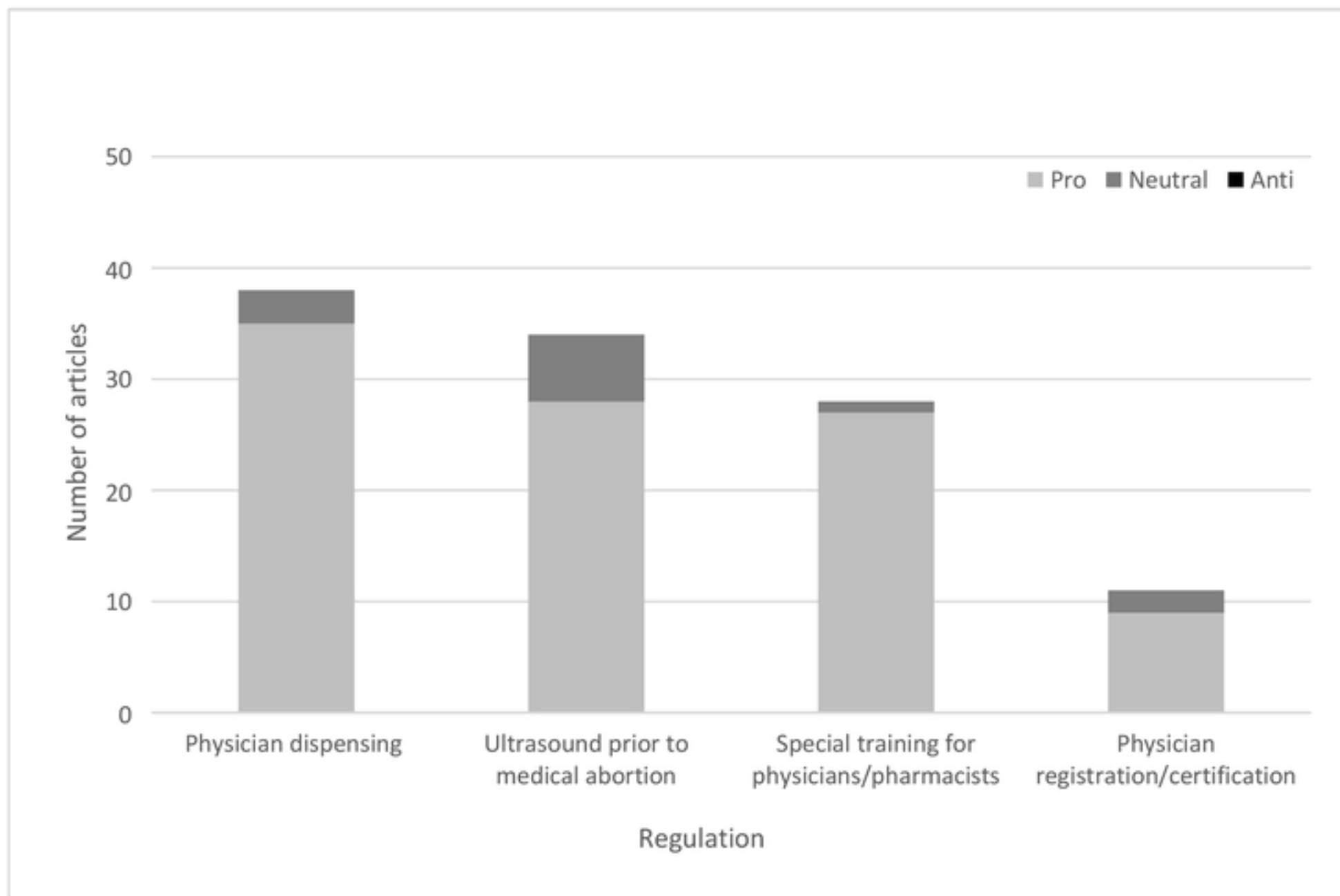
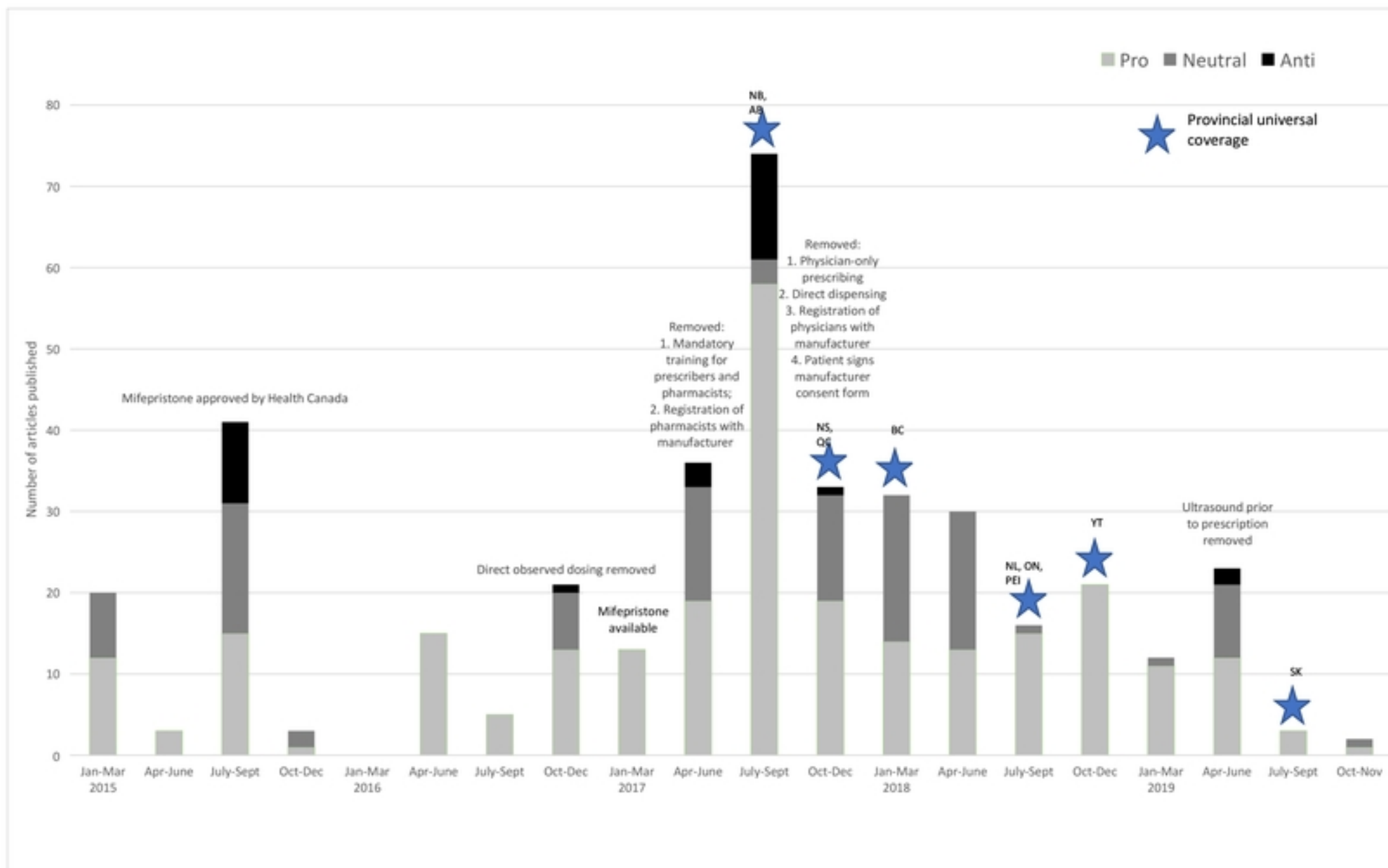


Figure 2: ***Speakers in Canadian newspaper mifepristone articles by occupation and tone, Jan 2015 to Nov 2019***

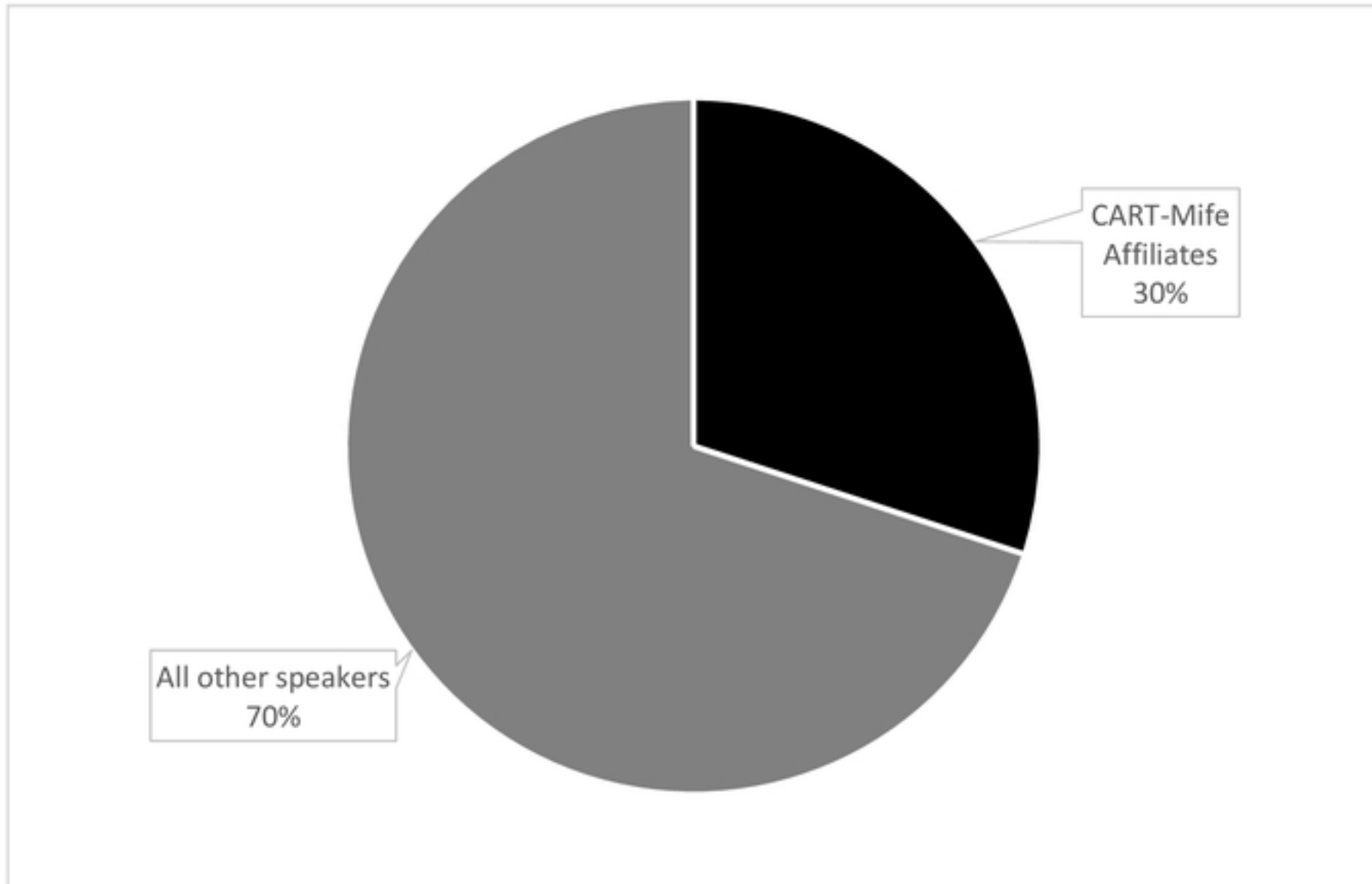

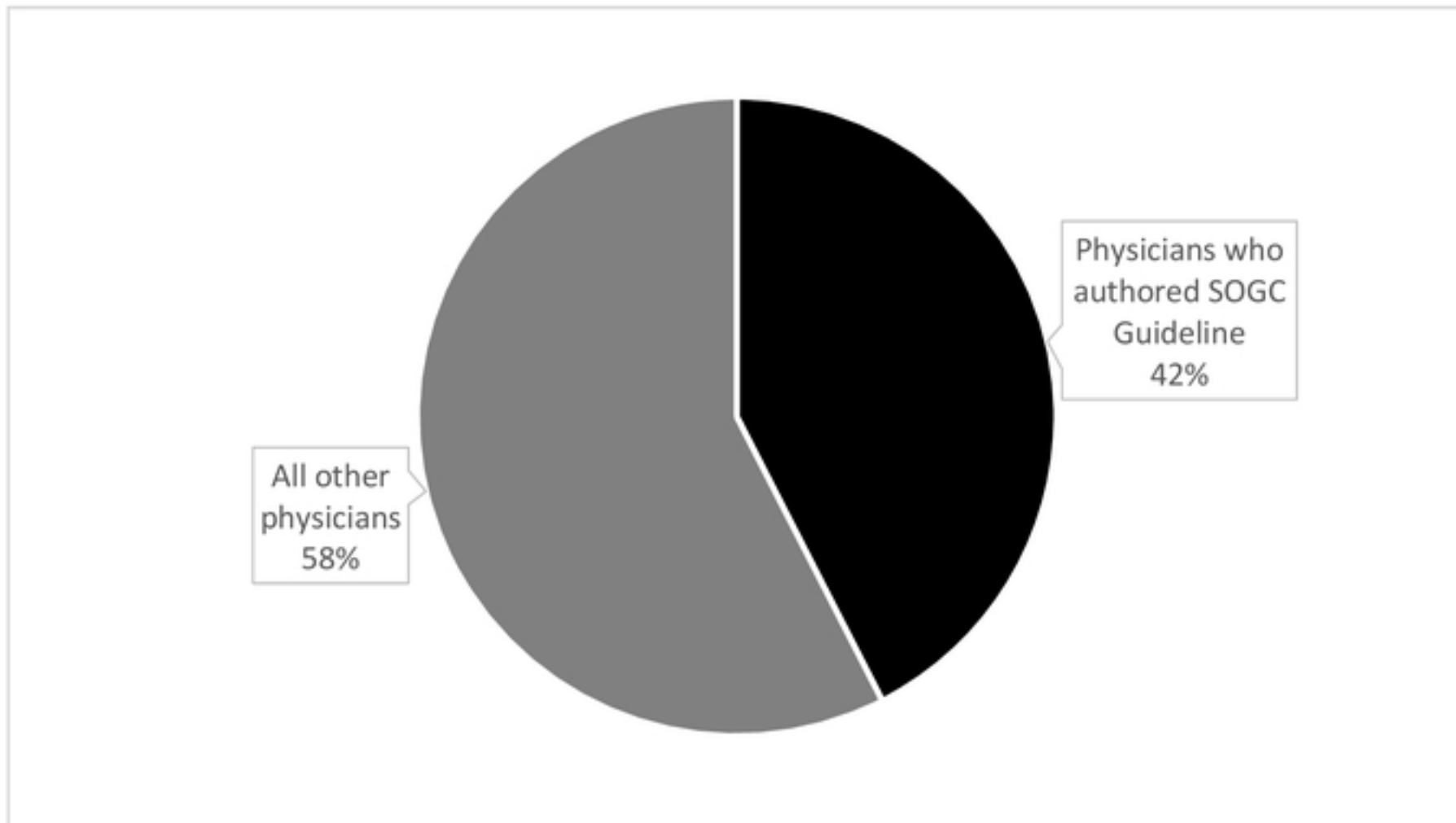
**Figure 3: Restrictive regulations identified in Canadian newspaper articles discussing availability of medical abortion, Jan 2015 to Nov 2019**
