#### 45 S1 Text. Helpful functions used to generate inputs for runserosim

46

47 **S1.1 Text.** generate\_pop\_demography: This function helps users build their demography tibble 48 with birth times, removal times, and specific demographic elements of interest. This function calls 49 both the simulate\_birth\_times and simulate\_removal\_times functions which simulate random 50 birth times and removal times for each individual. See the generate pop\_demography help file 51 for more information on how to specify the limits and probabilities of birth and removal times. With 52 the aux in generate\_pop\_demography, users can specify other demographic elements of 53 interest by passing through a list of the column name, options and distributions for each option 54 type. The returned demography tibble can be modified post-hoc to use user-specified distributions 55 and values.

57 S1.2 Text. reformat biomarker map: This function will reformat the biomarker map or 58 model pars objects so that exposure\_ID and biomarker\_ID are either both numeric (if passed 59 as characters) or characters (if passed as numeric) (See S1 Fig). runserosim requires that both exposure ID and biomarker ID are numeric entries. 60

62 **S1.3 Text. plot biomarker mediated protection:** If the user has specified an immunity model 63 with biomarker mediated-protection, they can use this function to produce a plot of the probability 64 of infection given an individual's biomarker quantity at exposure conditional on 65 biomarker prot midpoint and biomarker prot width which are specified within 66 model pars. Ready-to-use immunity models which incorporate biomarker mediated protection 67 are immunity model ifxn biomarker prot and immunity model vacc ifxn biomarker prot (S5 Table). Users can use this function to 68 determine the best values for these two inputs within model pars.

S1.4 Text. plot biomarker dependent boosting: If the user has specified a function to draw 71 72 parameters with biomarker quantity dependent boosting effects, they can use this function to 73 produce a plot displaying the proportion of full boost received at each starting biomarker quantity 74 given the biomarker quantity ceiling threshold and the biomarker quantity ceiling gradient which 75 are specified within model pars. Ready-to-use draw\_parameters functions which incorporate 76 biomarker dependent boosting are draw parameters fixed fx biomarker dep and 77 draw parameters random fx biomarker dep (S7 Table). Users can use this function to 78 determine the best values for these two inputs within model pars.

#### 79 S2 Text. Optional runserosim arguments

81 **S2.1 Text.** exposure histories fixed: The exposure histories array, specified by 82 exposure histories, is a 3-dimensional array indicating the exposure history (1 = exposed; 0 =not exposed) for each individual (dimension 1) at each time (dimension 2) for each exposure 83 84 event (aka exposure ID) (dimension 3) (S2 Fig). This array normally contains NA's but can also 85 include pre-specified information if exposure histories are known which can be passed to

- runserosim with exposure histories fixed. Wherever an entry is provided, runserosim assumes that exposure time and type are known and fixed (e.g., specifying known vaccination times or specifying known infections from a transmission model). If the entry is left as NA, then runserosim simulates an exposure event for that entry using the specified models. S2.2 Text. verbose: If an integer is specified then a progress update will be printed once the simulation reaches that individual and every multiple thereafter. **S2.3 Text.** attempt precomputation: If TRUE, the simulation attempts to perform as much pre-computation as possible for the exposure model to speed up the main simulation code. If FALSE, the simulation skips this step.

The probability of successful exposure(vaccination event) depends on the number of vaccines an individual has received prior to time $t$ and whether an individual is eligible for vaccination. If the individual is under the maximum vaccinations allotted and eligible for vaccination then the probability of a successful exposure event is 1.
immunity_model_ vacc_ifxn_simple	This immunity model should only be used with vaccines and natural infection. The probability of successful exposure for vaccination events depends on the number of vaccines an individual has received prior to time <i>t</i> and their current age. If the individual is under the maximum vaccinations allotted and is of an age eligible for vaccination then the probability of successful exposure is 1. The probability of a successful natural infection is dependent on the total number of infections that individual has experienced thus far. If the individual is under the maximum number of infections allotted then the probability of successful exposure event is 1.

The probability of a successful exposure event is dependent on the individual's biomarker quantity at the time of exposure.
