## 44 A protocol for a systematic critical realist synthesis of school mindfulness 45 interventions designed to promote pupils' mental wellbeing

### 47 Abstract

48

### 49 Introduction

50 The review described in this protocol will be the first critical realist review of the literature  
51 reporting on the impact of mindfulness interventions in schools on the mental wellbeing of  
52 pupils. Mindfulness interventions are increasingly being introduced into schools to promote  
53 children's (and teachers') wellbeing. Findings from impact evaluations, including systematic  
54 reviews and metanalysis, suggest that school-based mindfulness interventions promote  
55 pupils' wellbeing. However, there is a need for further evidence on how they work and for  
56 whom and under what circumstances.

57

### 58 Methods and analysis

59 A critical realist review methodology will be used to provide a causal interdisciplinary  
60 understanding of how mindfulness interventions in schools promote the mental wellbeing of  
61 pupils. This will be done through a systematic literature review and extrapolating context,  
62 agency, intervention, mechanisms, and outcome configurations. This will enable us to  
63 understand how in certain contexts, pupils can use the resources offered by a mindfulness  
64 intervention to trigger mechanisms that promote their mental wellbeing and what  
65 mechanisms in the context support, restrict or prevent change. We will then use retrodiction  
66 and retrodution to develop the most plausible interdisciplinary middle-range theory to  
67 explain the findings.

### 69 Discussion

70 The review findings will inform a critical realist evaluation of a mindfulness intervention in  
71 schools that we will be carrying out. The findings from the review will enable us to inform  
72 policymakers and other stakeholders about what conditions need to be in place for  
73 mindfulness interventions to promote pupils' mental wellbeing and for which pupils. We will  
74 publish the findings from the review in academic and professional publications, policy briefs,  
75 workshops, conferences, and social media.

## 83 **Introduction**

84

85 This critical realist review aims to understand how and why school-based mindfulness  
86 interventions (SBMIs) work or do not work in promoting children's mental wellbeing. The  
87 broad purpose is to move from empirical observation to develop theorised understanding.

88 This will produce knowledge that enables us to make recommendations to improve practice,

89 that is, the delivery of mindfulness interventions in schools (1). In this sense, we can locate

90 the main purpose, to build a middle-range theory (2) that identifies the discursive formation

91 in which it is most fruitful to discuss the phenomena (i.e. the ontology within which the results

92 are to be understood), and uses this discourse to model the main underlying mechanisms. It

93 proceeds to explain how they are triggered by the agency of pupils in response to the

94 mindfulness interventions and how these interactions and interconnections make the

95 interventions work (or not and to what extent) in given contexts (schools, neighbourhoods,

96 countries). The findings will enable us to refine the programme theory for research we are

97 carrying out examining the potential for SBMIs to promote the mental wellbeing of children

98 and adolescents. The findings will also support policymakers and others globally to

99 implement policies promoting the mental wellbeing of children and adolescents through

100 SBMIs.

101

102 Poor mental wellbeing is a serious global challenge (3–6), with the lifetime risk of

103 experiencing mental health problems being 28-41% in low-and-middle-income countries and

104 17-49% in high-income countries (6). Income and gender inequalities exacerbate the

105 problem, with women being nearly twice as likely to develop depressive illnesses as men (7).

106 Poor people are likelier to have mental health problems than those better off (8). It is also

107 estimated that just under 50% of adults with mental health issues experienced them before

108 they were 18 and a third before 14 years (9). A life-course approach is, therefore, essential

109 to break the cycle of intergenerational transfer of mental disorders (6,10). Promoting CA

110 mental wellbeing is even more urgent owing to the negative impacts COVID-19 has had on

111 their mental wellbeing, including girls having been more negatively affected than boys (3,11).

112

113 All children have a right to enjoy their childhood, attain their full potential, and lead  
114 productive adult lives (12). The absence of mental wellbeing means we can envisage a 'real'  
115 utopia (13) where the mental wellbeing of all children is promoted. However, the low  
116 prioritisation of mental wellbeing means that children are vulnerable to abuse of their human  
117 rights as set out in the United Nations Convention *on the Rights of the Child* (14). The  
118 benefits of promoting mental wellbeing to children, their families and societies are high,  
119 meaning that there is a strong economic as well as a moral case for promoting their mental  
120 wellbeing (15,16). Improved mental wellbeing improves individuals' quality of life and  
121 productivity, and collective improvements in mental wellbeing reduce healthcare costs.  
122 Schools are seen as an appropriate place to deliver interventions because of how much time  
123 children spend in them and the economies of scale that can be achieved (15,17,18). Such  
124 interventions benefit all children, empower them, are preventative and have some  
125 therapeutic value. The WHO recommends providing mental wellbeing interventions for all  
126 children (19,20).

127  
128 Mindfulness has been identified as an effective intervention for promoting children's mental  
129 wellbeing, as evidenced by systematic reviews and meta-analyses (21–23), especially when  
130 integrated into a whole-school approach (21,24,25). Mindfulness training is relevant for CA  
131 across the spectrum of mental wellbeing (26). SBMIs aim to support the education system  
132 by reducing stress in pupils and teachers, reducing teacher absenteeism and burnout, and  
133 improving pupil learning outcomes. Systematic reviews and meta-analyses of the impact of  
134 SBMIs have shown positive outcomes, including increased prosocial behaviour and  
135 resilience, improved attention, cognitive and socio-emotional skills, and better academic  
136 performance in general, as well as reduced stress. Mindfulness interventions also reduce  
137 teachers' stress levels, improve their mental wellbeing and life satisfaction, and their  
138 relationships with students making classroom environments more conducive to student  
139 learning (27–31). The finding that mindfulness has a positive effect across several outcome  
140 domains has led to calls for the broad introduction of mindfulness in schools (28,31,32). The  
141 consensus is that mindfulness is unlikely to cause harm, and the potential benefits are high  
142 (33,34).

143  
144 Whole-school interventions have the advantage of being relatively inexpensive, non-  
145 stigmatising and inclusive. They can be integrated into the school curriculum and taught by  
146 teachers after a short pre- or in-service training (16). Locating the intervention in schools  
147 recognises that mindfulness is fundamentally relational and only has meaning when it is a  
148 shared social practice (35,36). Whole school interventions also aim to improve the school  
149 climate, create prosocial classrooms, improve pupil-teacher and pupil-pupil relations,

150 increase children's engagement, and support pupil and teacher wellbeing (23,37). Such  
151 interventions aim to create schools where pupils and teachers share a disposition to  
152 mindfulness and a sense of personal control and investment and feel more in control of their  
153 lives. They enable pupils to develop a range of educational skills, including 'the flexible  
154 transfer of skills and knowledge to new contexts, the development of deep understanding,  
155 student motivation and engagement, the ability to think critically and creatively, and the  
156 development of more self-directed learners' (38). SBMIs are then defended against the  
157 charge of commodifying children and producing neoliberal subjects because they bring  
158 about, or can bring about, educational aims and benefits (in addition to socioeconomic ones)  
159 (16,37,39,40).

160  
161 Promising as these findings are, we are left with unresolved issues that limit our ability to use  
162 them. While systematic reviews have indicated promise regarding impacts, there have been  
163 varying outcomes, and not all interventions have been shown to work (41). Mindfulness-  
164 based interventions consist of several elements, vary in theoretical underpinnings, duration  
165 and mode of delivery, and have heterogeneous outcomes (16,42). Most studies are from  
166 Western, high-income countries, most notably the USA and the UK, with few in low-and-  
167 middle-income countries (LMICs). Most notably, the evidence does not indicate *what makes*  
168 *these programmes work, how, where, with whom and to what extent*. Researchers' primary  
169 focus has been asking if mindfulness works rather than how and why it works (43). Most  
170 theories assume that practising mindfulness exercises bring about the observed changes  
171 (44) and that mindfulness is about changing the wiring of the brain and the psychology of  
172 individuals (39,42,44). A scoping review to elucidate the mediators, moderators and  
173 implementation factors in delivering universal mindfulness training in schools (45) identified  
174 mediators and moderators that influenced the outcome of the intervention. These included  
175 the fidelity of the intervention, the dose, the quality, the reach, and the receptivity of the  
176 pupils. However, the analysis is descriptive rather than explanatory. The authors also point  
177 out that few studies of SBMIs report findings from the process evaluation. It concluded that  
178 what is required is higher quality trials that include process evaluation.

179  
180 However, constant conjunction does not explain how mindfulness works, and psychological  
181 theories of mindfulness are inadequate for explaining how an intervention designed to  
182 promote mental wellbeing, a bio-psycho-social phenomenon, works. Evidence, for example,  
183 suggests that group effects are important (46), as suggested by findings from whole-school  
184 interventions (23,37,38). Mindful schools cultivate mindfulness as a disposition that changes  
185 pupil (and teacher) behaviour, thereby improving the school 'climate'. Evidence from low,  
186 middle and high-income countries shows that school climate is important for positive student

187 outcomes, including mental wellbeing, with feedback loops between teachers' improved  
188 mental wellbeing and pupils' (47–49). A realist review of MBIs at the workplace designed to  
189 improve employee wellbeing found that the intervention triggered four mechanisms that  
190 participants were able to use: awareness/self-regulation, acceptance/compassion, feeling  
191 permitted to take care of the self, and a sense of growth and being able to attain goals (44).  
192 Critically, this research also found that a *supportive environment at work* was important,  
193 linking mindfulness practice to specific practice settings and existing goals and practices.  
194 The fear of being seen as non-productive stimulated the adoption of mindful practices and  
195 reduced the extent of non-adherence/dropout.

196  
197 Given the limitations of existing evidence on how SBMIs work, new interdisciplinary  
198 knowledge considering their net effects and investigations of how and why, for whom and  
199 under what circumstances they work (or do not) will provide the necessary evidence for  
200 policy and decision-makers. Such research can generate the knowledge to understand  
201 better what needs to be done to implement SBMIs, so they benefit pupils' and teachers'  
202 mental wellbeing and improve their quality of life. To do so, they must open the black box  
203 and map the complex pathways linking the mindfulness intervention to outcomes. The  
204 conclusion from recent SBMI trials is that this should be a priority for future research (50,51)  
205 rather than the usual recommendation of more trials of higher quality to demonstrate efficacy  
206 definitively. That SBMIs and improvements in child mental wellbeing are correlated in many  
207 instances has established a 'demi-regularity'. It is this demi-regularity that needs to be  
208 explained (52). We need to determine the contexts and agential responses to the  
209 mindfulness interventions that enable them to work for some children in some contexts and  
210 not others.

## 211 Aim and Objectives

212

213 The aims of the review are to:

214

- 215 (a) describe plausible explanations for the effectiveness of mindfulness interventions  
216 designed to promote pupils' wellbeing, and  
217 (b) create transferable theories that can inform programme design and implementation in  
218 different settings.

219

220 To achieve the aim, the objectives are to identify:

221

- 222 • theories about how mindfulness interventions work in schools;

- 223 • the contexts and mechanisms that may facilitate or hinder implementation;
- 224 • how pupils and teachers respond to mindfulness interventions (agency);
- 225 • how school contexts influence the agency of pupils in responding to the mindfulness
- 226 intervention and trigger mechanisms that change the context and lead to outcomes;
- 227 • how the school system changes (roles and relationships), including pupil-teacher
- 228 relations and pupil-pupil-relations;
- 229 • how the school attitudes and values change (culture), and;
- 230 • the outcomes resulting from the interventions.

## 231 Methodology

232

### 233 Introduction

234

235 To achieve our aims and objectives, we will conduct a systematic critical realist review to  
236 identify how mindfulness interventions promote pupils' mental wellbeing. A critical realist  
237 review is explanatory; it seeks to explain how interventions work and generate different  
238 outcomes in different contexts (53,54). We will explore how mindfulness interventions are  
239 supported or inhibited by contextual mechanisms in schools, how CA and teachers respond  
240 to them and the outcomes that result from the interaction between the intervention and  
241 contextual mechanisms and the response of CA and teachers. In doing so, we will identify  
242 the 'demi-regularities', the contexts over time and space in which mindfulness interventions  
243 enable pupils' agency to trigger mechanisms that promote their mental wellbeing (52).  
244 Because critical realism affirms the reality of objects, agents, and mechanisms, which cannot  
245 be viewed directly but only deduced from their effects, it seeks to identify, by retrodiction  
246 and retrodiction, the middle-range interdisciplinary theory that most comprehensively  
247 explains how mindfulness interventions work. Such theories are always open to refinement  
248 in the light of new evidence.

249

250 There is no agreed standard or guide for critical realist reviews, but they are underpinned by  
251 a critical realist meta-theory and draw on some elements of the realist review methodology  
252 of Roy Pawson (1). We have adapted the standard for realist reviews (55,56) and taken into  
253 account recommendations for traditional systematic reviews (57–59). PRISMA offers  
254 transparency, validity, replicability, and updateability (Additional Material 1).

255

### 256 A critical realist research paradigm

257

258 Our methodology is informed by critical realist metatheory (Table 1 defines key critical realist  
259 terms used in this protocol). Critical realism in the social and health sciences is most  
260 frequently associated with the work of Roy Bhaskar (60). It has informed the development of  
261 methods for systematic reviews and impact evaluations that are designed to explain how  
262 and why interventions work in the ways they do (61). However, few systematic reviews and  
263 impact evaluations have used the approach. Understanding how meta-theory can inform  
264 carrying out and reporting on critical realist systematic reviews is still evolving.

265  
266 Critical realism provides guidelines for inter/transdisciplinary research (13,62–64), including  
267 research on promoting wellbeing (13,65). Inter/transdisciplinary research is essential when  
268 considering mental wellbeing. It is a bio-psycho-social phenomenon and requires the  
269 identification of the biological, psychological and social generative mechanisms (65–68). The  
270 outcome of SBMIs are likely due to the complex interaction of neurobiological, cognitive,  
271 psychological, social-structural and cultural mechanisms. The interdisciplinary team must  
272 include researchers with expertise in these disciplines committed to working together to  
273 develop trans-factual middle-range theories of how the intervention works (13).

276

277 **Table 1: Critical Realist Terminology**

<b>Agency</b>	The power of individuals to engage in meaningful actions. Agents have causal powers because they respond to the intervention and, within their context, can trigger mechanisms that change the context.
<b>Abduction</b>	Reinterpreting events into a conceptual framework.
<b>Complexity</b>	Outcomes result from the complex interaction of mechanisms. Therefore, change is non-linear and involves feedback loops.
<b>Context</b>	The context sets limits to the efficacy of a programme intervention. Structures are material, physical, and human resources and associated practices. Culture is the realm of intersubjectivity, social values/ideas, and ideational influences. Contexts are dynamic and can change through agency triggered by the intervention.
<b>Context Mechanisms</b>	The resources and restrictions embedded in the social and organisational (relational) structure that can influence the outcomes and must be identified. They can be physical, social,



	interpersonal, intrapersonal, or conceptual and have causal powers. While they may not be observable, they can be retrodeduced from what is observed.
<b>Culture</b>	Intersubjectivity, ideas and ideational influences.
<b>Demi-regularities</b>	Partial event regularities indicate that an intervention in some contexts triggers mechanisms that result in the same outcome.
<b>Depth Ontology</b>	Reality is stratified into three domains. <ol style="list-style-type: none"> <li>1. The Empirical: experiences of what actually happens;</li> <li>2. The Actual: things that happen independently of whether we observe them or not;</li> <li>3. The Real: constituted by mechanisms with generative power, events, and experiences.</li> </ol>
<b>Emergence</b>	The ability of mechanisms to combine to create something new that cannot be reduced to the mechanisms from which it emerged.
<b>Intervention</b>	The intervention is designed to bring about change in a given context.
<b>Intervention mechanisms</b>	The mechanisms triggered by the experiences, interpretations, and responses to interventions by actors that can change the context mechanisms.
<b>Judgemental Rationalism</b>	The evaluation of competing explanations to identify the one that has the most credible explanation, the one that is most practically adequate.
<b>Laminated System</b>	The social world is understood as an open, complex, stratified (layered) system of objects that make things happen. There are seven layers, from the Global to the sub-individual level, each influencing the other.
<b>Middle-Range Theory</b>	Middle-range theories lie between untestable grand theory and concrete description. They are theories that can generate hypotheses that can be tested and refined through empirical research.
<b>Morphogenic Approach</b>	Based on the view that there are three primary causal powers in society, structure, culture and agency, and that structure and culture necessarily predate the actions that transform them.

<b>Open System</b>	A (social) system where multiple causal factors interact and influence each other, and it is impossible to isolate variables as in laboratory conditions. The multiplicity of mechanisms other than the ones triggered by the intervention means that what happens may not necessarily be what was envisaged.
<b>Outcome</b>	Outcomes are the changes in the context that result from how people respond to the intervention and the contextual mechanisms.
<b>Retrodiction</b>	Determining what mix of mechanisms interact reinforce, moderate, or counteract) to produce the outcomes.
<b>Retrodution</b>	Inferential thinking – what makes the observable phenomena possible, what must the real be like.
<b>Structure</b>	Material, physical, and human resources and their associated practices at the level of social and systems integration, that is, the relations between members of society and the relationship between institutions
<b>Transitive and Intransitive Dimensions</b>	The intransitive dimension is the physical and social world we inhabit; things are as they are and are not constituted by our understanding of them and are independent of how we describe them. The transitive is the theories and discourses we hold in order to understand our world.

279

280 Critical realist research is evolving, and there is no single approach. Critical realism is a  
 281 philosophy of science that in itself explains nothing; it is a meta-theory of how it is possible to  
 282 have scientific knowledge about the social world. What is necessary is to develop an  
 283 explanatory programme. Our approach draws on Margaret Archer's practical morphogenic  
 284 approach (70,71), a methodology that complements Critical Realism's social ontology (72).  
 285 We developed our approach to the literature review, drawing on Porter's and Hind's and  
 286 Dicksons' identifications (from the perspective of critical realism) of the weaknesses of the  
 287 realist approach to systematic reviews based on the work of Ray Pawson (73–75).

288

289 Critical realism is: ontologically realist, arguing that phenomena exist in the social world  
 290 relatively independent of what we know or think about them, and epistemologically  
 291 interpretivist, arguing that the way we come to know about phenomena is context-  
 292 dependent, fallible, prone to individual interpretation, and seen from our angle of vision

293 (61,76). Critical realism rejects Humean' constant conjunctions' that B invariably follows A as  
294 an empirical basis for conceptualising social reality. They argue that correlations are  
295 descriptive and fallible and do not explain how interventions work. Instead, they argue that  
296 there are demi-regularities, and it is how they occur that needs to be explained; that is why  
297 an intervention works in some contexts and not others and for some people and not others  
298 (52). Critical realism is theory-driven and seeks to explain/theorise why things occur in the  
299 way they do, what the (generally hidden) mechanisms are that generate events, recognise  
300 that social systems are open, eliminated and layered and that events are often the outcome  
301 of the complex interaction of mechanisms (75,77–80). The effectiveness of an intervention is  
302 not based only on its inherent qualities but on the action of agents in taking up the  
303 opportunities afforded by the intervention to trigger mechanisms that result in the outcomes  
304 (60,71). Change is non-linear and often involves complex feedback loops (78,79,81,82).  
305 Critical realists are committed to social justice, moving from how things are to how they  
306 should be to improve people's lives enabling fairness in society (83–85). Different contexts  
307 may be more or less supportive of change; therefore, outcomes are context-specific, and all  
308 theories are fallible and open to modification or refutation.

309  
310 Archer's morphogenic approach is the methodological complement to Bhaskar's model of  
311 social transformation (71). She argues that every theory about the social involves  
312 understanding the relationship between structure, agency, and culture (SAC) (Figure 1). She  
313 argues against conflating agency with structure; the context in which we live comprises both  
314 structural and cultural mechanisms, and that these mechanisms are analytically separable  
315 from and necessarily predate the agency which reproduces or transforms them. Structural  
316 and cultural mechanisms are real; they exist independently of us and place limitations on  
317 opportunities for agency. The context in which agents live shapes their beliefs, desires, and  
318 opportunities and limits their agency – context conditioning. However, the interaction  
319 between context and agency shapes and reshapes the context; agency can change the  
320 context (morphogenesis) or reproduce it (morphostasis). There are three morphogenetic  
321 cycles, material, cultural and agency. An intervention such as introducing mindfulness into a  
322 school aims to bring about change by giving pupils and teachers the resources to trigger  
323 mechanisms that can lead to material and cultural change. Their responses to the  
324 intervention are shaped, but not determined, by the context, and individuals generate  
325 outcomes through actions and interactions. When actors trigger new mechanisms (material  
326 and/or cultural), the context changes. However, pupils and teachers can resist, redefine,  
327 repudiate, suspend, or circumvent engagement with the intervention.

331

332 **Methods/Design**

333

334 **Step 1: establishing the scope of the work.**

335

336 The review will focus on SBMIs designed to promote the mental wellbeing of pupils in high-,  
337 middle-and low-income countries. We will document differences between SBMIs  
338 underpinned by different theories, aims, approaches and techniques and delivered differently  
339 for different lengths of time (86,87). The review will also capture other individual differences  
340 and programme characteristics that can impact programme receptivity and impact (24). We  
341 will only include school mindfulness interventions that include mindfulness meditation as a  
342 central pedagogical component (16,88) aimed at improving pupils' behavioural, cognitive  
343 and mental wellbeing outcomes. Nevertheless, outcomes will likely vary by the precise  
344 nature of the mindfulness intervention.

345

346 **Step 2: search for evidence**

347

348 **Search techniques**

349 A rigorous systematic Preferred Reporting Items for Systematic Reviews and Meta-Analysis  
350 (PRISMA) approach will be used to search for literature (89). A PRISMA diagram will show  
351 the steps of the inclusion and exclusion of documents (Additional Material 2). The literature  
352 search will be in three phases: searching electronic databases, searching other sources  
353 such as relevant journals and core publishers, and citation tracking to ensure all relevant  
354 studies are included. The aim is to include as wide a range as possible of academic and  
355 grey literature without restrictions on study type or publication date. No location restrictions  
356 will be applied to gain a wide range of relevant studies internationally in high-, middle- and  
357 low-income countries. Databases that index health, psychology, sociology and/or education  
358 literature will be searched. The search will be restricted to publications in the English  
359 language. The search terms and the databases used are based on the advice of an  
360 academic librarian.

361

362 Twenty-one scholarly databases will be searched: MEDLINE, PsychoInfo, Web of Science  
363 Core Collection, PubMed Central, Google Scholar, Cochrane Library, Proquest, SciELO

364 Citation Index, Embase, Sociological Abstracts, Scopus, Current Content Connected, Child  
 365 Development and Adolescent Studies, British Education Index, Data Citation Index  
 366 (Clarivate), CINAHL, ERIC, Education Abstracts, Education Research Abstracts,  
 367 IngentaConnect, and JSTOR.  
 368  
 369 Seven databases will be used to search for the grey literature: the Bielefeld Academic  
 370 Search Engine, OpenGrey, PsycEXTRA, ProQuest Dissertations and Theses, Grey Matters,  
 371 ResearchGate, Academia.edu, and the Social Science Research Network.  
 372  
 373 For books and book chapters, the websites of eight academic publishers will be searched,  
 374 Routledge (Taylor & Francis), Palgrave Macmillan, Springer, Elsevier, Wiley, SAGE, Oxford  
 375 University Press and Cambridge University Press.  
 376  
 377 The Search terms will be: 'mindfulness' or 'mindful' or 'mindfulness-based cognitive therapy'  
 378 or MBCT or MBSR and 'school' or 'whole school' or 'school-based' or 'educational context'

### 385 **Inclusion/exclusion criteria**

#### 386 **Inclusion**

- 387 • Study design: all published study types reporting empirical research but excluding
- 388 literature reviews and meta-analysis. (The references of literature reviews and meta-
- 389 analyses will be scrutinised to ensure that all studies are included in the review. We
- 390 will also record their main conclusions on a separate extraction table).
- 391 • Documents: from any country or region.
- 392 • Publication date: any.
- 393 • Document type: any document type that will inform the review.
- 394 • Population: children aged 7-16 years participating in a SBMI.
- 395 • Intervention: includes mindfulness meditation as a central pedagogical component
- 396 and aims to improve behavioural, cognitive, and mental wellbeing outcomes.
- 397 • Language: English.

398

#### 399 **Exclusion**

- 400 • Only includes special needs schools.
- 401 • Therapeutic interventions targeted at pupils with mental health problems.
- 402 • Only includes meditation, with mindfulness meditation not being a central
- 403 pedagogical component.
- 404 • Only includes yoga.
- 405 • Only includes pupils outside the 7-16 years age group.
- 406 • In languages other than English.

407

#### 408 **Article screening**

409 *Covidence* will be used to manage article screening and data extraction.

- 410 1. Remove duplicates and citations without abstracts or summaries;
- 411 2. Two reviewers (PA and IS) will review the titles and abstracts of all retrieved
- 412 documents captured by our search strategy and code them as 'potentially relevant'
- 413 and 'not relevant'. Any disagreements will be resolved by discussion or, if necessary,
- 414 bringing in a third reviewer (LD);
- 415 3. Download the full text of potentially relevant documents.

416

### 417 Step 3: document appraisal and data extraction

418

419 Extract information from the documents that potentially meet our inclusion criteria into an  
420 Excel spreadsheet:

- 421 1. Document details – title, authors, year of publication, location of study;
- 422 2. Country, income group (low, lower-middle, upper-middle, high) and main religion(s);
- 423 3. The mindfulness intervention description – the type of MBI, trainers, design,  
424 aim/purpose, length of training;
- 425 4. Sample characteristics- age of pupils, sex/gender, socioeconomic status, ethnicity,  
426 type of school;
- 427 5. The study design and if it is fit for purpose (quality/rigour);
- 428 6. Rational for SBMI, including any social justice framing;
- 429 7. Contextual factors (mechanisms) before the intervention was introduced;
- 430 8. Proximal outcomes measured;
- 431 9. How proximal outcomes were measured;
- 432 10. Outcomes;
- 433 11. Agency;
- 434 12. Generative mechanisms triggered by the intervention that could have supported  
435 change (positive mechanisms);
- 436 13. Generative mechanisms triggered by the intervention that could have  
437 restricted/prevented change (negative mechanisms);
- 438 14. Contextual mechanisms that could have supported change (positive mechanisms);
- 439 15. Contextual mechanisms that restricted/prevented change (negative mechanisms);
- 440 16. Any theoretical explanations identified for explaining the outcomes and the level of  
441 the explanation that is, biological, psychological, or social;
- 442 17. Changes in context following the introduction of the mindfulness intervention.

443

444 The extraction tool will be piloted. PA, LD, IS and GN will independently read two documents  
445 and complete the extraction table. They will then meet, compare their extraction tables, and  
446 agree on any necessary modifications.

447

448 PA will extract all information. PA will remove any documents containing insufficient relevant  
449 data to inform how and why the intervention worked (or did not work) and/or not using  
450 credible and trustworthy methods. Documents will be considered relevant if they can help to  
451 answer the research questions; that is, they report findings from research on SBMIs. They  
452 will be included as credible if the methods used are adequate for generating the findings;

453 documents will be excluded if they are not based on credible research or are purely  
454 anecdotal. The reasons for the exclusion of any document will be noted. A critical realist  
455 synthesis does not require that two independent reviewers complete screening for quality or  
456 data relevance. However, LD will review any documents PA identifies as not contributing or  
457 not using credible and trustworthy methods, with differences being resolved by discussion  
458 and, if necessary, by bringing in a third reviewer, GN.

459  
460 We will provide a descriptive narrative summary of the findings from this stage of the review.

461

## 462 Step 5: Analysis and Reporting

463

464 The analysis will aim to identify a middle-range interdisciplinary theory that explains how  
465 mindfulness interventions work in schools to promote pupils' mental wellbeing. It will open  
466 the black box and identify the mechanisms the mindfulness interventions triggered that  
467 explain how the intervention caused the reported outcomes (Figure 2). An interdisciplinary  
468 middle-range theory will then be developed that explains how mindfulness interventions  
469 work, recognising that outcomes will likely differ in different contexts.

470

472

473 The analysis will follow the critical realist stages of analysis for applied interdisciplinary  
474 research, Resolution, Redescription, Retrodiction, Elimination, Identification, Correction  
475 (RRREIc) (Table 3) (13,90). Mental wellbeing is the outcome of a complex interaction of bio-  
476 psycho-social mechanisms. An adequate explanation of how mindfulness interventions  
477 impact children's mental wellbeing must be interdisciplinary (65). The framework consists of  
478 six steps to build transdisciplinary accounts of phenomena. These are: (1) break down  
479 complex events into component parts and identify disciplinary explanations of impact; (2)  
480 redescribe impacts in mono-theoretically meaningful ways; (3) use retrodiction to identify  
481 trans-factual theories that explain the ways the mechanisms interact to produce outcomes;  
482 (4) eliminate alternative competing hypotheses; (5) identify the most comprehensive  
483 explanation; (6) refine scientific knowledge in light of (provisional) findings (91).

487 To do this, we will first build CAIMOs for each mechanism identified (92). This will involve a  
 488 detailed and systematic analysis based on the outcome patterns, context, agency,  
 489 interventions, mechanisms triggered by agency, and outcomes: the CAIMO configuration  
 490 (Figure 4). The four critical realist evaluation categories are the context before the  
 491 intervention, the children's agency, the mechanisms triggered by children's (and teacher's)  
 492 agency and the outcomes. Agency is pupils' (and teachers') responses to the mindfulness  
 493 interventions, mechanisms are triggered by agency and enable pupils (and teachers) to  
 494 benefit from the intervention, and the pre-existing structures and culture are the contextual  
 495 conditions that facilitate or inhibit pupils' potential to benefit from the intervention (see Figure  
 496 3).

497

498 Outcomes patterns are the mental wellbeing outcomes pupils experience from participating  
 499 in SBMIs. Within each category, findings will be broken down thematically and reported  
 500 narratively to distinguish between different contexts, agency responses, mechanisms

501 triggered, and outcomes (Figure 4). The key themes that describe processes and causal  
502 mechanisms for explaining mindfulness intervention outcomes in schools will then be  
503 identified. Hypothetical links will then be made between the CAIMO themes, creating  
504 potential pathways that account for the impacts of school-based mindfulness interventions  
505 on pupils and why, for whom and under what circumstances these impacts occur.

506

508 However, to take account of complexity, it is necessary to develop a non-linear pathway of  
509 change showing how the complex interaction of mechanisms (context mechanisms that  
510 predate the intervention and those triggered by the intervention) leads to the observed  
511 outcomes (Figure 4) (75,79,80,93). To do this, we will use feedback loop diagrams to model  
512 change, showing both mechanisms triggered by the intervention that cause change, those  
513 already in the context that supported change (+ve mechanism) and those already in the  
514 context and mechanisms triggered by the intervention that restricted or prevented change (-  
515 ve mechanisms). Outcomes will likely be more complex than a dichotomy between  
516 morphogenesis (structural change) and morphostasis (structural reproduction).

## 519 **Ethics**

520

521 Formal ethics approval is not required for a literature review. However, ethical approval has  
522 been obtained from the University of Aberdeen, Addis Ababa University, and the University  
523 of Rwanda for the research programme, of which the critical realist review forms an integral  
524 element.

## 525 **Dissemination**

526

527 We will publish at least one article in a peer review journal reporting the findings from the  
528 literature review, conforming to RAMESES publication standards (56) and a policy brief  
529 intended for policymakers with the target audience including WHO, UNESCO, UNICEF and  
530 the UK and Scottish Governments. Findings from the review will be disseminated via an  
531 article in the Conversation, seminar and conference presentations, and podcasts posted on  
532 the project website and disseminated by social media.

## 533 Discussion

534

535 Our review will be the first critical realist (or realist) review of the literature on mindfulness  
536 interventions in schools. In the review, we aim to identify the generative mechanisms and  
537 social structures that explain how and why school-based mindfulness interventions promote  
538 the mental wellbeing of CA. This will enable policymakers and school leaders to understand  
539 under what circumstances school-based mindfulness interventions promote CA mental  
540 wellbeing and for which CA they work.

541

542 The main challenges are likely to be that: most studies will have been carried out in high-  
543 income countries, so we will not be able to identify critical context elements and relevant  
544 mechanisms that are unique to low-and-middle-income countries; there will be little  
545 information in the documents on the context and; the documents may not include details of  
546 the theoretical reasoning underpinning their intervention to enable us to develop middle-  
547 range theories.

548
