


Figure 1. The relationship between age delta, predicted age and chronological cardiovascular age in the hypertension cohort. (a) Predicted and chronological cardiovascular age. (b) Delta and chronological cardiovascular age. Ages jittered, density contours, linear model with 95% confidence intervals, and a marginal density plot, (n=1330).

Description of graph and dense neural networks




Figure 2. Details of the graph neural network structure, where nodes are transformed using a concatenation of constant, position and FPFH features transformations, while edge attributes are generated as spherical coordinates of the edges.

In Figure 2, we present the details of the graph neural network structure, where nodes are transformed using a concatenation of constant (preserve the original nodes as coordinates), position and Fast Point Feature Histograms features transformation, while edge attributes are generated as spherical coordinates of the edges.




Figure 3. Details of the dense neural network structure.

Age delta estimation

To obtain the age-delta estimate, we first predict age for both healthy and hypertension groups, and apply a bias correction procedure to the predictions (Algorithm 1). We next perform propensity matching by age and sex in the healthy and hypertension groups (n = 1044 in each group). We next fit a linear regression model where the predicted age is modelled as the response variable and the indicator function of whether the participant has hypertension or not is a covariate. For each covariate, we present the coefficient, standard error as well as the z-score, and the *P* value and confidence intervals. The heart of a person with hypertension has a biological age that is Δ years older than that of a healthy person, where $\Delta = 4.19$ for females and $\Delta = 4.19 - 2.57 = 1.62$ for males.




Figure 4. Explainability using saliency maps. Explanability algorithm using saliency maps when predicting age for averages meshes over **A** all of healthy participants and **B** all of hypertensive participants. Darker regions indicate higher importance levels.
