Title: Lower Dynamic Cerebral Autoregulation following Acute Bout of Low-Volume

High-Intensity Interval Exercise in Chronic Stroke Compared to Healthy Adults

1 Abstract

Fluctuating blood pressure during high-intensity interval exercise (HIIT) may challenge dynamic 2 3 cerebral autoregulation (dCA), specifically post-stroke after an injury to the cerebrovasculature. We hypothesized dCA would be attenuated at rest and during a sit-to-stand, immediately 4 following and 30 min after HIIT in individuals post-stroke compared to age- and sex-matched 5 6 controls (CON). HIIT switched every minute between 70% and 10% estimated maximal watts 7 for 10 min. Mean arterial pressure (MAP) and middle cerebral artery blood velocity (MCAv) 8 were recorded. Resting dCA measured spontaneous fluctuations in MAP and MCAv via transfer function analysis. For sit-to-stand, time delay before an increase in cerebrovascular conductance 9 index (CVCi = MCAv/MAP), rate of regulation, and %change in MCAv and MAP were 10 11 measured. Twenty-two individuals post-stroke (age 60±12 yrs, 31±16 months) and twenty-four CON (age 60±13 yrs) completed the study. VLF gain (p=0.02, η^2 =0.18) and normalized gain 12 $(p=0.01, \eta^2=0.43)$ had a group-by-time interaction, with CON improving immediately and 30 13 min after HIIT. Individuals post-stroke had impaired VLF phase (p=0.03, $n^2=0.22$) immediately 14 15 following HIIT compared to CON. We found no differences in the sit-to-stand. Our study showed lower resting dCA up to 30 min after HIIT in individuals post-stroke compared to CON 16 17 while the sit-to-stand response was maintained. 21 Introduction

Dynamic cerebral autoregulation (dCA), or the cerebral vasculature's ability to react to 22 rapid changes in mean arterial pressure (MAP),¹⁻³ is impaired after stroke,⁴⁻⁸ At rest, dCA can be 23 24 quantified using transfer function analysis using spontaneous fluctuations in MAP and cerebral artery blood velocity, to obtain gain (amplitude of cerebral blood velocity change for a given 25 oscillation in MAP) and phase (difference in the timing of the MAP and cerebral blood velocity 26 27 waveforms) metrics. dCA also responds to changes in MAP during everyday activities, such as standing up from a seated position.³ During a sit-to-stand, there is a transient drop in MAP, due 28 to gravity and venous pooling. dCA then responds prior to the activation of the arterial baroreflex 29 through an increase in cerebrovascular conductance index (CVCi).³ However, the effects of 30 aerobic exercise on the dCA response in individuals post-stroke with impaired dCA are 31 unknown.9 32 It is important to examine the ability of the cerebrovascular system to react to changes in 33 MAP after aerobic exercise,^{10, 11} as dCA post-stroke may be less effective at buffering 34 fluctuations in MAP, potentially leaving the brain less protected.¹² In individuals with a pre-35 existing injury to the cerebrovascular system such as stroke, the dCA response should be an 36 important factor in prescribing aerobic exercise and determining post-exercise recovery care.¹² 37 Specifically, one type of aerobic exercise, which may influence dCA and has gained in 38 popularity for individuals post-stroke, is high-intensity interval exercise (HIIT).¹³⁻¹⁵ 39 HIIT may challenge dCA due to the rapid fluctuations in MAP when switching between 40 high-intensity exercise and recovery.^{10, 11, 16} Despite multiple narrative reviews suggesting HIIT 41 may attenuate dCA to a larger degree in individuals with a cerebrovascular injury such as stroke 42

43 compared to healthy adults,¹⁰⁻¹² HIIT is starting to be implemented within stroke rehabilitation to

44 improve motor outcomes.^{13, 15, 17} Therefore, we need to fill the gaps in knowledge on the effects
45 of low-volume HIIT on cerebrovascular health and the dCA response in individuals with chronic
46 stroke, specifically after exercise.¹²

47 While no studies have examined dCA after an acute bout of HIIT in individuals poststroke,⁹ prior work in healthy adults reported dCA was less effective during repeated squat-48 stands following HIIT.¹⁸ During exercise recovery following HIIT, MAP decreases^{16, 19} which 49 50 could challenge the dCA response, as dCA seems less effective at buffering decreases compared to increases in MAP at rest.²⁰ During recovery following moderate to vigorous intensity 51 continuous exercise in healthy adults, dCA at rest has been shown to be effected immediately 52 following exercise and recover by 30 min.^{21, 22} However, the dCA response may take longer than 53 30 min to recover in individuals post-stroke potentially due to post-exercise hypotension and 54 prolonged recovery of MAP.¹² Recovery of end tidal carbon dioxide (P_{ET}CO₂) may also 55 influence cerebral blood velocity following HIIT²³ in individuals post-stroke compared to 56 healthy adults¹⁹ and could also play a role in the dCA response during recovery.^{16, 24, 25} 57 58 To address these critical gaps in knowledge, we characterized the dCA response using spontaneous fluctuations in MAP and middle cerebral artery blood velocity (MCAv) as well as 59 during a single sit-to-stand following an acute bout of low-volume HIIT in individuals with 60 chronic stroke compared to age- and sex-matched adult controls (CON). We hypothesized that 61 individuals with chronic stroke would have attenuated dCA initially following HIIT as well as 62 during a follow-up at 30 min after HIIT, compared to CON. We also hypothesized that P_{ET}CO₂ 63 during recovery following HIIT would influence the dCA response. 64

65 Material and Methods

66 The University of Kansas Medical Center Human Subjects Committee approved all study procedures and the Declaration of Helsinki and local statutory requirements were followed. This 67 study was registered on clinicaltrials.gov (NCT04673994) and STROBE guidelines reported. 68 Our methods have been described previously.^{16, 19} Individuals with stroke were included 69 within this study if they were: 1) between 40-85 years old, 2) treated for stroke 6 months to 5 70 years ago, 3) classified as inactive by performing <150 min of moderate intensity exercise per 71 72 week, and 4) able to answer consenting questions and follow a 2-step command. Individuals 73 within the CON group were matched to the sex and age ± 5 years of an individual post-stroke and also classified as inactive. Individuals were excluded from the study if: 1) stroke etiology 74 75 was due to COVID-19, 2) they were unable to stand from a chair without physical assistance from another person, 3) they were unable to perform exercise on a recumbent stepper, 4) 76 77 diagnosed with insulin-dependent diabetes, 5) diagnosed with another neurological disease, or 6) we were unable to find a transcranial Doppler ultrasound (TCD) signal on left or right side. 78 Study Visit 1 79 80 All participants were informed of study procedures, benefits, and risks before providing voluntary written consent. We then collected participant demographics, current medications, 81 prior medical history, and self-reported disability via the modified Rankin scale (mRS).²⁶ Lower 82 extremity function in individuals post-stroke was assessed using the Fugl Meyer Lower 83 Extremity Subscale and the 5 Times Sit-to-Stand Assessment.^{27, 28} We then screened for an 84 MCAv signal on both the left and right side using TCD probes (2-MHz, Multigon Industries Inc, 85 Yonkers, New York). TCD signal acquisition was performed following standard depth, gain, and 86 power.²⁹ The position of the probes were recorded on *study visit 1* to ensure accurate signal 87

power. The position of the proces were recorded on sindy visit 1 to ensure decidate s

acquisition on *study visit 2* when recordings were performed.

89 <u>Submaximal Exercise Test</u>

90	As previously reported, ^{16, 19} the total body recumbent stepper (TBRS, T5XR NuStep, Inc.			
91	Ann Arbor, MI) submaximal exercise test was used to determine the estimated maximal watts			
92	(estimatedWatt _{max}) for the acute HIIT bout. ^{30, 31} If individuals were on a beta blocker medicatio			
93	maximum HR was determined using the beta-blocker equation $(164 - (0.7 * age))$.			
94	Exercise Familiarization			
95	The low-volume HIIT exercise familiarization was performed at least 15 min after the			
96	TBRS submaximal exercise test or once HR and MAP returned to near baseline values. Based on			
97	previously published low-volume HIIT protocols in older adults and clinical populations, low-			
98	volume HIIT was dosed at 70% estimated Watt _{max} and active recovery at 10%			
99	estimatedWattmax. ^{15, 32-37} Participants practiced switching between high-intensity exercise and			
100	active recovery bouts every min for approximately 10 min.			
101	Study Visit 2			
102	Following our laboratory protocols, the room was dimly lit and kept at a constant			
103	temperature (21 - 23°C). ^{16, 38} All participants were asked to refrain from caffeine for 8 hours, ³⁹			
104	food for 2 hours, ⁴⁰ vigorous exercise for 24 hours, ¹⁸ and alcohol for 24 hours. ⁴¹			
105	Equipment Set-Up			
106	Participants were seated on a recumbent stepper and fitted with the following equipment:			
107	1) bilateral TCD probes were secured to an adjustable headset to ensure a stable position and			
108	angle to measure MCAv throughout testing, 2) a 5-lead electrocardiogram (ECG; Cardiocard,			
109	Nasiff Associates, Central Square, New York) to collect HR, 3) a left middle finger Finometer			
110	cuff (Finapres Medical Systems, Amsterdam, the Netherlands) to measure beat-to-beat MAP, 4)			
111	a right arm brachial automated sphygmomanometer with a microphone (Tango M2; Suntech,			

112	Morrisville, NC) for calibration of the Finometer, and 5) a nasal cannula attached to a
113	capnograph (BCI Capnocheck Sleep 9004 Smiths Medical, Dublin, Ohio) for $P_{ET}CO_2$
114	monitoring. In individuals post-stroke with left arm spasticity, the Finometer was placed on the
115	right arm.
116	Cerebral Autoregulation Measures
117	To quantify spontaneous dCA metrics, participants performed a 5-min seated rest
118	recording 1) at BL, 2) immediately following HIIT and 3) 30 min after HIIT while capturing
119	MCAv, MAP, HR, and $P_{ET}CO_2$ (Figure 1).
120	Using a sit-to-stand procedure, we recorded MCAv, MAP, HR, and $P_{ET}CO_2$ and
121	quantified dCA, based on our previously published methodology, 1) at BL, 2) following 5 min of
122	passive recovery after HIIT, and 3) 35 min after HIIT. ⁴² Participants placed the hand with the
123	Finometer across their chest and a sling was used to secure the arm at heart-level during the sit-
124	to-stand recording. ⁴² Participants placed their feet flat on the ground, sat in an upright posture,
125	and had a force-sensitive resistor (SEN-09376, Mouser Electronics Inc., Tx) to detect the exact
126	moment of stance from the chair or the moment of arise-and-off (AO). ⁴² The sit-to-stand
127	recording lasted a total of 3 minutes (see Figure 1). Individuals began in a seated position for 1
128	min and then were given a 3-s countdown and asked to quickly transition to standing at 60-s and
129	remained standing for 2 min for hemodynamic stability. Study personnel were standing next to
130	the participants during the sit-to-stand transition. Initial orthostatic hypotension (within 15 s of
131	standing) was determined by a drop of systolic blood pressure >40 mmHg and a drop in diastolic
132	blood pressure >20 mmHg as well as symptoms of dizziness, blurry vision, nausea, or weakness
133	with standing. ⁴³⁻⁴⁵

134 <u>Low-Volume HIIT Protocol</u>

Repetitive 1-min intervals of high-intensity exercise (70% estimatedWatt_{max}) separated 135 by 1-min active recovery bouts (10% estimated Watt_{max}) were performed for 10 min.^{16, 19} The 136 first minute of HIIT was an active recovery bout, to avoid a Valsalva Maneuver, which would 137 cause a transient decrease in MCAv.⁴⁶ Following HIIT, resistance and step rate were decreased 138 for a 2-min cool-down. 139 Data Acquisition 140 Data was collected at 500 Hz via an analog-to-digital unit (NI-USB-6212, National 141 Instruments) and custom-written code within MATLAB (v2014a, TheMathworks Inc, Natick, 142 Massachusetts).³⁸ Beat-to-beat data was processed offline using the ORS complex of the ECG.³⁸ 143 144 The left MCAv signals for CON was used for analysis. However, if left MCAv was not

145 obtainable or had noise, the right MCAv signal was used.³⁸ In individuals post-stroke, the

146 ipsilesional hemisphere's MCAv signal was used to compare to CON.

147 <u>Transfer Function Analysis</u>

Quantification of spontaneous TFA metrics followed the recommendations of the 148 Cerebrovascular Research Network (CARNet).^{47, 48} The 5-min seated rest recordings were 149 computed to cross spectral analysis via fast Fourier transform utilizing Welch's method, 100-s 150 151 Hanning windows, and 50% superposition. Waveforms of MAP and MCAv were analyzed via 152 TFA and described through gain (amplitude), phase (shift in radians), and coherence (association). Due to dCA acting as a high-pass filter, measures of gain, phase, coherence, and 153 power spectral density (PSD) of the integrate area were reported within very low frequency (0.02 154 -0.07 Hz) and low frequency (0.07 - 0.2Hz) bands. Following CARNet recommendations, the 155 critical threshold of coherence was set at 0.34.⁴⁷ Coherence determined whether estimates of gain 156 and phase were reliable and could be compared across time.⁴⁷ We visually inspected our data for 157

158	phase wrap-around and if detected these data points were removed. ⁴⁷ Attenuated dCA was
159	interpreted as higher gain (greater differences in amplitude) and lower phase (smaller shift)
160	following HIIT compared to baseline.
161	Sit-to-Stand Analysis
162	Metrics of dCA included the time delay (TD) before the onset of the regulatory response,
163	rate of regulation (ROR), percent change in MCAv (Δ MCAv), percent change in MAP
164	(% Δ MAP), and the ratio of % Δ MCAv/% Δ MAP. To measure the TD before the onset of the
165	regulatory response, beat-to-beat CVCi was calculated (CVCi = MCAv/MAP). Based on
166	previously published methods, ^{2, 42} 2 trained researchers selected the physiological heart beat
167	when CVCi began to increase (without immediate transient reduction). ² The TD before the onset
168	of the regulatory response was calculated as the time in s from AO until the continuous increase
169	in CVCi. The ROR was used to determine the efficiency of the regulatory response, by
170	calculating the slope of the 3 heart-beats following TD (ROR = $\Delta CVCi/\Delta t/\Delta MAP$). ² The ROR is
171	taken within phase 1 of the sit-to-stand response (1-7 s after standing), prior to the onset of the
172	arterial baroreflex response. ^{3, 43} The % Δ MCAv and % Δ MAP were calculated from the seated
173	baseline (15 s prior to AO) to nadir (the lowest value of MCAv and MAP after standing).
174	$\%\Delta = ((\text{seated baseline} - \text{nadir}) / \text{seated baseline}) * 100$
175	An attenuated dCA response was interpreted as a longer TD before the onset of the regulatory
176	response and smaller ROR, greater % Δ MCAv and a higher ratio of % Δ MCAv/% Δ MAP. ^{2, 43}
177	Statistical Analysis
178	A Shapiro-Wilk test was used to verify the assumptions of normality and a priori α was
179	set at 0.05. Participant characteristics were compared using an independent t-tests for continuous
180	variables or the Mann-Whitney U tests for non-normally distributed continuous variables.

181	Categorical variables were compared using a Chi-square. Baseline differences between groups			
182	were compared using an independent t-tests. The primary aim of this study was to examine dCA			
183	during spontaneous fluctuations at rest and during a sit-to-stand: 1) at BL, 2) following HIIT, and			
184	3) at a follow up 30 min after HIIT in individuals post-stroke compared to CON. Mixed-model			
185	ANOVAs were used to determine group, time, and group by time interaction effects. Post-hoc			
186	comparisons used one-sided t-tests. As a sensitivity analysis, we controlled for $P_{ET}CO_2$ after			
187	HIIT within the mixed model ANOVAs.			
188	Results			
189	Sixty individuals were enrolled within the study. Forty-six individuals were included in			
190	the primary analysis: individuals post-stroke ($n = 22$) and CON ($n = 24$), shown in Figure 2 .			
191	Participant characteristics are described in Table 1 and have been published in part			
192	within our previous work. ^{16, 19} Briefly, individuals post-stroke had a significantly slower 5x sit-			
193	to-stand, lower average workload at high-intensity, and lower workload during active recovery			
194	compared to CON. Individuals post-stroke had slight-to-moderate disability as shown by the			
195	mRS and lower extremity Fugl-Meyer sub score.49			
196	Dynamic Cerebral Autoregulation during Spontaneous Fluctuations in MAP and MCAv			
197	Twenty-two individuals had complete TFA data sets across all 3 timepoints, shown in			
198	Table 2. The reduction in TFA sample size is common and occurs due to reduced coherence			
199	within the VLF range, ⁴⁷ which could be attributed to non-linearity. ⁵⁰ At BL, there was no			
200	significant differences between groups in all measures. MAP PSD and MCAv PSD within the			
201	VLF and LF range were also not different between groups or across time.			
202	Our primary analysis showed a significant group by time cross-over interaction effect for			
203	VLF gain ($\eta^2 = 0.18$) and VLF normalized gain ($\eta^2 = 0.43$), with the CON group having			

204	decreased VLF gain and normalized gain immediately following HIIT and 30 min after HIIT
205	compared to BL. While average VLF gain and normalized gain in individuals post-stroke
206	changed in the opposite direction of CON following HIIT, creating a cross-over interaction, there
207	was no significant within-group differences across time. There was also a significant group effect
208	for VLF phase ($\eta^2 = 0.22$), with individuals post-stroke having lower VLF phase compared to
209	CON immediately following HIIT ($p = 0.01$), and returned to being not significantly different
210	between groups at 30 min after HIIT. Finally, there was a linear time effect for LF normalized
211	gain, where CON individuals had reduced normalized gain at 30 min following HIIT compared
212	to BL ($p = 0.03$).
213	Our sensitivity analysis showed that when controlling for reductions in $P_{ET}CO_2$ after
214	HIIT, the group by time interaction remained for VLF gain ($p = 0.01$) and VLF normalized gain
215	(p = 0.004). The group effect for VLF phase $(p = 0.046)$ also remained when controlling for
216	$P_{ET}CO_2$. However, the time effect for LF normalized gain (p = 0.56) was no longer significant
217	when controlling for $P_{ET}CO_2$. The transfer function analysis across the frequency ranges (0.02 –
218	5 Hz) in individuals with chronic stroke compared to CON are shown in Figure 3 .
219	Sit-to-Stand Measures of Dynamic Cerebral Autoregulation
220	There were no significant group or time effects on the sit-to-stand measures of dCA
221	following HIIT in individuals post-stroke compared to CON, shown in Table 3. When
222	controlling for seated $P_{ET}CO_2$ after HIIT, there were still no group or time effects for TD onset,
223	ROR, $\Delta MCAv$, ΔMAP , or $\Delta MCAv/\Delta MAP$.
224	Figure 4 shows the CVCi response during the sit-to-stand at BL in individuals post-
225	stroke compared to CON. Monitoring of beat-to-beat MAP during the sit-to-stand allows for the
226	detection of initial orthostatic hypotension, defined by the literature as a decrease in systolic

227 blood pressure >40 mmHg and/or diastolic blood pressure >20mmHg within 15 s after standing as well as symptoms of dizziness or syncope.⁴⁵ These values differ from the clinical thresholds of 228 delayed orthostatic hypotension (systolic >20mmHg and/or diastolic >10mmHg) taken after 3-229 min of standing.⁵¹ We report that no individuals met the criteria of initial orthostatic hypotension 230 (having both decreases in blood pressure and symptoms of cerebral hypoperfusion)⁴⁵ during our 231 study. However, following HIIT, three CON individuals met the criteria for initial drops in blood 232 233 pressure upon standing but reported no symptoms of dizziness. At 35-min after HIIT, 2 different 234 CON individuals met the criteria for an initial drop in blood pressure upon standing. While no 235 individuals post-stroke met the blood pressure thresholds of drops of >40mmHg systolic or 236 diastolic >20mmHg upon standing, one individual post-stroke reported slight dizziness upon standing at baseline (lasting < 3 s) and another individual post-stroke reported slight dizziness 237 238 upon standing (lasting <3 s) following HIIT.

239 Discussion

Our findings collectively show that while dCA was not different at baseline between 240 241 individuals with chronic stroke and their age- and sex-matched peers, dCA was lower during spontaneous fluctuations in MAP and MCAv immediately following HIIT. While various 242 reviews have outlined the importance of examining the dCA response to HIIT in individuals 243 post-stroke,¹⁰⁻¹² our study is the first to show: 1) individuals post-stroke had lower VLF phase 244 immediately following HIIT compared to CON, and 2) VLF gain and normalized gain had a 245 246 cross-over interaction effect in which CON individuals had a significant decrease in gain 247 immediately following HIIT and 30 min after HIIT compared to BL while TFA gain in individuals post-stroke increased. Reductions in PETCO2 following HIIT only accounted for the 248 249 significant difference in LF normalized gain. Interestingly, while dCA was lower following HIIT

250 during spontaneous MAP and MCAv fluctuations, our study did not find differences in the sit-to-

stand dCA response between individuals post-stroke and CON, even when controlling for

252 P_{ET}CO₂. Therefore, dCA in individuals post-stroke may maintain the ability to respond to a

single drop in MAP upon standing, after 6 min of seated rest recovery following HIIT.

254 Spontaneous Dynamic Cerebral Autoregulation

While previous systematic reviews have reported impaired resting dCA in individuals 255 post-stroke compared to controls,⁵² our results did not show a difference between groups at 256 257 baseline. Most of the previous studies reporting impaired dCA in individuals post-stroke were 258 conducted during the acute stage (1-7 days post) and subacute stage (7 days - 6 months) poststroke.⁵³⁻⁵⁵ To our knowledge, only 1 other study has examined dCA in the chronic stage (≥ 6 259 260 months) post-stroke and reported decreased resting phase (within 0.06 - 0.12 Hz) at exactly 6months post-stroke compared to healthy controls.⁵⁶ However, our study found no difference in 261 resting BL dCA between individuals 31 ± 16 months post-stroke and their age- and sex-matched 262 peers. This could be due to differences in supine vs. seated rest recordings, TFA frequency 263 ranges utilized, or the chronicity of stroke. It is possible that dCA at rest during spontaneous 264 blood pressure oscillations may continue to recover within the chronic stage post-stroke.⁵² 265 266 To show differences in dCA between individuals with chronic stroke and healthy adults, 267 the cerebrovascular system may need to be hemodynamically challenged, such as with an acute 268 bout of HIIT. We show that immediately following HIIT, dCA during spontaneous MAP and 269 MCAv fluctuations was lower in individuals post-stroke compared to CON, with lower VLF phase and increased VLF gain and normalized gain. Lower VLF phase immediately following 270 271 HIIT in individuals post-stroke compared to CON can be interpreted as dCA being less efficient at buffering the cerebrovascular system from changes in peripheral blood pressure.⁵⁷ The cross-272

over interaction in VLF gain and normalized gain shows that while CON individuals had significant improvements in the ability of the cerebrovasculature to dampen the amplitude changes in MAP fluctuations⁵⁷ immediately following HIIT and 30 min after HIIT, individuals post-stroke had a reduction in the cerebral vessels' dampening ability. Even when controlling for changes in P_{ET}CO₂, the differences in dCA between groups during recovery were maintained within the VLF range.

279 Lower dCA in individuals post-stroke, quantified via TFA immediately following HIIT, could be due to dCA's sensitivity to decreasing MAP.^{19, 58, 59} Previous studies have shown that 280 dCA at rest²⁰ and during repetitive squat-stands⁵⁸⁻⁶⁰ was less efficient at regulating decreases in 281 MAP in comparison with MAP increases, and HIIT may exacerbate this directional sensitivity in 282 healthy adults.⁶¹ It is unknown whether individuals post-stroke have lesser dCA sensitivity to 283 284 decreasing MAP compared to CON, however, this could potentially explain the differences between groups found immediately following HIIT. However, when forcing blood pressure to 285 286 decrease using a single sit-to-stand following HIIT, we did not find any differences in the 287 cerebral pressure-flow relationship in individuals post-stroke. Previous studies have also shown that blood pressure medications such as beta-blockers and calcium channel blockers may 288 attenuate dCA.⁶²⁻⁶⁵ Our study reports individuals post-stroke had greater beta-blocker use and 289 290 trended toward greater calcium channel blocker use compared to CON. While we did not directly measure the effects of blood pressure medications on dCA, they could have also contributed to 291 292 the lower dCA response in individuals post-stroke following HIIT.

293 <u>Sit-to-Stand Dynamic Cerebral Autoregulation Response</u>

There were no differences between individuals post-stroke and CON in the sit-to-stand dCA response at BL and after HIIT. We did not find a significant change in the TD before the

296	onset of dCA or the ROR response in individual post-stroke following HIIT compared to CON.
297	Therefore, the temporal response of increasing CVCi during a sit-to-stand was maintained
298	following HIIT in individuals post-stroke. A previous study in healthy adults has shown that the
299	initial dCA response during a sit-to-stand (occurring 2 ± 2 heartbeats after standing) may be due
300	in-large to compliance of the cerebrovasculature, which occurs prior to cerebral vasodilation
301	(occurring 11 ± 3 heartbeats after standing). ⁶⁶ While not measured within the study,
302	cerebrovascular compliance may play a role in the preserved dCA sit-to-stand response
303	following HIIT in individuals post-stroke and aging adults. We also did not show a significant
304	difference in $\Delta MCAv / \Delta MAP$ following HIIT. These findings may suggest that the
305	cerebrovascular system in individuals post-stroke did not become more pressure passive
306	following HIIT, and changes in MAP when standing up from a seated position resulted in similar
307	concordant changes in MCAv. ⁶⁷ However, when interpreting the dCA sit-to-stand findings, one
308	must also take into account that the participants had a notable amount of seated recovery (~6
309	min) before the dCA sit-to-stand measure. Therefore, future studies should examine the sit-to-
310	stand response immediately following aerobic exercise, without seated rest, to determine stability
311	of the dCA response and how long someone should wait before standing up.

312 <u>Clinical Importance</u>

Within the clinic, traditionally only peripheral blood pressure is used to determine hemodynamic stability during exercise recovery. However, our study shows the need to also examine the cerebrovascular system in individuals post-stroke. While the clinical implications for a lower dCA response during passive recovery immediately following HIIT are unknown, clinicians may want to continue practicing the recommended post-exercise precautions within the first 5 minutes following HIIT.¹² When waiting \geq 6 min after HIIT to stand up from the

seated position, individuals post-stroke did not differ in the dCA response compared to BL or
CON. However, two individuals post-stroke did report slight dizziness upon standing, despite not
meeting the peripheral blood pressure criteria for initial orthostatic hypotension. Symptomatic
thresholds associated with drops in MCAv during sit-to-stands following exercise should be
established⁶⁸ in individuals post-stroke to better understand the cerebrovascular response rather
than making inferences of "hypoperfusion" from peripheral blood pressure.

325 <u>Methodological Considerations</u>

The results of this study cannot be generalized to the entire population of individuals 326 327 post-stroke, such as individuals with more severe impairments. Our findings within the chronic 328 stage of stroke also cannot be generalized to individuals within the acute and subacute stages, where dCA has been shown to be impaired at baseline.⁵² While TCD is currently the best method 329 330 to capture beat-to-beat MCAv for TFA, one must assume a constant MCA diameter. While we could not directly measure MCA diameter during the study, a previous study using 4D Flow 331 332 Magnetic Resonance Imaging in older adults showed no significant change in diameter during an 8-mmHg change in P_{ET}CO₂.⁶⁹ Our sample size to quantify TFA metrics was also reduced due to 333 low coherence, potentially due to non-linearity of spontaneous fluctuations.⁵⁰ Although we 334 followed the CARNet recommendation of a 5-min recording,⁴⁷ to increase coherence via non-335 linear modeling requires longer recordings (~40 minutes).⁵⁰ Measuring the dCA response via a 336 single sit-to-stand was chosen due to its real-life applicability as well as accounting for 337 338 neuromuscular fatigue after HIIT in individuals post-stroke. While our sit-to-stand methodology 339 accounted for the exact time in which individuals stood from the chair by using a force sensor, we did not use an accelerometer to account for the speed of standing. During the sit-to-stand, we 340 341 were also unable to account for other potential confounding factors including neurovascular

342	coupling, sympathetic activity, and cardiac output. Since accumulating evidence also suggests
343	directional sensitivity of the cerebral pressure-flow relationships, ^{20, 58-61, 70, 71} further research
344	quantifying dCA while considering the direction of MAP changes will be necessary to better
345	understand whether the reported attenuated dCA after HIIT is in response to reductions in MAP,
346	increases in MAP, or both.
347	Conclusion
348	We show that dCA at rest during spontaneous fluctuations in MAP and MCAv was lower
349	following HIIT in individuals post-stroke compared to CON. However, the dCA response during
350	a sit-to-stand following HIIT (after ~6 min seated rest) did not show a significant difference
351	compared to CON. These findings provide the groundwork for further characterization of the
352	dCA response following aerobic exercise of varying intensities in individuals across the stages of
353	stroke recovery. The cerebral autoregulation response to aerobic exercise and recovery is "an
354	essential physiological consideration to protect the brain when progressing exercise intensity
355	[post-stroke]". ¹² Future research should develop therapeutic strategies to improve dCA post-
356	exercise in individuals post-stroke.
