

Investigating of the causes of seizures in children admitted to Kerman hospitals in 2017

Abstract

Introduction: Seizure in children with the prevalence of 4 to 6 cases in 1000 is the most common neurological disorder in pediatrics. This study aimed to determine the causes of seizures in children admitted to Kerman hospitals in 2017

Materials and methods: In this retrospective study, 250 hospitalized children suffering from seizure were selected through census method. Data collection tool was a checklist. The obtained data was analyzed employing SPSS₂₄ software, using chi-square, and correlation coefficient statistical tests at the significant level $P < 0.05$.

Results: Out of 250 children studied, 55.6% were male and 44.4% were female. The mean age of the children was 10.54 ± 3.7 years. 80.4% were born with vaginal delivery and 19.6% were born with cesarean section. 44% of the patients had febrile seizure, 23.2% epilepsy, 12.4% infection, 10% gastroenteritis, 5.2% static encephalopathy, 2.8% meningitis, 1.6% hypocalcaemia, 0.4 % metabolic disorders and 0.4 % tumor. That underlying factors of febrile seizure were upper respiratory infection (43.6%), gastroenteritis (15.7%), shigellosis (10.5%), urinary infection (9.9%), pneumonia (8.1%), unidentified fever (7.8%), otitis (3%) and dental abscess (1.4%) respectively.

Conclusion: According to this study, the most common cause of the seizure is a febrile seizure, which confirms the results of other studies. Common seizure require diagnosis, planning, and special treatments that can be obtained by taking a complete history, accurate examination, and effective Para clinical evaluations.

Introduction:

Seizures a transient occurrence of signs and/or symptoms due to abnormal excessive or synchronous neuronal activity in the brain (1). They happen because of sudden, abnormal electrical activity in the brain (2,3). Five million people in the world have seizures (three million of them are children) (4). The results showed that seizures in children have the prevalence of 4 to 6 cases in 1000 people and it is the most common neurological disorder in pediatrics. In the last five years, about 880,000 children and adolescents in the United States need medical attention for evaluation of a newly occurring seizure disorder (5). The prevalence of seizures in Iran was estimated to be around 5% (6). There is a large difference in the incidence rate of Febrile Seizures (FS) around the world. Between five percent of all

children less than five years old in Europe and the United States experience at basically the least one seizure associated with a febrile illness (7).

The study of Delpisheh and et al conducted in Iran (4599 people) showed that the prevalence of FS according to the age of children under 2 years and 2 to 6 years were 55.8% and 44.1%, respectively in Iran (8). Seizures can be caused by chemicals in the blood, infections like meningitis or encephalitis (10, 11). A common cause of seizure is fevers (12). Other causes include head trauma, stroke or lack of oxygen to the brain, genetic defects or brain tumors, hypoglycemia and deficiency of vitamin B6 (13-16)

With the epidemiological studies in the field of children's seizure disorder, the incidence, prevalence, genetic background, age, and therapeutic approaches can be evaluated (17).

In a 14-year follow up (in the field of neurological complications of fibrillary seizure), the results showed that 17% of children had the neurodegenerative developmental delay, 10% had neurological anomalies, and 4% had neurological defects (18).

The study of Abbaskhanian and et al. Showed that prevalence of neonatal seizure was 12.4% in Sari city (north of Iran) (19). The results of Sabzehei and et al showed that the prevalence of seizures was 9.1 % (20).

On the other hand, the diagnosis of seizures in children is one of the major problems for pediatric residents and general practitioners (20). It takes a lot of time and energy (19).

Due to high prevalence of seizures, its psychosocial and cognitive importance, and determining the underlying factors of the disorder, in addition no study evaluated the frequency of seizures in the southeastern region of Iran (New Aspect) and other existing studies are old, so the present study was conducted to determine the causes of seizures in children admitted to Kerman hospitals in 2017

Materials and methods:

This retrospective cross-sectional study was conducted on all children aged 1 month to 16 years with the initial diagnosis of Seizure that admitted to Kerman hospitals (included Afzalipour, Sahid Bahonar, and Shafa) from January to September 2017 .

Kerman is located in the south-central part of Iran. On December 31, 2016, the population in ages from 1 month up to 16 years was 135,688 people (21). There were 65,147 girls and 70,541 boys .

This research was performed using the hospital data registration medical records in order to select all children with the diagnosis ' Seizure' recognized between January to September 2017 (22).

The Statistical Population was all children aged 1 month to 16 years with the initial diagnosis of Seizure that admitted to Kerman hospitals (included Afzalipour, Sahid Bahonar, and Shafa) from January to September 2017.

Sampling was done using the census method (Sample Size= 250 Participants) and the sample size was all children aged 1 month to 16 years due to abnormal movements or abnormal behavior admitted to Kerman Hospitals with a diagnosis of Seizure.

Data collection was done through a checklist (data collection form) which included demographic data, family history, age at seizure onset, type of seizure, perinatal data, mental and motor development, seizure types, other diseases accompanied with seizures as a symptom, treatment.

Definition:

Seizure defined as is a period of symptoms due to abnormally excessive or synchronous neuronal activity in the brain. (23-25).

Diagnosis and classification:

Diagnosis of seizure and classification of etiology of seizure in children should be based on history, physical examination, and clinical judgment of one pediatric neurologist based on ILAE (International League against Epilepsy) criteria (26).

Statistical methods and statistical tests

We used mean and standard deviation and relative and absolute frequency to analyze quantitative and qualitative variables, respectively. Moreover, to investigate the association between demographic and epidemiological factors of seizure types, χ^2 and Fisher's Exact Test was performed. Then, the obtained data was analyzed employing Statistical package for particularly social science (SPSS) version 24 (IBM Inc., Chicago, IL, USA) and correlation coefficient statistical tests at the significant level $P < 0.05$.

Ethical considerations

The research protocol was approved in the Medical Ethics Committee of Kerman University of Medical Sciences (Ethical Code: IR.KMU.AH.REC.1395.659).

Results:

55.6% of participants (total participants= 250) were male and 44.4% were female. 80.4% born with Normal Vaginal Delivery (NVD) and 19.6% were born with Cesarean Section (C/S). The mean \pm SD of the duration of admission was 8.73 ± 1.2 days, the mean \pm SD age of the children was 10.54 ± 3.7 years, and the mean \pm SD birth weight was $2675.48\text{gr} \pm 453.64$, 40.4% of children had a seizure for the first time. The frequency of seizure repetition in 35.1% of the children was 4 times a day and 38.5% of them had a positive familial history. Table 1 shows seizures causes. The most common cause was a febrile seizure (45.5%).

There was not any significant association between gender ($P=0.35$), type of delivery ($P=0.83$), birth weight ($P=0.56$) with causes of seizures but there was a significant association between age at the onset of seizures with it ($P<0.01$).

The result showed that underlying factors of febrile seizure were upper respiratory infection (43.6%), gastroenteritis (15.7%), shigellosis (10.5%), urinary infection (9.9%), pneumonia (8.1%), unidentified fever (7.8%), otitis (3%) and dental abscess (1.4%) respectively (Table 2).

Furthermore, the most common types of seizures were focal with Secondary generalization (25.6%), focal (16.4%), myoclonic (12%), and atonic (11.6%) respectively (Table 3).

Discussion:

Considering the cultural and socioeconomic differences, food habits, and regional diseases, this study was focused on the causes of children's seizures in patients admitted to hospitals of Kerman in order to find out its causes and resolve them and finally prevent the occurrence of seizure attacks.

This was the first study in the southeastern region of the country to investigate the causes of seizures in children, which is important.

In our study, most of the children's seizures happened in the boys, which is similar to previous studies (27-25). The cause of it is controversial and needs complementary investigations.

On the other hand, it is probable that more attention is paid to boys in developing countries lead to the number of identified boys be higher than girls (30, 31).

The prevalence of FS in this study is relatively high compared with other studies, which is due to the fact that patients are referred from nearby provinces and other cities to Kerman hospitals (32).

The common causes of seizures were FS, epilepsy, infection, gastroenteritis, static encephalopathy, meningitis, hypocalcemia, metabolic disorders, and tumor which is similar to many studies (30, 33).

The most common cause of seizure was FS (44%) that is similar to many studies (27-33). Proper warnings and suitable training should be given to parents who have a child with a history of FS (34). Therefore, rectal diazepam should be given for prophylaxis in these children when fever is higher than 38 degrees of centigrade (30).

The second cause of seizure was epilepsy (23.2 %) which is similar to many studies (30, 33). Epilepsy is a common disorder in developed countries (about two to four percent) which is higher in developing countries (35).

The third cause of seizure was Infection (12.4 %) that is similar to many studies (30, 33). Infections are a major cause of seizures in developing countries like Iran (36). It can cause both acute symptomatic seizures and epilepsy (37). The etiologies of Infectious include tuberculosis, HIV, cerebral malaria, neurocysticercosis, subacute sclerosing panencephalitis, cerebral toxoplasmosis that sometimes have a structural correlate (35).

The next cause of the seizure was gastroenteritis (17.2 %). Seizures due to gastroenteritis are seen in infants and children and known among neurologists and pediatricians which is similar to the results of this study (38).

On the other hand, shigellosis in children of developing countries is associated with high fever and seizures (39). In the study of Ashkenazi and colleagues, 153 children had shigellosis and seizures. 20% of them had a positive family history of seizure, indicating an important role of genetics in seizure due to gastroenteritis (40).

Despite other studies, the high frequency of seizures due to static encephalopathy (5.2 %) in our research can be attributed to poisoning, drug abuse, and mitochondrial disorders .

The results showed that Meningitis (2.8 %) known as a cause of the seizure that is similar to other studies (41-43).

Therefore, if a child less than two years old had a seizure, meningitis could be one of the diagnoses, and more testing and examination should be done for r/o it (44). The results showed that the frequency of seizures due to hypocalcemia is 1.6 % and is related to the onset age of rickets symptoms in children (45).

Seizures due to metabolic disorders (0.4 % in our study) could be a presenting feature of late-onset metachromatic leukodystrophy caused due to lack of saposin B and arylsulfatase A enzyme deficiency (46).

The results showed that seizure can be one of the important symptoms of brain tumors that is similar to the results of other studies (47-49).

In this study, 94 children had previous history of seizure and 156 children (62.4%) was new cases, that indicating the important role of genetic, that is similar to textbooks of neurology (48). totally, 19% of children had a family history of febrile seizures that 35 participants were in the group with the FS diagnosis that is also similar to textbooks. Genetics not only affects the incidence of FS; It also affects the recurrence and type of it, as the probability of recurrence FS and complex seizures is higher in children with a positive family history (49).

From 250 children, 64 patients were treated with anticonvulsant medications that 19 people discontinued their medication during the last days and week's which play an important role in the occurrence of recurrent seizures (50, 51).

Totally, the causes of children's seizures in the Merritt's textbook (52) include idiopathic epilepsy (3.5%), degenerative diseases (5.2%), infections (5.65%), malignancies (4.1%), trauma (5%), maternal diseases (8%) and vascular diseases (10.9%), which is different from the results of our study. The variation in results is probably explained by the location of the studies. Because this research conducted in a deprived province, and people of its community should be followed up until complete treatment. Also in these areas, people visit a doctor when their children get seizures, and they continue the treatment just for a short time. Some people do not pay enough attention to the seizures risk factors and medical advice and still insist on their own habits and traditions. Sometimes the high cost of treatment prevents patients from complementary follow-ups.

In this study, underlying factors of FS were upper respiratory infection (43.6%), gastroenteritis (15.7%), shigellosis (10.5%), urinary infection (9.9%), pneumonia (8.1%), unidentified fever (7.8%), otitis (3%) and dental abscess (1.4%). Some studies showed that the risk of seizure in children less than 3 years who have a viral upper respiratory infection with positive family history is higher than others (51-54).

This study had limitations on sample size and time interval and we could not investigate the association of some variables like maturity (term or preterm) and history of admission with causes of seizure. We suggest that future multicenter studies be conducted in larger sample sizes and extended time intervals.

Conclusion

Altogether the results showed that the most common cause of children's seizures was FS, Epilepsy, and Infection. So appropriate policies should be made to reduce the rate of them. Due to the economic costs and complications of seizure in our society regular monitoring and follow-ups of seizure can reduce the mortality and morbidity of it.

Conducting similar studies in other regions of Iran is necessary and help to detect other causes of seizure and achieve more comprehensive and complete results. It is suggested that other studies investigate the association between other causes of the seizure (did not mention in our study) in children and variables such as age, gender, and season.
