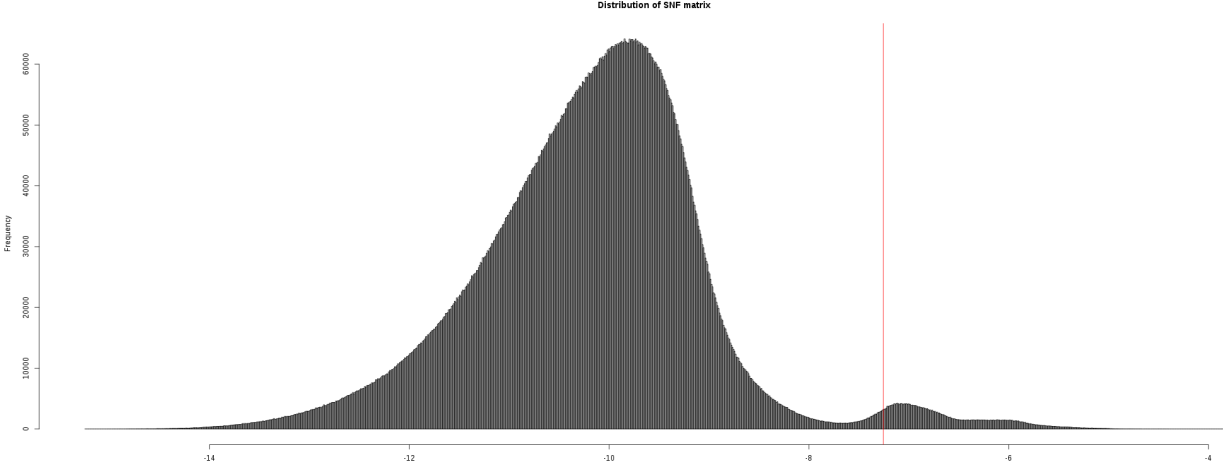
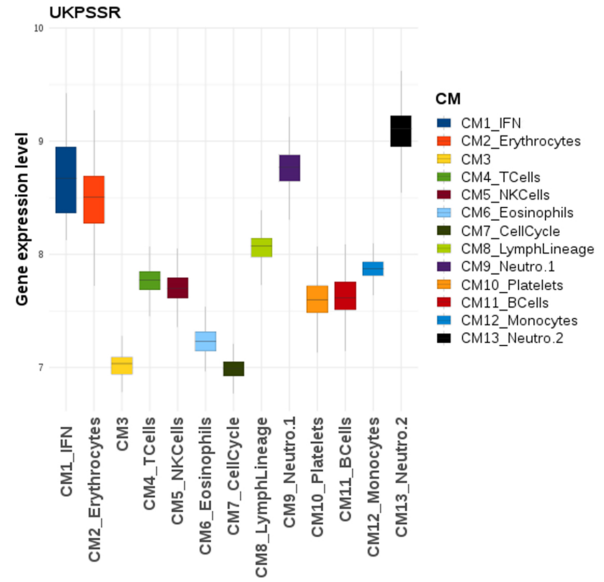
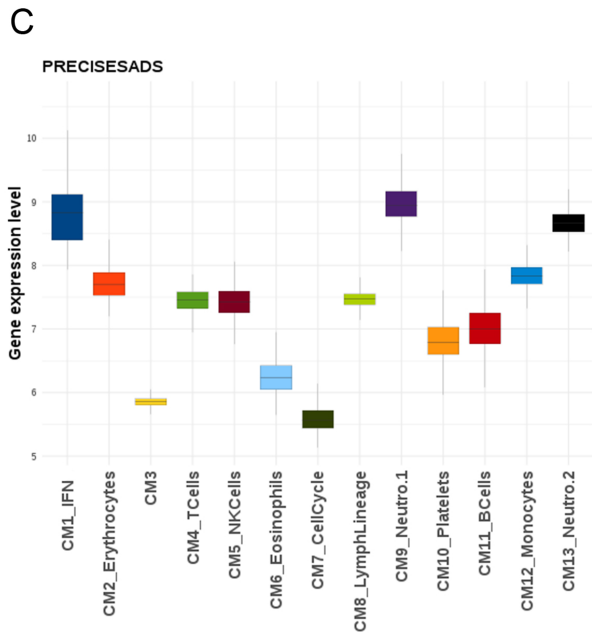
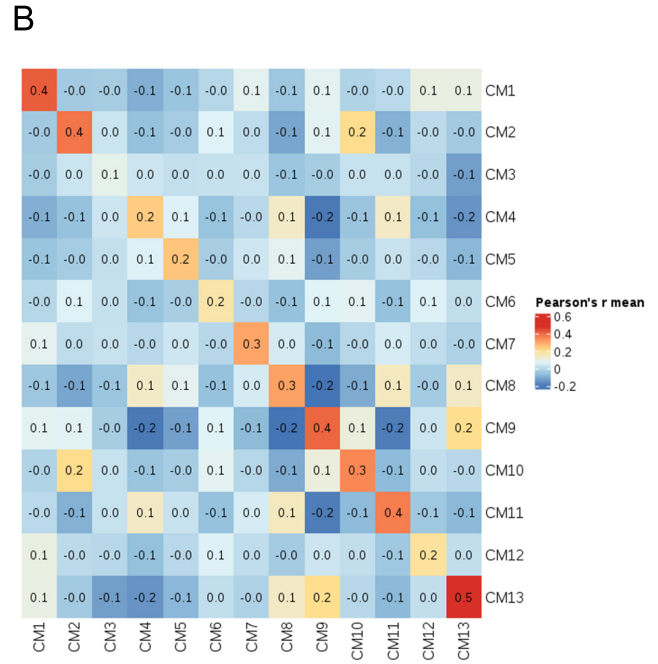
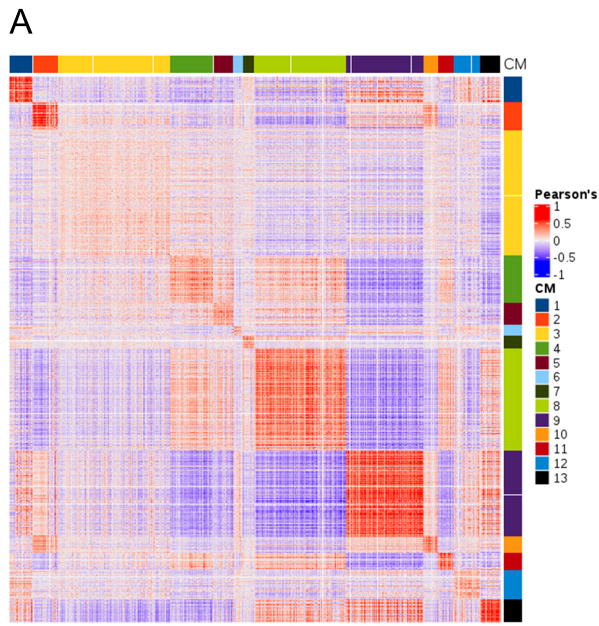


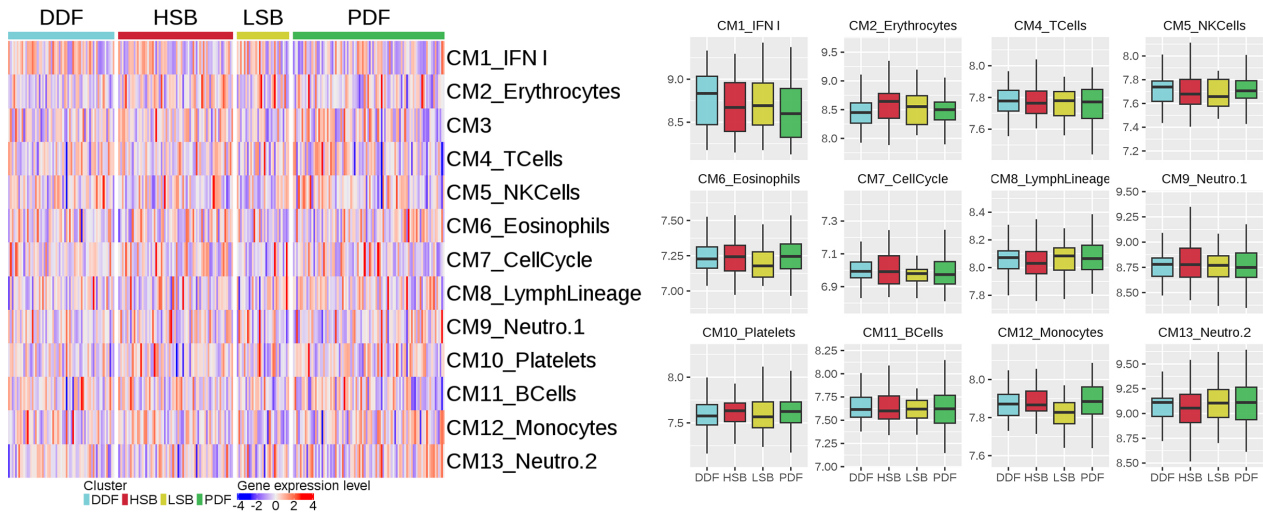

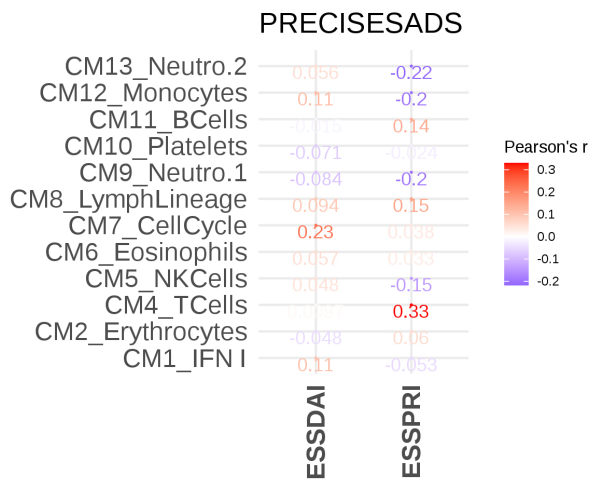

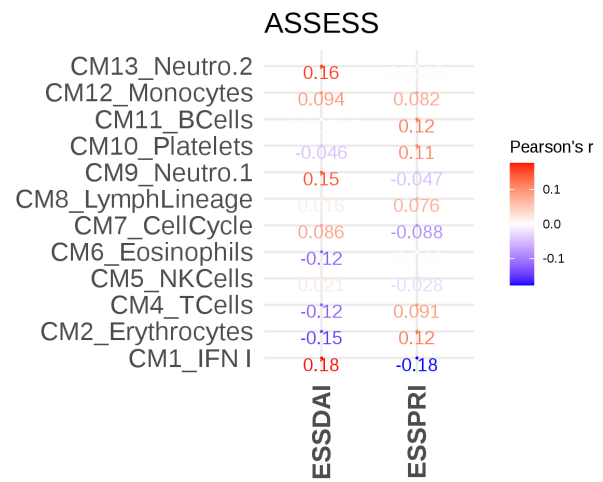


Supplementary Fig3. CMs scores across patient subgroups of the Tarn classification in UKPSSR cohort

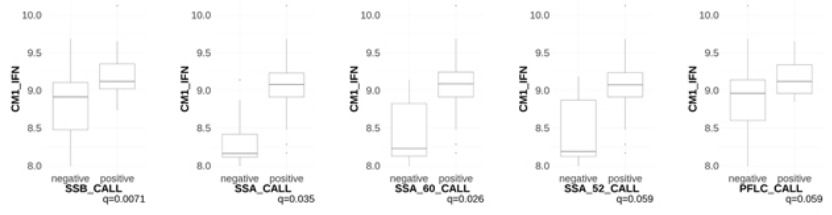
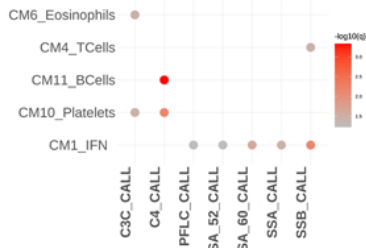

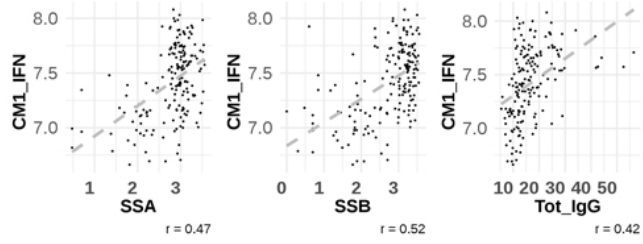
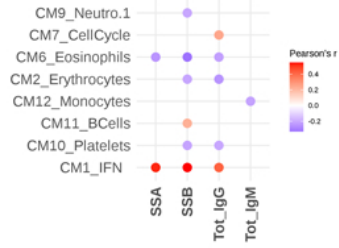

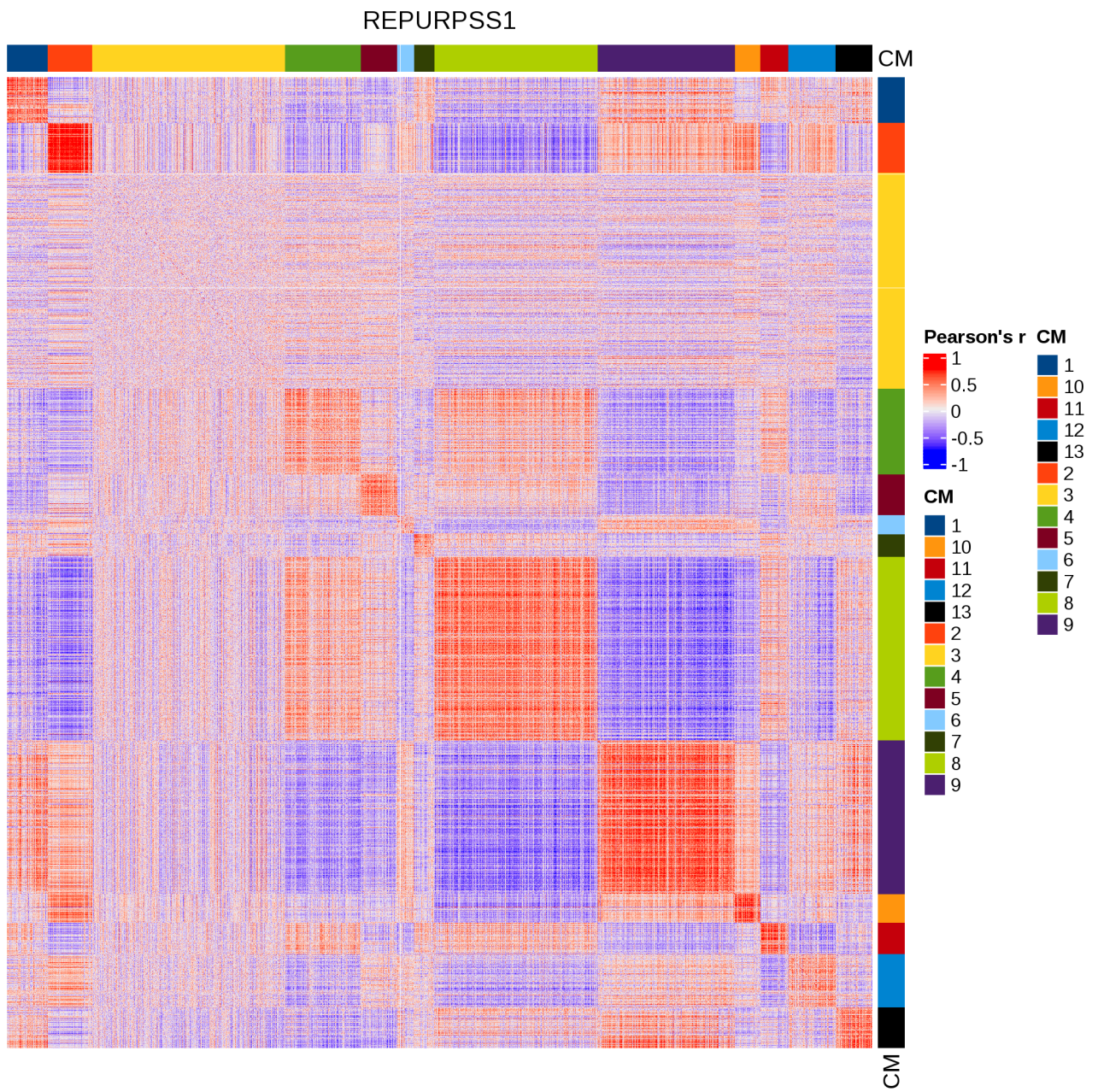

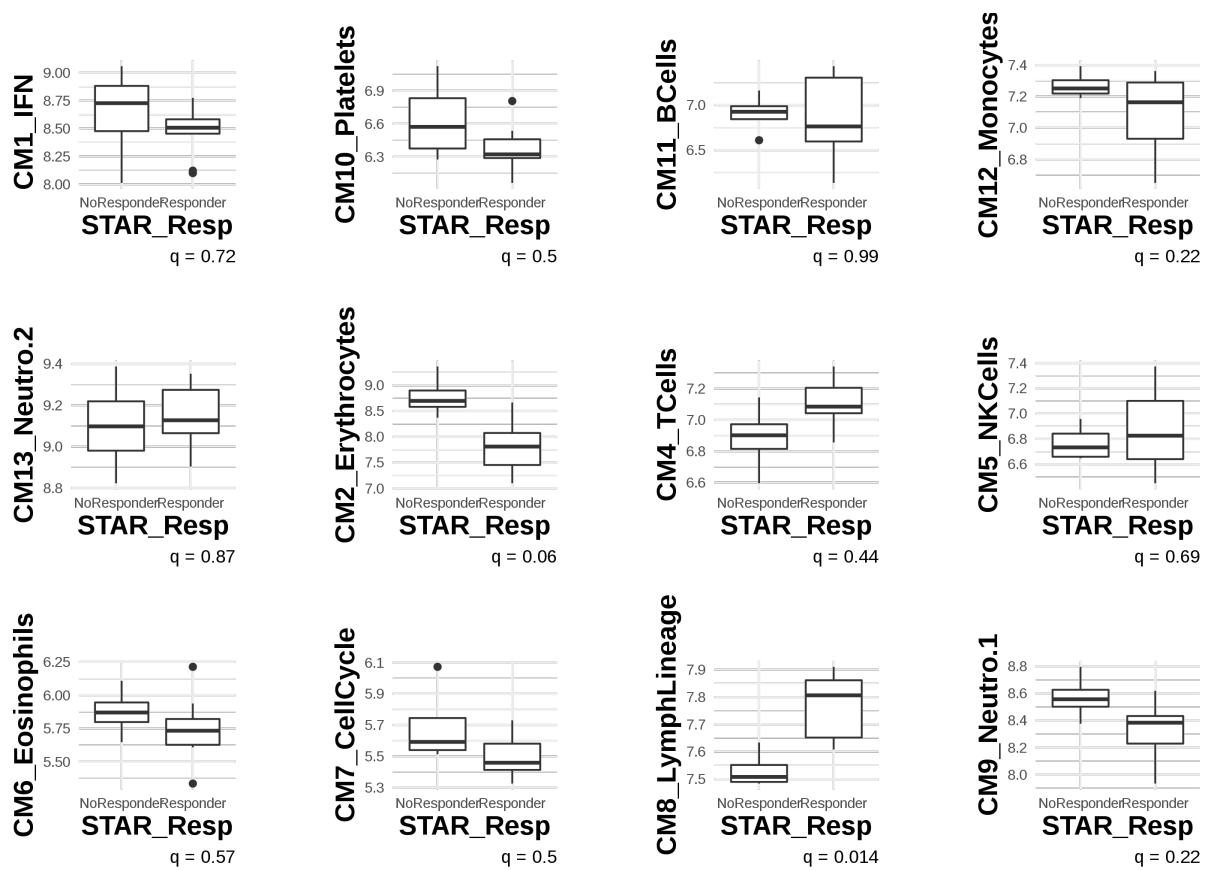
