Assessing the Quality of Hand-Dug Wells in the Sunyani Municipality, Ghana

Abstract

**Background** 

Hand-dug well water represents one of the main sources of drinking water for many settlements,

especially people without access to treated potable water. However, water from such alternative

sources can sometimes be polluted and not conducive for human consumption, due to the

presence of pathogenic parasitic organisms. This study assessed the physico-chemical and

microbial quality of hand-dug wells in the Sunyani Municipality in Ghana.

Methods

The study was cross-sectional in nature and results were laboratory-based analyses. The study

used Global Positioning System (GPS) tracker to locate and sample hand-dug wells within the

Sunyani Municipality. Fifteen (15) households with hand-dug wells were randomly selected

from fifteen major communities within the Sunyani Municipality. One (1) sample was collected

from each of the 15-household hand-dug wells for the study.

**Results** 

Physico-chemical analyses suggest that the temperature of water from all sources ranged

between 25.8°C and 27°C whiles phenolphthalein alkalinity of all water samples was 0. But the

total alkalinity was between 28 to 116 mg/L. Relatively higher concentrations of nitrate were

also observed in samples from all locations and most wells were exposed. However, all samples

contained 18.2MPN Index/100ml of faecal coliform compared to 0.0MPN Index/100ml of

acceptable national limits.

**Conclusion** 

Apart from most samples recording parameters exceeding World Health Organization (WHO)

and Ghana Standards Authority recommended levels, majority of wells were exposed and sited

around unhygienic environment. Hand-dug well water in the Sunyani Municipality is not

completely safe for drinking purposes and requires periodic expert supervision and sample

testing.

Introduction

Water quality constitutes a significant factor in public health especially due to the immense

benefits of water to the health and wellbeing of populations. The World Health Organization

(WHO) opined that 75% of all diseases affecting developing countries are triggered by drinking

polluted water and further observed that about 884 million people across the globe used

unimproved water for drinking <sup>1</sup>.

Groundwater sourced from shallow wells, boreholes and springs remains a major source of water

for various uses in Sub-Saharan Africa and other parts of the developing world <sup>2</sup>. Tapping

groundwater from shallow aquifers comes with water quality challenges, especially when these

'hand-dug wells' are provided near beneficiary communities and within individual households<sup>3</sup>.

It is worth noting that even the so-called protected deep boreholes are also oftentimes polluted by

on-site sanitation facilities. This situation occurs when there is a hydrologic connection between

deep aquifers and geologic layers on the earth surface where all on-site sanitation systems are

erected <sup>4</sup>.

The aforementioned situation is more evident in low-income communities and peri-urban areas

in Sub-Saharan Africa, where onsite sanitation systems are predominantly used. And sadly, the

presence of on-site sanitation systems predisposes groundwater sources to pollution by microbial

pathogens<sup>5</sup>.

Water is the most abundant substance on earth which occupies about 71% of the earth's total

surface <sup>6</sup>. However, in most developing countries like Ghana, access to quality water and

adequate sanitation services is conspicuously lacking. Due to this, much of the urban population

solely depend on groundwater aquifer achieved through the construction of hand-dug wells to

source water for drinking and other domestic purposes such as for cooking, washing and bathing

<sup>7</sup>. However, in such developing countries, the hand-dug wells are highly susceptible to several

sources of pollution <sup>8,9</sup>.

Contaminants including bacteria, viruses, heavy metals, nitrates and salt have contributed

significantly to the pollution of such water sources due to inadequate treatment and disposal of

waste from humans and livestock 10,11. This therefore, necessitated the need to assess water

quality from hand-dug wells within the Sunyani Municipality of Ghana in order to determine

their safety for drinking and other relevant uses.

Methodology

Study Area and design

The study was done in the Sunyani Municipality which is one of the administrative districts in

the Bono Region of Ghana. It lies between Latitudes 20°N and 70.05°N and Longitudes 20.30°W

and 20.10°W. Sunyani is the largest settlement in the Bono Region in terms of population and

area (Figure 1). The study was cross-sectional in nature and results were laboratory-based

analyses. The study used Global Positioning System (GPS) tracker to locate and sample hand-

dug wells within the Municipality. The Global Positioning System (GPS) was also used to

allocate sample codes for easy identification (contact corresponding author to request access

to these data).

Sampling

The water samples were the main experimental materials. Fifteen (15) households with hand-dug

wells were randomly selected from fifteen major communities within the Sunyani Municipality

(contact corresponding author to request access to these data). One (1) sample was collected

from each of the 15-household hand-dug wells for the study. About 500 ml of water each was

taken from the household in the morning between 8 am and 11 am and transported to the

laboratory immediately between July and September 2022. Laboratory tests were carried out at

the Ghana Water Company laboratory in Sunyani, a well-equipped government laboratory for

the Municipality.

**Instrument and Test Procedures for Microbial Quality** 

Two analytical techniques - Membrane Filtration (MF) and Multiple Tube (MT) were used to

determine Total coliform (TC), Faecal coliform (FC), Escherichia coli (E. coli) and Total

heterotrophic (TH) bacteria. To draw water samples from the various houses, the containers used

for the collection of samples were first cleaned with 70% ethanol to avoid pre-contamination.

The water samples were collected using hard plastic and screw-capped bottles that have been

sterilized to avoid contamination by any physical, chemical or microbial means. The collected

hand-dug well water samples were aseptically transferred into sterile containers. Samples for

bacteriological analyses were kept in screw-capped bottles that were sterilized in an autoclave

for 15 minutes at 121°C. Samples were then transferred to the laboratory for microbial analysis.

Aliquots of 100 ml of each sample were separately filtered and each membrane filter placed on

appropriate medium for the parameter to be determined. The following microbiological media

were used for the membrane filtration analysis: M-Endo Agar for Total coliform bacteria at 37°C

for 18-24 hours; MFC Agar for faecal coliform bacteria at 44°C for 18-24 hours; Hichrome Agar

for Escherichia coli bacteria 37°C for 18-24 hours; and Nutrient Agar for Total heterotrophic

bacteria at 37°C for 18-24 hours. For the MTF analysis, 10 ml of sample was dispensed into each

of the 10 Lauryl Tryptose tubes containing pre-sterilized broth media.

Bottles were inverted and shaken three to five times to mix contents and to eliminate any air

trapped in the inner vial (Durham tube). After that, the tubes were incubated at  $35 \pm 0.5$ °C and

observed for gas production which was accompanied by a cloudy appearance of the broth at the

end of 24 and 48 hours. Positive presumptive results (gas produced) were recorded on the Most

Probable Number MPN test data sheet and the corresponding MPN index determined. Following

incubation, aliquots from the cultured positive tubes were aseptically streaked on MacConkey

agar for Total coliform at 37°C.

**Instrument and Test Procedures for Physico-Chemical Quality** 

The water samples collected were also tested to determine the physico-chemical quality.

Different test methods were used to determine pH, Colour, Turbidity, Conductivity, Total

dissolved Solids, Hardness, calcium, iron, Nitrite, Fluoride, Arsenic, and manganese. The

physico-chemical parameters which were done in situ were pH, colour, conductivity,

temperature, turbidity and total dissolved solids. The following methods were employed for the

various parameters: Electrometric for pH, Conductivity, Total dissolved Solids, Platinum-cobalt

for Colour, Nephelometric for Turbidity, Titrimtric for Total hardness, Argentometric for

Chloride, Diazotization for Nitrite, Cadmium reduction for Nitrate, Spands for Fluoride, EZ

arsenic for Arsenic, and Periodate oxidation for Manganese.

**Results** 

**Physico-Chemical Test of Hand-Dug Well water** 

Temperature: This study was carried out to assess the suitability of potable water used for

domestic activities in fifteen selected suburbs in Sunyani. Water quality parameters such as

temperature, pH, electrical conductivity (EC), and total dissolved solids (TDS), were measured.

Table 2 is a presentation of laboratory analysis of water samples taken from the different sources.

Results are in comparison with national water quality standards specified by the Ghana Water

Company Limited. Results indicate that the temperature of water from all sources ranged

between 25.8 °C and 27°C, with Nkwabeng South (926) and Penkwase number 1(924) recording

the lowest temperatures of 25.8°C. The highest temperature of 27°C was recorded at New Town

(939). Observable discomfort could be associated with temperatures higher than 36°C but

temperature levels were within limits for this present study.

**pH:** Considering national guidelines, pH lower than 4 will produce sour taste and higher values

above 8.5 give water a bitter taste. From the results presented in Table 2, all but Baakoniaba

Number 1(code 920) had water sources with pH levels (7.18) within national standards of 6.5-

8.5. Area 3 (code 930) presented the lowest pH value of 5.33. The various indications have

suggested that even though pH levels are lower than national standards, water from all fifteen

sources is likely to have a normal taste, considering that they are above a minimum pH value of

4 and below a maximum value of 8.5. However, other side effects could be associated with

current pH levels apart from taste.

**Conductivity:** Electrical conductivity is a useful tool to evaluate the purity of water, which was

minimum at Magazine (code 938 (57.6µ Scm<sup>-1</sup> at 25 °C)) and maximum at Zongo (code 923)

(640µ Scm<sup>-1</sup> at 25 °C). Relatively higher levels of conductivity were also observed in all other

well water samples.

**TDS:** TDS are those solvents which dissolve in water and cannot be separated from water by

filtration. They may be chemically organic or inorganic. In the current study, the highest value

(320ppm) was recorded at Zongo (923) and the lowest (28.8ppm) at Magazine (938). The

difference in values may be due to evaporative loss of water and increase in the concentration of

salts present in water. The national standard for dissolvable solids is up to 1000 ppm permissible

quantity, and the results indicate that samples from all the fifteen sources were within

permissible limits.

Turbidity: Considering a national turbidity level of 5 NTU, the analysis revealed that

Baakoniaba number 1 (920) had the highest turbidity level (21.9NTU), with Nkwabeng South

(926) recording the least value of 0.96 NTU. Other locations that had turbidity levels above

national standards included Penkwase number 1 (924), (20.1NTU) and Berlin Top (918),

(5.85NTU). Aside these, all other locations presented turbidity levels less than acceptable

national specifications for drinking water.

Colour: The colourless nature of drinking water is the initial physical assessment of a clean

drinking water source. However, except Berlin Top (918) (9pt.co.), water from all other sources

contained colour higher than acceptable limits of 0-15pt.co., with South Ridge (919) having the

highest (66pt.co).

**Total Hardness:** Hardness has no known adverse effects. Hardness above 500ppm of water is

not suitable for domestic use in washing, cleaning, laundry and drinking. The total hardness of

water samples ranges from 18ppm at Magazine (938) to 540ppm at Nkwabeng North (927).

**Alkalinity:** The phenolphthalein alkalinity of all water samples is 0. But the total alkalinity for

current study was found between 28 to 116 mg/L. According to Environmental Protection

Agency, the acceptable limit of total alkalinity of drinking water sample is 500 mg/L CaCO<sub>3</sub> and

maximum desirable limit is 1500 mg/L CaCO<sub>3</sub>. Therefore, all samples contained alkalinity levels

within acceptable limits.

Chloride: Chloride exists in all natural waters. The concentrations vary very widely and do not

pose a health hazard to humans. Principal consideration is in relation to palatability. Chloride

values for this study ranged from 30ppm in South Ridge (code 919) to 162ppm at Zongo (code

923). The acceptable desirable limit is 250ppm. Results showed that all samples fell within

acceptable national limit for drinking water.

Nitrate: Relatively higher concentrations were observed in samples from all locations with

Nkwabeng South (926) being the highest (13.64ppm) and Magazine recording the lowest

(2.2ppm) Nitrate concentration. South Ridge (code 919) and Airport (code 928) were locations

also recording slightly lower (2.64ppm, respectively) nitrate concentrations than national limits

for drinking water.

Sulphate: Aside the ability of sulphate to give drinking water a bad taste, it can also act as a

purgative in humans. The levels of sulphate in the water samples were generally low, ranging

between 1ppm in Nkwabeng South (926), South Ridge (code 919), and Airport (code 928) to

22ppm in Newtown (code 939) and 16ppm in Nkwabeng North (code 927). WHO/national limit

for sulphate concentration in drinking water is 250ppm. Results from the analysis have indicated

that all fifteen samples were within acceptable limits.

Iron concentration: Iron is an essential component in human diet. Estimates of the minimum

daily intake for iron depend on age, physical status, sex and iron bio-availability. Although iron

has got little concern as a health hazard but is still considered as a nuisance in excessive

quantities. Samples that were higher than national specifications included those from Penkwase 1

(924), (20.1NTU) (1.63ppm), Baakoniaba number 1 (code 920) (0.59ppm), Airport (code 928)

(0.24ppm), and South Ridge (code 919) (0.12ppm). Long-term consumption of drinking water

with a high concentration of iron can lead to liver diseases. Aside these, all other samples

analyzed were within acceptable limits, as they indicated concentration levels less than 0.3ppm

national limit.

**Phosphate:** Phosphate naturally occurs in water and often in high concentrations. The water

samples analyzed recorded phosphate concentrations measuring between 12.19ppm from

Penkwase number 2 (code 937) samples, 0.69ppm from Baakoniaba number 1 (920) and least

concentration of 0.01ppm at Berlin Top (918). Majority of samples analyzed were below

national concentration limit of 0.3 ppm.

Fluoride: The result suggests that all samples (15 samples) had fluoride concentration less than

1.5 ppm recommended limit. Zongo (923) recorded the highest concentration of 0.27 ppm,

followed by concentration of 0.21ppm from Berlin Top (918), 0.18ppm from Estate (922) and

0.17ppm from Nkwabeng South (926). All other sample concentrations were less than 0.13ppm.

**Trace metals** 

Manganese: Considering a national acceptable limit of 0.4ppm, Airport (1.0ppm), Penkwase

Number 2 (0.6ppm), Baakoniaba number 2 (Code 940) (0.6ppm) and Zongo (923) recorded

values higher than acceptable limits. On the other hand, all other samples contained manganese

lower than 0.4ppm, which is considered acceptable.

**Aluminum:** Aluminum was one metal analyzed for its presence in water samples. The results

indicate a trace in samples from South Ridge (0.76ppm), Area 3 (0.31ppm) and Nkwabeng South

(0.22ppm) were higher than acceptable limits of 0.2ppm. However, traces of aluminum in other

samples were below 0.2ppm limit set for the presence of the metal in drinking water. In

analyzing for the presence of other substances, traces of cyanide (national limit of 0.07ppm),

lead, and Arsenic (national limit of 0.01ppm) were not recorded in all samples (Table 2).

## **Microbiological Test Results**

The presence of *E. coli* in water indicates recent faecal contamination and may indicate the possible presence of disease-causing pathogens. From Table 3, analysis of *E. coli* from all fifteen samples had no traces of *E. coli*. However, all samples contained 18.2 MPN Index/100ml of faecal coliform compared to 0.0MPN Index/100ml of acceptable national limits. On Total Viable Count (TVC), only Estate (922) and Penkwase Number 2 (937) recorded no values. Conversely, New Town number 2 (939) had the highest TVC of 150 CFU, followed by Area 3 (77 CFU), Baakoniaba number 2 (44 CFU), and New Town Number 1 (33CFU). Still on TVC, samples from Zongo (923) contained 27 CFU, Nkwabeng North (927) recorded 22 CFU, and 21CFU was recorded in samples from South Ridge. All other samples contained TVC less than 20 CFU (Table 3).

**Discussion** 

Water of good quality is very essential for sustaining life 12. Therefore, a study assessing the quality of water, in this case, hand-dug-wells is very crucial. The general characteristics of the wells used for this study have been listed (Table 4). The results of this study suggest that temperature from all collected samples was within nationally recommended level, as compared to findings <sup>13</sup>, in Sri Lanka, where variations in water temperature had adverse effects on the quality of water. Variations in water temperature in the two study settings may be due to variations in general atmospheric conditions. Conversely, studies in other parts of Ghana reported a temperature of 40 °C <sup>14</sup>, far above that reported by the current study. Meanwhile, observable discomforts could be associated with water temperature higher than 36 °C. In similar studies conducted in Northwest of Iran, while researchers reported electrical conductivity (EC) to range between 110 and 1750 µs/cm <sup>15</sup>, EC values in the current study were lower. Even though the Ghana Ministry of water resources indicated that water colour increases coagulant chemical usage and associated high cost of water treatment <sup>16</sup>, all water samples collected for this current study had colour above the World Health Organization threshold of 15Pt.Co <sup>15,17</sup>. Meanwhile, colour in water is known to impede the visibility of physical impurities. Even though nitrate is known to have less effect on the overall quality of drinking water, it is still a public health concern <sup>18–20</sup>. The presence of high nitrate level in all samples collected for this study was noted.

This is slightly different from those reported in Nigeria which ranged between 2.97-40.68 mg/L

<sup>21</sup>. Even though alkalinity reported by this study was within acceptable limits, findings by <sup>22</sup> were also within acceptable limits but higher than those reported from current findings. Aside this, several acceptable alkalinity levels have been cited in literature <sup>23–25</sup>. Nitrate in water is known to pose some level of danger to human health, especially when it is higher than acceptable levels.

In similar studies conducted in Ghana on the quality and health risk of well water <sup>26</sup> and water quality of dug-out wells <sup>14</sup>, the presence of nitrate was reported to be high which agrees with findings of this current study. Contrary to these findings, research from other parts of Ghana reported relatively lower levels of nitrate in well water <sup>27</sup>. The presence of nitrate can sometimes be attributed to the prolonged use of agricultural fertilizer at close range to hand-dug wells. Manganese is considered an important component of human existence but its presence in drinking water should be measured for health risk purposes. High amounts of manganese in water samples collected from a number of hand-dug wells in sections of Ghana have been recorded <sup>26</sup>, contrary to findings of our study where the presence of manganese in water samples was lower. Even though the presence of iron is significant to human nutrition <sup>28</sup>, traces of iron in samples of this study were low. This finding agrees with earlier studies conducted in other parts of Ghana <sup>10</sup>, but contrary to findings reported by <sup>29</sup> where high iron level in well water samples was found. The low presence of iron in water is an indication of water quality since high amount of iron is known to lead to liver diseases and other conditions <sup>23,28</sup>.

A study in Iran observed variations in levels of fluoride but reported a general level less than 0.5 mg/L <sup>15</sup>. This, however, is higher than findings of this study as the current research cited only 0.27mg/L as the highest rate of fluoride. It is worth noting that the difference in the study area could have accounted for variations in the levels of fluoride in water samples. Most importantly is the fact that both studies reported traces of fluoride below WHO acceptable levels, since high

consumption of fluoride could lead to skeletal and dental fluorosis 10,30. In ensuring the

wholesomeness of drinking water for human consumption, trace metals are essential elements to

investigate.

Laboratory analysis from the current study indicates high presence of faecal coliform in well

water samples. This finding concurs with earlier studies <sup>24,31,32</sup>, where the total faecal coliform

count ranged between 3.0 x 102 to 9.3 x104 CFU/ml. Even though both studies reported faecal

coliforms higher than the WHO acceptable levels of 0.00 CFU/ml <sup>33</sup>, the difference may have

resulted from the location of the wells, methods of sample analysis or proximity of wells to

human settlements. It is also reported in literature that total faecal coliforms in drinking water

vary due to seasonal treatment of wells <sup>34,35</sup>. Other studies have acknowledged the influence of

Streptococcus in drinking water assessment and ensuring drinking water quality. The current

study found no traces of *Streptococcus* in samples <sup>36,37</sup>.

Conclusion

Even though majority of samples had parameters within acceptable limits, other indicators show

that samples had parameters above limits. Most trace metals were within acceptable limits whiles

indicators such as Nitrate and Total Viable Count were above national standards and WHO

recommendations. Generally, hand-dug well water is not completely safe in the Sunyani

Municipality, considering the exceeding limits of Total Viable Counts, presence of faecal

coliform and varying pH levels. Most wells are also left open and sited at unhygienic

surroundings. This study has implications for policy direction on the siting of wells for domestic

use. It is necessary to periodically conduct well inspection, education on safe water and sample

testing to ensure the availability of safe water for users of hand-dug well water. Pathogenic

organisms like bacteria if present in drinking water could expose users to various health

problems like diarrhea, hence the need for periodic testing to ensure the integrity and safety of

the hand-dug well water for consumers.

**Ethical Considerations** 

This study did not involve the use of live participants hence did not require ethical clearance

from an institutional review board. However, written informed consent was obtained from

owners of all hand-dug wells after the objectives, risk and purpose of the study were explained to

them. Voluntary participation was assured and no benefits were given to participants who

permitted the collection of samples from their wells.
