Two-way ANCOVA detailed explanation

A two-way ANCOVA was applied on each biomarker in each region with two main factors (disease status, and SDB condition) and four covariates to control, including age, sex, APOE ϵ 4 existence, and BMI. For each ANCOVA, we have the below factors and their degree of freedom

We used partial eta squared to estimate the effect size of the disease-SDB interaction on the biomarkers in different regions, as shown in Supplementary Figure 1. The null distribution differed around its mean, which was approximately 0.04. Additionally, according to the mathematics of partial eta squared, we expected the null effect size mean to be around 0.04, as shown in Equations 1^1 and 2^2 .

Similarly, when investigating only the SDB condition effect, regardless of disease status (Supplementary Figure 2), we expected the mean value for the null distribution to be around 0.02.



Supplementary Figure 1. Disease-SDB interaction effect sizes on AD biomarkers. The mean effect size of the *interaction* between disease status (Alzheimer's disease, mild cognitive impairment and cognitively unimpaired) and SDB condition (SDB-positive, and SDB-negative) for each cortical and subcortical parcel's neuroimaging biomarker (amyloid-plaque burden (A β), regional fluorodeoxyglucose (rFDG), grey matter volume (GMV)). The black dashed line indicates the arbitrary threshold, and null model distribution represented with a violin plot. Colored points which have passed the dashed color and are larger than the null model distribution has been considered as medium effect sizes.



Supplementary Figure 2. SDB condition effect sizes on AD biomarkers. The mean effect-size of SDB condition (SDB-positive, and SDB-negative) *alone* for each cortical and subcortical parcel's neuroimaging marker (amyloid-plaque burden (A β), fluorodeoxyglucose (FDG), grey matter volume (GMV)). The black dashed line indicates the arbitrary threshold, and the null model distribution has represented by a violin plot. Colored points which have passed the dashed color and are larger than the null model distribution has been considered as medium effect sizes.



Supplementary Figure 3. Association between disease-SDB interaction and CSF biomarkers. Highlighted regions are significantly associated with disease-SDB interaction effect size on CSF biomarkers (CSF Aβ42, CSF p-tau).
