1 Evaluating public health effects of risk-based travel policy for the

2 COVID-19 epidemic in Scotland

22 Abstract

| 23 | Background: Decisions to impose temporary travel measures are less common as |
|----|--|
| 24 | the global epidemiology of COVID-19 evolves. Risk-based travel measures may |
| 25 | avoid the need for a complete travel ban, however evaluations of their effects are |
| 26 | lacking. Here we investigated the public health effects of a temporary traffic light |
| 27 | system introduced in the United Kingdom (UK) in 2021, imposing red-amber-green |
| 28 | (RAG) status based on risk assessment. |
| 29 | Methods: We analysed data on international flight passengers arriving into Scotland, |
| 30 | COVID-19 testing surveillance, and SARS-CoV-2 whole genome sequences to |
| 31 | quantify effects of the traffic light system on (i) international travel frequency, (ii) |
| 32 | travel-related SARS-CoV-2 case importations, (iii) national SARS-CoV-2 case |
| 33 | incidence, and (iv) importation of novel SARS-CoV-2 variants. |
| 34 | Results: International flight passengers arriving into Scotland had increased by |
| 35 | 754% during the traffic light period. Amber list countries were the most frequently |
| 36 | visited and ranked highly for SARS-CoV-2 importations and contribution to national |
| 37 | case incidence. Rates of international travel and associated SARS-CoV-2 cases |
| 38 | varied significantly across age, health board, and deprivation groups. Multivariable |
| 39 | logistic regression revealed SARS-CoV-2 cases detections were less likely among |
| 40 | travellers than non-travellers, although increasing from green-to-amber and amber- |
| 41 | to-red lists. When examined according to travel destination, SARS-CoV-2 importation |
| 42 | risks did not strictly follow RAG designations, and red lists did not prevent |
| 43 | establishment of novel SARS-CoV-2 variants. |
| 44 | Conclusions: Our findings suggest that country-specific post-arrival screening |
| 45 | undertaken in Scotland did not prohibit the public health impact of COVID-19 in |

- 46 Scotland. Travel rates likely contributed to patterns of high SARS-CoV-2 case
- 47 importation and population impact.

51 Background

- 52 On 24th March 2020, Scotland with the rest of the United Kingdom (UK) entered a
- national lockdown to limit SARS-CoV-2 spread and subsequent COVID-19-
- associated hospitalisations. This early period of the pandemic was characterised by
- 55 British nationals being advised against all but essential travel (1), alongside
- ⁵⁶ unprecedented border closures implemented increasingly by countries globally (2).
- 57 However, prior to implementation of these stringent travel restrictions in the UK,
- 58 hundreds of introductions of SARS-CoV-2 into Scotland had already occurred
- 59 through international travel and community transmission was underway (3).
- ⁶⁰ By July 2020, circulating SARS-CoV-2 was dramatically reduced (4) and Scotland
- had moved to Phase 3 of a route map out of lockdown (5). Whilst interventions
- 62 focusing on reducing social contacts remained in place, travel restrictions were
- relaxed with the lifting of quarantine measures from certain overseas destinations (6).
- 64 A country-specific risk assessment approach was subsequently undertaken with the
- 65 introduction of 'travel corridors', relaxing self-isolation measures for individuals
- travelling to countries not considered to be high risk for high levels of SARS-CoV-2
- 67 exposure (7).
- 68 Progress out of lockdown was short lived however, with increasing COVID-19
- incidence linked to travel in the summer of 2020 (4,8) and the subsequent

70 identification of the first novel SARS-CoV-2 Variant of Concern (VOC), Alpha (B.1.1.7 71 Pango lineage (9)), in Scotland during November 2020, first identified in the UK and 72 classified VOC based on risk assessment (10). Scotland subsequently entered a 73 period with travel restrictions enforced at a local authority level based on regional 74 infection rates, regulating both domestic and international travel, and the country entered its second national lockdown on 5th January 2021. By 4th January 2021, 75 76 Alpha was the dominant variant circulating in the UK and managing the tradeoff between COVID-19 hospitalisations and recovery of the economy including the travel 77 78 industry was of high concern. Other variants of concern were also identified, such as 79 Beta (B.1.351) in South Africa, resulting in a long-standing travel ban to this country. 80 Subsequently, in line with the lifting of lockdown restrictions and safe resumption of 81 international travel, May 2021 marked the introduction of a 'traffic light system' across 82 the UK which applied relaxed guarantine and testing requirements for travellers on a 83 country-specific basis through Red-Amber-Green (RAG) list designations (11). 84 During this period, the epidemiological course of the epidemic shifted in the UK, with 85 the importation of a fourth novel VOC, Delta (B.1.617.2; first identified in India)(12), 86 although widespread rollout of the national COVID-19 vaccination programme was 87 also in place at this time. Delta replaced Alpha as the dominant variant in Scotland by the end of May 2021 (13). The traffic light system was subsequently lifted across the 88 UK on 4th October 2021, with Scotland adopting a simplified system of 'red list' and 89 90 'not red' (14). However, a fifth novel VOC, Omicron (the BA.1 sub-lineage; first 91 identified in South Africa), was identified in Scotland at the end of November 2021 92 (15,16). Several countries deemed high risk were given red list status in an attempt 93 to slow the introduction and spread of Omicron in the UK (17), although this highly 94 transmissible variant was soon established in the community. Travel regulations were

eventually lifted incrementally and fully removed across the UK on 18th March 2022
(18).

| 97 | International travel continues to present the main risk pathway for importations of |
|-----|--|
| 98 | novel SARS-CoV-2 variants of public health significance. In the UK, a temporary |
| 99 | increase in surveillance was recently reintroduced for individuals travelling from |
| 100 | specific locations, owing to the evolving epidemiological situation of other nations |
| 101 | experiencing increased COVID-19 activity and the emergence of further variants of |
| 102 | potential public health significance (19). There is, however, a need for improved |
| 103 | understanding of how risks of novel SARS-CoV-2 introductions and subsequent |
| 104 | spread vary by the geography and demography of populations, to inform |
| 105 | proportionate travel-related interventions and early warning surveillance systems. |
| 106 | There have been few observational studies providing evidence for the public health |
| 107 | effects of COVID-19 travel restrictions, with the majority focused on border closures |
| 108 | put in place to curb global spread early in the pandemic (2,20,21). |
| 109 | Here we use Scottish community surveillance and SARS-CoV-2 whole genome |
| 110 | sequence data to evaluate the public health effects of the COVID-19 traffic light travel |
| 111 | policy in Scotland. Our objectives were to quantify the effect of the traffic light policy |
| 112 | on (i) international travel frequency, (ii) temporal, demographic, and geographic |
| 113 | patterns of SARS-CoV-2 importation risk, and the odds of SARS-CoV-2 case |
| 114 | detections, (iii) national SARS-CoV-2 case incidence, and (iv) the risk of importing |
| 115 | specific SARS-CoV-2 VOC across RAG groups. This evaluation has importance for |
| 116 | providing an evidence-based approach to future public health guidance and decision |
| 117 | making around international travel policy. |

118 Methods

119 Datasets

120 Civil Aviation Authority data

121 Data on the monthly number of passenger arrivals into Scottish airports, by country

and airport of origin, were provided by the Civil Aviation Authority (CAA). There were

123 5,508 records capturing 9,383,947 passengers in total from the period April 2019 to

124 September 2021, from flights arriving into 11 Scottish airports from 290 airports in 70

125 countries. Data were grouped providing total monthly numbers of flights into Scottish

- airports by country of origin.
- 127 COVID-19 Passenger Locator Forms

128 From June 2020, measures were introduced requiring all UK arrivals to complete a

129 Passenger Locator Form (PLF) to support compliance with COVID-19 travel

measures (23). The dataset contained weekly data for the period 28th June 2020 to

131 19th March 2022 on the number of PLFs submitted to Border Control and the

originating countries from which passengers had travelled from into Scotland. Over

the 90-week period, passengers arrived into Scotland from 247 countries.

134 To enable like-for-like country-level comparison with PCR data, data on the Canary

135 Islands and Madeira were merged with that of Spain and Portugal respectively in

both the CAA and the PLFs.

137 COVID-19 microbiological surveillance data: Community cases

138 Data on SARS-CoV2 infections in Scotland were accessed from the NHS Scotland

139 Corporate Data Warehouse (CDW), a database designed to support the analysis and

140 reporting of COVID-19 surveillance in Scotland. The national case definition for a

141 SARS-CoV-2 infection was applied for the study duration, whereby respiratory

| 154 | The CDW database captured post-arrival travel-related tests from 15 th February | |
| 155 | 2021. During the traffic light period, tests were taken on or before day 2 (red, amber | |
| 156 | and green list countries) and on or after day 8 (red and amber list countries). | |
| 157 | Individuals were required to self-report the main country they travelled to when | |
| 158 | booking a COVID-19 test if they had travelled internationally within the preceding 14 | |
| 159 | days. All individuals were required to take pre-departure tests until this requirement | |
| 160 | was incrementally removed from 7 th January 2022. | |
| 161 | There were 425,764 SARS-CoV-2 PCR test records from individuals reporting recent | |
| 162 | international travel over the study period. Deduplication of SARS-CoV-2 tests was | |
| 163 | conducted by grouping multiple tests based on a unique identifier (Community Health | |
| 164 | Index) for individuals with specimen dates falling within a 14-day period and relating | |

to the same travel destination, thereby defining travel events by country. Following

166 this process, 345,045 travel records remained representing 290,044 individuals. Over 167 the study period, 41,934 (14.5%) of individuals had more than one travel event, with 168 a minority of individuals (n=1,178, 0.4%) reporting travel to more than one country 169 within a 14-day period. Tests with specimen dates out with a 90-day period were 170 deemed a separate episode of infection (following the national case definition (24)). 171 Positive test records were preferentially retained over negative records for each 172 travel event. Monthly PCR test frequencies for travellers were strongly correlated with 173 numbers of passengers into Scotland based on PLFs (Figure S1, Supplementary 174 Material). 175 COVID-19 microbiological surveillance data: Case-control analysis 176 Logistic regression modelling was employed to assess the relative odds of SARS-177 CoV-2 case detection between international travellers and non-travellers. For this analysis, PCR tests were extracted for the traffic light period (17th May 2021 to 30th 178 179 September 2021). There were 184,126 deduplicated travel records for this time 180 period, and among 183,839 with the information, 1.9% had self-reported symptoms.

Non-travel records (n=4,011,152) were deduplicated as for the travel records. Those with specimen dates out with 90 days of the first identified records were presumed a separate episode of infection, retaining a single record per episode. Positive test results were retained over negative test results. Test records without a unique identifier were assumed to be from different individuals. Following deduplication, there were 1,891,873 non-travel records during the traffic light period and among 1,499,890 tests with the information, 43.3% had self-reported symptoms.

188 SARS-CoV-2 whole genome sequencing data

| 189 | Whole Genome Sequencing (WGS) of SARS-CoV-2 samples was introduced in |
|-----|--|
| 190 | Scotland in March 2020. Following emergence of the Alpha variant, a push to |
| 191 | sequence all positive SARS-CoV-2 samples was stepped up to allow for surveillance |
| 192 | of variants, though with prioritisation toward travel-related samples to identify |
| 193 | importation of VOC. WGS results were uploaded by sequencing labs and quality |
| 194 | assessed via the COVID-19 Genomics UK (COG-UK) pipeline hosted on the Cloud |
| 195 | Infrastructure for Microbial Bioinformatics (CLIMB) as part of COVID-19 Genomics |
| 196 | UK (COG-UK)(25). Definitions based on mutational patterns were then applied to |
| 197 | resultant genomic information to designate a variant (9) and these results were linked |
| 198 | to the original PCR test via a unique specimen identifier. |
| 199 | During the study period there were 317,570 samples from COVID-19 cases resident |
| 200 | in Scotland that underwent SARS-CoV-2 whole genome sequencing. Samples which |
| 201 | had a low-quality genome and samples that could not be linked to a positive SARS- |
| 202 | CoV-2 PCR test, and therefore could not be confirmed as a Scottish sample, were |
| 203 | excluded (n=78). |

Traffic light system country designations

The Red-Amber-Green (RAG) status of each travel destination was extracted from Scottish Government online travel updates (18). Test records, including genome sequences, were linked to RAG status based on the recorded travel destination and the specimen date of the test. Analyses aggregating data on a weekly basis applied the country's RAG status pertaining to the start of each week, all other analyses applied the daily designations.

211 Statistical analysis

Assessment of travel patterns by time, location and demography

213 Descriptive statistical analyses were performed to characterise key trends of 214 international travel for the Scottish population before and during the pandemic, based 215 on CAA and PLF data. Changes in the count of passengers entering Scotland, at or 216 between key time points, was used as an objective indicator of the impact of travel-217 related measures on travel. To assess the impact of the traffic light system on the risk of SARS-CoV-2 218 219 importations, trends in the weekly numbers and proportions of PCR-positive 220 travellers were examined for the top 30 most frequently visited travel destinations, 221 spanning a period before (February-May 2021), during (May 2021-October 2021), 222 and after (October 2021-May 2022) the traffic light system. Although post-arrival tests 223 were a mandatory travel policy, some exceptions were in place and compliance is not 224 quantified (23). PLF data were therefore used to assess how representative the PCR 225 test data was of travel frequency by destination during the traffic light period. 226 Groups at risk of importing SARS-CoV-2 through international travel were also 227 assessed by comparing travel frequencies across demographic (age, sex, relative 228 deprivation of residential location, as measured by the Scottish Index of Multiple 229 Deprivation; SIMD) and geographical (territorial NHS Board) factors. An ANOVA test 230 was used to assess differences in mean travel frequencies across demographic and 231 geographic groups, with a p-value <0.05 applied to indicate statistical significance. 232 The potential impact of travel on the epidemiological situation in Scotland was 233 assessed by quantifying the numbers of travel-related SARS-CoV-2 cases as a 234 proportion of all Scottish SARS-CoV-2 cases. Ranking of travel destinations 235 according to travel frequency, importation risk, and impact gave an overall

assessment of risk, shown for a period of low (June 2021) and high (September

237 2021) travel frequency.

238 Logistic regression modelling

239 SARS-CoV-2 tests were extracted and deduplicated across travellers (with a recent

travel event) and non-travellers (records with no recent travel event) for calendar

months spanning the period of the traffic light system (17th May 2021 and 30th

242 September 2021 inclusive).

The combined dataset was linked to the RAG status according to the travel

244 destination of each record. A 'travel status' variable was created whereby those with

an international travel event were grouped by level of RAG status and with the

remaining forming a 'non-traveller' group.

247 Statistical analyses were performed to assess the association between travel status

and the odds of detecting a SARS-CoV-2 case in a test-negative case-control design,

adjusting for demographic, geographic and temporal factors. Unadjusted odds ratios

were initially quantified in univariate binary logistic regression models examining

associations between SARS-CoV-2 infection and travel status, age group (0-19y, 20-

252 39y, 40-59y, 60-79y, 80y+), sex (male versus female), month (May, June, July,

August, September) and NHS Board (fourteen territorial health boards).

254 Multivariable mixed-effects logistic regression modelling was then used to quantify

the relative odds of SARS-CoV-2 case detection adjusting for age group, sex, and

calendar month as fixed effects and NHS Board location as a random effect.

257 Statistical interactions were assessed for all factors that were significant in the final

258 multivariable model, with a p-value less than 0.05 indicating statistical significance. A

small number of individuals (n=8990, 0.4%) had duplicate records (positive and/or

| 260 | negative tests). Restricting analyses to the first observed records per individual did |

| 262 | All analyses were performed in R v3.6.1 (26). The glm function was applied for single |
| 263 | effect statistical models and the Ime4 (1.1-27.1 package) for mixed-effect models. |
| 264 | Results |
| 265 | Impact of COVID-19 policies on patterns of international travel in Scotland |
| 266 | Prior to the COVID-19 pandemic, numbers of international flight passengers arriving |
| 267 | into Scotland per month were estimated to range from around 445,000 passengers |
| 268 | (February 2019) to 952,000 (July 2019) during the peak summer period (CAA data, |
| 269 | see Figure 1). During the COVID-19 pandemic, monthly numbers of international |
| 270 | flight passengers decreased substantially owing to travel restrictions (Figure 1). A |
| 271 | reduction in travel of 97.7% (to around 17 thousand passengers per month, |
| 272 | compared to the same period in 2019) was observed during the first national |
| 273 | lockdown (April to May, 2020), by 86.7% (to around 95 thousand passengers per |
| 274 | month, compared to same period in 2019) during a period of relaxed travel |
| 275 | restrictions (data from July 2020 to January, 2021), and by 87.4% (to around 111 |
| 276 | thousand passengers per month, compared to the same period in 2019) during the |
| 277 | period of the traffic light system (May to September 2021). |
| 278 | The magnitude of reduced international travel across the phases of COVID-19 travel |
| 279 | restrictions was largely consistent across destinations and data sources (Figure S2, |
| 280 | Supplementary Material). Despite large reductions in travel, the most frequently |
| 281 | visited destinations remained largely consistent however, with Spain the most |
| 282 | common destination both prior to and during the COVID-19 pandemic (Figure 2). |

| 283 | The traffic light system (17 th May 2021 to 4 th October 2021) followed a country- |
|-----|--|
| 284 | specific risk-based approach (see Figure S3, Supplementary Material), with |
| 285 | quarantine reserved for high-risk countries (red list), and others requiring self- |
| 286 | isolation together with day 2 and 8 post arrival tests (amber list), or day-8 post-arrival |
| 287 | tests only (green list). The frequency of international arrivals into Scottish airports |
| 288 | subsequently increased by 754% from May 2021 to September 2021, compared with |
| 289 | a 12% increase over the same period in 2019 (Figure 2). |
| 290 | The ranking of travel frequency across RAG groups remained consistent over time |
| 291 | when retrospectively applying designations to the pre-pandemic period, with amber |
| 292 | list countries the most frequently visited (83.8% and 70.0% in the pandemic period |
| 293 | based on PLF and CAA data sources respectively, and 74.8% pre-pandemic (CAA |
| 294 | data)). A small discrepancy was seen between red and green list countries although |
| 295 | they were largely consistent throughout the traffic light period (Figure S3, |
| 296 | Supplementary Material). The largest decrease in travel frequency, comparing May- |
| 297 | to-September inclusive pre-and-post pandemic, was seen for red list (87.7% |
| 298 | decrease) followed by amber (78.8% decrease) and green list (63.2% decrease) |
| 299 | countries (Figure S2, Supplementary Material). |
| 300 | Despite the lifting of the traffic light system and incremental removal of travel |
| 301 | restrictions in winter 2021/22, the frequency of international travel declined during |
| 302 | this period consistent with the typical seasonality of travel (Figure 1). |
| 303 | Travel and case patterns by demographic and geographic groups |

- 304 A significant difference in average weekly rates of travel was found by age group,
- deprivation, and NHS Board, but not for sex, with a similar pattern observed for
- 306 SARS-CoV-2 detection rates among travellers (Table 1). Both travel and SARS-CoV-

| 307 | 2 case detection rates were notably higher in working aged adults (age groups 20- |
|--|---|
| 308 | 39y and 40-59y), for residents of NHS Boards with larger populations, and increased |
| 309 | with decreasing deprivation (over half of all travel events were from individuals |
| 310 | residing in the lowest deprivation groups). |
| 311 | However, some variation was seen, with younger (20-29y) working aged females and |
| 312 | older (30-39y and 50-59y) working aged males having the greatest travel frequencies |
| 313 | (Figure S4a), and a relatively high proportion of travellers resided in high deprivation |
| 314 | (low SIMD score) locations for specific destinations (Figure S4b). Despite the |
| 315 | temporal variation, differences across NHS Boards showed general consistency with |
| 316 | more populous regions tending to have higher travel rates (Figure S4c). |

Figure 4 summarises the rankings of the top 30 most frequently visited countries according to travel frequency, SARS-CoV-2 importation risk, and population impact (as measured by the proportion of all Scottish SARS-CoV-2-positive PCR tests with

an associated travel event). Countries ranking high across each metric represented
the greatest risk when combining exposure and consequence. Notably, four red list
countries appeared in the top seven, and two in the top three, ranking of SARS-CoV2 importation risks during the lowest (June) and highest (September) travel frequency
periods respectively. However, one green list country had the highest combined
ranking across all metrics during June, and by September there was no discernible
pattern of risk distinguishing green and amber list destinations.

338 Overall, the rate of SARS-CoV-2 cases detections was estimated to be 17 per 1,000 339 among those with an international travel event, compared to 190 per 1,000 among 340 those without an international travel event over the same period. Employing 341 multivariable mixed-effects logistic regression, the odds of detecting SARS-CoV-2 342 cases increased from green-to-amber and amber-to-red list countries but was lower 343 for travellers relative to the non-traveller PCR-tested community. This finding was 344 consistent regardless of RAG group, controlling for age group, sex, month and 345 geographical location (see Table 2 for details). Some variation in the effect of travel 346 status was found according to age group, sex, and month, however the relative odds 347 of case detection was consistently greater among those with no recorded recent 348 international travel event.

Several demographic factors were identified as independently associated with the odds of detecting SARS-CoV-2, regardless of travel status, with cases more likely detected among 0-19y olds relative to 20-39y olds, among males relative to females, and among individuals' resident in more deprived areas. These predictors of SARS-CoV-2 cases differed from that observed among travellers (as highlighted also by differences in the modelled predicted probabilities when comparing traveller and nontraveller groups; results not shown) and the patterns of travel frequency.

356 **Risks and population impact of SARS-CoV-2 novel variant importations**

357 through international travel during the period of the traffic light system

358 Figure 5 shows the weekly numbers of sequenced SARS-CoV-2 cases by variant 359 group against a timeline of travel policy changes. For most travel destinations and 360 periods of the epidemic, the most likely imported VOC reflected the dominant variant circulating in the UK representing 50% or more of sequenced cases (Figure S5. 361 362 Supplementary Material). However, some variation in the risk of VOC importation 363 was observed across travel destinations, particularly during the period of Alpha 364 variant dominance albeit based on small numbers of sequenced cases. The Delta variant was identified in Scotland on 4th April 2021 before the relaxation of 365 366 travel restrictions for some destinations through the traffic light system. Figure 6 367 compares weekly numbers of variants identified among sequenced SARS-CoV-2 cases returning from non-red and red-list travel destinations, alongside non-traveller 368 community cases during the period in which Delta emerged. Although several 369 countries were added to the red list from 9th April 2021, Delta was primarily detected 370 371 among travellers returning from non-red list countries (except for a short period from 372 late April to end of May). Community transmission was evident from late-April, 373 following which Delta was relatively more frequently identified among non-travellers. Delta replaced Alpha to become the dominant variant in Scotland from 19th May 2021 374 (Figure S6, Supplementary Material). 375

Shortly after the traffic light system was removed on 4th October 2021, Omicron
(BA.1 sublineage), emerged with the specimen of the first known case in Scotland
dated 22nd October 2021 (Figure S6, Supplementary Material). In contrast to Delta,
Omicron was first identified in the community among non-travel-related cases (Figure

7), with only 2.6% of sequenced Omicron cases associated with recent international
travel compared to 22.1% of Delta cases in the first four weeks of their respective
emergence. Overall, both Delta and Omicron were more frequently detected among
non-travellers and similarly to Delta, detection frequency for Omicron was higher in
those returning from non-red list than red list countries.

385 Discussion

With the ongoing generation of novel variants able to infect vaccinated and

387 previously infected individuals, SARS-CoV-2 can be expected to persist globally with

388 continued spread of novel variants of public health significance. While acquired

immunity either from prior waves of infection or from vaccines are now mediating

390 disease severity in most cases of infection, the future evolution of SARS-CoV-2

remains unpredictable. In the event of a new VOC emerging, border closures may

³⁹² provide a means for reducing the numbers of imported cases and control the

³⁹³ progression of outbreaks locally. However, it is well recognised that unless

implemented rapidly and informed by the true risks, the public health benefit is

395 limited.

396 Once community transmission has been established, risk-based quarantine and post-

travel screening may be proportionate measures to reduce the public health

398 consequences of international travel. Risk-based screening measures have recently

been reintroduced by several nations, including the UK, owing to increasing global

400 COVID-19 spread (19). However, there is a lack of understanding of travel policy

401 effectiveness pre-dating COVID-19, including for pandemic influenza and other

402 emerging infectious diseases (27,28). Most studies assessing the public health

403 effects of COVID-19 travel-related policies have used modelling approaches in the

| 404 | absence of empirical data, and have focused on the early phase of the pandemic |

| 405 | when reduced international travel was of paramount interest to curb the global |
| 406 | spread of disease (2,20,21,29,30). One study suggests the quarantine of |
| 407 | symptomatic COVID-19 cases is insufficient to significantly delay the onset of an |

| 409 | The traffic light system employed in the UK during May to October 2021 aimed to |
| 410 | provide a risk-based approach to targeting quarantine and screening measures for |
| 411 | travellers returning from specific destinations. To our knowledge, our study is the first |
| 412 | to evaluate the potential public health effects of this measure. Firstly, our study |
| 413 | shows, as expected, that international travel increased substantially during the period |
| 414 | of the traffic light system. The highest travel rates were seen for working aged adults, |
| 415 | and those resident in more populous health boards and in low deprivation areas. The |

Thirdly, there were significant differences in the rates of SARS-CoV-2 infections
detected amongst travellers across age groups and deprivation, but not for sex,
aligning with patterns of travel frequency. However, cases of SARS-CoV-2 were

more likely detected among non-travellers than travellers overall during the traffic
light period, and the relative odds of detecting cases differed from the pattern of
cases observed among travellers. Overall these findings highlight the complexity in
understanding predictors of case detections that are specific to travellers, but that
patterns of travel may be a good proxy indicator of this.

433 The likelihood of detecting a SARS-CoV-2 infection among travellers increased from 434 green-to-amber-to-red list countries, although with some variation when examining individual travel destinations. The highest frequency of travel was seen for an amber 435 436 list country, resulting in relatively high numbers of imported SARS-CoV-2 cases when 437 coupled with importation risk (proportion of travellers testing positive) together with a 438 high population impact (proportion of Scottish SARS-CoV-2 cases attributed to 439 travel). However, our study shows that despite fewer travel events, the highest 440 SARS-CoV-2 importation risk was associated with a green list country in June 2021. 441 Furthermore, by September 2021, a number of green list countries ranked higher 442 than red list countries for population impact, highlighting the complexity of 443 proportionate applications of RAG systems. We note however that our study does not 444 assess the impact of quarantine and isolation measures in place for those returning 445 from red and amber list countries which is expected to have reduced the population impact of international travel. Travel frequency and the context of existing community 446 circulation are key factors affecting the public health effects of international travel, 447 448 along with the epidemiological situation of the travel destination. Identifying specific 449 countries as high risk without considering the speed of spread of SARS-CoV-2 450 variants to other regions internationally, coupled with large differences in international 451 surveillance efforts, will severely limit the effect of a traffic-light system.

452 Finally, our study spanned two novel SARS-CoV-2 variant introductions. Stringent 453 travel restrictions did not prevent the introduction of Delta into the UK, whilst the risk-454 based red list policy did not prevent establishment in the community once 455 introductions had occurred. However, decreased case numbers were observed for some red list countries during the Delta wave despite a high SARS-CoV-2 456 457 importation risk, likely owing to decreased travel to these destinations. The rapidity 458 by which community transmission was established in the case of Omicron, with most 459 initial cases detected among non-travellers, suggests the direct impact of travel to 460 red list countries during this period was likely minimal, especially given the 461 requirement for guarantine. It was not possible however to assess the impact of the 462 evolving epidemiological situation in red list countries and degree of global spread on 463 the risks of Omicron variant importations from amber and green lists countries. Our study has a number of limitations. Firstly, laboratory surveillance data may not 464 465 capture all travellers; an unknown number of individuals were exempt from testing 466 and compliance is not quantifiable. Secondly, deductions of SARS-CoV-2 infection 467 risks across traveller and non-traveller groups must be made with caution. The 468 greater odds of detecting SARS-CoV-2 cases in the non-traveller group may be 469 explained by the targeted testing of symptomatics and known close contacts of confirmed cases. 470 471 Furthermore, those entering the UK were required to take a pre-departure test during

the traffic light period, so the proportion of cases in this group is expected to reflect the risk of SARS-CoV-2 importation - combining the risks of a travel-associated infection and testing negative prior to departure. This should not preclude the validity of comparing SARS-CoV-2 case frequency over time, by travel destination, and across demographic and geographic groups. Thirdly, case misclassifications may

have arisen, with some over-ascription of infections to the period of international
travel (the acquisition of infection before or after travel cannot be ruled out, including
from household transmission). Fourthly, in the absence of a suitable control
population or period, our study did not assess the reduction in SARS-CoV-2 case
incidence in Scotland attributable to the traffic light system.

482 **Conclusions**

483 Our findings show that risk-based post-arrival screening undertaken in Scotland did

484 not in practice prohibit the importation of SARS-CoV-2 cases, or the establishment of

485 SARS-CoV-2 VOC in the Scottish community, arising through international travel.

486 Overall SARS-CoV-2 case importation risks did not strictly follow RAG designations.

487 This is likely explained by travel frequency, regardless of country risk status, coupled

488 with rapid global spread and local community transmission limiting the value of red

lists to control VOC importations and population impact. Our study provides valuable

⁴⁹⁰ learnings that may support decision making in Scotland during any future emergency

response for COVID-19 or pandemics. These lessons may be of relevance to other

492 nations and infectious diseases although differences in the epidemiology, disease

493 surveillance systems, and travel policy implementations should be borne in mind.

494 While it is clear that risk-based travel restrictions may have limited value in isolation

- in the case of a pathogen like SARS-CoV-2, which has the potential to spread
- rapidly, they could potentially work more effectively if international variant

497 surveillance systems were compatible, and with information shared in a timely and

⁴⁹⁸ open manner, to rapidly detect and respond to new variants as they arise.
