

A systematic review and meta-analysis of PM10 exposure on risk of myocardial infarction

Review question

Within adults (aged 18 or older), does high PM10 exposure result in an increased risk of myocardial infarction when compared to low PM10 exposure?

Searches

The Ovid MEDLINE, Web of Science, and EBSCO CINAHL databases were searched on January 17, 2023, which included all studies prior to this date. There is no limitation for language.

Types of study to be included

Inclusion criteria includes: time-series or case-crossover studies

Exclusion criteria includes: secondary studies (narrative reviews, systematic reviews, meta-analyses, scoping reviews)

Condition or domain being studied

A particulate pollutant is a tiny or microscopic mixture of solid and liquid particles that are suspended in the air. Particulate matter may be emitted by a variety of human activities, including vehicle emissions, smoke, dust, and ash from industrial processes. There are three primary categories of particulate matter: coarse particles (PM10), small particles (PM2.5), and ultrafine particles (PM0.1). Generally speaking, the origins and health consequences of these particle sizes vary.

Short-term health consequences from exposure to small particles include irritation of the eyes, nose, throat, and lungs, as well as coughing, sneezing, runny nose, and shortness of breath. In addition to impairing lung function, exposure to tiny particles can exacerbate existing medical disorders, including asthma and heart disease. Research has also shown that exposure to particulate matter can also elevate the risk of cardiovascular events. However, particulate matter 10 exposure has been poorly studied in relation to myocardial infarction in adults. As such, this study aims to review and meta-analyze this association, specifically looking at risk of myocardial infarction in adults.

Participants/population

Inclusion criteria includes: population \geq 18 years of age, and participants have not had MI previously.

Exclusion criteria includes: population < 18 years of age (children), and participants that have had MI previously.

Intervention(s), exposure(s)

Inclusion criteria includes: PM10 as an exposure

Exclusion criteria includes: studies which only look at PM2.5 as an exposure

Comparator(s)/control

Our control includes populations with low exposure to PM10.

Main outcome(s)

The main outcome is the risk of myocardial infarction (relative risk (RR), odds ratio (OR), prevalence).

Additional outcome(s)

None

Data extraction (selection and coding)

Two individuals screened the abstracts of all studies from the literature search by following the predefined inclusion and exclusion criteria. Two separate researchers resolved conflicts of this screening process to reach consensus of studies to include for further analysis.

Risk of bias (quality) assessment

Publication bias will be determined by assessing funnel plot symmetricity, and performing a Begg's and Egger's test. Statistical heterogeneity (inconsistency) will be assessed by analyzing the I^2 statistic.

Strategy for data synthesis

Study attributes will be provided in tables according to PRISMA guidelines. Meta-analysis will be performed in Review Manager 5.4.1. We will use the random effects analysis model to measure heterogeneity amongst all screened studies.

Analysis of subgroups or subsets

If sufficient data exists, stratification according to age will be undertaken.
