25 Summary

Background: Arboviral diseases, transmitted by infected arthropods, pose significant
 economic and societal threats. Their global distribution and prevalence have increased in
 recent years, driven by factors such as climate change, biodiversity loss and urbanization.
 These diseases are often underestimated due to uneven surveillance and asymptomatic
 cases. Current surveillance relies on monitoring vector occurrence and spatial distribution, as

well as syndromic monitoring. In this work, we aimed to explore the utility of wastewater-based
 surveillance as an additional, added-value tool for vector-borne viruses tracking.

- **Methods:** A retrospective wastewater-based surveillance survey was conducted at ten wastewater treatment plants covering a large part of Portugal mainland (North, Lisboa and Vale do Tejo and South regions). Using RT-gPCR, we guantified the RNA concentrations of
- 36 Dengue (DENV) and Chikungunya (CHIKV) viruses for a period of 12 months (n = 273 raw 37 wastewater samples), ranging May 2022 - April 2023.
- **Findings:** DENV was detected in 25% of the samples, with concentrations spanning from 3.5
- 39 to $6.8 \log \text{ copies/L}$. CHIKV was detectable in 11% of the samples, with concentrations up to
- 40 6·3 log copies/L. Notably, the occurrence of DENV and CHIKV was rather similar between the
- 41 three regions. The Lisboa and Vale do Tejo region exhibited in general the highest median
- 42 concentration for DENV and CHIKV following normalization with crAssphage (1.5×10^{-4} and 1.1×10^{-3} respectively)
- 43 $1 \cdot 1 \times 10^{-3}$, respectively).
- 44 Interpretation: We demonstrate the efficacy of wastewater-based surveillance as a potent
- 45 tool for gauging the epidemiological landscape of both DENV and CHIKV in mainland Portugal,
- 46 where autochthonous cases have not been detected yet. Therefore, WBS should be integrated
- 47 as a supplementary component to standard surveillance strategies.

49 **Research in context**

50 Evidence before this study

51 Wastewater serves as a valuable resource for wastewater-based surveillance (WBS). This 52 surveillance method involves analyzing biomarkers of human metabolism, activities and 53 lifestyle in wastewater to gain insights into public health trends. Previously, WBS has been 54 employed to track chemical substances like illicit drugs, including cocaine, as well as 55 oseltamivir during the 2009 influenza pandemic. It has also played a crucial role in the global 56 polio eradication program by contributing to assess poliovirus circulation in populations and 57 evaluating immunization effectiveness.

During the SARS-CoV-2 pandemic, there was a significant boost in wastewater-based 58 59 surveillance. To the best of our knowledge, our study represents the first extensive application of this approach to comprehensively investigate and identify the presence of vector-borne 60 61 viruses RNA such as chikungunya and dengue.

62 In December 2022, we conducted a search on PubMed and Google Scholar for publications using the search terms "wastewater" and "dengue virus" or "chikungunya virus" or "West Nile 63 virus" or "Zika virus", encompassing manuscripts in all languages. Our search yielded only 64 65 one study that focused on detecting arboviruses in wastewater, specifically Dengue. 66 Surprisingly, the authors were unable to detect viral RNA despite the reported cases of Dengue 67 between 2017 and 2019, when the wastewater samples were collected. This period included 68 a major outbreak in 2019, with more than 7,000 confirmed cases. Remarkably, no other study 69 has shed light on the presence and concentration of Dengue and Chikungunya viral RNA in 70 wastewater.

72 Added value of this study

73 In response to the gap identified in the literature review, this study makes a significant 74 contribution by reporting for the first time the presence and concentration of arboviral RNA, 75 specifically focusing on the Dengue and Chikungunya viruses. Notably, it has demonstrated 76 the circulation of these viruses, even when only a few travel-associated cases have been 77 reported throughout the years and where no autochthonous have been reported within the 78 community, although the vector (Aedes albopictus) has been identified in several occasions in 79 mainland Portugal. This research underscores the vital role of wastewater-based surveillance 80 in gaining insights into the circulation trends of underreported pathogens within communities 81 at the sewershed level.

83 Implications of the available information

Arboviral infections are significantly underreported, especially in non-endemic countries, and 84 85 they can lead from mild to severe health issues and even mortality. The symptoms are 86 unspecific and resemble those of various other illnesses, such as Influenza and COVID-19. 87 Consequently, many infected individuals may not seek medical assistance, and when they do, 88 their infections might be misdiagnosed. This results in surveillance for arboviral infections 89 being biased toward individuals presenting with unusual symptoms or severe illness, or 90 returning from endemic regions, leading to delayed reporting and limited temporal and spatial 91 accuracy.

92 In contrast, wastewater surveillance provides results within 24 hours of sample collection and offers a representation of the population served by the sewer system. This includes 93 94 asymptomatic individuals and those with mild symptoms who may not seek medical care. This approach increases the likelihood of detecting viral circulation and thus prompt public health 95

96 intervention, namely through vector control, limiting the potential transmission to new hosts, 97 breaking the cycle of transmission.

98 Wastewater surveillance data can play a crucial role in informing public health and 99 environmental decision-making. It can reveal the presence of unaccounted-for infections, indicating the need for control and mitigation strategies, both at the population and mosquito 100 101 vector levels. Although the arboviral activity is assumed residual in Portugal, wastewater 102 monitoring can be used in complement to the efforts that are already done under the National 103 Vector Surveillance Network. Moreover, this data can be used to communicate with the 104 general public, encouraging them to take actions that can help control the mosquito 105 population, such as reducing stagnant water sources where mosquitoes lay their eggs. This 106 is especially important for vulnerable populations, enabling them to make more informed 107 decisions to mitigate the underlying risks effectively.

109 Introduction

Arboviruses, which encompass a diverse range of viruses, including Chikungunya virus 110 111 (CHIKV) and Dengue virus (DENV), are a heterogeneous group hailing from multiple viral 112 families. These viruses are transmitted to humans through arthropod vectors, primarily 113 mosquitoes and ticks. The array of arboviruses linked to human diseases surpasses a hundred, resulting in considerable disease burden and socioeconomic implications, especially 114 115 in tropical and subtropical regions¹. Presently, arboviruses pose a global public health concern 116 due to the influences of climate change, globalization, biodiversity loss, landscape 117 homogenization and urbanization^{2,3}.

Among arboviruses, DENV stands out as the most clinically significant, as it is endemic in over

119 100 countries⁴. Its far-reaching presence contributes to an estimated 390 million infections

annually, with only approximately 25% of these cases reporting symptoms⁵. Conversely,

121 CHIKV has instigated extensive outbreaks across Africa, Asia, and the Americas; however, it

- has subsequently extended its reach to regions where previously it was not native, including
 Europe⁶.
- Assessing the presence of arboviruses such as DENV and CHIKV involves multiple approaches, including clinical surveillance and monitoring within the sylvatic and entomological cycles. Clinical surveillance remains the primary method for tracking arboviral diseases. However, it is estimated that over 50% of arboviral infections may be asymptomatic or exhibit mild symptoms⁷. Additionally, non-severe arboviral infections often manifest with nonspecific symptoms, complicating early outbreak detection⁸.
- On the other hand, monitoring arbovirus circulation in the sylvatic and entomological cycles is also commended. However, this approach presents challenges, such as the need to capture animals and trap insect reservoirs. Moreover, using the presence of insect reservoirs as proxy for human infections may not reflect the epidemiological scenario⁹. Therefore, both clinical surveillance and vector cycle-based monitoring lack sensitivity and specificity, are resourceintensive, and lack spatial precision^{10,11}.

The Asian tiger mosquitoes, *Aedes albopictus* and *Aedes aegypti*, act as the primary vectors of DENV and CHKV. *A. albopictus* was detected for the first time in mainland Portugal, in the North region, by the end of July 2017, and associated to international trade of used tires that can be used by mosquito as oviposition site. Detection in the Algarve region was subsequently reported. Imported dengue cases have been identified in mainland Portugal, although there is no evidence of local transmission (SNS 24: <u>https://www.sns24.gov.pt/tema/doencasinfecciosas/dengue/#vivo-em-portugal-devo-preocupar-me-com-o-risco-de-infecao-pelo-</u>

144 Given the limitations of current surveillance methodologies for arboviral diseases concerning particularly the asymptomatic and mild cases, there is a pressing need for rapid, near-real-145 146 time approaches to determine the extent of arboviral circulation in human populations. 147 Wastewater-based surveillance (WBS) has successfully been used to trace pharmaceuticals, 148 illicit drugs, and even polio. It was extensively employed during the severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) pandemic ¹³. Studies have confirmed the excretion of 149 DENV and CHIKV RNA in urine at concentrations as high as 5.2 log₁₀ copies/mL for DENV.¹⁴ 150 Additionally, research has indicated that DENV RNA can persist for several days at 151 152 temperatures as high as 37 °C, suggesting that monitoring of viral RNA in wastewater could complement clinical surveillance for arboviral diseases¹⁵. 153

In this study, we present a nation-wide analysis of DENV and CHIKV RNA in raw wastewater across Portugal over a 54-week period. The CrAssphage served as a normalization factor to adjust the arboviral concentrations, taking into consideration the varying dilution rates of raw urban wastewater and the shifting proportion of human fecal material over time.¹⁶ These

158 factors, influenced by stormwater, industrial discharges, and water infiltration, could potentially 159 lead to misinterpretations when utilizing WBS. The insights gained from this research will 160 advance our understanding of the potential underlying wastewater-based surveillance for 161 monitoring arboviral outbreaks, including those caused by DENV and CHIKV, especially in

162 non-endemic regions.

164 Methods

165 Study design

Twice a month, raw wastewater samples (n = 273) were systematically collected from ten wastewater treatment facilities situated across the North (n = 75 samples), Lisboa and Vale do Tejo (n = 98), and South (n = 100) regions of Portugal, from May 2022 to April 2023 (appendix page 7). Employing automated samplers (ISCO, USA), 24-hour composite samples were collected. Following collection, the samples were promptly refrigerated and transported to the laboratory within an 8-hour window, where they were immediately processed.

173 Processing of raw wastewater

174 To concentrate the samples, a hollow fiber method following the procedure outlined by Monteiro and colleagues was employed (appendix pp 2)¹⁷. In brief, 1 liter of raw wastewater 175 underwent concentration using Inuvai R180 hollow-fiber filters (Inuvai, a division of Fresenius 176 177 Medical Care, Germany). The elution of samples was conducted in 300 mL of 1x phosphate-178 buffered saline (PBS) supplemented with 0.01% sodium polyphosphate (NaPP) and 0.01%179 Tween 80/0.001% antifoam, with subsequent overnight precipitation with 20% polyethylene glycol (PEG) 8000. Samples were subjected to centrifugation at 10,000 xg for 30 minutes, 180 followed by resuspension in 5 mL of 1x PBS at pH 7 4. The samples were stored at (-80 \pm 10) 181 182 °C until further processing.

184 Viral RNA extraction, detection, and quantification

Nucleic acid extraction was carried out on 220 µL of concentrated samples using the QIAamp
 FAST DNA Stool Mini kit (QIAGEN, Germany) with a final elution volume of 100 µL, following
 the manufacturer's instructions (appendix pp 2).

The primers and probes employed in this study can be found in Table 1. For DENV RNA detection, the focus was on a segment in the 3'-untranslated region (3'UTR), while CHIKV RNA detection targeted both the Nsp1 and the E region¹⁸⁻²⁰. Quantification of crAssphage was executed using the previously established CPQ_056 assay²¹.

Detection of DENV and CHIKV involved one-step RT-qPCR assays (Luna Universal Probe 195 One-Step RT-qPCR, New England Biolabs, USA), while qPCR assay (PerfeCTa qPCR 196 197 ToughMix, Quantabio, USA) was used for crAssphage quantification. To detect viral nucleic 198 acids, 4-fold dilutions of each viral extract were concurrently assayed alongside crude extracts 199 to overcome any potential inhibition of amplification caused by the complex nature of the 200 samples.

201 The reaction mixture's final volume was 15 µL, consisting of 800 nM of each primer, 200 nM of probe, and 5 µL of the extracted viral nucleic acid. RT-qPCR for DENV and CHIKV followed 202 a temperature profile of 55 °C for 10 min, 95 °C for 10 min, and 45 cycles of amplification at 203 95 °C for 15 s, and 60 °C for 1 min. The qPCR for crAssphage was conducted at 95 °C for 10 204 205 min, followed by 45 cycles of amplification at 95 °C for 15 s, and 60 °C for 1 min. All 206 amplification reactions were performed using a QuantStudio 5 Real-Time PCR System 207 (ThermoScientifc, USA).

Quantification of DENV and CHIKV was achieved through calibration curves utilizing 5- and 208 10-fold dilutions of the TaqMan Arbovirus Triplex Control Kit (ZIKV/DNV/CHIKV) 209 (ThermoScientific, USA), ranging from 6.0 to 6.0×10^3 and 1.0 to 1.0×10^4 genome copies (gc) 210 211 per reaction. Standard curves for crAssphage were generated from genomic crAssphage DNA 212 and quantified as per the guidelines in appendix (pp 2). The performance details of the 213 standard curves can be found in appendix pp 3. Negative controls, including extraction and 214 RT-gPCR assays, were also carried out using DNase/RNase-free distilled water (appendix pp 215 4-6).

217 Validation of arboviral detection in wastewater by sequencing

To validate the detection of DENV and CHIKV in wastewater samples, the amplicons were 218 219 visualized after electrophoresis on a 4.0% agarose gel, and ethidium staining. The bands with the correct size (Table 1) were excised from the gel and extracted using the EXTRACTME 220 221 DNA clean-up gel-out kit (Blirt, Poland) following the manufacturer's instructions. The DNA 222 was recovered in final volume of 50 µL. Positive controls for both viruses were also sequenced 223 in parallel with the samples. The sequencing was conducted by an external laboratory. Upon receiving the sequences, the results were checked and compared with publicly available 224 225 sequences by using the BLAST program of the National Center for Biotechnology Information 226 (available from: URL: https://blast.ncbi.nlm.nih.gov/Blast.cgi?PROGRAM=blastn&BLAST_SPEC=GeoBlast&PAGE 227 228 TYPE=BlastSearch).

Statistical analysis 230

- Data analysis was conducted using SPSS version 26 (IBM Corporation, USA) and RStudio 231
- 232 (version 2023.06.1-524). Figures were generated with RStudio, employing the gaplot2 233 package (version 3.4.0).

In preparation for statistical analyses, all positive data underwent a log transformation.
Quantitative analysis was exclusively performed on positive samples, with non-detects (ND)
being excluded from quantitative calculations. The normality of the data was assessed using
the Shapiro-Wilk test. The study employed the Kruskal-Wallis test (KW statistics) to assess
variations in viral RNA concentration across different regions and seasons. Additionally,
Spearman's rank correlation coefficient was utilized to identify potential relationships between

- Spearman's rank correlation coefficient was utilized to identify potential relationships between
 the three viral targets (DENV, CHIKV Nsp1, and CHIKV E). Differences were considered
- 241 statistically significant if p < 0.05.

242 **Results**

- The control experiments yielded the anticipated outcomes (including negative and positive extraction and amplification controls). The median concentration of crAssphage, utilized for normalizing arboviral concentration across all samples, was $6\cdot8 \times 10^8$ copies/L, with a range of $4\cdot4 \times 10^6$ to $5\cdot5 \times 10^9$ copies/L and an interquartile range between $2\cdot7 \times 10^8$ and $1\cdot2 \times 10^9$ copies/L. Our study's crAssphage concentration results align with findings from previously published studies.^{22,23}
- The RNA from all viruses under scrutiny was consistently detected in raw urban wastewater samples (see Figure 1). DENV was consistently present throughout the sampling period, while CHIKV detection was more prevalent in 2023, particularly during March and April. Specifically, DENV was found in 68 samples (25%), while CHIKV was detected in 30 samples (11%).
- Among the samples positive for arboviral RNA, 62 (67%) were positive for DENV, 24 (26%)
- for CHIKV, and, overall, both viruses were concomitantly detected in six (7%) of raw urban
- 255 wastewater samples.

256 Regarding DENV, the highest positivity rate during the study period occurred in September 257 2022 (59%), and the lowest was in January 2023 (4%). As for CHIKV, the first detection was 258 observed in a single sample from the LVT region in December 2022 (see Figure 1F), and the 259 highest positivity rate was noted in April 2023. The trends for DENV varied slightly across the 260 three regions. Initially, the highest detection rate occurred in the North and LVT regions (33%). 261 The positivity rate in the North region decreased until August, while an increase in positive 262 samples was registered for the LVT and South regions until September 2022, with rates reaching up to 75% for LVT and 63% for the South region. Two additional peaks were observed 263 264 in the North region, in September and October 2022, as well as between February and April 265 2023. In the LVT region, there was a sharp decrease in positivity rate after October 2022, 266 followed by an increase from February 2023 onward. In the South region, a peak was detected 267 between December 2022 and February 2023, with no positive samples in March and April 268 2023.

For CHIKV, the LVT region showed the first positive samples in December 2022, with subsequent detections in January (13%), March (38%), and April (63%). The North and South regions had their first positive samples in March 2023 (33% and 50%, respectively), with all April samples testing positive in both regions.

The normalized concentrations ranged between a median of $1 \cdot 1 \ge 10^{-4}$ and $7 \cdot 8 \ge 10^{-4}$ copies/L for DENV and the CHIKV gene E (see Figure 2; Table 2).

296 The median normalized concentration of the CHIKV Nsp1 gene was similar (3.1 x 10⁻⁴ 297 copies/L). Generally, the South region exhibited the lowest average concentrations, while the LVT region had the highest. For DENV, the normalized concentration varied between 2.4 x 10⁻ 298 ⁶ copies/L in the South region and 1.5×10^{-4} copies/L in the LVT region. The concentration of 299 the E gene followed a similar trend, with the highest median concentration $(1.1 \times 10^{-3} \text{ copies/L})$ 300 in the LVT region and the lowest (4.0 x 10⁻⁴ copies/L) in the North region. However, the 301 concentration for the Nsp1 gene was very similar across regions (ranging from 1.5×10^{-4} to 302 303 5.1 x 10⁻⁴ copies/L for the South and North regions, respectively). No statistically significant 304 differences were observed in the normalized RNA viral concentration among the three locations (DENV: KW = 2.738, degrees of freedom = 2, p = 0.25; CHIKV – Nsp1: KW = 3.864, 305 degrees of freedom = 2, p = 0.15; CHIKV – E: KW = 0.437, degrees of freedom = 2, p = 0.80). 306

310 In general, the concentration of DENV was lowest between the end of October 2022 and the beginning of January 2023, with the highest concentrations observed between September and 311 312 October 2022, and a resurgence at the start of 2023, except for the South region where DENV 313 remained mostly undetected. For CHIKV, the virus was primarily undetected during 2022 but 314 saw a steep increase from January until the end of the time series. The non-normalized concentration followed a similar trend to that of the normalized concentration for both viruses 315 316 (appendix pp 8). Concentrations of both CHIKV genes were positively correlated with each other (r = 0.44, p < 0.001), while no significant association was found between DENV and 317 318 CHIKV genes (appendix pp 9). The limited occurrence of CHIKV throughout the sampling 319 period contributed to this result.

The impact of the four different seasons on the occurrence of viral RNA was evaluated. Statistically significant differences were observed for all targets (DENV, CHIKV – Nsp1, and

CHIKV – E) (p < 0.001). For DENV, the difference was notable between warmer seasons 322 (spring and summer) and colder seasons (fall and winter), with higher concentrations and 323 324 positivity rates found during the warmer months (appendix pp 9, 10). Conversely, CHIKV was 325 more dominant during spring, with a statistically significant difference observed between 326 spring and the other seasons (appendix pp 9, 10).

327 The sequencing data, although not being able to provide discrimination between viruses (in 328 the case of dengue, serotypes) and therefore not being able to establish a phylogenetic tree, 329 due to the small size of the fragments, confirmed the detection of each virus in the positive 330 samples.

332 Discussion

333 To the best of our knowledge, this is the first study to document the presence of RNA from 334 DENV and CHIKV in raw urban wastewater samples.

335 DENV was detected throughout the study whereas CHIKV RNA was seldomly detected in 336 wastewater. CHIKV and DENV co-occurred in six samples (7%). Both viruses co-circulate in 337 many regions of the globe, implying that these viruses can be spread simultaneously to other 338 regions where the viruses are not endemic (ECDC: https://www.ecdc.europa.eu/en/mosquito-339 borne-diseases. Last accessed: October 2023). Moreover, the co-circulation of both viruses 340 and of the vectors facilitates the occurrence of concurrent infection in the human population.²⁴ 341 An association between viral RNA in raw urban wastewater and clinical surveillance could not 342 be established, given the absence of data, encompassing both autochthonous and travel-

343 associated cases, of CHIKV and DENV in Portugal from August 2022 to July 2023 (Turismo

344 de Portugal: https://travelbi.turismodeportugal.pt/turismo-em-portugal/turismo-em-numeros-345 2022/. Last accessed: October 2023).

346 Between 2015 and 2021, Portugal reported only three cases of CHIKV and 96 cases of DENV, 347 all travel-associated (ECDC: https://www.ecdc.europa.eu/en/surveillance-atlas-infectious-348 diseases. Last accessed: October 2023). However, changing climate, which favors vector 349 activity and viral replication, coupled with increased globalization (including travel, migration, 350 and international trade), is expected to lead to a rise in CHIKV and DENV cases across 351 Europe. In fact, the A. albopictus is presently expanding across Europe temperate and 352 Mediterranean regions, being established in Italy, France, and Spain, among other countries, 353 where it has mostly been associated to intermittent and short-lived outbreaks rather than 354 continuous transmission (ECDC: https://www.ecdc.europa.eu/en/publications-data/aedes-355 albopictus-current-known-distribution-august-2023. Last accessed: October 2023).

DENV exhibited its highest concentration and positivity rate in September 2022, with a 356 357 resurgence between March and April 2023. In contrast, CHIKV was predominantly detected 358 from January 2023 onward. There is no discernible seasonality associated with either virus, 359 and the peak in the number of cases in Europe varies from year to year, influenced by climatic 360 conditions and fluctuating travel patterns (The European Climate Adaptation Platform Climate-361 ADAPT: https://climate-adapt.eea.europa.eu/. Last accessed: October 2023). This lack of seasonality pattern may be due to the high ecological adaptability and plasticity of A. 362 albopictus, with cold-acclimated adult mosquitoes and drought-resistant eqgs.²⁵ 363

Portugal, being a significant tourist destination, experienced a substantial influx of international 364 365 guests, with peaks in July, August, September, and October. This surge in tourism, equivalent 366 to approximately 20% of the country's population in these months, may have a notable impact 367 the presence DENV de Portugal: on of and CHIKV (Turismo 368 https://travelbi.turismodeportugal.pt/turismo-em-portugal/turismo-em-numeros-2022/. Last accessed: October 2023). Portugal also attracted an increasing number of immigrants, 369 370 including digital nomads from countries such as Brazil, the USA, and the UK, potentially

371 contributing to the circulation of these viruses. Moreover, Portugal has direct flight around the year from Sub-Saharan Africa and Latin America, specially from countries that are former

372 373 Portuguese territory.

374 In addition to its status as a significant tourism hub, Portugal has also emerged as an enticing permanent 375 destination for residence (Instituto Nacional de Estatística: 376 https://www.ine.pt/xportal/xmain?xpid=INE&xpgid=ine_publicacoes&PUBLICACOESpub_bo 377 ui=65586079&PUBLICACOESmodo=2. Last accessed: October 2023). Between December 378 2021 and December 2022, Portugal's population experienced a notable increase of 46,249 379 individuals, primarily driven by a net migration influx of nearly 87,000 people. This marked an 380 uptick of nearly 15,000 migrants compared to the previous year (DGS: https://www.dgs.pt/emdestaque/mosquito-aedes-albopictus-identificado-no-municipio-de-lisboa.aspx. 381 Last 382 accessed: October 2023).

383 Notably, the SARS-CoV-2 pandemic shifted established work norms towards remote employment, leading to a surge in digital nomads choosing Portugal as their touch base. 384 385 Census data for the year 2021 reveals that Brazil, Italy, and India ranked among the top five 386 nationalities of immigrants, with Brazil comprising nearly 30% of the total immigrant population 387 Nacional (Instituto de Estatística: 388 https://www.ine.pt/xportal/xmain?xpid=INE&xpgid=ine_publicacoes&PUBLICACOESpub_bo 389 ui=65586079&PUBLICACOESmodo=2. Last accessed: October 2023). Additionally, the 390 number of immigrants from South Asian nations like India and Pakistan has experienced a 391 steep rise in the mainland territory for the past two years since the last census. Major 392 Portuguese cities, including Lisbon, Porto, Setúbal, Faro, and Braga, situated within the 393 regions under study, attract the majority of immigrants and also host the highest influx of 394 tourists. Consequently, the interplay between tourism to and from Portugal, coupled with the 395 escalating immigrant population, may have played a role in influencing the positivity rates and 396 concentrations of both viruses in the region.

397 Before this study, in the scope of another work particularly focusing on the fate of SARS-CoV-398 2 across the water cycle, we have detected, via shotgun viral metagenomic sequencing by 399 Illumina, a densovirus (Brevidensovirus genus, subfamily Densovirinae) specific of A. albopictus (Cunha et al., unpublished data). Detection of this densovirus in raw wastewater 400 401 from the North, Algarve and LVT regions of Portugal was confirmed for a number of samples 402 collected during 2021. Mosquito densoviruses exert mosquito-specific entomopathogenicity 403 and their detection may also be used as proxy of mosquito occurrence. According to the 404 ECDC, the distribution of A. albopictus in the mainland territory of Portugal between March 405 2021 and August 2023 was confined to the North (Penafiel) and the Algarve regions (ECDC: 406 https://www.ecdc.europa.eu/en/publications-data/aedes-albopictus-current-known-

407 distribution-august-2023. Last accessed: October 2023). However, using metagenomic 408 detection of A. albopictus densivirus in wastewater as proxy for the presence of the mosquito 409 vector, wastewater analyses was able to extend information on the spatial distribution of A. 410 albopictus across the mainland territory, confirming for the first time its occurrence in the 411 Lisbon area already back in 2021, a fact that only in 2023 was confirmed via classical mosquito 412 https://www.dgs.pt/em-destaque/mosquito-aedes-albopictusmethods (DGS: trapping identificado-no-municipio-de-lisboa.aspx. Last accessed: October 2023). This additional data 413 414 supports the utility of WBS for understanding the circulation trends of arboviral pathogens and 415 their vectors.

- Despite the absence of reported DENV and CHIKV cases in Portugal, uncertainties persist 416 417 regarding disease occurrence when testing wastewater. Information on the concentration of 418 viral particles excreted by infected individuals, whether symptomatic or asymptomatic, or the
- 419 concentration of these viruses in the vectors is limited and challenging to obtain. Wastewater

420 surveillance is not suitable for intervention at the individual level and cannot discriminate 421 infection patterns from permanent and transient populations.

422 Nonetheless, this study successfully identified the presence and concentration of DENV and 423 CHIKV, even in the absence of data for reported cases. The lack of reporting can be attributed 424 to several factors, including the absence of symptoms, the presence of mild symptoms, or 425 misdiagnosis. For example, it is estimated that only around 25% of DENV cases exhibit 426 symptoms.⁵ Moreover, both DENV and CHIKV can cause mild and common symptoms, such 427 as fever, headache, muscle pain, and fatigue, which are also typical of SARS-CoV-2, influenza 428 or other entero- or neurotropic viruses. This leads to a situation where asymptomatic 429 individuals may not seek medical care, and even when they do, they may receive a 430 misdiagnosis.

Continuous and active surveillance remains indispensable to timely detect and manage 431 432 potential outbreaks caused by Dengue and Chikungunya viruses. The detection of A. 433 albopictus densiviruses across WWTP via unbiased metagenomic sequencing, together with 434 tailored molecular diagnostic tests targeting the genome of specific arboviruses in wastewater. 435 enrich the available surveillance toolbox for relevant arboviral diseases, which traditionally has 436 been circumscribed to syndromic surveillance and vector trapping/testing. These novel 437 approaches combining the information pool from wastewater and clinical samples amplify 438 methodological choices for predicting the infection risk, aiding to prevent and mitigate potential 439 Dengue and Chikungunya outbreaks. Furthermore, since mosquito surveillance and control 440 remain the most effective strategy to prevent and reduce arboviruses transmission, integrating 441 vector occurrence and distribution from wastewater data with ongoing harmonized 442 surveillance of Aedes invasive mosquito species is crucial to mitigate human vector-borne 443 diseases.

444 Further research is warranted to comprehensively understand the levels of arboviral excretion 445 by symptomatic and asymptomatic individuals, patterns of infection, and vector dynamics. 446 Such knowledge would enable accurate modeling of the number of infected individuals within 447 a sewer system based on viral concentration, thereby facilitating the modeling of epidemiological parameters.²⁶⁻²⁷ Nevertheless, WBS is poised to become an even more critical 448 tool in combating arboviral diseases, both in endemic and non-endemic regions, as these 449 450 areas are expected to become increasingly susceptible to diseases such as dengue and 451 chikungunya.
