### Document characteristics: source, use, and nature of evidence

Literature	Formal data	<p>76 articles from Medline, EMBASE, Web of Science, Cochrane Database of Systematic Reviews, and PsycINFO. There were 28 articles from the UK; 15 from the USA; six from Australia; five from Ireland; four each from the Netherlands and New Zealand; three each from Norway, Canada and Spain; one each from Denmark, Ghana, Israel and Malta; one was undetermined. There were 50 empirical studies (including three quality improvement studies): 15 qualitative studies; 18 randomised trials; four other types of trials; nine observational; three quantitative; one mixed-methods. Twenty-three empirical studies were from the UK; six from the USA; five from Ireland; three each from Australia, Spain, and Norway; the remainder from New Zealand, the Netherlands, Italy, Canada, Denmark, Israel, Ghana, Malta. We included nine literature reviews and 17 commentary articles.</p> <p>Included articles are listed alphabetically below.</p>

Wider STEP-UP team and advisory group	Feedback, advice and sense-making	<p>Discussion and feedback from four face-to-face meetings (three in the regular wider STEP-UP team meetings and one as part of the advisory group meeting). In addition to the multi-professional and interdisciplinary expertise of the wider STEP-UP team, the advisory panel had representation from a lay member, commissioner, national policy maker and an epidemiologist.</p>
