29 ABSTRACT

30 Objectives: This study aimed to validate the Japanese version of the Survey of Perceived Organizational  
31 Support (SPOS-J) for the Japanese workforce by examining its reliability, factorial, construct, and  
32 test-retest validity.

33 Methods: We conducted an online baseline survey with 6,220 employed Japanese individuals, followed  
34 by a follow-up survey two weeks later to examine the test-retest reliability of the SPOS-J. The SPOS-J  
35 was translated in accordance with the ISPOR Task Force Guidelines. Both confirmatory and exploratory  
36 factor analyses were utilized to examine factorial validity. Construct validity was assessed using  
37 Pearson's correlation analysis, while internal consistency was determined through the calculation of  
38 Cronbach's alpha values. Additionally, test-retest reliability was evaluated with Cohen's weighted kappa  
39 and intraclass correlation coefficients.

40 Results: The SPOS-J demonstrated a better fit for a two-factor structure, comprising two subscales -  
41 SPOS-J (supported) and SPOS-J (unsupported) – compared to the one-factor structure of the original  
42 version. It exhibited high internal consistency, with Cronbach's alpha coefficients of .93 for the overall  
43 SPOS-J, .97 for the SPOS-J (supported), and .95 for the SPOS-J (unsupported). Test-retest reliability  
44 was found to be good for the overall SPOS-J (.62) and moderate for its subscales, with Cohen's weighted  
45 kappa values of .54 for SPOS-J (supported) and .42 for SPOS-J (unsupported). The construct validity  
46 was confirmed with significant correlations between the SPOS-J, its antecedents, and outcomes.

47 Conclusions: The SPOS-J is a reliable and valid measure for assessing perceived organizational support  
48 among Japanese workers.

## 49 1. INTRODUCTION

50 Perceived Organizational Support (POS) is a concept proposed by Eisenberger et al.<sup>1</sup> in 1986, and is  
51 defined as "global beliefs concerning the extent to which the organization values their contributions and  
52 cares about their well-being." A major characteristic of POS is that it focuses not on the company's  
53 (management and human resource management department's) point of view, but on the employee's point  
54 of view, i.e., how the employees who work there feel about the company. POS is based on social  
55 exchange theory, the theory that human beings form and develop relationships through the exchange of  
56 various tangible and intangible rewards<sup>1</sup>. Therefore, it is based on the idea that the more support an  
57 employee feels from the organization, the more favorable the employee feels toward the organization,  
58 and the more the employee will make further efforts to contribute to the achievement of the  
59 organization's goals. Therefore, POS is seen as a concept with important benefits for both employees and  
60 organizations, and research on POS began to increase in the mid-1990s and has progressed rapidly in  
61 recent years.

62 Studies have shown a relationship between POS and a variety of health-related indicators.  
63 Antecedents of POS include procedural justice<sup>2</sup> (i.e., one of the sub-concepts of organizational justice),  
64 supervisor support<sup>3,4</sup>, organizational rewards<sup>5</sup>, and job conditions<sup>6-8</sup>, while outcome factors include  
65 emotional commitment to the organization<sup>3</sup>, job satisfaction<sup>9</sup>, performance<sup>10,11</sup>, and withdrawal  
66 behavior<sup>4,12</sup>. Many of these antecedent and outcome factors are positively correlated with POS. On the  
67 other hand, antecedent factors such as job conditions (role ambiguity<sup>7</sup>, role conflict<sup>8</sup>, size of  
68 organization<sup>7</sup>) and organizational politics<sup>13</sup>, and outcome factors such as withdrawal behavior (turnover

69 intentions<sup>12</sup>, turnover<sup>4</sup>) and strains are negatively correlated with POS.

70 A representative measure of POS is the Survey of Perceived Organizational Support (SPOS)<sup>14</sup>. The  
71 SPOS is a 36-question measure developed by Eisenberger et al. in 1986<sup>1</sup>. In much of the past literature,  
72 the original version of the SPOS was one-dimensional and had high internal reliability, leading to the use  
73 of shortened versions such as the 16-item version<sup>1</sup> and the 8-item version<sup>6</sup>. Studies using the SPOS have  
74 been conducted mainly in English-speaking countries, European countries, and China, and besides the  
75 English version, Malay<sup>15</sup> and Turkish<sup>16</sup> versions of the SPOS have been developed. However, there is  
76 currently no Japanese version of the SPOS that has been tested for reliability and validity; therefore,  
77 studies have been conducted using original questionnaire items that reflect the POS concept<sup>17</sup>, and it has  
78 not been possible to compare findings from Japanese studies with those from foreign studies.

79 Currently, in many developed countries, including Japan, the working-age population is declining due  
80 to the low birthrate and aging population<sup>18</sup>. Therefore, companies are faced with the need to make  
81 strategic efforts to improve POS by showing active consideration for the well-being of their employees,  
82 and to aim at improving corporate performance and curbing employee turnover behavior through  
83 improving employee job satisfaction and work engagement. Furthermore, since companies need to build  
84 good relationships with diverse employees due to the recent diversification of employee employment  
85 patterns and needs, concepts, and indicators that reflect employees' evaluations and opinions of the  
86 company, such as POS, are considered useful in verifying the effectiveness of personnel policies that aim  
87 to absorb diversity.

88 The purpose of this study is to examine the reliability and validity of the Japanese version of the

89 SPOS (SPOS-J) for the general workforce in Japan. More specifically, we examined its factorial and  
90 construct validity as well as its reliability (i.e., internal consistency and test-retest reliability).

## 92 2. METHODS

### 93 2.1 Participants

94 A baseline online survey was conducted from January 24 to February 3, 2022, among registrants of  
95 Cross Marketing Inc. (Tokyo, Japan), a private online survey firm in Japan. As of January 2022, there  
96 were approximately 2.95 million registered participants, from which 102,032 were randomly selected to  
97 receive participation invitations via e-mail. Of these, 15,676 responded to the preliminary survey and  
98 participated in the main survey (baseline survey) if they met all of the screening criteria: (1) age 20–64,  
99 (2) currently working, and (3) employed (full-time, contract, temporary, part-time, or casual employee).  
100 For this baseline survey, the sample was collected based on data from the 2020 Labor Force Survey  
101 (Ministry of Internal Affairs and Communications), stratified by gender (men: 54.4%, women: 45.6%),  
102 age (20–29: 18.6%, 30–39: 21.1%, 40–49: 27.7%, 50–59: 24.0%, 60–64: 8.7%), and region of residence  
103 (Hokkaido: 3.8%, Tohoku: 6.5%, South Kanto: 31.6%, North Kanto/Koshin: 7.4%, Hokuriku: 4.1%,  
104 Tokai: 12.2%, Kinki: 15.7%, Chugoku: 5.5%, Shikoku: 2.6%, Kyushu/Okinawa: 10.5%). Responses to  
105 this survey were on a first-come, first-served basis, and due to budget constraints, the target number of  
106 respondents was set at 6,000, and once the final 6,220 respondents were reached, the recruitment process  
107 was closed because the sample was collected at a stratified percentage.

108 In addition, to examine the test-retest reliability of the SPOS-J, a follow-up study using the SPOS-J

109 was conducted two weeks after the baseline study. The follow-up survey was administered to those  
110 respondents to the baseline survey who answered "no" to both (1) "changed workplaces within the past  
111 two weeks" and (2) "had a significant change in workplaces within the past two weeks" at the time of  
112 their follow-up survey responses. As in the baseline survey, responses were on a first-come, first-served  
113 basis, and the survey was closed when the number of respondents reached 452. Because the online  
114 survey required all questions to be answered, no participants had incomplete responses.

## 116 2.2 Measures

### 117 2.2.1 SPOS-J

118 The Japanese version of SPOS was prepared in accordance with International Society for  
119 Pharmacoeconomics and Outcomes Research (ISPOR) Task Force Guidelines<sup>19</sup>. First, permission for  
120 Japanese translation was obtained from the original author (Robert Eisenberger), and the original version  
121 of SPOS<sup>1</sup> was independently translated into Japanese by four native Japanese-speaking researchers (KO,  
122 TN, HE, and KM), and a draft Japanese version was prepared after discussion among the researchers.  
123 Next, native experts who had not read the original text were asked to translate the draft Japanese version  
124 into English. The original author reviewed the back-translated English version, and the draft Japanese  
125 version was revised. Since there is no corresponding Japanese word for "well-being" and the specific  
126 image of "well-being" varies from person to person, we consulted with the original author and added the  
127 definition from the Longman Dictionary of Contemporary English<sup>20</sup>, adding that it is in the context of  
128 work, "a feeling of being comfortable, healthy, and happy through work" was added as a supplementary

129 explanation. Next, as a cognitive debriefing, we asked five workers of various occupations and ages  
130 collected through snowball sampling for their opinions by asking them, "Please advise us if you have  
131 any difficulty understanding or answering any questions in Japanese. As a result, minor comments were  
132 received, including suggestions for the use of more easily understood verbs and adjectives. The four  
133 researchers considered the pros and cons of reflecting these comments in the translation, and adjusted  
134 the translation so that it would not affect the meaning when translated into English. The Japanese version  
135 of SPOS (SPOS-J) was thus completed.

136 The SPOS-J consists of 36 items, and as in the original version of the SPOS, respondents were asked  
137 to respond to each item on a 7-point scale (0 = strongly disagree to 6 = strongly agree). Of the 36 items,  
138 18 items asked for positive content, while the remaining 18 items asked for negative content. The  
139 scoring of the latter items asking about negative content was reversed, with higher scores for all items  
140 indicating a higher POS. Finally, the average score for the 36 items was calculated.

141

#### 142 2.2.2 Relevant Variables

143 In this study, the following indicators were selected based on the fact that existing studies have shown  
144 that these indicators have a strong correlation with POS<sup>14</sup> and that valid Japanese language scales are  
145 available for use. Role conflict from job conditions and intention to leave from withdrawal behavior  
146 were selected as indicators of negative correlation with POS.

148 Possible antecedents



149 · Supervisor Support : The corresponding subscale of the New Brief Job Stress Questionnaire (New  
150 BJSQ) was used. The New BJSQ has been validated with Japanese workers and found to have  
151 acceptable levels of internal consistency, reliability, and construct validity on almost all subscales<sup>21</sup>.  
152 Three items from the New BJSQ regarding supervisor support (e.g., How freely can you talk with your  
153 supervisor?) were rated using a 4-point scale (1 = extremely to 4 = not at all). The scores were reversed  
154 in the analysis to make them more intuitive and easier to understand, and the average score for the three  
155 items was calculated. The Cronbach's alpha coefficient for this scale was .88.

156 · Organizational Justice (procedural justice/ interactional justice) : Using the Japanese version of the  
157 Organizational Justice Scale<sup>22</sup>, which is the Japanese version of the modified version of the  
158 Organizational Justice Scale<sup>23</sup> developed by Moorman<sup>24</sup>, we rated each of the two subscales, procedural  
159 justice (7 items) and interactional justice (6 items), using a 5-point scale (1 = strongly disagree to 5 =  
160 strongly agree) and calculated the mean score. Cronbach's alpha coefficients for these subscales were .94  
161 and .96 for procedural and interaction justice, respectively.

162 · Role conflict : One item on the New BJSQ ("I receive incompatible requests from two or more people")  
163 was rated using the four-point scale (1 = definitely to 4 = not at all), and the scores were reversed in the  
164 analysis for easier understanding.

165

166 Possible outcomes

167 · Job Satisfaction : One item ("I am satisfied with my job") from the New BJSQ was used to evaluate the  
168 results. This indicator was rated using a 4-point scale (1 = satisfied to 4 = dissatisfied), and the scores

169 were reversed in the analysis for ease of understanding.

170 · Organizational (Affective) commitment : Three items from the Japan Institute of Labour (Current The  
171 Japan Institute for Labour Policy and Training) Human Resource Management checklist<sup>25</sup> regarding  
172 affective commitment (e.g., "I feel as if this company's problems are my own problems") were evaluated  
173 using a 5-point scale (1 = not at all true to 5 = very true), and the average score was calculated. The  
174 Cronbach's alpha coefficient for this scale was .73.

175 · Turnover intention : A one-question shortened version of the Japanese version of the Turnover Intention  
176 Scale<sup>26</sup> ("How often have you seriously considered quitting your current job?") was used and rated using  
177 a 6-point scale (1 = not at all to 6 = very often).

178

### 179 2.2.3 Demographic Characteristics

180 Participant demographic items were collected at the time of the baseline survey. In addition to gender  
181 (men, women) and age, respondents were asked to provide their final education (junior high school/high  
182 school, vocational school/junior college, university/graduate school), household income (< 3.00 million  
183 Japanese yen (JPY), 3.00–4.99 million JPY, 5.00–9.99 million JPY, and 10.00 million JPY or greater),  
184 and job type (administrative, professional/technical, clerical, sales, service, security,  
185 agriculture/forestry/fishing, production process jobs, transportation/machine operation,  
186 construction/mining, transportation/cleaning/packaging, and others) based on the Japan Standard  
187 Occupational Classification (statistical standard established in December 2009).

188

### 189 2.3 Statistical Analysis

190 A confirmatory factor analysis was performed using a one-factor model for SPOS-J based on the  
191 original version of SPOS<sup>1</sup> by Eisenberger et al. Model fit was evaluated using a combination of  
192 goodness-of-fit indices, including  $\chi^2$  goodness-of-fit statistic, Root Mean Square Error of Approximation  
193 (RMSEA), Akaike's Information Criterion (AIC), Comparative Fit Index (CFI), and Standardized root  
194 mean squared residual (SRMR). Acceptable model fit criteria were defined as RMSEA and SRMR <  
195 0.08 and CFI > 0.90<sup>27</sup>. In case the results of the confirmatory factor analysis showed a poor fit of the  
196 one-factor model, an exploratory factor analysis was conducted. Exploratory factor analysis (maximum  
197 likelihood method, promax rotation) was performed on all 36 items of the SPOS-J, and the number of  
198 factors was determined at the junction where the cumulative contribution exceeds 50%. A confirmatory  
199 factor analysis was performed on the factor structure supported by the exploratory factor analysis, and  
200 the model goodness of fit was compared to the one-factor structure of the original version.

201 To assess construct validity, Pearson's correlation coefficients were calculated for the SPOS-J  
202 (including subscales) with the antecedents (supervisor support, organizational justice, and role conflict)  
203 and outcome factors assumed above (job satisfaction, organizational commitment, and turnover  
204 intention). Following Cohen<sup>28</sup>, we describe effects as small (0.10), medium (0.30), and large (0.50). To  
205 assess internal consistency, we calculated Cronbach's alpha coefficients for the SPOS-J and its subscales.

206 To assess test-retest reliability, the Kolmogorov-Smirnov Test was first used to check whether the  
207 SPOS-J and its subscales, each of the 36 items, followed a normal distribution. Since these were found  
208 not to follow a normal distribution, Cohen's linearly weighted kappa coefficients were calculated for

209 each and evaluated using Landis & Koch criteria<sup>29</sup> (poor: -1.00 to 0.20; reasonable: 0.20 to 0.40;  
210 moderate: 0.41 to 0.60; good: 0.61 to 0.80; and very good: 0.81 to 1.00) . The intraclass correlation  
211 coefficient (ICC [1,1]) and standard error of measurement (SEM) were calculated as parametric statistics  
212 for test-retest reliability as reference values. Data from 452 individuals who responded to the follow-up  
213 survey were used to calculate Cohen's weighted kappa coefficient, ICC, and SEM.

214 The significance level was set at 0.05 (two-tailed). All analyses were performed using IBM SPSS  
215 Statistics Version 27.0, Stata version 16.

### 217 3 . RESULTS

#### 218 3.1 Characteristics of participants

219 Table 1 shows the number of participants in the baseline and follow-up surveys and the characteristics  
220 of the participants. In the baseline survey, participants had the same gender and age distribution as in the  
221 data from the 2020 Labor Force Survey (Ministry of Internal Affairs and Communications), and  
222 participants' annual household income of 5.00–9.99 million JPY was the highest (43.2%), and 50.5% of  
223 participants had a college degree or higher as their final education level. The most common occupations  
224 were clerical, professional/technical, and service, in that order. There were no significant differences in  
225 gender, age, final education, or occupation between baseline and follow-up.

226

#### 227 3.2 Factorial validity

228 Based on the original version of the SPOS, a confirmatory factor analysis was performed on the

229 SPOS-J with a one-factor model, and the model fit was significantly lower ( $\chi^2 = 85197$ ;  $P < 0.001$ ,  
230 RMSEA = 0.151, SRMR = 0.245, CFI = 0.511, AIC = 85341), so an exploratory factor analysis was  
231 performed. The number of factors was determined at the boundary point where the cumulative  
232 contribution exceeds 50%, and the number of factors was set to 2. The results of exploratory factor  
233 analysis (maximum likelihood method, promax rotation) under the assumption of two factors are shown  
234 (Table 2). The results indicate that the SPOS-J has a two-factor structure, with the first factor being items  
235 asking for supportive content (e.g., my organization values my opinion) and the second factor being  
236 items asking for non-supportive content (e.g., my organization shows little interest in my interests).  
237 Therefore, the first factor was designated SPOS-J (supported), and the second factor was designated  
238 SPOS-J (unsupported). A confirmatory factor analysis was performed on the 2-factor model, and the  
239 model fit was higher than the 1-factor ( $\chi^2 = 24706$ ;  $P < 0.001$ , RMSEA = 0.081, SRMR = 0.067, CFI =  
240 0.861, AIC = 24852), but not sufficient in terms of the acceptable model fit criteria set in this study  
241 (RMSEA, SRMR  $< 0.08$ , CFI  $> 0.90$ ) (Table 3).

242

### 243 3.3 Construct validity

244 Table 4 shows the correlations between the SPOS-J and its two subscales, SPOS-J (supported) and  
245 SPOS-J (unsupported), and all study variables, including antecedents (supervisor support, organizational  
246 justice [procedural and interactional], and role conflict) and outcome factors (job satisfaction,  
247 organizational commitment, and turnover intention). The two subscales showed a small negative  
248 correlation with role conflict, a small to medium negative correlation with turnover intention, and small

249 to high positive correlations with other antecedents and outcome factors.

250

251 3.4 Reliability (internal consistency and test-retest reliability)

252 Table 5 shows the Cronbach's alpha coefficients, Cohen's weighted kappa coefficients, ICCs, and  
253 SEM for SPOS-J, SPOS-J (supported), and SPOS-J (unsupported). Cronbach's alpha coefficients for  
254 SPOS-J, SPOS-J (supported), and SPOS-J (unsupported) showed high consistency (.93, .97, and .95,  
255 respectively). In addition, Cohen's weighted kappa coefficients and ICCs showed good test-retest  
256 reliability for SPOS-J and moderate test-retest reliability for SPOS-J (supported) and SPOS-J  
257 (unsupported) in the 2-week interval test-retest.

259 4 . DISCUSSION

260 4.1 Reliability and validity

261 This study created the SPOS-J and verified its reliability and validity. To assess factorial validity,  
262 confirmatory and exploratory factor analyses were conducted, and to assess construct validity, the  
263 SPOS-J was examined in relation to antecedent and outcome factors identified from existing research.  
264 Furthermore, internal consistency and test-retest reliability were examined to assess the reliability of the  
265 SPOS-J.

266 Regarding Factorial validity, the two-factor structure consisting of two subscales, SPOS-J (supported)  
267 and SPOS-J (unsupported), was a better fit than the one-factor structure in the original version. SPOS-J  
268 (supported) items asked for supportive content, while SPOS-J (unsupported) items asked for

269 non-supportive content. This result may be related to the cultural background of the Japanese. While the  
270 West has an independent construal of self, Japan is known to have a predominantly interdependent  
271 construal of self, and a culture shaped by an interdependent construal of self will tend toward self-critical  
272 self-evaluation, focusing on its own weaknesses and problems in comparison to the ideal role image by  
273 society<sup>30</sup>. In fact, it has been reported that in Japan, there is a self-critical tendency to evaluate oneself  
274 lower or more negatively than others<sup>31</sup>. This tendency toward self-criticism may be the result of low  
275 self-estimation as well as high estimation of others, and Endo<sup>32</sup> reported the possibility that Japanese  
276 people are simultaneously lowering their self-estimation and raising their evaluation of others. In the  
277 SPOS-J survey, respondents were asked to evaluate their own organizations, and from their perspective,  
278 the organizations to which they belonged could be considered as others. Therefore, it is possible that  
279 respondents gave stronger positive evaluations of their own organizations and weaker negative  
280 evaluations of others, resulting in a two-factor structure that eliminates the one-dimensionality of the  
281 results.

282 In this validation, the model fit was not necessarily sufficient even for the two-factor model. One  
283 reason for this is that the present validation was conducted using all 36 items of the SPOS-J. These items  
284 may include questions that are inappropriate or meaningless depending on the country's culture,  
285 employment system, or specific industries (e.g., civil servants and other industries with high  
286 employment security). In fact, when examining the reliability and validity of the SPOS for teachers,  
287 Dolma et al.<sup>16</sup> excluded items from the 36 items of the SPOS that were not appropriate for their  
288 employment environment as teachers. The original version of the SPOS<sup>1</sup> by Eisenberger et al. was

289 basically developed to understand POS for U.S. workers. To develop POS research in Japan in the future,  
290 it is necessary to improve the scale to make it more suitable for Japanese workers by removing items that  
291 do not fit Japanese culture and labor practices.

292 Regarding construct validity, this study examined the relationship between supervisor support,  
293 organizational justice [procedural and interactional], and role conflict as antecedents of the SPOS-J. The  
294 SPOS-J was highly correlated with supervisor support ( $r = .52$ ). Several studies examining supervisor  
295 support as a variable affecting POS have confirmed a highly positive relationship between supervisor  
296 support and POS<sup>3,4,33</sup>, which is consistent with the results of this study. Regarding organizational justice,  
297 this study confirmed the relationship between the SPOS-J and procedural and interactional justice. We  
298 found a high positive correlation ( $r = .57$ ) between procedural justice and SPOS-J, which is consistent  
299 with the finding of Moorman et al.<sup>2</sup>. Interactional justice has also been reported to be positively  
300 correlated with POS<sup>34</sup>. The results of a meta-analysis by Rhoades & Eisenberger<sup>14</sup> also reported a high  
301 correlation between interactional justice and POS, consistent with the results of this study ( $r = .59$ ).  
302 Stressors are another antecedent of POS, but research on POS has focused primarily on the effects of  
303 stressors related to their role in the organization. Regarding role conflict, a role-related stressor, several  
304 studies<sup>8,35</sup> have shown that role conflict and POS are negatively correlated, but the strength of the  
305 correlation ranges ( $r = -.20$  to  $-.64$ ). The results of this study showed a medium negative correlation ( $r =$   
306  $-.23$ ), which was close to the results of Hutchison et al.<sup>35</sup>.

307 We examined the relationship between job satisfaction, organizational (affective) commitment, and  
308 turnover intention as outcome factors on the SPOS-J. Job Satisfaction has been empirically found to



309 have a medium positive correlation with POS<sup>9</sup> and was generally consistent with the results of this study  
310 ( $r = .46$ ). Based on social exchange theory and the idea of reciprocity norms, Eisenberger et al.<sup>1</sup> argue  
311 that POS can foster a sense of obligation to the organization and increase affective commitment to the  
312 organization. The results of this study also showed that POS had a middle positive correlation ( $r = .43$ )  
313 with affective commitment, and many existing studies<sup>5,10,36</sup> found a positive relationship between POS  
314 and affective commitment, although the strength of the correlation varied ( $r = .38$  to  $.81$ ) . This variation  
315 may have been caused by differences in the target population. In a meta-analysis by Rhoades &  
316 Eisenberger<sup>14</sup>, among withdrawal behaviors (turnover intentions, turnover, and other withdrawal  
317 behaviors), the strongest relationship with POS was found for turnover intentions, and turnover  
318 intentions have been empirically shown to have a middle negative correlation with POS<sup>12</sup>. This result  
319 was consistent with the results of this study ( $r = -.39$ ).

320 The SPOS-J (unsupported), a subscale of the SPOS-J, had weaker correlations with all antecedent and  
321 outcome factors than the SPOS-J or another subscale, the SPOS-J (supported). This result may be due to  
322 the tendency of Japanese people to evaluate negative evaluations of other organizations more weakly  
323 because of their cultural background<sup>30,31</sup>.

324 For reliability, the internal consistency of SPOS-J, SPOS-J (supported), and SPOS-J (unsupported)  
325 was sufficient with Cronbach's alpha coefficients (.94, .92, and .87, respectively), and SPOS-J (36 items)  
326 was equivalent to the original version (36 items)<sup>1</sup>. Test-retest reliability was confirmed to be good for  
327 SPOS-J and moderate for SPOS-J (supported) and SPOS-J (unsupported), as indicated by Cohen's  
328 weighted kappa coefficient and ICC. To the best of our knowledge, we could not find any studies that

329 examined test-retest reliability abroad, but this study suggests that, at least for the SPOS-J, it has a  
330 certain level of test-retest reliability.

331

#### 332 4.2 Practical Implications

333 In recent years, there has been a great deal of research on the relationship between work engagement,  
334 which has received attention as a predictor of physical and mental health<sup>37</sup> and job performance<sup>38</sup>, and  
335 POS, and work engagement has been found to be positively related to POS<sup>39</sup>. The concept of  
336 strategically working to improve POS by showing active consideration for employee well-being, and  
337 aiming to improve corporate performance and curb employee turnover by improving employee job  
338 satisfaction and work engagement, is highly compatible with the concept of health and productivity  
339 management<sup>40</sup> that is gaining popularity in Japan. Therefore, making SPOS-J available as an evaluation  
340 indicator for organizations may contribute to the further development of occupational health practice and  
341 health and productivity management in Japan though the provision of a new evaluation indicator.

342

#### 343 4.3 Limitations

344 This study has several limitations. First, this study is an Internet-based survey and may not represent  
345 the general population of Japanese workers, since those who do not have Internet access or are not  
346 registered with an online survey firm are omitted from the target population. However, since this study is  
347 based on data from a labor force survey conducted by a public agency, and the sample was collected  
348 stratified by gender, age, and region of residence to reduce sampling bias, the generalizability of the

349 study's results is considered sufficient. Second, this study is based on survey data from self-reports, and  
350 the present results should be replicated in the future using objective measures (e.g., measures related to  
351 performance, leaving a job, and other behaviors). Third, this study did not assess known-groups validity,  
352 criterion validity, cross-cultural validity, or responsiveness.

353

## 354 5 . CONCLUSION

355 In conclusion, this study confirms that the Japanese version of SPOS (SPOS-J) can adequately  
356 measure POS and can be used in a Japanese context.
