Supplemental Methods

Joint Tensor Factorization algorithm

We adopt the model setting proposed in [1], which can be used to reduce the dimensions jointly between multiple temporal tensors formed by \bar{T}_1 and \bar{T}_2 through the objective function:

$$\min_{\lambda, a_{i,2}\xi} \sum_{i,j,t\in T_i} \left(\left(\bar{T}_1\right)_{ijt} - \lambda_1 a_i b_{ij} \xi_{it} \right)^2 + \sum_{i,j,t\in T_i} \left(\left(\bar{T}_2\right)_{ijt} - \lambda_2 a_{i,b_{2j}} \xi_2 t \right)^2$$

Where $q_1\lambda_1, \lambda_2$ are updated separately.

$$\begin{split} \hat{a}_{i}^{(t+1)} &= \arg _{a} \left[\sum_{j,t \in T_{i}} \left(b_{1j}^{(t)} \xi_{1}^{(t)} \lambda_{1}^{(t)} \right)^{(t)} + \left(b_{2j}^{(t)} \xi_{2t}^{(t)} \lambda_{2}^{(t)} \right)^{2} \right\} a_{i}^{2} \\ \mathbf{a} &- 2 \sum_{j,t \in T_{i}} \left\{ \left(\bar{T}_{1} \right)_{ijt} \lambda_{1}^{(t)} b_{1j}^{(t)} \xi_{1t}^{(t)} + \left(\bar{T}_{2} \right)_{ijt} \lambda_{2}^{(t)} b_{2j} \xi_{2}^{(t)} s_{2}^{(t)} \right\} a \right] \\ &= \frac{\sum_{j \cdot t \in T_{i}} \left\{ \left(\bar{T} \right)_{ij\tau} b_{1j}^{(t)} \xi_{1t}^{(t)} \lambda_{1}^{(t)} + \left(\bar{T}_{2} \right)_{ijt} b_{2j}^{(t)} \xi_{2\tau}^{(\tau)} \lambda_{2}^{(t)} \right\} \\ \lambda_{1}^{(t)} \sum_{t \in T_{i}} \xi_{1t}^{(t)^{2}} + \lambda_{2}^{(t)^{2}} \sum_{t \in T_{i}} \xi_{2t}^{(t)^{2}} \\ \hat{\lambda}_{1}^{(t+1)} &= \arg \lambda_{1} \min \left[\sum_{i,j,t \in T_{i}} \lambda_{1}^{2} (a_{i}b_{1j}\xi_{1}t)^{2} - 2 \sum_{i,j \cdot t \in T_{i}} \left(\bar{T}_{1} \right)_{ijt} a_{i}b_{1j}\xi_{1} \lambda_{1} \right] \\ &= \frac{\sum_{i,t \in T_{i}} \left(\bar{T}_{1} \right)_{itt} a_{vi} b_{ij}\xi_{1t} \\ \sum_{i,t \in T_{i}} \left(a_{i}\xi_{1t} \right)^{2} \\ \hat{\lambda}_{2}^{(t+1)} &= \frac{\sum_{i,j=t \in T_{i}} \left(\bar{T}_{2} \right)_{ijt} a_{i}b_{2j}\xi_{2t} \\ \sum_{i,j \in T_{i}} \left(a_{i}\xi_{1} \right)^{2}, \hat{b}_{1}^{(t+1)} &= \hat{b}_{1}^{(t+1)} / \left\| \hat{b}^{(t+1)} \right\|_{2} \\ \hat{b}_{2j}^{(t+1)} &= \frac{\sum_{i \in I_{i}} a_{i}\xi_{2t} \left(\bar{T}_{2} \right)_{ijt} , \hat{b}_{2}^{(t+1)} \\ \sum_{i,t \in T_{i}} \left(a_{i}\xi_{1t} \right)^{2}, \hat{b}_{2}^{(t+1)} &= \hat{b}_{2}^{(t+1)} / \left\| \hat{b}_{2}^{(t+1)} \right\|_{2} \end{split}$$

where a are subject loadings, b are feature loadings that can be used to identify features contributing to the beta analysis, $\xi^{(l)}(t)$ is the temporal loading that captures the shared temporal patterns among subjects and features, and λ quantifies the contribution of each component. For each b^1 and b^2 we define W^1 and W^2 respectively given by:

$$\mathbf{W}^1 = (\lambda_1 b^{1^T})^T$$
$$\mathbf{W}^2 = (\lambda_2 b^{2^T})^T$$

The temporal covariance and correlations of all features across all input matrices are calculated from the final estimated matrices by:

temporal feature covariance matrix =
$$\begin{bmatrix} W_1 \\ W_2 \end{bmatrix} \begin{bmatrix} W_1 \\ W_2 \end{bmatrix}^T$$

Which provides the estimated relationships between the features across both input temporal tensors across time.
