#### Childhood listening and associated cognitive difficulties persist into adolescence

15	Abstract (457 words /500 words)
16	Objective: Listening difficulty (LiD) refers to the challenges individuals face when trying to hear and
17	comprehend speech and other sounds. LiD can arise from various sources, such as hearing sensitivity,
18	language comprehension, cognitive function, or auditory processing. Although some children with LiD
19	have hearing loss, many have clinically normal audiometric thresholds. To determine the impact of
20	hearing and cognitive factors on LiD in children with a clinically normal audiogram, we conducted a
21	longitudinal study. The Evaluation of Children's Listening & Processing Skills (ECLiPS), a validated and
22	standardized caregiver evaluation tool, was used to group participants as either LiD or typically
23	developing (TD). Our previous study aimed to characterize LiD in 6- to 13-year-old children during the
24	project's baseline, cross-sectional phase. We found that children with LiD needed a higher signal-to-noise
25	ratio during speech-in-speech tests and scored lower on all assessed components of the NIH Cognition
26	Toolbox than TD children. The primary goal of this study was to examine if the differences between LiD
27	and TD groups are temporary or enduring throughout childhood.
28	
29	<b>Design:</b> This longitudinal study had three data collection waves for children with LiD and TD aged 6-13
30	years at Wave 1, followed by assessments at 2-year (Wave 2) and 4-year (Wave 3) intervals. Primary
31	analysis focused on data from Waves 1 and 2. Secondary analysis encompassed all three waves despite
32	high attrition at Wave 3. Caregivers completed the ECLiPS, while participants completed the Listening in

1	Spatialized Noise Sentences test (LiSN-S) and the NIH Toolbox Cognition Battery during each wave. The
2	analysis consisted of 1) examining longitudinal differences between TD and LiD groups in demographics,
3	listening, auditory, and cognitive function; 2) identifying functional domains contributing to LiD; and 3)
4	test-retest reliability of measures across waves. Mixed-effect models were employed to analyze
5	longitudinal data.
6	
7	Results: The study enrolled 169 participants, with 147, 100, and 31 children completing the required
8	testing during Waves 1, 2, and 3, respectively. The mean ages at these waves were 9.5, 12.0, and 14.0
9	years. On average, children with LiD consistently underperformed TD children in auditory and cognitive
10	tasks across all waves. Maternal education, auditory and, especially, cognitive abilities independently
11	predicted caregiver-reported listening skills. Significant correlations between Waves 1 and 2 confirmed
12	high, long-term reliability. Secondary analysis of Wave 3 was consistent with the primary analyses of
13	Waves 1 and 2, reinforcing the enduring nature of listening difficulties.
14	
15	Conclusion: Children with LiD and clinically normal audiograms experience persistent auditory,
16	listening, and cognitive challenges through at least adolescence. The degree of LiD can be independently
17	predicted by maternal education, cognitive processing, and spatial listening skills. This study underscores
18	the importance of early detection and intervention for childhood LiD and, for the first time, highlights the
19	role of socioeconomic factors as contributors to these challenges.

#### **1 INTRODUCTION**

2 Listening is commonly defined as an active form of hearing (Sweetow and Henderson-Sabes 2004). It 3 facilitates an accurate understanding of speech, a key component of everyday communication. Successful 4 communication allows healthy language development, as seen in improved language outcomes in children 5 with hearing loss who received early interventions (Pimperton and Kennedy 2012; Yoshinaga-Itano et al. 6 1998; Moeller 2000; Dettman et al. 2007). Problems with listening may similarly predispose children to 7 challenges in language acquisition. It is difficult, however, to determine the direction of the causal 8 pathway because children with primary language or other cognitive problems may have difficulties 9 comprehending speech that prevents them from active hearing (listening). Listening difficulty (LiD) 10 describes difficulty hearing and understanding speech and other suprathreshold sounds (Petley et al. 2021; 11 Dillon and Cameron 2021; Sharma et al. 2014). LiD is an umbrella term that describes symptoms; the 12 underlying causes of LiD may be problems in multiple domains, including hearing, language, cognition, 13 and auditory processing (Dillon and Cameron 2021; Sharma et al. 2009; Tomlin et al. 2015). Although 14 some children presenting with LiD have hearing impairments, as indicated by elevated audiometric 15 thresholds, other children with LiD have clinically normal audiometric sensitivity (Hind et al. 2011). To 16 clarify the contribution of hearing and cognitive factors to LiD for individuals with clinically normal 17 audiograms, we prospectively studied children with LiD, identified using a validated and standardized 18 caregiver questionnaire, Evaluation of Children's Listening & Processing Skills (ECLiPS) (Barry and 19 Moore 2021). 20 In the Sensitive Indicators of Childhood Listening Difficulties (SICLiD) study, we characterized LiD

21 in a cohort of 6- to 13-year-old children during a baseline, cross-sectional phase of the project, using 22 caregiver questionnaires and a battery of audiological, auditory processing, and cognitive tests (Petley et 23 al. 2021; Hunter et al. 2021). We found no group differences in audiological measures (pure-tone 24 audiometry, tympanometry, and middle ear muscle reflexes) between LiD and typically developing (TD) 25 children (Hunter et al. 2021). However, children with LiD required a higher signal-to-noise ratio during 26 speech hearing in noise testing (Listening in Spatialized Noise-Sentence, LiSN-S (Cameron and Dillon 27 2007)), had abnormal auditory processing measures tested using SCAN-3:C (Keith 2009), and lower 28 cognitive scores in all tested components of the NIH Cognition Toolbox (Weintraub et al. 2013b) relative 29 to their TD peers (Petley et al. 2021).

Whether LiD persists from childhood into adulthood or resolves over time remains unclear.
 Answering this question is essential for informing clinical management and understanding the
 mechanisms and consequences of LiD. If LiD is a persistent problem, more comprehensive assessment
 and aggressive treatment may be warranted compared to a transient problem of childhood. Some evidence
 suggests LiD may be persistent - young adults with a history of LiD in childhood reported ongoing

1 communication challenges nearly 10 years after initial diagnosis (Del Zoppo et al. 2015). However, 2 quantitative longitudinal data tracking changes in listening, auditory, and cognitive functioning in 3 children diagnosed with LiD earlier in life is lacking. As part of the SICLiD study, we performed 4 behavioral testing in the same cohort of children every two years to assess longitudinal changes. 5 Socioeconomic status has been associated with childhood cognitive performance (Christensen et al. 6 2014), language development (Pungello et al. 2009), mental health problems (Reiss 2013), and health 7 disparities (Fiscella and Williams 2004). However, the impact of social factors on LiD remains unclear. 8 Given the association between LiD and cognitive performance, we hypothesized that the degree of LiD 9 may also be associated with social factors. In a prior cross-sectional study, we developed a model 10 showing that SCAN-3:C, LiSN-S, and NIH Cognition Toolbox scores partially accounted for caregiver 11 reports of LiD (Petley et al. 2021). While social factors were evaluated, they were not incorporated into 12 the final model. Longitudinal data allowed us to assess social and other demographic factors across time 13 and with increased statistical power. 14 Evaluating longitudinal cognitive performance during development can be challenging because of the 15 different rates of development and potential practice effects (Sullivan et al. 2017). In the SICLiD study, 16 we used the NIH Cognition Toolbox to assess cognition. Weintraub et al. (2013b) showed that the 17 Toolbox test results had high reliability in pediatric samples with short testing intervals between 7 and 21 18 days, with intraclass correlations (ICCs) between 0.76 and 0.99. However, recent literature on the 19 reliability for longer intervals (> 1 year) has been mixed, with ICCs between 0.24 and 0.85 (Taylor et al. 20 2022) and 0.43 and 0.82 (Anokhin et al. 2022). The SICLiD study enabled evaluation of the reliability of 21 the NIH Cognition Toolbox over the years. 22 We had three aims in the current study. The primary aim was to evaluate longitudinal changes in 23 listening, auditory, and cognitive functions of children with LiD relative to control children. We 24 hypothesized that LiD would be long-lasting because LiD was seen across ages (between 6 and 13 years 25 old) in our Wave 1, cross-sectional data (Petley et al., 2021), and because of the general persistence 26 through adolescence and into adulthood of developmental problems associated with LiD, such as attention 27 (Hechtman et al. 2016; Roy et al. 2017), reading (Shaywitz et al. 1999; Lohvansuu et al. 2021), and 28 language (St Clair et al. 2011). Second, building on the previous model (Petley et al., 2021), we aimed to 29 develop an enhanced model of contributors to LiD using longitudinal data. Finally, we examined long-30 term test-retest reliability of the NIH Cognition Toolbox, ECLiPS, and LiSN-S by using prospectively 31 collected data from children with and without LiD. 32

#### 33 MATERIALS AND METHODS

1 The Institutional Review Board of Cincinnati Children's Hospital (CCH) Research Foundation

- 2 approved this study.
- 3 **Participants**

4 LiD and TD children were 6 to 13 years old at enrollment. The LiD group was recruited from 5 children referred to CCH for audiological evaluation and from the community. All the participants in the 6 TD group were recruited from the community. Recruitment from the community involved flyers posted in 7 relevant CCH clinics (Audiology, Pediatrics, Speech-Language Pathology) and emails sent to all CCH 8 employees and families interested in research. Interested caregivers completed (i) a background 9 questionnaire and (ii) the ECLiPS (Barry and Moore 2021) to confirm eligibility for the LiD or TD group. 10 Total standardized ECLiPS scores of  $\geq$  7 defined the TD group, and scores < 7 defined the LiD group. 11 However, four children with LiD had a previous audiologic diagnosis of auditory processing disorder 12 (APD) but scored 7 - 9 on the ECLiPS at enrollment. APD is a hypothesized source of LiD (Dillon and 13 Cameron 2021). The inclusion criterion for both groups was English as the child's native language. 14 Exclusion criteria for both groups were reported neurologic (e.g., epilepsy or stroke), psychiatric (e.g., 15 attention deficits hyperactivity disorder (ADHD) requiring medical treatment), or intellectual conditions 16 that would prevent or restrict their ability to complete testing procedures. The TD group additionally 17 could not have any reported listening difficulty, or cognitive or learning disorder (e.g., developmental 18 delay, attention, language, reading, or high-functioning autistic diagnoses). Eligibility was determined 19 based on caregiver responses to the background questionnaire. Groups were age-matched by proportional 20 sampling (Table 1). 21 One hundred sixty-six participants (74 with LiD, 92 TD) were enrolled; 19 withdrew or otherwise

exited the study (6 with LiD, 13 TD). Reasons for withdrawal were schedule conflicts, transportation
availability, and becoming ineligible after enrollment. The remaining 147 participants (68 with LiD, 79
TD) completed the assessments at baseline (Wave 1). After the initial study visit, we contacted the
participants after ~2 years (Wave 2) and 4 years (Wave 3) to collect longitudinal data. A total of 100 (52
with LiD, 48 TD) and 31 (16 with LiD, 15 TD) children participated in Wave 2 and 3, respectively (Table

1). The sample size for Wave 3 was notably smaller than other waves, partly because of the COVID-19

28 pandemic. All participants had clinically normal hearing bilaterally, as detailed below.

29 Procedure

All caregivers of eligible and interested participants reviewed the informed consent form with a study staff member and discussed the purpose, procedures, risks and benefits, duration, and expectations involved in the study. According to institutional policy, children aged 11 and above also assented using a child-friendly version of the consent document. All participants received financial compensation for their participation. Each participant completed audiometric and behavioral testing during the study visit, as

1 listed below. Several additional tests, including brainstem and cortical evoked responses and structural

2 and functional MRI, were also performed during the visit as part of the SICLiD study. The results of these

- 3 additional tests are beyond the scope and not included in the current manuscript. Some results of these
- 4 additional tests have been reported elsewhere (Hunter et al. 2021; Stewart et al. 2022; Hunter et al. 2023).

#### 6 Background Questionnaire

7 Study staff developed a background questionnaire to collect information about the participants, 8 including demographics, medical and surgical history, and socioeconomic status. This questionnaire lacks 9 reliability or validity data because of its basic nature. Specific information collected by this questionnaire 10 was age, sex, race, ethnicity, maternal education (a proxy for socioeconomic status (Sherar et al. 2016)), 11 primary language used at home, and diagnosis and treatment received for otologic, neurologic, behavioral, 12 developmental, and psychiatric problems. The questionnaire included specific developmental conditions 13 as examples, such as ADHD, autism spectrum disorder, and dyslexia. Caregivers completed the same 14 background questionnaire at each Wave. Demographic variables at each time point are summarized in 15 Table 1.

#### 17 Caregiver Evaluation of Children's Listening

18 The ECLiPS (Barry and Moore 2021) was administered at each wave to assess participants' 19 listening and communication abilities. This questionnaire consists of 38 straightforward statements (items) 20 describing behaviors commonly observed in children. Caregivers rated their child on a five-point scale, 21 ranging from strongly disagree to strongly agree, based on their agreement with each statement. These 22 ratings were averaged to derive age-scaled scores for five subscales: speech and auditory processing 23 (SAP), environmental and auditory sensitivity (EAS), language/literacy/laterality (L/L/L), memory and 24 attention (M&A), and pragmatic and social skills (PSS), each containing 6 to 9 distinct items. The 25 subscales were further grouped into Language, Listening, Social, and Total aggregate (composite) scores, 26 all of which were standardized with a population mean of 10 (SD = 3) based on British data (Barry et al. 27 2015). All ECLiPS subscales exhibit high test-retest reliability, with intraclass correlations (ICCs) above 28 0.8 (Barry and Moore 2021). Construct validity has been demonstrated through convergence with other 29 established tests measuring similar skills, including the Children's Auditory Processing Performance 30 Scale (CHAPS; (Smoski et al. 1998)), the CCC-2 (Bishop 2006), and the Social Communication 31 Questionnaire (Rutter et al. 2003). Although the ECLiPS provides scores for five latent factors related to 32 listening (SAP, EAS, L/L/L, M&A, and PSS), these scores are not validated for diagnosing specific 33 impairments in each area. Consequently, eligibility for inclusion in the LiD category was determined 34 based on the ECLiPS Total composite score (below 7, which defines a cutoff of < 1 SD from the

population mean). The Total composite score represents the overall degree of LiD (Barry and Moore
 2021) and is appropriate for this purpose.

#### 4 Audiometry

5 Otoscopy was completed, and if necessary, cerumen was removed before audiometry. All 6 audiometric tests were completed in a double-walled soundproof booth. Standard (0.25 - 8 kHz) and 7 extended high-frequency (10-16 kHz) thresholds were measured using the manual Hughson-Westlake 8 method for the range of 0.25 to 8 kHz at octave intervals and at four additional frequencies (10, 12.5, 14, 9 and 16 kHz) using an Equinox audiometer (Interacoustics Inc., Middelfart, Denmark) with Sennheiser 10 300 HDA headphones. Participants with elevated thresholds (>20 dB HL) in either ear and at any 11 standard clinical frequency were excluded and referred for further clinical care as appropriate.

## 13 The Listening in Spatialized Noise-Sentences (LiSN-S) test

14 The Listening in Spatialized Noise – Sentences (LiSN-S) test (Cameron and Dillon 2007; Brown 15 et al. 2010) measures the ability to listen and repeat simple, spoken sentences in the presence of 16 distracting sentences, developed using the same child-friendly criteria as the BKB sentences (Bench et al. 17 1979). We selected LiSN-S as the auditory assessment tool for the SICLiD study because of its 18 multifaceted approach to evaluating spatial and speech-hearing abilities, as well as its specific design for 19 use in pediatric populations. The LiSN-S (US Edition (Brown et al. 2010)) was administered at each wave 20 using a commercial CD played on a laptop, a task-specific soundcard, and Sennheiser HD 215 21 headphones. Participants were asked to repeat a series of target sentences, presented using virtual space 22 generic head-related transfer functions (Humanski and Butler 1988), directly in front (0°: diotic) while 23 ignoring two distracting speakers.

24 The LiSN-S has four listening conditions in which the distractors change voice (different or same 25 as target) and/or position ( $0^{\circ}$  and  $90^{\circ}$ ) (Humanski and Butler 1988). The LiSN-S is adaptive: the level of 26 the target speaker decreases or increases in SNR relative to the distracting speech if the listener responds 27 correctly or incorrectly during up to 30 sentences in each condition. The speech reception threshold (SRT) 28 represents 50% correct SNR for the condition. The Low Cue condition is where distractors are in the 29 same voice as the target and in front  $(0^{\circ})$  relative to the listener. Distractors are in different voices and 30  $\pm 90^{\circ}$  relative to the listener in the High Cue condition. Derived scores of the LiSN-S are the Talker 31 Advantage and Spatial Advantage, so-called because each is the difference between SRTs from two 32 conditions. This subtraction process should, to varying extent, separate auditory from cognitive influences 33 (Cameron and Dillon 2007; Petley et al. 2021). Spatial Advantage thus represents the participant's ability 34 to separate the spatial source of the speech using purely auditory cues, while Talker Advantage

1 demonstrates the participant's ability to distinguish individual talkers, which involves both acoustic and

2 linguistic information (Perrachione et al. 2011; Quinto et al. 2020). Test-retest comparisons for the four

3 listening conditions of the LiSN-S showed significant improvement from the first test to the second but

- 4 no differences in the advantage scores (Cameron et al. 2011).
- 5 A spatial "Pattern Score" is a quantitative clinical measure of the benefit of adding virtual spatial
- 6 cues to the information in the LiSN-S (i.e., target and distracting stimuli presented diotically) (Cameron
- 7 and Dillon 2011). The pattern score is calculated as follows.

- 8 The Pattern Score has been used as both a diagnostic score and a treatment outcome for a specific
- 9 auditory disorder termed Spatial Processing Disorder (SPD) (Cameron et al. 2011, 2012; Cameron et al.
- 10 2014). The age-specific cutoff value of the pattern score is determined as follows.

#### 12 Cognition (National Institutes of Health, NIH Toolbox)

Participants' cognitive abilities were evaluated using the NIH Toolbox for the Assessment of
Neurological and Behavioral Function, Cognition Domain (Weintraub et al. 2013a; Weintraub et al.
2013b). Participants completed testing either online or via an iPad app in a private sound-attenuated booth
or a quiet room at each wave. The precise composition of the testing battery depended on participant age.
Up to eight standardized cognitive instruments measuring different aspects of fluid or crystallized
reasoning were utilized.

19 All participants in this study completed the Picture Vocabulary Test (PVT), Flanker Inhibitory 20 Control and Attention Test (Flanker), Dimensional Change Card Sort test (DCCS), and Picture Sequence 21 Memory test (PSMT). Each test produced a US age-corrected standardized score. The scores from all four 22 tests were combined to calculate a single Early Childhood Composite (ECC), which provides a measure 23 of overall cognitive skill for children aged six years and older. The PVT is an adaptive test that evaluates 24 the participants' vocabulary skills. Participants listen to an audio recording of a word and select one of 25 four pictures that closely matches the word's meaning. The Flanker assesses the participant's ability to 26 inhibit responses and focus their attention. Participants report the direction of a central visual stimulus in 27 a series of five similar, flanking stimuli, where the flanking stimuli may either be congruent or 28 incongruent. The DCCS tests cognitive flexibility (attention switching). Target and test card stimuli vary 29 along two dimensions, shape, and color. Participants are asked to match test cards to the target card 30 according to a specified dimension that varies for each trial. The PVT and DCCS scores both measure 31 accuracy and reaction time. The PSMT assesses episodic memory by presenting illustrated objects and

1 activities along with audio-recorded descriptive phrases. Participants are scored on the number of adjacent 2 picture pairs correctly remembered over two learning trials. The length of the picture sequences varied 3 from 6 to 18 pictures based on the participant's age. The ECC score derived from these tests allows for a 4 comprehensive evaluation of overall cognitive performance in early childhood. 5 Children at least 8 years of age qualify for additional subtests from the Toolbox, contributing to a 6 Total Composite (TC) measure of general cognitive skill. These additional tests were administered to all 7 children 8 years of age and older (i.e., all children for Waves 2 and 3). Fluid Composite measures include 8 the list sorting working memory (LSWM), the pattern comparison processing speed (PCPS) tests, and the 9 DCCS, Flanker, and PSMT. The LSWM subtest evaluates working memory by requiring participants to 10 arrange visually and auditorily presented objects (food and animals) in order of size. In the PCPS subtest, 11 participants were instructed to indicate as quickly as possible whether two visually presented cards were 12 the same or different. Participants completed the Reading Recognition (RR) test in addition to the PVT 13 for the Crystallized Composite measure. The RR requires participants to read words and letters aloud. 14

#### 15 Analysis

16 The analysis of the study was divided into three distinct parts, each corresponding to a specific 17 aim of the research. In the first part, we evaluated the longitudinal changes in listening, auditory, and 18 cognitive functions of children with LiD in comparison to TD children. In the second part, we developed 19 a model to explain childhood listening difficulty using longitudinal data. Finally, the third part aimed to 20 establish the long-term test-retest reliabilities of the NIH Cognition Toolbox, ECLiPS, and LiSN-S, using 21 prospectively collected data.

22 In Part 1 of the analysis, we investigated differences between two groups, TD and LiD, on their 23 demographics, auditory, and cognitive function. Demographic information included age, sex, race, 24 ethnicity, and maternal education. Test scores of ECLiPS, LiSN-S, and NIH Cognition Toolbox were 25 compared. We used mixed-effect models (Verbeke 1997; Fitzmaurice et al. 2012) to analyze the 26 longitudinal data. These models can handle repeated measures and are flexible on missing data. We 27 assumed the data were missing at random (MAR) and used Restricted Maximum Likelihood (REML) 28 estimation. We tested the MAR assumption with Little's test (Little 1988). A mixed-effect model has 29 fixed effects and random effects. Fixed effects are variables that have a consistent effect on the outcome 30 variable, while random effects are variables that have a varying effect on the outcome variable depending 31 on the level of another variable. Mixed-effect models are useful for analyzing data that have repeated 32 measurements or hierarchical structures. Mixed-effect models can use both dependent and independent 33 variables of multiple time points by modeling the change in the outcome variable over time as a function

of fixed and random effects. This allows accounting for within-subject correlation and between-subject
 variations in the data.

3 For each demographic characteristic, we created a mixed-effect model using group (TD vs. LiD), 4 wave (Wave 1, 2, and 3), and interaction (Group x Wave) as fixed effects and participant as a random 5 effect. Maternal education was collapsed into four groups: up to high school education (High school), 6 some college education (College), Bachelor's degree (Bachelor), and post-graduate education (Post-grad). 7 Race was collapsed into two groups: white and non-white. Ethnicity was collapsed into two groups: 8 Hispanic or Latino and others. Demographic characteristics that are statistically different between groups 9 (p < .05) may confound the statistical analysis that compared behavioral testing results between TD and 10 LiD. Therefore, such demographic variables were included in the analyses to control potential 11 confounding. 12 Next, we evaluated longitudinal changes in listening and cognitive skills of TD and LiD children

13 using the ECLiPS sub-scores and Total Scaled score, LiSN-S Advantage, Cue and Pattern scores, and 14 NIH Cognition Toolbox sub-tests and composite scores. We constructed a mixed-effect model for each 15 test, incorporating fixed effects for group (TD vs. LiD), wave (Wave 1 vs. 2), interaction (Group x Wave), 16 and maternal education (a potential confounding variable), and participant as a random effect (Part 1a 17 model). All analyses were conducted using standardized scores adjusted for age on the test date. We 18 applied Benjamini and Hochberg (B-H) adjustment (Benjamini and Hochberg 1995) to the p-values for 19 multiple comparisons, accounting for eight ECLiPS sub-scores, four LiSN-S scores, seven NIH Cognition 20 Toolbox sub-scores, and four NIH Cognition Toolbox composite scores with a false discovery rate (FDR) 21 of less than 5%. Wave 3 data were not included in these mixed-effect models due to the smaller sample 22 size compared to other waves. To examine further longitudinal changes in Wave 3, we created separate 23 mixed-effect models using data only from participants who completed all three waves (Part 1b model).

24 In Part 2 of the analysis, our objective was to identify the functional domains that contributed to 25 LiD. We first tested whether a model developed in our prior cross-sectional study (Petley et al. 2021) 26 could predict the ECLiPS Total Scaled score at Wave 2. The original model included the SCAN-3:C 27 Composite Score, the LiSN-S Talker Advantage score, and the NIH PVT and DCCS scores as predictors 28 of ECLiPS Total Scaled scores at Wave 1. Since the SCAN-3:C was not administered in Wave 2, this 29 model included only the LiSN-S Talker Advantage score and NIH PVT and DCCS scores from Wave 2 30 as predictors. Next, we developed a new mixed-effect model using the longitudinal data to predict 31 ECLiPS Total Scaled scores. This longitudinal model included both predictor variables and outcome 32 variables from Waves 1 and 2 in a single mixed-effect model. Candidate predictors were maternal 33 education, five LiSN-S scores (Cue, Advantage, and Pattern scores), and measures of cognitive function 34 (either the seven NIH Cognition Toolbox subtests or the four NIH Toolbox composite scores), and the

outcome variable was the ECLiPS Total Scaled score in both Waves 1 and 2. By modeling the trajectories of ECLiPS scores over time as a function of the predictors, this approach accounts for both within-subject correlations across waves and between-subject variations. The random effects of the model capture individual differences in trajectories, while the fixed effects estimate overall trends. Separate models were tested using the NIH Cognition Toolbox subtests or composite scores as candidate predictors to avoid including duplicate variables in the model. Owing to its smaller sample size, Wave 3 was omitted from this longitudinal model.

8 All candidate predictors were initially examined against the ECLiPS Total Scaled score through 9 univariate analyses using a mixed-effect model, with participants used as a random effect and predictor 10 variables and the interaction term (predictor x wave) as fixed effects. Only variables with p < 0.1 in the 11 univariate analysis were included in the backward selection. Pairwise comparisons among the levels of 12 significant variables were adjusted for using Tukey-Kramer multiple adjustment. Beta weights for each 13 predictor variable were calculated to indicate the strength of their effects on the ECLiPS Total Scaled 14 score.

15 The aim of Part 3 of the analysis was to evaluate the test-retest reliability of the measures. To 16 achieve this, Intra-class correlation coefficients (ICC) and Pearson correlation coefficients were computed 17 to investigate the consistency of the test outcomes between Waves 1 and 2 for all participants. Wave 3 18 data were excluded from the analysis due to the limited sample size. Furthermore, we calculated test-19 retest differences as another relevant metric. For each measure, we subtracted the Wave 2 score from the 20 Wave 1 score for each participant. We then calculated the mean and standard deviation of these difference 21 scores. To determine whether there were any variations in the correlation coefficients between the TD and 22 LiD groups, the coefficients were calculated separately for each group, and z-tests were performed. To 23 avoid type I errors, the p-values were adjusted for multiple comparisons using the B-H adjustment method 24 (Benjamini and Hochberg 1995) with an FDR of less than 5%. B-H adjustment was separately applied to 25 four LiSN-S scores, seven NIH Cognition Toolbox sub-scores, four NIH Cognition Toolbox composite 26 scores, and eight ECLiPS sub-scores. All analyses used SAS version 9.4 (SAS Institute, Cary, N.C.), 27 setting the two-sided significance level at 0.05.

## 29 **RESULTS**

#### 30 LiD group associated with lower maternal education

31 Table 1 shows the number and demographics of participants in each group and wave. As Part 1 of our

32 analysis, we compared the TD and LiD groups on their demographics, auditory, and cognitive function.

33 Among the demographic variables, only maternal education differed significantly between the two groups,

34 with a significant Group x Wave interaction observed (see Table 1, Supp. Table 1). Specifically, the TD

1	group consistently had higher maternal education than the LiD group across all waves, and this difference
2	increased from Wave 1 to Wave 3. To address the potential confounding effect of maternal education, we
3	included it as a covariate in the subsequent analyses.
4	
5	Group differences in caregiver-reported listening skills were maintained at Wave 2
6	By design, the LiD group had lower ECLiPS scores than the TD group at Wave 1 (Figure 1A and Table 2)
7	(Petley et al. 2021). This difference between the groups persisted at Wave 2 (Analysis Part 1a model).
8	There was no significant change in ECLiPS scores across the two waves for either group. Furthermore,
9	there was no significant Group x Wave interaction effect, indicating that the listening skills of both
10	groups remained stable over time (Supp. Tables 2, 3).
11	
12	LiD group had consistently lower cognitive scores
13	The LiD group scored significantly lower than the TD group on all seven sub-tests and four composite
14	scores of the NIH Cognition Toolbox across Waves 1 and 2 (Figure 1B, Table 3, Supp. Tables 4, 5).
15	Scores did not change significantly over time for either group as indicated by non-significant Wave or
16	Group x Wave interaction effects.
17	
18	LiD group had consistently lower skills in segregating sentences
19	The LiD group had lower LiSN-S z-scores than the TD group across waves (Figure 1C and Table 2, Supp.
20	Table 5, 6). Spatial Advantage scores increased significantly from Wave 1 to Wave 2 for both groups.
21	Other LiSN-S z-scores did not show any significant change over time. Spatial Pattern Scores were similar
22	between groups and waves. Notably, fewer children met the diagnostic criteria for SPD based on Pattern
23	Scores at Wave 2 than at Wave 1: only three children (3 LiD, 0 TD) compared to thirteen children at
24	Wave 1 (7 LiD, 6 TD).
25	
26	Differences between the TD and LiD groups persisted through adolescence
27	We examined longitudinal changes in listening skills, speech-in-speech skills, and cognitive function
28	across three waves based on 31 participants who completed all three waves (Figure 2). The TD group had
29	higher ECLiPS sub-scores and Total Scaled scores than the LiD group (Analysis Part 1b model, Supp.
30	Table 7), as in the Part 1a analysis of Waves 1 and 2 data. However, both groups had improved listening
31	skills over time relative to the age-standardized scores. ECLiPS speech and auditory processing subscale

- 32 score and composite Listening score were significantly higher in Wave 2 than Wave 1 across both groups.
- 33 Moreover, ECLiPS Total Scaled scores in Wave 3 were significantly higher than Wave 1. In contrast to
- 34 the listening skills, there was no significant change in cognitive function or speech-in-speech skills over

- 1 time for either group. The TD group had significantly higher NIH Cognition Toolbox scores and two
- 2 LiSN-S z scores (Low Cue and Talker Advantage) than the LiD group. Wave 1 participants who did not
- 3 participate in Wave 2 dropped out randomly (Little's p = 0.74). However, those who did not participate in
- 4 Wave 3 were non-random (Little's p = 0.01), suggesting systematic reasons for attrition. Maternal
- 5 education was not included in the model due to the small sample size.
- 6

# 7 Cognitive, sensory, and socioeconomic factors independently contributed to parent-reported

# 8 listening skills

- 9 For Part 2 of the analysis, we compared two models to predict ECLiPS Total Scaled scores: one based on
- 10 Wave 2 data only (Petley et al. 2021), and another based on longitudinal data from both Waves 1 and 2.
- 11 The original model explained 42% of the variance of ECLiPS Total Scaled scores at Wave 2. Our new
- 12 model explained 54.8% of the variance ( $\chi^2(2) = 48.21$ , p < 0.0001). The new model included three
- 13 significant predictors: maternal education ( $\beta = .70$ , p = .0038), NIH total composite score ( $\beta = .49$ , p
- 14 < .0001), and LiSN-S Spatial Advantage ( $\beta = .16$ , p = .0023). These results indicate that children's
- 15 listening skills during Waves 1 and 2 were independently influenced by their cognitive function, speech-
- 16 in-speech skills, and maternal education level. Children whose mothers had a Bachelor's degree scored
- 17 higher on the ECLiPS than those whose mothers had a High school diploma by 3.1 points.
- 18

## 19 ECLiPS, LiSN-S, and NIH Toolbox scores demonstrated reliability between Waves 1 and 2

- 20 As Part 3 of the analysis, we evaluated the test-retest reliability of the measures (Figure 3, Table 4, Supp.
- 21 Table 8). The ECLiPS Total Scaled scores showed good reliability across Waves 1 and 2 with no
- 22 differences between TD and LiD groups. The mean test-retest difference on the ECLiPS was 0.10, and the
- 23 SD was 2.33. The NIH Toolbox sub-tests and composite scores also had significant and consistent
- 24 correlations across waves (ICCs for each sub-test ranging from 0.48 to 0.82) and groups (p values from z-
- tests ranging from 0.07 to 0.92; Supp. Table 8). The mean test-retest differences ranged from -5.59 to
- 4.58, with the SDs ranging from 9.66 to 27.02 compared to the normalized mean score of 100. LiSN-S
- 27 scores revealed a moderate but significant agreement between waves, with ICCs ranging from 0.28 to
- 28 0.42. The mean test-retest differences in standard deviation units were between 0.18 and 0.41, with SD
- 29 between 1.26 and 2.13.
- 30

#### 31 **DISCUSSION**

#### 32 Impact of study

We found that ECLiPS, LiSN-S, and NIH Toolbox scores were stable over time. Children with
 LiD, identified by the ECLiPS caregiver questionnaire, consistently performed more poorly than TD

1 children on auditory and cognitive tasks across multiple years. Maternal education was a significant

2 predictor of caregiver-reported listening skills, independent of auditory and cognitive skills.

3 Socioeconomic factors may, therefore, play a crucial role in this complex condition. Aligning with our

4 prior cross-sectional study, cognitive skills played a relatively larger role in the parent report of listening

5 difficulty than auditory skills. The enduring nature of LiD has clinical implications for early detection

6 and intervention for childhood LiD, which may have long-term effects on affected individuals.

7

## 8 Socioeconomic factors in listening difficulties

9 This study is the first to show how socioeconomic factors affect reported listening skills in 10 children with LiD after partially controlling for auditory and cognitive skills measured by the LiSN-S test 11 and NIH Toolbox scores. Previous studies have linked maternal education to various aspects of child 12 development, such as academic outcomes (Harding et al. 2015), language skills (Magnuson et al. 2009), 13 attention problems (Hjern et al. 2010), and auditory brainstem responses (Skoe et al. 2013). It is therefore 14 unsurprising that maternal education was associated with the degree of LiD in this study, given the known 15 relation between LiD and these other developmental factors (Moore et al. 2018; Hunter et al. 2023). 16 However, the finding is noteworthy because we controlled for cognitive and sensory functions using the 17 LiSN-S test and NIH Toolbox scores, which suggests that maternal education may have an independent 18 effect on LiD beyond these factors. Alternatively, maternal education may influence LiD through other 19 factors. Future studies could further explore and parse the influence of socioeconomic factors. In the 20 meantime, maternal education and socioeconomic factors may inform the risk of LiD and guide clinical 21 management, including the frequency of follow-up and intervention. Clinicians could also provide 22 support and guidance for parents with lower socioeconomic status who may face more challenges in 23 accessing resources or implementing home-based activities for their children. They could also refer the 24 children to other services, such as social workers or community programs, that can help them overcome 25 disadvantages.

26

#### 27 Persistent listening challenges

This study provides evidence that children with LiD overall experience persistent listening challenges across time, as indicated by significantly lower mean ECLiPS scores compared to TD children across three waves of testing. Our analysis also accounts for the stability of scores for each participant over time, as we used mixed-effect models to evaluate the longitudinal score changes of each participant. The findings suggest that differences between TD and LiD groups are not due to a supra-normal performance of TD children, as their ECLiPS scores were consistent with other independent samples of children without LiD (Barry et al. 2015). The results are consistent with previous research (Del Zoppo et

1 al. 2015) and underscore the need for early diagnosis and active management to minimize the long-term 2 effects of LiD. Our findings also raise questions about the effectiveness of current management strategies 3 for LiD, which may not adequately address the unique needs of these children. In reviews of medical 4 records, we found that more than half the children with LiD had received specialist assessment and 5 interventions before and/or during the study period. To better evaluate the efficacy of these interventions, 6 future research should use quantitative outcome measures specific to each treatment. This will help 7 identify the most effective strategies for addressing the persistent listening challenges experienced by 8 children with LiD.

#### 10 Cognitive challenges

11 Cognitive challenges of LiD participants were persistent throughout the study period, as shown 12 by our prior Wave 1 study (Petley et al. 2021; Stewart et al. 2022) and longitudinal data from this study. 13 LiD participants performed more poorly than controls on all the NIH Toolbox subscale and composite 14 scores. Modeling revealed that the NIH Total Composite score was the most predictive cognitive measure 15 for reported LiD, surpassing any combination of NIH Toolbox subscales. Moreover, the NIH Total 16 Composite score had a threefold higher beta weight than the next most predictive outcome, speech-in-17 speech repetition (LiSN-S Spatial Advantage). This finding underscores the substantial role of cognitive 18 impairment in parent-reported LiD. It is worth noting that the LiD group in our study may have included a 19 variety of underlying etiologies, as we used the ECLiPS Total Scaled score as an inclusion criterion. 20 Consequently, our results are relevant to children with LiD as a whole, rather than to a specific underlying 21 condition of LiD. To address distinct needs, individual children with specific deficits should receive 22 evidence-based, targeted treatment (Dillon and Cameron 2021; Sharma et al. 2012; Musiek and Chermak 23 2007).

24

## 25 Speech-in-speech listening

26 One purpose for using LiSN-S was to characterize the specific pattern of impairment in LiD 27 participants using individual and derived scores of LiSN-S that represent different aspects of listening 28 abilities. In this study (Part 1a), the TD group outperformed the LiD group on all age-adjusted LiSN-S 29 scores. Our results thus highlight the significant challenges that LiD children face across multiple 30 domains of listening ability. Interestingly, in the Part 1b analysis, children with LiD scored lower only in 31 the Low Cue and Talker Advantage, similar to our previous findings in Wave 1 (Petley et al., 2021). 32 Taken together, the data suggest that Low Cue and Talker Advantage may be more sensitive measures for 33 differentiating TD and LiD than other LiSN-S scores for most children in this cohort.

1 Although the number of cases was small, the prevalence of SPD decreased at Wave 2, despite 2 ongoing listening, auditory, and cognitive challenges in the LiD group and without any participants 3 receiving specific treatment for SPD (Cameron et al. 2012). Furthermore, neither the Pattern score nor the 4 frequency of SPD differed significantly between the TD and LiD groups, suggesting that, at least in this 5 cohort, SPD does not represent the listening problems identified by the ECLiPS (Petley et al. 2021). 6 Future research clarifying the clinical significance and natural history of SPD would be beneficial. 7 Among LiSN-S scores, only the Spatial Advantage age-adjusted scores increased significantly from 8 Waves 1 to 2 in both groups. This could be due to developmental changes or inconsistent normalization 9 and is unlikely to be training effects after a 2-year separation between tests.

10

#### 11 **Reliability**

12 We believe our findings are based on reliable longitudinal data, as the current study utilized a 13 large sample of children and had a 68% follow-up rate at Wave 2, much higher than a prior longitudinal 14 study of childhood LiD with only a 13% follow-up response rate (Del Zoppo et al. 2015). Additionally, 15 loss to follow-up at Wave 2 was random, suggesting a low likelihood of sampling bias. Findings from 16 Waves 1 and 2 thus likely represent the typical progression of LiD. Unfortunately, due to COVID, the 17 follow-up rate of Wave 3 dropped significantly, and sampling bias was introduced. However, analysis of 18 Wave 3 participants showed overall longer-term results that were consistent with the primary analysis of 19 Waves 1 and 2.

20 ECLiPS, LiSN-S, and NIH Toolbox scores all showed statistically significant correlations 21 between Waves 1 and 2. These correlations were similar for the TD and LiD groups. The high reliability 22 of the Toolbox scores observed in this study, even with long testing intervals of two years, seems to 23 alleviate recent concerns regarding these scores (Taylor et al. 2022). This high reliability may be 24 attributable to consistent testing procedures carried out by research staff at a single site, as opposed to 25 testing across multiple sites (Taylor et al. 2022). Although LiSN-S age-adjusted scores were significantly 26 correlated between Waves 1 and 2, the agreement between waves ranged from poor to good, and 27 correlation coefficients were generally lower than those reported in a previous study (Cameron et al. 28 2011). The higher retest reliability for that previous study may be explained by shorter testing intervals 29 (2-4 months) and older (above 12 years old) participants (Cameron et al. 2011).

30

## 31 Limitation

32 Due to the small sample size of Wave 3, we ran a separate analysis focusing on longitudinal 33 changes of Wave 3 participants to reduce sampling bias. Though this method reduced bias, the analysis 34 remained underpowered. Despite this limitation, our overall research findings are significant because we

- 1 showed long-lasting challenges of childhood LiD that may influence clinical management strategy, and
- 2 we identified a social factor, maternal education, that independently contributes to reported LiD.

# 4 Conclusion

- 5 Children with LiD and clinically normal audiograms have persistent auditory, listening, and
- 6 cognitive challenges through at least early adolescence. The degree of LiD can be independently
- 7 predicted by maternal education, cognitive processing, and spatial listening skills with a relatively larger
- 8 influence of cognitive processing over other factors.






