

		applicable to staff members). Individuals are required to show their vaccine pass
		for digital scanning and record. Vaccine Pass is a QR code on a paper
		vaccination certificate or the LeaveHomeSafe app that contains COVID-19
		vaccination history. Individuals who have not received at least one dose are
		prohibited from entering government buildings and the other 24 types of
		designated premises listed above, or otherwise may face a maximum fine of
		HK\$10,000 (US\$1280). Under the arrangement of the Vaccine Pass, a person
		who is medically unsuitable for vaccination is required to obtain an Exemption
		Certificate issued by a doctor.*

^{*}Of note, approximately 40,000 exemption certificates were issued (for reference, the population of Hong Kong is 7.3 million). On 27 September 2022 the government invalidated more than 20,000 exemption certificates issued by seven doctors, and banned those seven doctors from issuing any further exemption certificates. Several doctors and more than 20 patients were arrested in connection with allegedly fraudulent certificates, and at least two of the seven doctors subsequently faced criminal charges in court.
