1. Age-dependent risks

The agent-based model uses age dependent hospitalization, ICU and death risks based on Table S1. Symptomatic individuals of different age groups either recover or get hospitalized, require ICU or die through different rates reflecting their immunity or comorbidity status.

2. Lockdown schedules in Hillsborough County, FL.

The closure and lockdown schedules followed in Hillsborough County were collected from the mandates issued by the governors [2-6]. The detailed lockdown schedules that were applicable to places ranging from schools and workplaces to community places are shown in Figure S1. Since they include finer details, we distilled this information to reflect the closures vis-à-vis schools, workplaces, community place to inform our DT-ABM system. The distilled information that is used in the DT-ABM-system is shown in Table S3.




Figure S1. Lockdown timelines in Hillsborough County, Florida, during COVID-19 pandemic.

3. Vaccine schedule and doses

We use the daily vaccine doses data available from CDC for Hillsborough County to implement vaccination in the simulator. Since there are gaps in the data we use polynomial fits to approximate the data and use the numbers suggested by these polynomials to vaccinate individuals in the agent-based model. The vaccine dose data and the fitted polynomial curves are shown in Figure S2. Furthermore, each dose type is divided into number of doses to different age groups as shown in Table S4.




Figure S2. Daily vaccine numbers delivered in Hillsborough over time, starting with vaccine dose 1, dose 2, booster 1, booster 2.

4. Model complexity

The full DT-ABM relies on data availability to function. Based on the details of the available the complexity of the system increases. A summary of data availability and complexity is shown in Figure S3. As an example, if race/income data is available then individuals' race/income specific data is used in the DT-ABM. The output from DT-ABM analysis could then be used income and race-related risk factors.




Figure S3: The complexity of the simulator increases as data for age-, comorbidity-, race- and gender-based transmission factors become available at the zip-code or county level.
