


Figure S3. PRISMA diagram




Figure S4. Countries represented in the review




Figure S7. Quality assessment results for the included studies




Figure S9.1 Forest plot showing sensitivity analyses results for limiting nicotine in smoked tobacco products




Figure S10.1 Forest plot of sample size against proportion of support (tobacco endgame goal)




Figure S10.2 Forest plot of sample size against proportion of support (limiting nicotine in smoked tobacco products)




Figure S10.3 Forest plot of sample size against proportion of support (restricting cigarettes supplies and sales by birth year, i.e., TFG)




Figure S10.4 Forest plot of sample size against proportion of support (banning cigarette sales)




Figure S10.5 Forest plot of sample size against proportion of support (reducing commercial viability of tobacco companies)
