Spells

The unit of analysis for ACSC in this report is a continuous inpatient (CIP) spell. A CIP spell is a continuous period of care in hospital, regardless of any transfers which may take place; it may include more than one episode or provider. An episode is a continuous period of admitted patient care under one consultant within one healthcare provider. The length of stay (LoS) is the duration of a spell, i.e. days between admission and discharge. ACSC spells are those CIP spells where the first episode is an ACSC episode.

The method of discharge (DISMETH) is 1, 2 or 3 (Discharged on clinical advice, Self-discharged, or discharged by a mental health review tribunal, i.e. not died, a baby or still in hospital).

For the first episode of the CIP spell (EPIORDER=1):

- The patient classification is an ordinary admission only (CLASSPAT=1).
- The primary diagnosis doesn't relate to Obstetrics (DIAG_01 doesn't begin with 'O')
- It is a General episode (EPITYPE = 1)

- The age at start of episode is between 0 and 120 (STARTAGE)
- Patient date of birth not 01/01/1900 or 01/01/1901 representing unknown (MYDOB)
- The sex of patient is male or female (SEX is 1 or 2)
- The Main specialty is not

For the last episode of the CIP spell:

- It is a general episode only (EPITYPE=1)
- The Main specialty is not Obstetrics, Midwifery or General Practice with Maternity Function (MAINSPEF) is not 501, 560 or 610

And CIP spells that belong to patients who have had cancer episodes or chemotherapy for cancer both within the reporting year or anywhere in the 365 days prior to admission are not considered ACSC spells (DIAG_01 – DIAG_20 not C00-C97, D37-D48 or Z51.1.

One ACSC condition is assigned to each spell. Conditions numbered 1 to 15 in the list below use primary diagnosis at time of admission, so these conditions were assigned to the ACSC spells first. The last four conditions in the list can appear in any diagnosis position in the admission episode and therefore were assigned after the first 15, as only one ACSC condition has been assigned to a spell.

- 3. Chronic obstructive pulmonary disease
- 4. Angina
- 5. Iron deficiency anaemia
- 6. Hypertension
- 7. Nutritional deficiencies
- 8. Dehydration and gastroenteritis

- 10. Perforated/bleeding ulcer
- 11. Cellulitis
- 12. Pelvic inflammatory disease
- 13. Ear, nose and throat infections
- 14. Dental conditions
- 15. Convulsions and epilepsy
- 16. Gangrene
- 17. Diabetes complications
- 18. Influenza and pneumonia
- 19. Other vaccine preventable

Readmissions

For purposes of this report, if a patient is admitted to hospital within 29 days from the previous discharge, this is considered a readmission. The previous admission must be an ACSC spell for the subsequent admission to be considered as an ACSC readmission. The number of days between discharge date (DISDATE) of the ACSC spell and the admission date (ADMIDATE) of the subsequent admission, irrespective of whether it is an ACSC spell or not, must be between 0 and 29 days for it to be considered a readmission.



Ethnicity

The ethnicity of the patient, as specified by the patient is recorded using 18 possible values as defined in the 2001 census. In this report they have been grouped as shown below.

Organisation reference data

The Clinical Commissioning Group (CCG) used in this analysis is derived in HES. It contains the code for CCG of Responsibility. In HES, this is derived from postcode of patient's GP practice, but if that data is not available it uses postcode of patient's residence and if that data is not available it uses postcode of the provider to lookup the CCG code from the Postcode Directory which is available in ODS section in the NHS Digital website.

The Sustainability and Transformation Partnership (STP) codes are derived using reference data available in ODS section in NHS Digital website from CCG of responsibility present in HES.

Suppression

Data suppression is based on HES Disclosure Control Methodology for Hospital Episode Statistics for the Admitted Patient Care (APC) data set. For the counts of spells: Zeroes remain unchanged, counts between 1 and 7 (inclusive) are shown as 5 and all other counts are rounded to the nearest 5.
