# A Protocol for a Scoping Study of Economic and Data System Considerations for Climate Change and Pandemic Preparedness in Africa

#### **Abstract**

**Background:** Africa's changing climate heightens risk of disease outbreaks with impacts on vulnerable demographics already encumbered by health and socioeconomic burdens. Health preparedness policies to address disease outbreaks rely on integrated information systems and value-for-cost analysis to facilitate sound decision-making during a public health emergency. This rapid scoping review protocol describes the *a priori* objectives and methods to conduct a synthesis of the evidence on economic evaluation and data system capacity at the intersection of pandemic preparedness and climate change.

Methods: A search of six bibliographic databases will be conducted by a library information professional spanning the period 2010 – 2023, focused on literature published about pandemic preparedness in Africa in the context of climate change. Studies will be screened in a three-stage process by independent reviewers using Covidence software, with a proportion of excluded articles crosschecked by a reviewer not involved in screening. All articles included in the final study set will need to have a positive response to at least three out of four *a priori* screening questions. Data extraction will follow established frameworks for pandemic preparedness, a list of 14 target climate-sensitive infectious diseases with pandemic potential declared as Public Health Emergencies of International Concern and listed on the WHO's R&D Blueprint Pathogens, and economic evaluation or data systems domains. Evidence synthesis will include article bibliometric analysis as well as thematic topic categorisation. Gap analysis will be conducted through topic mapping.

**Discussion:** This protocol lists the methods and analysis that will be followed to survey the literature on the linkages between climate change and pandemic preparedness relating to economic evaluation and data systems structures and needs.

### **Background**

Climate change exacerbates exposures and intensifies vulnerabilities for populations worldwide encumbered by health and socioeconomic burdens. In Africa, low-and-middle-income countries (LMICs) contribute nominally to greenhouse gas (GHG) emissions but are projected to face outsized impacts of climate change which threaten population health. An absence of effective and joined-up institutional cooperation and strong governance mechanisms limit opportunities for transdisciplinary and data-driven responses to complex health emergencies such as epidemic and pandemic outbreaks.

In conjunction with shifting land-use patterns, climate change both heightens risks for climate-sensitive infectious disease (CSID) emergence and spread and can lead to the re-emergence of previously controlled infectious diseases. Alterations in both habitat suitability and geographic range of wildlife species potentiate new pathogen emergence by driving cross-species pathogen exchange at high-risk interfaces (Carlson et al., 2022; Gibb et al., 2020) or through introduction of non-endemic diseases into new geographic areas and new transmission pathways (Ranjan et al., 2023; Thomassen et al., 2013). Favourable environmental conditions might also allow recrudescence of particular diseases such as sporulating or saprophytic pathogens, or facilitate re-introduction of disease vectors previously excluded by programs of countermeasures (Cohen et al., 2012; Walsh et al., 2018). Notably, all eight of the viral diseases ever declared by the World Health Organisation (WHO) as Public Health Emergencies of International Concern (PHEIC) and eight of nine<sup>1</sup> diseases prioritised by the Research & Development (R&D) Blueprint for pathogens with epidemic potential (WHO, 2022) are categorised as climate-sensitive, according to a recent review (Mora et al., 2022). Socially marginalised demographic groups are most at risk from the unequal impacts of climate change, for instance flooding events may impede patient access to healthcare services causing delays to diagnosis or treatment (Zuurmond et al., 2016) with potential to raise the risk of uncontrolled disease spread and pandemic emergence.

While prevention and detection of emergence of CSIDs presents significant challenges, the spiralling costs of response and control measures associated with pandemic outbreaks due to long-lasting social, public health, and economic downturns, as seen in the 2014 Ebola outbreak in West Africa (Huber et al., 2018) and more recently with COVID-19, leave little doubt as to the necessity for established pandemic preparedness procedures. These recent outbreaks demonstrate the importance of agile and rapid decision-making by policy actors, reinforced by strong health governance and supported by integrated data systems and priority-setting processes based on value-for-cost assessments. Developing evidence-informed and data-driven policy responses builds confidence and public support for deployment of public funds during a public health crisis.

Economic considerations with respect to climate change and pandemic preparedness can be viewed through the lens of resource allocation choices which include exploring the cost-effectiveness of outbreak interventions and prevention. In this instance, economic evaluation (such as cost-effectiveness/cost-utility analysis, or cost-benefit analysis) is normally incorporated as part of priority-setting processes, which are ideally institutionalised and include approaches such as Health Technology Assessment (HTA) that consider a body of evidence and consider multi-stakeholder perspectives. Economic evaluation and priority-setting for CSIDs can be framed through an adapted framework outlining four stages of pandemic preparedness, namely, Prevention (Stage 1): pre-epidemic preparedness; detection (Stage 2): identify, investigate, evaluate risk; Response (Stage 3): outbreak response & containment; Evaluation (Stage 4): Post-epidemic evaluation (WHO, 2014). Successful priority setting structures requires capacity to exist both on the supply side in terms of evidence generation (e.g. the availability of skilled researchers able to undertake a relevant economic evaluation), and also on the demand side, such as the presence of formalised systems or bodies to use this evidence for policy.




Figure 1. Pandemic Preparedness Framework for Climate Sensitive Infectious Disease in Africa. Adapted from: World Health Organisation. (2014). Ebola and Marburg virus disease epidemics: Preparedness, alert, control, and evaluation. <a href="https://www.who.int/publications-detail-redirect/WHO-HSE-PED-CED-2014.05">https://www.who.int/publications-detail-redirect/WHO-HSE-PED-CED-2014.05</a>

As illustrated in Figure 1, Stage 1 of the adapted pandemic preparedness framework describes the emergence and re-emergence of infectious diseases with pandemic potential, whose emergence, distribution, or virulence can be affected by climate change. Literature that provides evidence of priority-setting methods, data collection systems, or economic evaluation of methods for the prevention of emergence/re-emergence of CSIDs will be categorised as Stage 1 evidence. In contrast, Stage 2 describes the effect of detection measures in preventing CSID outbreaks after emergence has occurred, including early warning surveillance and cost-effectiveness evaluations thereof. Stage 3 encompasses evidence on priority-setting processes and economic evaluation of outbreak response countermeasures. Finally, literature categorised as Stage 4 evidence will include post-outbreak and resource allocation analysis, such as after-action reviews.

### Rationale

There is an urgent need to map evidence gaps, define future research priorities, and strengthen stakeholder networks at the climate-health interface to support policy development for better health outcomes and improved health systems resilience for vulnerable populations. This requires multidisciplinary and whole-of-government approaches, drawing from the integrative fields of One Health and Planetary Health, with a focus on health equity to prioritise marginalised demographics. By improving understanding of the climate-health nexus, strategies to prevent, detect, and respond to disease outbreaks can be developed more effectively.

Scoping reviews offer a systematic method of mapping the state of knowledge to identify common themes and to uncover gaps in evidence. Rapid reviews condense these methods and are often used to accelerate the knowledge translation process when policy or strategy development is urgently needed (Haby et al., 2016). This rapid scoping review protocol thus outlines the process used to define key themes and identify evidence

gaps on economic evaluation and data systems in relation to pandemic preparedness and to develop a research agenda that supports progress on CSID knowledge and policy development in Africa.

### Scoping Review Objectives

- To map out key themes and entry points for future African-led research and to identify gaps in evidence for priority setting using economic evaluation and data systems for policy development;
- ii. To use bibliometric analysis to assess institutional stakeholder networks and to evaluate trends in research development on key themes and outputs included in the review;
- iii. To identify applications for a transdisciplinary and gender-intersectional approach for CSID preparedness and response.

### **Research Questions**

- What are the key themes, in terms of economic evaluation (including cost-effectiveness) and priority setting, that describe how climate change is incorporated into pandemic preparedness and outbreak response planning?
- ii. What data systems are currently in use or needed to support priority setting for integrated and multisectoral epidemic or pandemic planning for climate-sensitive infectious diseases in Africa?
- iii. What subnational, national, and regional structures are in place to support joined-up data sharing for CSID outbreak detection and response within and between African countries and the international community?

#### Protocol

Informed by the Preferred Reporting Items for Systematic Reviews and Meta-Analyses (PRISMA) for Protocols (Shamseer et al., 2015) we outline our methods a priori for this rapid scoping review. The protocol is registered online on the Open Science Framework repository (https://doi.org/10.17605/OSF.IO/VTGMC).

## Search Strategy

The search strategy will be compiled by a library information professional with a focus on four search concepts, namely:

- Pandemic preparedness AND
- Climate change AND
- Economic evaluation (including health technology assessment and priority-setting) OR
- Data systems

A draft search, run on the OvidSP Medline database is included as an appendix.

## **Information Sources**

Relevant literature will be included through searches of six bibliographic databases: OvidSP Medline, OvidSP Embase, OvidSP Global Health, EBSCOhost Africa-Wide Information, OvidSP Econlit and Clarivate Analytics Web of Science Core Content. Search terms will first be tested in one database prior to implementation in the other five. Additional sources of literature from hand-searching relevant reference lists and from work previously conducted by co- authors will be included.

Grey literature will be incorporated through review of relevant reports, documents, and publications from the International Development Research Centre (IDRC) and by asking key stakeholders for recommended literature, particularly non-indexed reports, through informal interviews taking place in parallel to the scoping review.

### Data Management

De-duplicated citations of bibliographic database and grey literature searches will be uploaded into Covidence software (Veritas Health Innovation, 2024) for reference management and multi-reviewer screening. Eligibility criteria will be used to identify articles for inclusion as described in the Data Selection process. All reviewers will be trained on the use of screening software.

#### Data Selection

Articles from the bibliographic database and grey literature search will be compiled and put through three-stage screening. An initial stage of title screening will be conducted to exclude articles that can be quickly disregarded at the title stage. The second stage of screening on the remaining articles will select eligible abstracts against a set of four screening questions. All abstracts must have a positive response to screening questions number 1 and 2 and at least one of either question 3 or 4 to be eligible for inclusion in the final full-text screening stage. Screening will be conducted by single independent reviewers and a proportion of excluded articles will be randomly selected for confirmation by one member of the review team. Abstracts in languages other than English will be documented but excluded; translations will not be sought for full-text articles not in English. Reasons for study exclusion will be documented at both the abstract and the full-text screening stage for future summary. Studies that are inconclusive on screening will be discussed by the scoping review team to reach consensus on eligibility.

### **Screening Questions**

- 1) Is the article relevant to pandemic preparedness?
- 2) Is the article about a climate-sensitive infectious disease(s) that is included in the target list of diseases?
- 3) Does the article refer to economic evaluation or health economic studies to support priority setting including Health Technology Assessment?
- 4) Does the article discuss data systems relevant to identified domains for priority setting (see Table A1).

## **Data Collection Process**

Data collection will use a standard form in Covidence, which will be formatted as a table with data items listed in columns to be populated for each article. The form will be pre-tested against ten articles in duplicate prior to use.

### Data Items

Data collected from each article will include article meta-data and article themes. Article meta-data will include year of publication, publication source (institution and country), first author and first author's institution, collaborating institutions and contributors, source of funding, conflicts of interest reported, type of publication. Topic data will also be extracted and thematically categorised based on identified frameworks of the review. All articles must fit into one of the identified stages of the Pandemic Preparedness Framework (WHO, 2014). CSIDs will be identified and listed to confirm which diseases with pandemic potential are most researched. Data systems will be further sub-categorised as to the type of health information they incorporate across human, animal, or climate data, accessibility and overall degree of multi-disciplinarity; gender disparities will be captured in the thematic assessment phase. A final mapping of challenges and constraints will be conducted by assessing topics with the least volume or least relevant literature, and by identifying repeated themes describing evidence gaps arising in the final study set.

### Risk of Bias

A risk of bias assessment will not be conducted in this rapid scoping review; therefore, the authors will not be able to qualify that the conclusions are not biased. However, the authors will extract and summarise study methodologies which may be useful as an indicator of potential bias of evidence. Additionally, exclusion of

non-English articles may bias the output to English-speaking countries in Africa, however, is a necessary exclusion criterion given the rapid nature of the scoping review.

### Synthesis of Results

The scoping review process used to achieve the final study set will be illustrated using a flow chart template. The number of studies at each stage of screening will be included and reasons for exclusion will be provided at both the title and abstract and the full-text screening stage. Extracted data will be analysed through three methods: bibliometric analysis to characterise the set of included articles; topic mapping to identify the key themes relevant to the review and identify evidence gaps; and narrative synthesis to contextualise the findings of the review.

### Bibliometric analysis

Bibliometric analysis is a methodology from the field of information science that is useful for identifying trends in large volumes of literature. In this review, we will use bibliometric analysis on tabulated article meta-data to define research hubs in Africa through institutional network analysis, to understand temporal trends in publication intensity, and to provide a summary of funding and research funders active at the intersection of pandemic preparedness and climate change. Both temporal and geographical trends will be assessed. We will attempt to explore authorship patterns to identify key advocates and networks of research on the African continent. We will also assess institutional affiliations of first authorship and corresponding authors as a measure of academic capacity, retention and leadership in the field.

### Topic mapping

Thematic topic categorisation will precede gap analysis. Evidence from the literature will be classified by its relevance to the four stages of the adapted Pandemic Preparedness Framework; by the share of research on each CSID; and by which sub-theme of economic evaluation or data system the article provides evidence for. Sub-themes will be categorised and mapped temporally and geographically, data permitting. Gap analysis will be conducted based on differences between research intensity per sub-theme category, as well as identifying institutional or regional discrepancies in evidence availability.

## Narrative synthesis

Articles will undergo simple narrative synthesis to describe the main objectives and findings which will be tabulated for use as a data reference of included articles. Narrative synthesis will also include determining the proportion of articles that consider transdisciplinary and multisectoral approach to data and information systems ("One Health" approach) and the proportion of articles that consider gender-intersectional themes.

### Ethics and dissemination

This review will use publicly available reports and articles from bibliographic databases and online. As no primary or identifiable data will be used, ethical approval is not required.

This scoping review protocol and the findings of the review itself will be shared with stakeholders and decision-makers and made available as an open-access report. Dissemination is anticipated through publication online and in peer reviewed journals as well as at relevant meetings and workshops.
