## Correlations between worry that oneself/family and friends/the child would get COVID-19 and the agreement with the authorities on the restrictions and on COVID-19 severity

A moderation analysis using a linear model to test if one's opinion on the restrictions would moderate the relationship between worry for self/others/baby getting sick and the suicidal ideation was not possible. That is because the relationship between the level of worry and the suicidal ideation was not linear, with the moderate levels of worry having the lowest scores of suicidal ideation, while not worrying at all or worrying very much had higher scores of suicidal ideation.
