Supplementary Results

Incidence rates across subgroups

Age subgroups

For the age subgroup, we estimate sex-adjusted rates. Across cohorts (e.g., overall meta-analytic estimate), the FBG range of 110-126 mg/dL had largest overall incidence rates and I² for both the mid-aged (45-65 years) and older (>65 years of age) individuals (Figure S4A), a meta-analytic estimate of 9% (I²: 99) and 8.1% (I²: 86%) respectively. This is in contrast to individuals with FBG lower than 110 mg/dL, whose overall incidence rate was 1% (Figure S4A) for both the mid-aged and older individuals.

BMI subgroups

For the BMI subgroups, the incidence rates we report are adjusted by age and sex. Across cohorts, obese individuals had higher incidence rates across all definitions of prediabetes (Figure S4B) versus individuals who were not obese nor overweight. The overall/across cohort incidence rate for FBG 110-125 mg/dL for obese individuals was 9.6 (95% CI: 4.8, 14) per 100-person years (I²: 99%). The incidence rate was approximately half for those under 25 kg/m2 (overall incidence rate of 5 per 100 person-years, I² 91%) for the same FBG range (110-125 mg/dL). Furthermore, individuals who were obese but had A1C% in the 5.7-6.5 range had an incidence rate of 3.6 per 100 person-years (95% CI: 1.9-5.3; I²: 95%) (Figure S3B). All the incidence rates for prediabetes ranges, as reflected by their I², had a high range between cohorts. Take, for example, prediabetes for individuals who were obese and had FBG between 110-126 mg/dL: we observed the maximum incidence rate in the MESA (16.5, 95%CI: 13.9-19.1) and JHS (14.6, 95% CI: 11.2-18.0) population versus for FHS 3 (5, 95%CI: 3-7) (Figure S4B).

The minimum incidence rate of 0.8 per 100 person-years observed for any prediabetes threshold was observed for individuals who had both lower BMI (<25 kg/m2) and had A1C between 5.7-6.5%. For individuals who were obese and had A1C less than 5.7%, the incidence rate was just 1 per 100 person-years (I²: 7%) (Figure S4B). Figure S5 describes incidence rates for age and body mass index for normoglycemic levels. For sex subgroup, we estimated age-adjusted rates and observed a lack of difference between males and females (Figure S6).

Black and White race/ethnicity subgroups

The MESA cohorts consisted of participants who were Chinese, White, Hispanic, and Black and the ARIC participants were Black or White (Table S1), in contrast to the FHS and JHS studies, which primarily were composed of Black or White individuals, respectively. We estimated the incidence rate for each cohort and the Black and White race groups (Figure S7). We found that cohort-level differences persisted: black individuals from JHS had higher incidence rate than Black individuals from ARIC; White individuals in MESA had higher incidence rate than White individuals from FHS 2 or 3. Specifically, for FBG 110-125 mg/dL, the incidence rate was 12.5 (95% CI: 9.8, 15) per 100 person-years for JHS (all participants of Black ethnicity) and 15 (95% CI: 12, 18) per 100 person-years for the Black population of MESA. For the Black population in ARIC, however, the incidence rate was only 6 (95% CI: 5.5, 6.8) per 100 person-years (Figure S6). The incidence rate for A1C-based threshold for the Black population in JHS, MESA, and ARIC were 5.2, 1.8, and 1.2 per 100 person-years, respectively. Again, for FBG 110-125 mg/dL, the incidence rate to diabetes for the White subgroup was higher in MESA than in ARIC and FHS: 14 (95% CI: 11, 16.7), 5.3 (95% CI: 4.9, 5.6), and 5% (95% CI: 4.5, 5.5) per 100 person-years, respectively.

Heterogeneity of data-driven thresholds

We estimated the heterogeneity of thresholds for fasting glucose and A1C% that are chosen that maximizes the accuracy of prediction of incident diabetes (Table 4). The range of "optimal" thresholds for fasting blood glucose was 95 mg/dL (JHS) to 104 (FHS 2) and for A1C% was 5.6 (ARIC) to 5.8 (JHS and MESA). The I² for

the thresholds was 91% for fasting glucose and 65% for A1C%. The range of accuracies for fasting glucose was 0.73 (ARIC) to 0.88 (MESA).










Supplementary Figure 2. Rates for incident higher fasting glucose greater than or equal to 126 mg/dL.




Supplementary Figure 3. A.) Age and B.) BMI subgroup incidence rate for prediabetes to diabetes per cohort.




Supplementary Figure 4. Diabetes Incidence Rates for normoglycemic thresholds for A) Age and B) Body Mass Index ranges.




Supplementary Figure 5. Diabetes Incidence Rates for prediabetes and normoglycemic thresholds by sex.
