



S1_Fig. Protein-protein interaction network (PPIN). In the PPIN, *nodes* represent proteins containing coding CHD-SNPs, and the *edges* signify interactions between physically interacting proteins. The 'black' nodes correspond to query proteins and 'grey' nodes represent additional proteins in the

network identified in the GeneMania query search. The size of each 'grey' node is determined by the gene score, reflecting the relatedness of these proteins according to GeneMANIA. Larger circles indicate a stronger predicted connection between these proteins. Width of the edges signifies the weight of interaction between proteins. Thicker edges indicate stronger physical interactions. The network is constructed using the cytoscape-GeneMANIA module.





S2_Fig: Clustering of protein-protein interaction network using MCL algorithm.
