

## Supplementary Material - 1

### *Validation of Climate Change Anxiety Scale (CCAS) in additional populations*

The validation of 22-item version of CCAS was tested with samples from the US<sup>1</sup>, France<sup>2</sup>, and Australia<sup>3</sup>, with one group concluding that it was statistically more appropriate to use the 13-item version<sup>2</sup>. Other studies directly tested the 13-item version with different factorial solutions in samples from Germany<sup>4</sup>, Italy<sup>5</sup>, France<sup>2</sup>, Philippines<sup>6</sup>, Poland<sup>7</sup>, Korea<sup>8</sup>, US, China, India, and Japan<sup>9</sup>. The four-item version of the CCAS was tested with Canadian adolescents<sup>10</sup>, and the six-item version was tested in a US sample<sup>11</sup>. These studies suggested different factorial structures for the scale. While Hogg et al.<sup>12</sup> supported the two-factor structure for the 13-item version of it, as a result of the factor analyses and high correlation between the two subscales of the 13-item version of CCAS, three studies suggested not to treat the two subscales (i.e., cognitive-emotional impairment and functional impairment) as separate constructs but to use a one-factor structure<sup>4,5,11</sup>. Although Cruz and High<sup>11</sup> conducted their studies in the same country as the original study, they did not replicate the same factor structure as Clayton and Karazsia<sup>1</sup>. Four of the studies conducted in different countries supported the two-factor structure<sup>2,6,8,9</sup>, whereas one study suggested three factors<sup>7</sup>.

### *Test of the factor structures*

To test the factor structure and the model fit to the data, exploratory factor analysis (EFA) and confirmatory factor analysis (CFA) were conducted for six scales in scale development studies<sup>1,12-14</sup>, while three scale development studies carried out only EFA<sup>15-17</sup> and one did not report any factor analysis result<sup>18</sup>. Three scale development studies<sup>12,16,17</sup> and two scale validation studies<sup>8,19</sup> reported performing EFA using Principal Component Analysis (PCA) method. Among the scale validation studies, five tested both EFA and CFA<sup>5,7,8,10,19</sup>, and six conducted only CFA<sup>2-4,6,9,11</sup>, while one did not report any factor analysis result<sup>20</sup>. Among those conducted both EFA and CFA, four studies used different samples to conduct the analyses<sup>1,10,12,13</sup>, while the other five conducted EFA and CFA in the same sample. Multigroup CFA was conducted by two studies<sup>3,9</sup>. For those conducted CFA, the model fit indices were indicated on Table 2. The Tucker–Lewis index (TLI), the comparative fit index (CFI), the root mean square error of approximation (RMSEA), and the standardized root mean squared residual (SRMR) were used to evaluate the measurement models. Acceptable values for CFI and TLI are typically above .90 or .95, and for SRMR below .08<sup>21</sup>. RMSEA values below .05 indicate a good fit<sup>22</sup> and below .08 indicate appropriate fit<sup>21</sup>. To these criteria, one of the scale validation studies showed poor CFI<sup>5</sup>. Except for four studies that did not report the TLI value<sup>5,11,14,19</sup>, all met the TLI criteria. Eight studies did not report SRMR, whereas the other nine provided the rule of thumb<sup>2,4,6-12</sup>. To the RMSEA criteria, one

study showed a good fit<sup>14</sup> and seven studies indicated an appropriate fit (eco-anxiety, eco-guilt, and ecological grief<sup>1,2,4,6,7,12,13</sup> while one did not report RMSEA<sup>11</sup>.

#### *Test of validity*

The studies testing the convergent or discriminant validity of the instruments employed various types of variables. The most frequently used variables were anxiety (generalized, trait, state, or future anxiety) used in ten studies and depression used in nine studies. Other emotional/behavioural/cognitive dimensions were also used, such as stress, environmental identity, and pro-environmental behaviours. Two studies compared the groups of people who were exposed and those who were not exposed to environmental damage. One study involving participants from more than one country provided evidence for the cross-cultural validity of CCAS<sup>9</sup>. The variables used to test the validity were indicated in Table 2. The results of analyses conducted to test factorial structures and validity of each scale were presented in Table 3.
