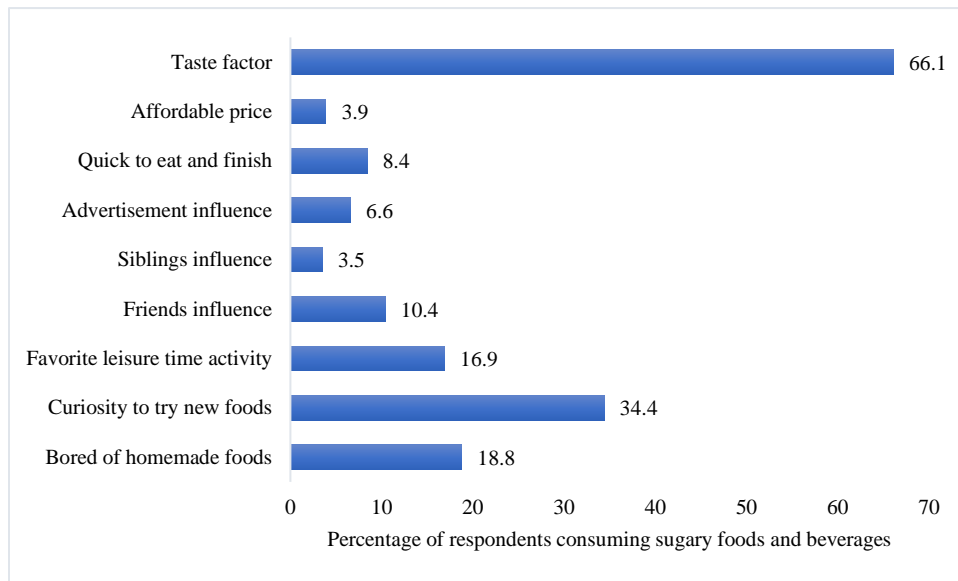


Figure A. Reasons for consumption of sugary foods and beverages among respondents
