Disease Definitions

Categories of interest, including diet, hypertension, type-2 diabetes (T2D) and cardiovascular disease (CVD) were defined based on recorded hospital episode statistics (HES) data and self-reported information. If the International Classification of Diseases 10th edition for HES data, or self-reported disease codes (UK Biobank fields) were reported at least once for each participant, at the time before the first imaging visit, they were classified as a case. A summary of the codes corresponding to the considered disease traits are provided in supplementary Table S1. Hypertension was defined as self-report of hypertensive medication use, or a prior diagnosis of hypertension, or mean blood pressure $\geq 140/90$ mmHg [3]. The codes for hypertension diagnosis were selected based on the ICD10 and the self-reported codes for hypertension. Hypertensive medication codes were selected from the medication fields, reporting as regularly taking blood pressure medication. The codes for T2D were selected based on the ICD10 and self-reported codes for type-2 diabetes (1). CVD was defined based on the ICD10 codes for angina, myocardial infarction, chronic ischaemic heart disease, atrial fibrillation, heart failure, and stroke (2).

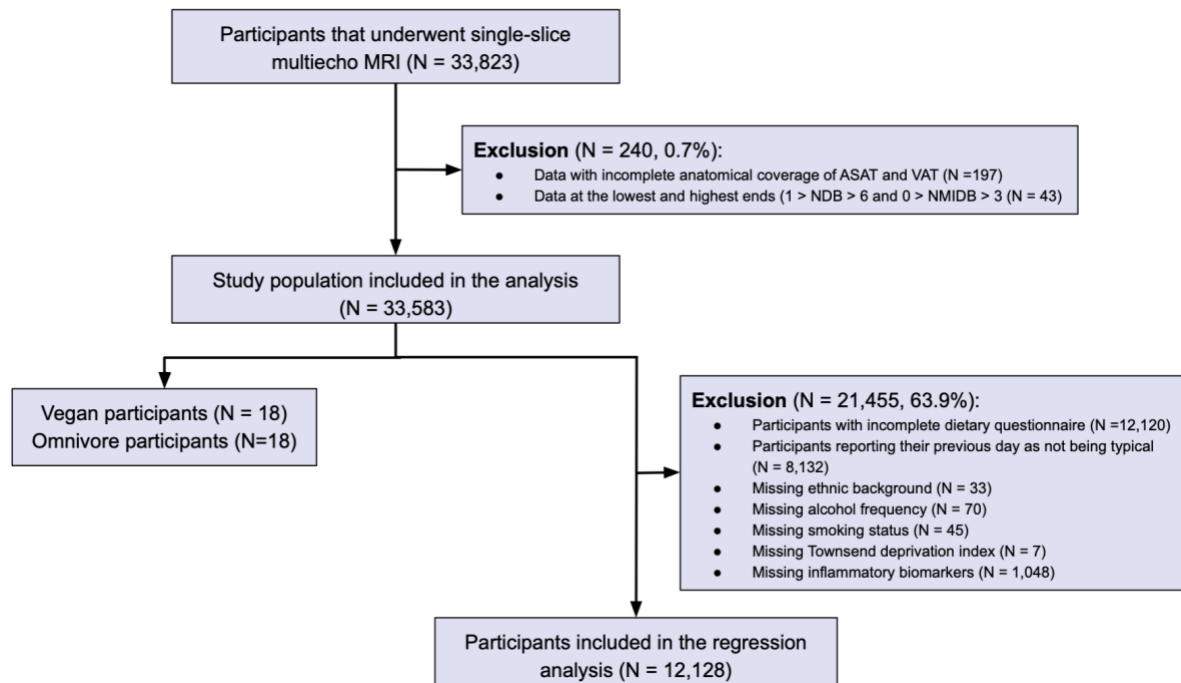


Figure S1. Flow diagram of the study population.
