


Figure supp 1: Schematic diagram of the different settings of Mendelian Randomization. **(A)** represents the univariate Mendelian Randomization analysis, used to estimate the causal effect of potential cardiometabolic risk factors. **(B)** represents the bi-directional Mendelian randomization analysis, used to estimate the reverse causality between uterine fibroids and cardiovascular diseases. The genetic variants used were selected with the GWAS significant threshold of $P < 5 \times 10^{-8}$.


