

Participants with MitoHPC run on whole genome sequencing data (n = 12,776)

Sample-level exclusion for heteroplasmy (n = 69)

- Suspicious (n = 57) of having 1) potential mitochondrial contamination at $\geq 3\%$, 2) ≥ 2 variants belonging to a different mitochondrial haplogroup, 3) multiple variants predicted to be NUMTs, or 4) low minimum base coverage (< 100) or low mean base coverage (< 500)
- mtDNA copy number ≤ 40 (n = 1)
- No visit information (n = 1)
- Heteroplasmy count ≥ 6 (n = 10)

Participants with mtDNA heteroplasmy data after QC (n = 12,707)

Exclusion due to ineligibility (n = 5,049)

- No WES data at the same visit (n = 4,340)
- No information on incident MN (n = 709)
- A potential MPN (n = 0)

Sample-level exclusion for CHIP calls (n = 4)

- High number of INDELs (n = 3)
- High number of CHIP variants (n = 1)

Exclusion due to missing data (n = 22)

- Missing smoking status (n = 22)
